Ms Hefler inquired about the status of a bus service for the Lucasville Road. She also requested changes to the tenancy act, specifically related to mobile home parks, that Bylaw services direct dangerous and unsightly orders be the renter's responsibility not the land owner. She also wanted to know the status of the community signs being placed in Lucasville.
