20. PUBLIC PARTICIPATION

Mr. Jim Gates, of Halifax noted his experience as a Firefighter and provided commentary with respect to the proposed changes to fire service staffing levels, service delivery standards, and dispatch times. He advised that proposed changes to operations and staffing for Fire and Emergency Services currently being considered by Council will be detrimental to service delivery, particularly as the population further densifies. He provided information with respect to resources required to safely and efficiently respond to a fire or emergency situation in all areas of the municipality and expressed concern in relation to potential increases in travel/response time and the appropriate level of staffing available to adequately respond. He encouraged members of Council to thoughtfully consider the impact of the recommendations of HRM staff with regard to Fire Services.

Councillor Craig thanked Mr. Gates for his comments and advised that the matter is currently before Council as it is within Regional Council's mandate. He advised that members of Community Council can listen to concerns brought forward by the public on this matter but cannot enter into a debate on the matter.

Mr. Brenden Marr, of Middle Sackville, noted his occupation as a Firefighter and expressed concern with staff's recommendations with respect to Fire Service standards. He provided commentary with respect to the proposed staffing levels and noted that Council should consider modestly increasing resources for Fire and Emergency Services to allow for the full staffing/resource compliment outlined in the 2006 study.

Mr. Nick Antov, of Waterstone, expressed concern with the proposed changes to Fire Services by HRM staff in particular the deployment of resources in the Sackville/Lucasville area. He advised that Council should reconsider staff's proposal.

Mr. Brad Little, of Middle Sackville, provided commentary with respect to his career as both a volunteer and career Firefighter. He expressed concern with respect to the proposed decommissioning of several fire stations within HRM and the potential impact that the proposed changes to operations and staffing will have on response times.

Mr. Tony Manning, Wellington, expressed concern the proposed recommendations from HRM staff regarding Fire Services. He provided commentary from his experience as a Firefighter noting the importance of having four individuals to staff an engine when responding to a fire emergency, particularly in the downtown. He advised that the proposed recommendations from HRM staff will negatively impact fire and emergency service delivery in the municipality.

Mr. MacDougall, of Dartmouth noted that the proposed fire services recommendations from HRM staff are having a negative impact on the moral of both volunteer and career Firefighters in HRM. He provided background information with respect to his career as a firefighter and advised that current proposal from HRM staff will negatively impact response times and service standards.

Mr. Darren Jones, of Halifax provided background information with respect to the importance of response time and adequate resourcing at emergency scenes. He expressed concern with the HRM staff's recommendation with respect to fire services and encouraged members of Council to listen to the concerns voiced by professional firefighters and the community when making a decision on the matter.

Mr. Len March, of Halifax reiterated points made by previous speakers in relation to response times and services standards for Fire and Emergency Services. He highlighted the importance of appropriate levels of weekend staffing levels.

Mr. Paul Boyle, of Halifax expressed concern with respect to the decommissioning of fire stations and the proposed staffing levels brought forward by HRM staff. He reiterated early points respecting the importance of response times and the resources required in responding to a fire emergency.

Mr. Steve Austen, of Halifax noted his occupation as a Firefighter and expressed concern with staff's proposed recommendations in relation to Fire Services. He provided commentary with respect to the detriments of potential increased travel and response times for firefighters to respond to an emergency.

Mr. Don Carrol, of Fall River advised that he is a volunteer Firefighter in Waverly. He provided commentary with respect to the high turnover rate of volunteers Firefighters in HRM, the difficulty in attracting and retaining new volunteer recruits, and the amount of time invested in properly training these individuals. He expressed concern with the staff's proposal to

Mr. Trevor Lucas, of Halifax noted his occupation as a career Firefighter. He provided background information with respect to shift schedules for those staffing an E-Platoon and noted that staff's proposal in this regard could lead to cases of fatigue and burn-out among his colleagues.

Mr. Jim Gates, of Halifax reiterated the points raised by Firefighters and members of the public in relation to HRM Fire Services. He thanked members of Community Council for listening to the concerns which were expressed.
