- 4.1.1 Case 19206: Development Agreement, 771 and 773 Bedford Highway, Bedford

MOVED by Councillor Johns, seconded by Councillor Whitman, that North West Community Council give Notice of Motion to consider the proposed development agreement, as contained in Attachment A of the January 5, 2015 report, to permit commercial land uses at 771 and 773 Bedford Highway, Bedford and to schedule a public hearing.

MOVED by Councillor Johns, seconded by Councillor Whitman, that North West Community Council appoint Councillor Matt Whitman from the North West Community Council membership to the St. Margaret's Bay Coastal Planning Advisory Committee for a term to November 2015. MOTION PUT AND PASSED.

4.1.3 Union Street Flooding

The following was before Community Council:

A staff recommendation report dated December 23, 2014

Mr. Richard MacLellan, Manager, Energy & Environment, reviewed the December 23, 2014 report with Community Council.

MOVED by Councillor Johns, seconded by Councillor Whitman, that North West Community Council recommend to Regional Council to direct staff to request that the Province of Nova Scotia Flood Reduction Assistance Program initiate a discussion with municipalities to examine roles, responsibilities, and opportunities to respond to emerging community residential abandonment needs with respect to climate change.

The Chair noted that addressing this matter is overdue, and noted that there are other areas of the Municipality that also require flood remediation.
