A staff report dated January 31, 2011 was submitted.

Ms. Stephanie Norman, Development Technician, provided the staff presentation outlining the Development Officer's decision to approve a variance of the Halifax Peninsula Land Use Bylaw for the conversion of a single-unit dwelling to a five-unit dwelling. Ms. Norman advised that the application proposed to add a four-unit addition to the rear of a single-unit dwelling and the variance was to allow the frontage

requirement of 40 feet to be reduced to 34.5 feet and a right side yard setback reduction from 6 feet to 5 feet, 7 inches. She noted that a neighbour appealed the Development Officer's decision.

Ms. Norman responded to questions from Community Council.

The Chair reviewed the rules of procedure and opened the variance hearing.

In response to a question by the Chair, Mr. Sean Audas, Development Officer advised that a notice of this appeal hearing was sent to the appellant.

Mr. George Ghosen, representing Fenwick Development Limited addressed Community Council and advised that the parking lot behind the property in question is currently uncontrolled and that there is usually 10 or 12 cars that park at their own discretion. He added this this proposal will reduce the amount of traffic going into that lot because the number of parking spots will be reduced and restricted to only the residents of the property.

The Chair called three times for anyone wishing to speak; there being none, it was MOVED by Councillor Blumenthal, seconded by Councillor Uteck that the appeal hearing close. MOTION PUT AND PASSED.

MOVED by Councillor Uteck, seconded by Councillor Blumenthal that Peninsula Community Council uphold the Development Officer's decision to approve the variance.

In moving the motion Councillor Uteck noted that she has received no complaints against this property and that the proposal will alleviate the concerns about the parking situation that currently exists on this lot.
