- 8.1 Variance #14949 1264 St. Margarets Bay Road
- A staff report dated January 12, 2009 was before Council.

Ms. Connie Sexton, Development Technician, presented the report to Council.

Councillor Rankin called for any speakers to come forward to speak to the Variance.

Mr. Fred Pope, the appellant, advised Council his concern is the setbacks, adding that

without a variance, the 5000 square feet of land would be useless. Mr. Pope distributed information to Council providing information on the history of the land. He advised Council that Nova Craft were supportive of his plan. He advised the intent for the land is industrial, as the water and sewer would not support any other type of use. He provided Council with a letter from the Johnson family, 1262 St. Margarets Bay Road, and Rosborough Boats Limited (Nova Craft Limited), adjacent owners, supporting the variance request.

In response to a query by Councillor Lund, Mr. Pope stated that 1264 St. Margarets Bay Road was built prior to 1986. He added that when it was built, it predated the Land Use Bylaw. Mr. Pope purchased the site in October 2007. He stated that in November 2007 when he acquired 1268, he was not aware of the regulations in place. He now understands the rules, and is going through the proper channels to request the variance for 1264 St. Margarets Bay Road.

Councillor Lund noted that when Mr. Pope purchased the land he was aware the risks involved.

**Mr. Vernon Johnson,** addressed Council, advising that Mr. Pole keeps a neat, clean property and has made upgrades to the community.

**Mr. Pope**, readdressed Council by stating that he would not let the community down and the area will continue to improve. He expressed his gratitude for the opportunity to present his case.

Councillor Rankin called three times for any further speakers on the variance. Upon the third and final call being given for any further speakers, and hearing none, it was MOVED BY Councillor Lund, seconded by Councillor Rankin that the Variance Appeal Hearing be closed. MOTION PUT AND PASSED.

Councillor Rankin advised that staff had done well in this application. He added that the he would like time to reflect and make a decision, as more information had been provided during the variance hearing.

MOVED BY Councillor Lund, seconded by Councillor Rankin, that Western Region Community Council defer the decision of Variance #14949 - 1264 St. Margarets Bay Road until the February 23, 2009 meeting. MOTION PUT AND PASSED.
