



THE FIRST ANNUAL MEETING

OF THE

SEVENTH MUNICIPAL COUNCIL

OF THE

COUNTY OF HALIFAX.

FIRST DAY.

HALIFAX, TUESDAY, Jan. 13th, 1891.

In accordance with the Statute, and by special notices issued by the County Clerk, the Councillors for the several Polling Districts of Halifax County, elected Nov. 20th, 1890, assembled at the County Court House, at 12 o'clock, noon, on Tuesday, the 13th day of January, 1891.

The Clerk took the Chair and read from the Revised Statutes, chap. 56, sections 3, 4, 5, 6, 30, the course of procedure for the Annual Meeting, and having called the Roll, declared the following persons duly elected Councillors for their respective Districts, as notified to him by the Presiding Officers, and verified by the Poll Books. The following gentlemen were present (except Messrs. Fraser and W. Burris) and took the Oaths of Allegiance and County Councillors.

The Councillors having signed the Roll, the Clerk announced the Council organized for business, and called for nominations for Warden.

Moved by Councillor Himelman, (who highly eulogized the gentleman proposed)—

Resolved, That John E. Shatford, Esq., be the Warden of the County of Halifax for the ensuing two years of this Council.

Seconded by Councillor Bissett, and carried by acclamation.

The Clerk swore the Warden into office, who then took the Chair and thanked the Council for the houor conferred.

Councillor Bissett was proposed as Deputy Warden, but with the consent of the mover withdrew.

Moved by Councillors Bishop and Bartlett—

That Councillor Joseph Himelman be Deputy Warden of this Municipality for ensuing two years. Passed unanimously.

Moved by Councillor Bissett, seconded by Councillor Poole-

Resolved,—That W. H. Wiswell be appointed Clerk and Treasurer. Passed unanimously.

The Clerk submitted a number of applications for offices, the Auditor's and Treasurer's Report and Account, and Inspector Reid's Report of Licenses to be granted, which required to be acted on to day.

On motion, deferred to the Afternoon Session. Moved by Councillors Bishop and Himelman...

Resolved, That Councillors Himelman, Taylor, Donaldson, Corbin and Bishop, be a Committee to nominate the Standing Committee.

In amendment by Councillors Sellars and Poole-

Resolved, That Councillors Madill, Bissett, Poole, Sellars, McKenzie, A. Thomas, and Fenerty, be a Committee to nominate the Standing Committees for the current year.

The Amendment was lost and the original Resolution carried. The Council adjourned to 2.30 p.m.

Afternoon Session.

TUESDAY, Jan. 13th, 1891.

The Council met, as per adjournment, at 2.30 P. M. Present the Warden and 28 Councillors. The Minutes of the Morning Meeting were read and passed, after the following amendment by Councillor Bissett, viz., by adding to the motion of the Clerk and Treasurer's reappointment the words "at the same salary as heretofore." The Minutes were then adopted.

His Honor the Warden then read the following introductory

address:--

THE WARDEN'S ADDRESS.

Gentlemen of the Municipal Council:

Those of you who have been members of previous Councils I must congratulate on having the confidence and support of the Districts you represent. To you who are here for the first time I bid a hearty welcome, and congratulate you upon the trust and confidence placed in you by those who sent you hither, and I feel sure that you will endeavor to retain that confidence for the next two years.

At the last Session of the Legislature some amendments were made in the County Incorporation Act, most of which were asked for by the Law Amendment Committee of this Council. These amendments will, to some extent, facilitate the work we have to do in certain emergencies that now exist, and from time to time may arise. Since our last Meeting an attempt was made to sever from the County one of the Polling Districts, by its inhabitants misconstruing the Towns Incorporation Act of 1888, in such a manner as to make any Village or District come within the meaning of the Act. At first I did not think it necessary to offer opposition to it,

but upon reflection, seeing the confusion the accomplishment of such a move would create in the Municipality, I deemed it advisable to oppose it, and did so successfully. If one Polling Section of the County could decide in that way, others would attempt the same thing, thus resulting in a state of confusion and turmoil throughout the whole County. In opposing this measure, I considered it my duty to maintain the whole Municipality intact, and prevent, if possible, its being broken up in small Sections, as it certainly would have been had No. 14 succeeded in accomplishing its object. Since our last Meeting the Arbitration Committee of this Council, and a Committee of the City Council, appointed for the same purpose, had a Conference respecting certain items in dispute between the two We arrived at a settlement of the questions and items in dispute, which I trust will be lasting and end the long and many misunderstandings that seemed to prevail between the County and The details of this Conference will be laid before you.

In reference to our Financial position, I may sav it is no worse than at the time of our last Annual Meeting. The Treasurer's Account and Balance Sheet will shortly be placed in your hands, when you will have a much better opportunity to judge of the Financial situation of the County than from any details I could give you here. I regret that I have to inform you that two of the Sections of the County have paid in a very small portion of their taxes for the year just closed, and one Section has failed to pay any portion of its County Rates for 1889. I beg to invite your attention to this fact, and ask you before the close of the Session to take such steps as is necessary and in keeping with the law, to have the taxes collected in the Districts referred to Many of you will remember our difficulties with the City Council and our many unsuccessful attempts to have a satisfactory adjustment of old outstanding c'aims. I am sorry to inform you that nothing has been done in the way of settlement since our last Meeting We claim that the City owed over \$11,000 previous to 1887, and since the change in the law whereby the County's proportion of taxes is a separate item in the City's Assessment and required to be paid over as collected, they have neglected to pay the County some \$9.000 since 1887, making in round numbers the sum of \$20,000 due the County by the City of Of the \$9,000 there can, however, be no dispute.

There is another important matter I desire to bring to your notice. I would have you not unmindful of the fact that at this Meeting the law requires you to appoint your District Officers. Heretofore in some Districts the Councillors have made mistakes in appointing transient persons to fill the various offices, and the result has been that they come here at the Semi Annual Meeting and ask the Council to appoint new officers. On a former occasion I called your attention to this matter, and I must now impress upon you most emphatically the great importance of appointing per-

manent residents of the Districts to office, and not men who follow avocations that necessitate their absence from home during the summer, when as constables, overseers of roads, assessors collectors and fence viewers, etc., they should reside in the Di tricts the year round.

In conclusion I must request you, especially those who are new Councillors, to make yourselves conversant with the By Laws of the County, in order that no misunderstanding may arise as to procedure or preference.

By consent, Councillor Fenerty referred to the clause relating to the projected Incorporation of N. W. Arm District, intimating that anumber of parties were not disposed to abandon the matter, and wished to submit it to test in the Supreme Court. The Warden said that evidently the legal Members of the Executive Council decided against that and similar District Incorporations.

On motion the Address was ordered to be printed in the Minutes. The Report of Inspector Reid relating to the granting of Licenses to sell Intoxicating Liquors by certain applicants, was submitted and

read.

To His Worship the Warden and Municipal Council for the County of Halifax now in Session.

I beg leave to submit the following Report on Applications for License to Sell Spirituous or Fermented Liquors for the ensuing License year:

The following applications have been received according to the requirements

of the Liquor License Act of 1886 and Amendments thereto:

Upon examining the petitions and certificates, I find that they all, namely, Wm. Wilson, H. N. Paw, Philip J. Colford, and W. E. Poppleton, have complied with the provisions of the Act, and there has been no objections made to any

of the applications, therefore I would recommend that their Licenses be granted. All of which is respectfully submitted.

The Report was adopted Moved by Councillors Donaldson and Bissett-

That William Wilson, of Bellevue Hotel, Bedford, be granted License for 1891, as he has complied with the provisions of the Act.

The motion passed, Councillor Him-lman dissenting Moved by Councillors Bisset and Donaldson -

That H. N. Paw, Proprietor of the St. Elmo Hotel, District 15, he granted License for 1891, he having complied with the provisions of the Act. Passed.

Moved by Councillors Bishop and Bartlett-

That William Poppleton be granted License for the ensuing year. Passed.

Moved by Councillors Bishop and Croucher-

That P. J. Colford, District 12, be granted License for 1891. Passed.

Moved by Councillors Bissett and Poole-

Resolved, That the Report of the License Inspector be received and adopted as a whole. Passed.

The Warden suggested that the Committee on Standing Committees have leave to retire so as to be able to report early the result of their work.

Discussion took place respecting the position of Chairman to each Committee, more especially the Chairman of Public Property Committee, as they had frequent meetings, and the Chairman considerable work and responsibility.

Councillor Himelman asked that the Council appoint the Chair-

man.

Councillor Fenerty, that the Council appoint the Chairman of all Committees.

The Warden stated that the Bye-Law fixed the mode that the first named on any Committee was its Chairman, and the discussion was therefore ultra vires.

The Clerk read from Minutes of 1830, the Resolution passed then that the Chairman of Public Property be paid \$50 for his services for the year.

Councillors Fraser and W. Burris arrived, and were sworn into

office by the Clerk.

Submitted and read the account of Albert Stuart, Presiding Officer District 18, for \$9.50, and letter stating that the Treasurer had refused payment of it for several reasons best known to himself, &c.

The Clerk said the reflection on himself could be passed over. His refusal was not on personal grounds, but Mr. Stuart had exceeded his powers in several ways, changing the polling place, printing ballots, rejecting written ballots; but his account being nearly double that of any other Presiding Officer, was the reason why it was not paid.

Councillor King considered the Presiding Officer justified in the course he pursued, and that the account ought to be allowed under

the circumstances.

Some discussion followed on the legal position and powers of such officers, and it was shown that the Law was indefinite thereon.

Moved by Councillors Poole and Bissett-

That the bill be referred to the Finance Committee. Passed.

Submitted and read as received from T. A. Chambers-

THE REPORT OF KEEPER OF COUNTY JAIL, 1890.

To His Honor the Warden and the County Council:

GENTLEMEN,-

I beg herewith to submit my report of the Commitments to the County Jail

during the year ending December 31st, 1890:-

For the year beginning January 1st and ending this date, there were: Criminals, 218; Debtors, 98; showing a decrease 7 Criminals and 31 Debtors, making a total 38 persons from the previous year.

At the present date there are 9 Criminals and no Debtors in the jail.

The largest number of persons in the jail at one time during the year was 25.

Annexed are statements showing the various crimes for which prisoners were

committed during the year.

There were quite a number of persons committed in 1889 who were not discharged until 1890, and one of them is still in jail from that year, and does not show in the copy of Commitments in consequence.

During the year there were 316 persons committed to jail, of which there

On the appointment of Commissioners for the Court House, the Warden mentioned that the control and management of the Court House was by Law in the hands of the Commissioners. The Government appointing two, the Council two, and the Warden ex officio. So far the Committee on Public Property had the charge of the building. This would now have to be changed. He had arranged for a meeting on Friday, and it was necessary to appoint the two Commissioners for the year.

Read, application from Mrs. Sentell to be re appointed Janitress of the Court House, and asking for additional rooms in the attic, as her family needed bedrooms, &c.

On motion of Councillors Amos Thomas and Bartlett-

That Mrs. Sentell be re-installed Janitress of the County Court House for the year 1891. Passed.

The matter of more rooms was referred to the Commissioners to

take action upon.

The application of Dr. Trenaman for re-appointment as Jail Surgeon, with increase of Salary to former amount, was deferred till his Annual Report is received.

On motion of Councillor Bartlett it was

Resolved, That Stipendiary Griffin, W. D. Harrington, J.P., and Edmund Ryan, J.P., be appointed Admitting Justices to Hospital for Insane for ensuing year. Passed.

Moved by Councillors W. Burris and John H. Taylor-

That Walter McCurdy, J.P., an J. D. Tupper, J.P., be Admitting Justices to Hospital for Insane. Passed.

Moved by Councillors Fraser and Kirker-

That John F. McKenzie, John Kirker and M. McFarlane, be appointed to examine and sign Commitments for Patients to be admitted to the Insane Hospital. Passed.

Application was read from George Dennaford to be County Constable. Appointment deferred.

Read, application from Harry N. Wright, asking to be appointed

Detective for the current year for the County.

Read, also a letter from D. Gorman, complaining that Wright had, as Bailiff, collected money for him, and had not paid it over to him.

Moved by Councillors Corbin and A. Thomas-

That the complaint against Harry Wright be referred to a Committee, who shall hear all parties interested and report. Passed.

The Committee named were Councillors Bissett (Chairman), Fraser, Poole, Corbin, Himelman. To notify Mr. Gorman and report to morrow afternoon.

Lists of Officers were handed to the Clerk, and the Warden

named Friday morning for passing them

Read, letter from John Lapierre. J. P., complaining of overassessment of a property in District 31.

On motion referred to Committee on Assessments.

Read, a petition from Jas. Murphy and a large number of persons in District 22, Upper Musquodoboit, objecting to opening road to Samuel Wilson's, and asking that the precept for that purpose be retracted for several reasons given.

A discussion followed in support of the petition. It was shewn that Wilson was to pay all expenses, and that it was solely for his interest and detrimental to other parties. The change was not required, nor ought to be a District charge, as now appeared.

On motion of Councillors Corbin and McKenzie-

The petition was referred to the Road and Bridge Committee, to consider and report upon. Passed.

The Warden received a letter, complaining of the conduct of H. N. Wright, signed in initials only. Being anonymous, he said he could take no notice of it.

Submitted Report of Ferriages between Point Pleasant and Purcell's Cove, for year ended Sept. 30th. In reply to enquiry the Treasurer said this was the only report of Ferries in the County. For some years past no grant was allowed to any of them from the Municipality. The Government subsidized some of them.

During the year 32 prosecutions were commenced, of these (3) eight were with fewam or dismissed, and (24) twenty-four were convicted. A full statement of these proceedings, giving names, dates, results, &c., is herewith presented. During the latter part of last year, and on several occasions this year, the Constables made unsuccessful attempts to arrest and convey to Jail Stephen. Thorpe, of Sheet Harbour, who was previously twice convicted of violating the License Law, but in October last three Constables were employed, and after

vigorous efforts were successful in effecting the re-capture of the prisoner, and bringing him safely to the Jail in Halifax, where he is now serving out a term of 150 days' imprisonment for three convictions for violating the Law. The expenses in Thorpe's case are large, but owing to the prisoner's resistance and escape, and

A letter was read from Dr Gow, with an account for Medical Services, \$10000, in connection with Diphtheria in Nov. last. at Ferguson's Cove, District No. 7. Also bill from same District, from John Thomas, engaged as watchman and nurse at same place and time, amounting to \$10.00 The subject of Infectious Diseases, and the law relating thereto, was discussed at length; also the mode of payment, which was found to be a County Charge.

Councillor Hayes explained the circumstances, and said the

Report of the Board of Health would show the facts of case.

On motion of Councillors Burris and Bissett, Dr. Gow's account

and letter were referred to the Finance Committee.

Read, the Report of Board of Health, for District No 17, submitted by Councillor Corbin, which fully explained the number and nature of the Diphtheria cases in Sackville District (No 17,) and the prompt and effective means undertaken to carry out the Law as well as to restore the patients to quarantine and confine the disease to disinfect and fumigate infected places, and to instruct the people how to treat the disease. This was by a printed pamphlet containing the Law and Sanitary directions. The results had been satisfactory and secured at very small cost, not over \$18.00 in all The Inspector's account being \$12.00, now due R. W. Tremain.

Councillor Corbin referred to the attempted incorporation of a District, and a similar proposal in Bedford District, the cause being the heavy taxation, and not much to show for it in those Districts. Part of this was caused by annual or constant heavy legal expenses which might be largely reduced by a better system. He thought that these expenses were excessive, footing up last year \$929.59, which, with the Stipendiary's Salary, made \$1,729.59. He moved that a legal gentleman be appointed to the office of Stipendiary, who shall also act as Recorder, at a salary not to exceed One Thousand Dollars.

Councillor Fitzgerald seconded the motion, .

A long discussion followed.

the Warden showed that the legal expenses for Counsel employed had been very moderate since the first year of the Council; and that the largest amounts incurred were for suits against the County, not initiated by the Council, but by outside matters, as Dartmouth case, Court House Extras, and in connection with the License Act, 1888.

Councillor Bissett and others mentioned the Fees collected by the present Stipendiary as paying more than half his Salary. That no lawyer of real ability could be had for \$1000 per year; and the fact of having a standing Counsel would lead to the institution of numberless suits on frivolous pretences.

On the motion being put it was defeated by 27 to 2.

The Council adjourned to Thursday, at 11 am., as Judge Johnston's Court would adjourn then.

THIRD DAY.

Considered his charges moderate. The disease had not been permitted to extend further, and no more cases occurred. The man Umlah was quite unable to pay any of the expenses.

HALIFAX, N. S., 1891.

To His Honor the Warden and the Councillors of the Municipality of the County of Halifax:

GENTLEMEN, - I beg to submit the following Report of the Sanitary state of

the Halifax County Jail for the year just ended :-

On the whole the health of the inmates has been good. No epidemic sickness on the whole the health of the immates has been good. No epidemic sickless has occurred, nor, except in one or two cases, has any serious illness presented itself. On July 23rd a prisoner named Arthur Wm. Bowen, who had been committed as a person of unsound mind, developed violent convulsions, and was removed in the Ambulance to Victoria General Hospital, where he died next day. Another inmate, Charles Sullivan, who had been committed to Jail from the City Police Court for safe keeping, having been violently insane, was, at the end of a week, handed over to his friends well, and returned to Montreal, whence he came.

Jerry Oliver, also committed as of unsound mind, and who gave the Jail officials much trouble, because of his conduct, was later removed to Mount Hope Hospital for the Insane. A fourth insane prisoner, Henry Bailey, a demented colored lad, also committed to Jail from the City Police Court, was afterwards sent to the Insane Ward at the Poor's Asylum, where he now is.

The usual number of cases of Chronic Drunkenness, sent to Jail to "sober up," has been our portion during the year, and I am glad to report no fatalities among them, all having been discharged greatly improved in their general condition, clothed and in their right mind.

During the year the Jail building and yards have been kept in a clean and healthy state. The food has been of good quality and well cooked, and the Jailor, Turnkeys, and Mrs. Chambers, have been considerate of the wants of the Jail's inmates.

We met with the Local Assessors in the Rural Districts, and have travelled mough Districts 31, 33, 29, 28, 30, and 7, 8, 9, 13 and 14. If time and weather had permitted we would have travelled through some other Districts. The Warden said he had ignored these accounts as Graves had no settlement in this County, and the large expense was principally incurred in Lunenburg or Chester District. Through a technicality of the law, by which the payment of taxes gives a settlement to the pauper, Graves, who had paid 20 cents while transiently working at Hubbard's Cove, and who became insane there, was sent to Mount Hope and charged to Halifax County until he went home from there. The accounts should be paid by the County to which he belonged.

On motion the Clerk was instructed to send the claims of Maclean and Cooper to the Lunenburg Council. Submitted an account handed in by Councillor Mitchell, District 27, from Constable H. Stoddard for expenses bringing Mary Westhaver, a lunatic, from that District to the Hospital for Insane. The Councillor had reduced one or two items of the charges as being too high.

RFPORT OF THE COMMITTEE ON PUBLIC PROPERTY.

1.—The Committee, in presenting their Report, would refer to the Surgeon's and Jailor's Reports on the County Prison, from which it appears that the past

The operation of the "Speedy Trials' Act" very materially relieves us from over-crowding in the Prison, and consequently reduces the risk and expense. The expenditure for repairs and maintenance has been less than for some years previous. vated and in good condition. 2.—There was one expenditure on the Court House, that is, the putting up of inside sashes and colored glass to the Court Room windows, which was not authorized or sanctioned by your Committee, and some friction has arisen in consequence between the Commissioners of the Court House and the Committee on Public Property, in which the Committee take the ground that the Commissioners are not empowered to make any repairs or engage in any additions or alterations to the Court House; but when such are necessary that they apply to the Committee on Public Property, who are alone authorized to incur the expense. Such was not done in the case in question, but the work was done at the suggestion of one of the Commissioners without consulting the others, or at least those appointed by the County, and there being no funds provided, the bills are not yet paid; and your Committee take this opportunity of bringing the case to your notice, leaving it to you to take such action, or inaugurate such arrangements as will govern our proceedure in the future.

3.—The Poor's Farm has been conducted with a fair measure of success. The new wings authorized by the Council in 1890 have been completed and are ready for occupancy, but owing to many unavoidable delays, were not got ready so early

as desired or anticipated.

4.—The supervision exercised by the Local Government in regard to plans

and general adaptation caused such delay that it was June before we were prepared to receive tenders, and then it was found that all the tenders exceeded by several hundred dollars the amount at our command, consequently we were forced to ignore them all; but eventually by giving longer time for completion were enabled to get the work done within the amount provided; but as the buildings were not ready for occupancy before 1st December, and as a new Council would come into nower. in January, it was not deemed expedient to remove any patients from the Insane Asylum, but leave the number and selection for the new Committee in January.

5.—There are a number of patients now at Mount Hope, who can'be cared for at the Farm, and whom the Government are desirous of having transferred.

This will engage the attention of your Committee at an early date.

6.—We may state that the two new buildings have been constructed with special reference to occupancy by the insane, which are not only better adapted to their needs than the other buildings were, but will separate and relieve the same poor from the annoyances they have been subjected in the past.

Owing to the present number of inmates and anticipated increase, it was found that the ovens and kitchen room were not equal to the demand on them. and it was deemed advisable to enlarge them before additional immates arrived

from the Asylum or from the County.

• 7.—A building affording stable room and shed for waggons and tools, as suggested by the Council in 1890, has also been built, and with these additions your

committee feel that no more will be needed for many years to come.

8.—The total bills for the year amount to \$6,429,00, of which \$3,000.00 is provided by Debentures, as authorized for the erection of the new buildings, which leaves \$3,429.00 it has cost to maintain the establishment in 1890, as compared with \$3,002.00 in 1888, but by reference to the Report of last year, you will notice it was estimated that there was about \$300.00 of due, but unpaid bills-(the actual amount proved to be \$333.44)—but this year we do not owe hardly any bills, wherefore it really represents \$3,129.00 for 1890, as against \$3,002.00 for 1889; but whereas in 1889 we had 1,720 weeks' attendance, in 1890 we had 1,942 weeks; which goes to show that the actual cost of maintenance for 1890 was about ten cents a week per capita less than in 1889, which demonstrates a gradual yearly reduction in cost of keeping immates at the Institution, which we trust will continue till the Farm is nearly or quite self-sustaining, and it may be appropriate to explain that these figures cover the entire running cost of the Farm, including Keeper's salary, Guards and attendance on Insane, Medical attendance and Medicine, Insurance, a new Sewing Machine, Stoves for new buildings, etc., but not, of course, repayment of Debentures for original cost of establishment, which are being yearly obliterated at the rate of \$800.00 a year, and this amount is even practically saved in the difference of cost of keeping the Insane at the Farm as compared with what we would have to pay at Mount Hope, which for 1891, when the new wings are occupied, may safely be set down at \$1,000 to \$1,200 profit or

9.—Wherefore your Committee consider the County has no cause to regret the establishment of the Poor's Farm, but rather congratulate itself upon the present

prosperous condition and favorable outlook for the future.

10.—The cultivated ground is being yearly extended and improved, notwithstanding we got such a limited amount of labor from the immates, but it all helps,

and will probably be more in the future.

11.—The produce raised is largely consumed on the Farm. During the summer season vegetables form the staple food of the inmates, and the Keeper reports During the sumnow on hand (produce of the Farm) 100 bushels potatoes, and the same amount of roots, as turnips, carrots, parsnips, etc., while large quantities of cabbage is made into saur krout, which is highly relished.

12.-And in conclusion the Committee feel they should not forget to refer to the services of the Keeper as Matron, who literally work without ceasing to for-

ward the interests of the Institution.

13.—The Keeper reports that the work at the Farm has so much increased that he is seriously hampered through want of more teams, and suggest the acquiring another horse, as better suited to the requirements than oxen, as suggested in this Council last year, and mentions as one reason that oxen would require a different class of vehicles, while for use with horses he has enough of the several descriptions; and the Committee, in view of the fact that they have not much to ask the

Council for this year beyond a high fence around a yard to accommodate the occu-

pants of the new buildings, would suggest that his request be granted.

14.—There are 41 immates at the Institution now, consisting of 17 Insane Paupers from the County and 8 from Dartmouth. There were four deaths during There are now at the Farm, one horse, two cows, one heifer, two hogs, and the usual supply of vehicles and agricultural tools.

Your Committee have long entertained the idea that we are maintaining a number of persons not legally chargeable to us, but we have only been able to shift the responsibility in one instance, that of John Connors, now at the Farm, whom it has been conclusively shown should be a Provincial charge, and his maintenance has been assumed by the Government.

15.—The case of McKay, of Cape Breton, is another where we are unjustly made to support a person who has no claims on us, but his relatives, since finding

out that he was comfortable and being provided, for, have made no sign, nor will out that he was communication. The only way we can suggest is to send a person there to collect the necessary evidence, which we have good authority for saying can be obtained, and then make the necessary demand for his removal.

Tuesday, January 20th, 1890.

. The Council met at 11 a. m Present the Warden and 30 Coun cillors. The minutes of last meeting were read and approved.

The report of the Committee on Public Property was taken up to be read clause by clause.

All the clauses from 1 to 7 inclusive were accepted.

In connection with clause No 8 Councillor Corbin spoke very strongly upon the condition and management of affairs at the Poor's Farm as found by him on a special visit there. He gave details respecting the bad smells, and general want of cleanliness of the house and inmates, the strong room and treatment of the insane, bad construction of the bake ovens, and thought that until a good efficient keeper be put in charge there would be no improvement, &c., &c.

Councillor Bissett replied in defence of the Institution and the parties in charge, referring to the favourable reports of Dr Page, Government Inspector, the House Physician, and other visitors, and that some of the inmates were filthy when they came there, and were always so in their habits. The keeper and matron were untiring in their work, and were greatly overworked in attending to so many and different persons to deal with. He preferred an investigation to pub ic discussion and personal reflections.

It was moved by Councillors Corbin and McKenzie-

That clause 8 be referred to a special Committee consisting of Fenerty, Fraser, Bartlett, Corbin, G. Burris and Taylor. Passed.

Councillors Taylor and Madill moved-

That Councillor Poole's name be placed on the Committee for Investigating matters of the Poor Farm instead of Councillor Taylor's name. Passed.

Moved by Councillors Pools and Geo. Burris-

That Mr. and Mrs. Turner be appointed Governor and Matron for the ensuing year for the Poor Farm, subject to this Council. Passed.

Moved by Councillors Poole and Fraser-

That all supplies needed for the Poors Farm should be got by Tender and Contract. Passed.

Moved by Councillors Corbin and Croucher-

That clause 12 and the remainder of the report be referred to the special Committee on clause 8. Passed.

On motion of Councillors Joseph Thomas and Gray, William Downey was appointed Overseer of Roads for Downey Town, District 30

The special Committee on Claim of George Richards for loss of a Horse was read as follows:

The Committee appointed to examine into the loss of the horse, etc., of Geo. Richards, of Chezzetoock, beg to report as follows:—That after hearing all the evidence that we could get bearing upon the subject, we unanimously beg to recommend that the Council pay the said George Richards the sum of Eighty Dollars.

They should therefore provide some one to see to the cleaning, keeping in order, repairs and general oversight. He had under the Committee of Public Property, in addition to other pressing work, given personal oversight to all that was needed. Was informed that the Commissioners had appointed him Secretary, which position he positively declined if it implied continuance of duties and responsibilities entirely out of his sphere.

Moved by Councillors Himelman and Bishop and-

Resolved, that the Treasurer be instructed by this Council to pay no bills in connection with the County Court House unless signed by a majority of the Commissioners, or the Chairman thereof. Passed.

Committee on bye-laws, to whom was referred the petition of James Murphy and eighty others, ratepayers in District No. 21, Recommend that unless petitioned against by at least one-third of the ratepayers in District 21 within twelve months from this date, the Council shall order that Horses, Asses, Mules, Cattle, Sheep or Swine shall not be allowed to run at large within the bounds of said District, and that the provisions of Chap. 26 of the Acts of 1890 shall be in force therein after the lapse of one year from date—unless in the meantime a petition, duly signed by at least one-third of the ratepayers of the District, as before mentioned, shall be forwarded to the Clerk of this Municipality. Also,—That parties making application to the Council for the opening or changing any section of Road in any District of this Manifestities and the provided to the council for the opening or changing any section of such intended District of this Municipality, shall be required to give notice of such intended change, by posting notices specifying the changes to be applied for in the vicinity of such section of road. A certificate of such notices having been duly posted to be attached to the application.

an increase of \$140,930 since 1880.

In the matter of appeal from over assessment of John Lapierre, District 31, your Committee are of the opinion that they have no power to grant the prayer of the petition, the board of Revisors being the proper body to deal with the case. Read, a protest of the Assessors of District 31, Messrs. Elssett and Farquharson, against the addition of 5 per cent. on the valuations returned by them—made by the Board of Revising Assessors—without consultation with the Assessors or any reliable person for information to warrant such increase, the district being already valued beyond adjoining Districts, and its aggregate valuation having in creased steadily since 1880. They ask the Council to disallow such an unjust act

The Warden stated that under the Assessment Act of 1888 the Revisors of Assessments were empowered to make amendments and changes in the returned District Valuations, and it did not appear that the Council could question their action. The time fixed for

appeals was the 4th Tuesday in January.

REPORT OF SPECIAL COMMITTEE ON POOR FARM AFFAIRS.

The Special Committee on County Poor Farm Affairs beg to Report—1.—We find the net cost of Paupers on the Poor Farm to be \$162 per capita per week. We find the Districts are only paying 75c. per week, and that the citizens of Dartmouth are only paying \$1.30.

2. -We find that in the purchase of many of the supplies of the Farm, notably Dry Goods, Beef and Drugs, have not been conducted in a manner conducive to the bests interests of the County, Arrangements should be made whereby all articles, of which a fair quantity is required, should be bought at wholesale prices.

3.—We recommend that Mr. Turner be employed under the same condition as

other officials of the Municipality.

4.—Your Committee recommend that the Poor Farm be conducted under an executive of the Public Property Committee, consisting of the Chairman and two members, one of whom shall retire monthly; and that the Committee meet on the 1st Saturday of each month at 11 o'clock.

The Chairman explained that this Committee had made no discrimination in calculating the per capita cost, but had been informed that the former Committee placed the Insane at the Asylum rate. By doing this, and counting the Dartmouth poor as charged, the Committee on Public Property's Estimate would be about as reported in their general report. The Clause was therefore not received.

The 2nd Clause passed without alteration.

The 3rd and 4th Clauses were also passed without alteration.

The Report of the Finance Committee was taken up and read clause by clause.

REPORT OF COMMITTEE ON FINANCE.

1.—Your Committee beg to report that the general accounts of the Treasurer have been examined and found correct, and duly audited, a copy of his report is appended.

2.—There is a balance on hand,\$9,746.03, with which to meet the current years expenses, until the year's income begins to be available in October; this will be lessened by unpaid bills of last year amounting in round numbers to \$1,500.00. This leaves an actual available balance of \$8,200.00.

3.—We desire to call your attention to the large outstanding account of the o.—we uestre to call your attention to the large outstanding account of the Provincial Government against the County, amounting to many thousand dollars. In this connection we would also earnestly press upon the Council the need that immediate steps be taken to reach a definite settlement of the very large claim the County has against the City, now amounting to over \$22,000.00. We recommend that a committee be appointed to prepare, ask for, and look after legislation for that purpose, and with power to applying augustal is required.

that purpose, and with power to employ counsel is required.

4.—Inspector Reid's accounts were found correct. Your Committee recommend that fuller details in future be given for travelling and incidental expenses.

5.- We beg to recommend the payment of the following bills. The Sheriff, \$209.50; Dr. Gow, \$100.00; R. W. Tremaine, \$12.00; J. McKenzie, \$31.80; John Thomas, \$10.00; Albert Steven's bill we have amended to \$5.50, to be paid. The Sheriff's bill for ballot and expenses contracted for incorporation in District 14, we recommend to be paid, and to be a special assessment on the District.

We have also passed the revisors' bill for payment as follows, H. Balcam,

\$38.50; J. Reynolds, \$37.71; E. Hubley, \$41.57.

6.—The petition of E. Moore, road overseer, for reimbursement for cost incurred in suit for assault, we cannot recommend. We are fully alive to the necessity for the County protecting its officers, but the evidence in this case, we regret to say, precludes any other course. Mr. Cole petitions to be paid for a horse lost by falling through a bridge claimed to be defective, we recommend it be referred to a special committee for information, both as to law and fact.

7.—The diversity and range of the bills presented by the assessors of different districts seemed so great and in some cases so apparently out of proportion to the size of the district, that your Committee have endeavored to find some scale that could be adopted as a maximum payment for each district that should bear an equitable relation to the amount of work done. We beg to recommend the follow-

ing scale.

That as per resolution of the Council, the pay of the assessors be at the rate of \$1.25 per day, but in no case shall a maximum exceed the subjoined for each district.

The mileage as per road scale of each district shall be doubled, this amount so obtained shall be added to the number of ratepayers in the district and for each district where the sum so obtained exceeds \$4.50 the maximum payment for each Assessor to be \$10.00, over 400 \$9.50, over 350 \$9.00, over 300 \$8.50, over 250 \$8.00, over 200 \$7.50, over 150 \$7.00, over 100 \$6.00. By this method the labor of assessing each rate payer is recognized as well as due consideration had for the number of miles travelled in visiting them.



The Municipal Council, pursuant to adjournment, Jan. 21st, and further postponement deemed necessary as per the Warden's Circular, met at the County Court House, this day, at 11 o'clock, a.m. The Warden and all the Councillors, except H. W. McKenzie and J. Kirker, who were on the way, were present at Roll call. The Warden having taken the Chair, the Minutes of the last meeting of the Annual Session were read and confirmed.

The Warden addressed the Council, as follows:

WARDEN'S ADDRESS.

Gentlemen of the Municipal Council:

It is with pleasure I again meet you for the purpose of discharging your Municipal duties. I regret that circumstances over which we had no control caused me to postpone our meeting until now, notwithstanding the resolution passed at the January meeting to meet on the 14th of this month. I may also say that in postponing the meeting I did it with a view to economy as well as to save you the inconvenience of attending two meetings of the Council this month. Considering the long distance some of you would have to come, and the disadvantages you would be put to, as well as the

expense it would entail on the County unnecessarily, I deemed it prudent and in the interest of all concerned to do as I did. sulted the Hon. Provincial Secretary and learned that in consequence of the late day the Legislature met it would be impossible for us to get the road grant before the present week. Had the Council met on the 14th we would have had to adjourn and go home until such time as the Government would be prepared to bring down the estimates and hand us the road grant for the present year. This would have been the legal course to pursue. The Hon. Provincial Secretary, however, kindly agreed to legalize any irregularity that might exist in consequence of the meeting having been postponed and not strictly in keeping with your resolution passed at the January meeting; therefore you must have no misgivings as to the action that had been taken in deferring the meeting. I think you will agree with me, nay, endorse my action when you consider that the course I have pursued will save the County at least \$300 to \$400, while not the least benefit could have resulted by calling you together on the 14th.

At this meeting the question of granting a subsidy to run an omnibus to the North-west Arm and Dutch Village, for the convenience and accommodation of the ratepayers and others of that district, will very likely be laid before you. I beg to invite your attention to the subject and to give it your most favorable consideration, with at the same time a view to the best interests of the County. This is one of the most wealthy Districts in the Municipality, and the ratepayers seem somewhat dissatisfied with present arrangements, and are of opinion that if better facilities are not provided for the travelling public between the city and the places above named that the value of property will largely depreciate, and

consequently result unfavorably to the County.

I must inform you that an Act to amend Chapter 56 of the Revised Statutes "of County Incorporations" has passed a Second Reading in the House of Assembly respecting representation of incorporated towns in the Municipal Councils. While I presume you will have no objections to fair representation from the City of Halifax, you will not endorse the mode of representation proposed in the Act and Amendment referred to. Whatever representatives the City may have let them be elected by the citizens and not by the City Council.

Beyond this there is nothing more than the usual business of the semi annual meeting, which consists principally of the division of the Road Grant and the reports of the different committees.

In conclusion, I must request that you expedite the business of the session with a due regard to economy and the best interests of the County and all concerned.

The Clerk distributed the printed minutes of the January Session

among the Councillors, also copies of the "Act relating to Imprisonment for Debt." which comes into operation May 1st, ensuing.

Also mentioned that he had received notice of the proposed enlargement of the Municipal Councils by the admission of representatives from Town Councils, requesting the careful attention and opinion of this Council, as the City and Dartmouth would come in under it. The Bill was in the Committee of the House of Assembly, being as follows:

An Act to amend Chapter 56 of the Revised Statutes, "Of County Incorporations."

Be it enacted by the Governor, Council, and Assembly, as follows:

1. In Counties or Municipalities containing within their boundaries one or more incorporated towns, each incorporated town within the municipality shall be entitled to two representatives in the Municipal Council, who shall be chosen in the manner hereinafter provided, and shall be entitled to vote in such Municipal Council on all questions relating to the expenditure of moneys to which such incorporated towns are required to contribute.

2 The representatives of such incorporated towns in such Municipal Councils shall be the Mayor and one Councillor, to be thosen by the Town Council at its first meeting after the annual

Town election.

3. The City of Halifax shall be entitled to six representatives in the Municipal Council of the Municipality of Halifax, who shall be entitled to vote in such Municipal Council on all questions relating to expenditure of moneys to which the City of Halifax is required to contribute.

4. The representatives of the City of Halifax in said Municipal Council shall be the Mayor of Halifax and five aldermen, to be chosen by the City Council of Halifax at its first meeting after the

annual civic election.

After a brief conversation, it was moved by Councillors Fenerty and Fraser-

That the consideration of the proposed Act to amend the County Incorporation Act be the order of the day for April 22nd, Morning Session. Passed.

Read a letter from Councillor Morash requesting payment of Emergency Repairs of Road in his District as allowed in January Session—the amount of account presented being \$65.10, which he considered moderate.

The Warden informed him that on being made out upon the regular Commission and Returns, the amount would be paid out of the

District Road Grant on presentation to the County Treasurer.

Read an application from Dr. Milsom for the surgeoncy of the

County Poor Farm at his former salary. In reply to questions the Clerk said that under present arrangement the service started from 1st June, at which time the position becomes vacant.

On motion the matter was referred to Committee on Public

Property.

Read a petition from inhabitants of District 12, asking that the regulations as to sheep going at large be extended to that district. Moved by Councillors Croucher and Donaldson—

That District Number Twelve be added to those named in the by-laws in regard to sheep running at large. Passed.

Read report of R. O. Innes, custodian of draw bridge, Porter's Lake, stating the bridge to be in good order, only requiring a new top stick on the western abutment.

On motion referred to Road and Bridge Committee.

Read letter from Jas. F. Turner, keeper of the Poors' Farm, asking that for the better and more economical working of the farm a pair of oxen be provided.

On motion referred to Committee on Public Property.

The following appointments and changes in District Officers were severally moved by the District Councillors, seconded and passed, viz.:—

Councillor Geo. Burris referred to the case of Alice Drady, a pauper who had been charged for at the Poor Farm to the Town of Dartmouth, and since found to belong to his District, No. 22. was recommended that the District arrange the amount advanced by Dartmouth, and pay the County for the rest of the time at the usual rate for District Poor.

The Council then adjourned to 2.30 p. m.

Afternoon Session.

Tuesday, 21st April, 1891.

The Council met at 2.30 p.m. Present, the Warden and 28 Councillors.

The minutes of the morning meeting were read and adopted.

On motion of Councillors G. Burris and Bishop, the sum of eighty-five dollars additional was voted for support of Poor District 22, for 1891.

On motion, the following District Officers were appointed:-In District 23—Peter Jollimore to be Assessor in lieu of Charles Slaunwhite, not qualified.

In District 18-Edward Miller, Assessor, in place of Thomas L.

Geddes not qualified, his valuation being too low.

In District 14—Thos. Keddy and Robert Innes to be Road

Overseers for 1891.

In District 25—Albert Boutilier and George Grant to be Overseers Statute Labor, and Daniel Currie to be Overseer in Section 8, District 25, in place of M. C. Killeen, left the District.

Moved by Councillors Bishop and G. Burris-

That Charles Merlin be Overseer of statute labor for District 13, instead of John Merlin, who has left the District. Passed.

The Clerk delivered copies of the "Act relating to Imprisonment for Debt" to each Councillor, and mentioned that it would come into operation on May 1st.

The Warden expected to have statement of Road Grant, Thursday. Read a Petition from Sambro, (District 9.) signed by about 20

persons, asking aid to repair the road extending through the Village.

Councillor Gray explained that a considerable amount had already
been expended there and that he had never seen and did not approve

of the prayer of the Petition.

On motion, the Petition was referred to Councillor Gray.

Read a petition from 99 ratepayers of District 21, referring to the
By-Law respecting the preventing of cattle, horses and sheep
running at large, asked for at the January session by Jas. Murphy
and others, by which the provisions of Chap. 26, R. S., should be in
force therein. The petitioners ask that the By-Law be annulled on
account of the expense and inconvenience to poor people in the
District.

The Warden stated that the By-Law not having as yet received the sanction of the Government, the Council could not consider the

prayer of this petition.

Moved by Councillors W. Burris and Poole-

That the prayer of the petition from ninety-nine ratepayers of District No. 21 in regard to cattle, etc., running at large, be granted. Passed.

Moved by Councillors King and Morash-

That Road Section No. 1, in District 18, be extended to the junction of the Guysboro Road, and that Section No. 2 be extended to the junction of the old road to Hollands at Fletcher's Lake. Passed.

Read, a letter from A. Elliot, Town Clerk Dartmouth, referring to a letter of the County Clerk April 23rd, 1890, concerning the taxation of the Woodside Property, known as the Halifax Sugar Refinery.

Read, also, the opinion of B. Russell, Recorder of Dartmouth, that certain portions of said Property were liable to taxation for

County and School purposes.

The County Clerk said his letter to Town Clerk last year was of the opposite opinion founded on the tenor of the Acts granting exemption to the said Refinery. The latest of which was Chapter 77 (1874) granting exemption from the County Assessment on all the Real and Personal Property and Capital of the Halifax Sugar Refinery for 21 years, etc.

The Act was read and with the assent of the Council the Warden ruled that the property under its provisions was not subject

to taxation.

Submitted letter and claim from W. G. Cole for \$58 00 for loss of horse and harness, owing to defective Bridge in District 35.

(This was deferred from the January session to be further in-

vestigated.)

Councillor W. Burris said Mr. Cole would be present in a day or two, and on motion, Councillors Fenerty, Himelman, Taylor, Madill, and Poole, were appointed a Committee to investigate and

report upon the claim.

The Clerk read a letter from A. S. Hunt, Mount Hope Asylum, April 10, in reply to enquiry respecting apparent over charge of \$60 in the Government Account for Insane Patients, Dec. 31, 1890, for interest, as reported by Committee on Insane. The letter enclosed a statement shewing how said interest was made up, and making it the same as before.

The letter answered questions in regard to Mrs. Noble, that no money had been paid on her account as a Patient charged to this

County.

The Council adjourned to Wednesday, 22nd, at 10.30 a.m.

SECOND DAY.

WEDNESDAY, April 22nd, 1891.

The Council met at 10 30 a.m. Present, the Warden and 29 Councillors

The minutes of yesterday afternoon were read and confirmed. Councillor Corbin questioned the statement of the vote as given in the minutes of January session in regard to appointment of a legal adviser. Instead of 27 to 2 it should have been stated as "lost" as names were not called.

Whilst waiting for Councillor Himelman's motion relating to the representation of towns in Municipal Councils, the subject of a

subsidy for a 'Bus to run to N. W. Arm was taken up.

Councillor Fenerty advocated the granting of the subsidy very strongly, fully showing that the large amount of taxes paid by, and very small sum drawn by District 14, and the falling off of valuations

there from want of such privileges, entitled the District to favorable consideration.

Moved by Councillors Corbin and Poole—

That the matter be referred to a committee to fully consider and report upon it. The committee named were Councillors Corbin, Poole, Taylor and Madill. Passed.

On motion the following officers were appointed:-

In District 28—Andrew Belfontaine to be Assessor, in place of James Julien, who is not qualified, and George Mayette to be Custodian of Canterbury Bridge.

In District 9-Caleb Gray to be Overseer of Roads, in place of

Gideon Smith, who is over age.

In District 13—Charles Merlin to be Overseer of Statute Labor, in place of John Merlin, who left the District.

The subject of towns' representation (being the order of the day)

was introduced.

The Clerk read the Act proposed to be passed for that purpose.

The Warden explained the origin and intention of the Bill; Councillors Fenerty, King, Himelman and others expressed their views forcibly against the principle and tendency of the Act as it stood. It was moved by Councillor Himelman, seconded by Councillor Bishop, and resolved—

Whereas, it has been intimated to this Council that an act in reference to representation of incorporated towns in the County Councils, where the incorporated towns contribute to the funds of the same, has passed its second reading in the House of Assembly; and whereas, it is proposed in the said act that the cities and towns in the Province shall elect from their own Council representatives from such cities and towns; and whereas, such a method of representation is in the opinion of this Council wrong in principle, inasmuch as it is in effect the sending of a special committee from such city or town council to meet the representatives of the rest of the counties elected in the manner provided by the County In orporation Act; Therefore resolved, that this Council strongly profest against the Act as now proposed; and further resolved, that while this Council are of the opinion that the city and towns should have fair representation therein, said representatives should be elected directly from the citizens for the purpose of county councillors, separate and apart from such city or town councils; and further resolved, that in the event of the city and towns of the Province having representation in the county councils, that the city and towns should have their proportion of all expenses in running the same; and further resolved, that a copy of this resolution be sent to the Honorable the Provincial Secretary. Passed.

The Council adjourned to 2 30 p.m.

Afternoon Session.

WEDNESDAY, April 22nd, 1891.

The Council met at 2 30 p. m. Present, the Warden and 30 Councillors.

The Minutes of morning session were read and approved.

Therefore Resolved, that Ephraim Haverstock be Inspector for said District. Passed.

Read report of Board of Health from District 15, recommending that in consequence of the difficulty of reaching as well as the expense of travel of the Sanitary Inspector, appointed for Districts. 15. 16 and 17 in January—the Councillor of the District should ask the Council to annul such appointment and have another person

Moved by Councillor Donaldson, seconded by Councillor A.

Thomas.

That James Currie be appointed Sanitary Inspector for Bedford, District 15, as per reasons explained in the Report of Board of Health for said District. Passed.

Read the following,

appointed for District 15.

Report of Committee on Grant for an Omnibus for N. W. Arm.

The committee appointed to consider the petition from district 14, North West. Arm, for the granting of a subsidy for the purpose of assisting the district in the attempt of getting a special conveyance to carry the inhabitants to the city and back, recommend that the sum of \$150 be granted as a subsidy whenever the district grants a like sum, and that the said subsidy be paid for three years, and that the said sum payable from the district be paid into the county treasury before the said subsidy be paid by the county treasurer to whom it may concern.

Councillor Fenerty, seconded by Councillor Bartlett, moved in amendment-

That the Council grant \$200 and the District \$100 for the object and timenamed.

The amendment was put and lost. The Report was then put and

also lost, 11 voting for, 18 against.

Submitted and Read two Petitions from District 27, one asking for special aid and allowance of half the Statute Labour of parties in Sections No. 1, 3, 4, 5, Musquodoboit Harbour, and grant repairs of the Beach Road, caused by the sea. The other Petition requests that the yearly grant be as large as possible to meet the heavy repairsneeded.

Councillor Mitchell supported and explained the Petitions. They were referred to the Road and Bridge Committee.

Submitted four Bills of Costs Taxed in Supreme Courts at Ottawa and Halifax, in the Suit and Appeals of the Queen vs. Town of Dartmouth, to determine whether the Town was liable for County School Assessments. Referred to Finance Committee.

Submitted and Read the Report of the Board of Health of Sheet Harbour District, stating that during the winter four families had been stricken with diphtheria, and had been looked after by the Board, who had found it necessary to provide nourishment and had appointed Dr. J. M. Gourley to attend to the patients. This District is now free from the disease. The accounts for these expenses amounted to \$9900, of which \$75 was the Doctor's bill.

Councillor Fraser thought this should be reduced.

On motion that the Report be received and adopted, it was moved in amendment to refer the account to the Finance Committee, which was carried.

Moved by Councillors Fenerty and Corbin-

That the amount of valuations of each District be taken into consideration in the apportionment of the Road Grant.

This led to a lengthy and general expression of the views of Councillors on the various conditions which should govern the allotments to each District, but without resulting in the suggestion of any definite system of doing so.

The Council adjourned to Thursday at 20.30 a.m.

THIRD DAY.

THURSDAY, APRIL 23rd, 1891.

The Council met at 10.30. The Warden and all Councillors present. The Minutes of Wednesday afternoon were read and confirmed.

The Clerk said he had received and handed to the Chairman of the Road and Bridge Committee the statement of the Road and Bridge Grant for 1891. The amount to be allotted was \$7,718.62, deducting Loan of last year. The mode of applying it requiring to be decided.

Moved by Councillor Burris, seconded by Councillor Thomas-

That the County Road Grant be expended by Commissioners.

On motion, the Council adjourned to meet Friday at 10.30 a.m., so that the Committees may make up their Reports.

FOURTH DAY.

FRIDAY, April 24th, 1891.

The Council met at 10.30. Present, the Warden and 29 Councillors.

The Minutes of Thursday morning were read and approved Read Report of Dr. Cunningham, Physician to the Poor Farm.

To the Warden and Council of Halifax County:

GENTLEMEN,—In reporting on the condition of the County Poor Farm, I beg leave to say that the health of the inmates has been, in general, good.

I regret to say, however, that a few cases of diphtheria occurred this spring -two cases among the inmates, and one of the attendants, three cases in all, with see dath

All possible precautions against its spread were promptly taken, as isolation, fumigation and thorough cleaning. The following shows the number of deaths and the cause:—

All the deaths occurred among the males; there were no deaths among the females.

The Wards, Outbuildings and Premises have been kept always clean, and the personal cleanliness and comfort of the inmates well looked after.

This has been due altogether to the constant and industrious care of Mr. and Mrs. Turner.

DARTMOUTH, April 22, 1891.

On motion the Report was received and adopted.

Read applications for the position of Physician to the Poor Farm from Drs. Cunningham, Milsom and Smith, offering to do the work respectively for \$90, including medicines; \$95 with medicines, and \$100 without medicines.

On motion of Councillors Bissett and Corbin, Dr. N. F. Cunningham was appointed Physician for the year, beginning June lst, salary including medicines as stated, \$90.

Submitted a Petition from F. W. Christie, R. F. Page and A. Hefler, residents of District No. 15, against T. Mitchell for non performance of Statute Labour and incorrect accounts, and objecting to his re-appointment.

The Warden said that as under by law and advertisement, no Petitions were receivable after the 3rd day of session, but with the consent of Council this could be read. Consent being given the Petition was read

Councillor Donaldson protested against another Councillor interfering with the officers of his district, but wished the matter investigated fully. Councillor Corbin offered some explanations.

On motion of Councillors Bissett and Burris-

Resolved, That Councillors Fenerty, Croucher and A. Thomas, be a Committee to investigate the charges made against Mr. T. Mitchell, and report at the January Session.

Councillor Fenerty submitted and read the

REPORT OF COMMITTEE ON CLAIM OF W. G. COLE FOR LOSS OF HORSE, &c.

Your Committee beg to report that they have gone as freely as possible into the matter of the loss of Wm. Cole's horse, Mr. Cole being present to give his version of the matter. We regret the Road Commissioner's evidence in the matter is not available, he being out of the Province. But it appears that the road and bridge in question are practically a private way, although work on the road and repairs to the bridge have been done by the Road Commissioner. The bridge was posted as dangerous by the Commissioner, who also repaired it in a measure, but to notify possible users that the repairs were of a temporary character, and not calculated to render the bridge safe for hard usage,—he directed that the "danger" notice should remain up, and as a matter of fact it did so remain. This fact and a local knowledge of the conditions of the bridge should have served to render a user careful.

Mr. Cole tried to cross the bridge with a load, a cord, more or less, of heavy poles and a pair of horses. He was using a sled. The bridge was evidently bare of snow at the time, as in their efforts to get the load across the horses pushed or folded the planks covering the bridge, and which were not spiked up, making a gap through which one of the horses fell and was drowned.

Your Committee are of the opinion, that under the circumstances and condition of this case, Mr. Cole's loss is largely, if not altogether, due to lack of prudence on his part in using a defective and dangerous bridge in the way he did. But recognizing the hardship of his loss, they recommend that the sum of twenty-five dollars be paid him in full of his claim. This to be a final settlement. five dollars be paid him in full of his claim. Respectfully submitted.

Read by permission of the Council, a petition from 41 inhabitants of Meaghers' Grant, asking that a precept be granted for a road from the Baptist Church to join the Harbour road, through the properties of Dunbrack, Joseph Secton and John Milne, the said Dunbrack having no direct way to the main road, and the new route would afford better facilities for the general public.

Read a counter Petition of 55 inhabitants of the district, asking

the Council not to grant the prayer of the Petition.

On motion both documents were referred to the Committee on Roads and Bridges.

The Council then adjourned to Saturday at 10.30 a. m.

FIFTH DAY.

SATURDAY, April 25, 1891.

The Council met at 10.30. Present, the Warden and 28 Councillors.

The Minutes of Friday morning were read and adopted. Read report of the

COMMITTEE ON ASSESSMENTS.

Your Committee on Assessments beg to present the following Report, giving herewith a statement showing the Deficits in the several Districts of the Municipality for the year 1890.

Your Committee find, on going over the Collector's Rolls, there are a number of Districts with large amounts of Taxes uncollected. In some cases warrants have been taken out, but no return made to date.

Your Committee recommend that the Law in regard to collection of taxes be more strictly enforced in future.

The Treasurer and the Councillors for Districts from which the larger amounts were due, explained the causes of non-payment of deficits as below. Warrants had been issued in all Districts where at the end of the year deficits were due, except Districts 8 and 10, in which the Councillors said that nothing could be collected at present, but would be shortly. The Clerk said that the new municipal assessment law worked very badly, and under it the deficits were much greater than formerly. The average deficit now was $6\frac{1}{2}$ per cent on the whole assessment, but by Districts some were very much beyond that.

Councillor Fenerty presented the

REPORT OF THE FINANCE COMMITTEE.

1. Your Committee regret to find that as part of the legacies inherited from the late Quarter Sessions, a number of bills of taxed costs in the suit of the Queen vs. Dartmouth in re School Assessment on that Town, have been presented to the County Treasurer for payment since the January meeting of Council. As the final decision in the Supreme Court of Canada (in the appeals) was against the County, there is no other recourse than to make provisions for these costs, which after all deductions, amount to the large sum of \$1,020.00. We recommend that on account of the claim, \$400 be placed in this year's estimate.

2. There is also to be added to the Estimate the expenses incurred in several districts by Boards of Health, which by law are a county charge. The bills already received and passed amount to \$250, and some have not yet come in. We recommend adding \$100 to this, making in all \$350.

Your Committee are strongly of the opinion that as a check on the expenditure in the Districts, each District should be directly taxed for portion of the

outlay in this direction, say the County two-thirds and the District one-third. In the bill for District 25, submitted by its Board of Health, we recommend that the Physician be paid \$50 instead of \$75 as charged therein.

Nothing was placed in the Estimate for claims for the loss of a Horse in District 30, reported on in January, and voted to be paid \$80.00. For a similar claim from District 35, the Special Committee will report.

The expenses of the County Council in consequence of the greater length of Sessions will exceed the estimate by about \$100, which the Treasurer will have

paid when the present meeting adjourns.

5. The Estimate for the Poor Farm did not include expenditures for which Accounts have since been received for sundry building material, cost of new barn, extension and refitting, kitchen and furniture and fittings for the new wings completed last year, nor allowance to Chairman voted last year. These items will amount to \$750.00, subject to reduction by committee on Poor Fara.

6. If passed the Clerk shall be authorized to include the foregoing amounts.

Several Councillors objected to the allotments for their Districts, and Councillor Poole requested the Chairman to state upon what principle the Committee had divided the Road Grant, as his mileage had been very greatly reduced. Councillor Fenerty suggested some considerations which should govern the mode of apportianing the amount.

COMMITTEE ON PUBLIC PROPERTY.

We, the undersigned Committee on Public Property beg to report as follows:

1. We have read a letter from B. C. Wilson to Councillor Bissett in which

he says he gave no authority to have the barn built.

2. Also a letter from Councillor Bissett to B. C. Wilson complaining of the discreditable manner in which the work was done and asking for information, in reply to which B. C. Wilson says he did not visit and examine the buildings, but trusted to the contractor to have the same completed in a proper manner, and any unsatisfactory work in the building could be deducted from the amount of the valuation of the barn.

3. After which the Committee on Public Property unanimously passed the

following resolution:

That the barn be valued and an estimate made of uncompleted work on houses, and the amount to finish uncompleted work be deducted from the valuation of the barn.

We recommend the purchase of pair oxen for Poors Farm, price not to

exceed \$95.

5. Your Committee had presented to them a bill of \$233, contracted by the late Chairman, the greater part of the articles are now unused and most of them at an exorbitant price, which action your Committee most strongly disapprove, although recommending payment.

Your Committee have valued the barn at \$1.75, which we recommend to be paid, less amount already paid and the amount to be paid for unfinished work

on houses, balance not to be paid until unfinished work is completed. 7. Your Committee also recommend that the yards around Poor Farm be

enlarged.

That the Bridge over the Salmon River, on the Main Post Road in District 30, be placed under the Bridge Act.

In the discussion that followed relating to number, condition and requirements of the Bridges in the County, Hon. Provincial Secretary gave some information as to the nature and kind of Bridges which came under the Bridge Acts. They must be built of substantial material and to cost not less than \$500. The small Bridges did not come under the Act and would require to be built out of the Road Grant, or if as previously done a Special Loan payable with interest out of the yearly grant could be provided. At present there were no funds for the larger Bridges, but the requisitions could be handed in to be acted on when provided for by subsequent legislation.

Councillor Fenerty referred to injurious reports in the newspapers in relation to the Petition against Thomas Mitchell, District

15, received yesterday.

He moved, seconded by Councillor Corbin-

That the Clerk be directed to notify the newspapers that the question of Thomas Mitchell's (Road Overseer in District 15,) honesty or dishonesty did not come before this Council, and that the Council regret that the newspaper report conveys that impression.

The Warden said that the reporters had taken their information from the report itself, which the clerk would read again if the Council so desired, but as a special Committee had been appointed in the matter, the resolution did not seem to be required.

That the Councillors be paid the usual fee for attendance at the Council. Also, that five hundred copies of the Minutes of the two Sessions of this Council be printed for distribution among the Councillors as heretofore. Passed.
