



THE FIRST ANNUAL MEETING

OF THE

TENTH MUNICIPAL COUNCIL.

FIRST DAY.

HALIFAX, TUESDAY, JAN. 10TH, 1899.

The Councillors elected on the 15th Nov., 1898, were summoned by advertisement and special notice each to meet at the County Court House, Halifax, Tuesday, Jan. 10th, at noon, in the Council Room.

After assembling, the Clerk read Sections of the County Incorporation Act, by which he is Returning Officer and Chairman until after the election of a Warden.

The Roll was then called and shewed all the Councillors

present, except D. Vaughan, elected for District 36.

The Clerk then proclaimed the following gentlemen duly elected, as shown by the Poll Books from the Presiding Officers :-

Each Councillor was then qualified by taking the Oath of Allegiance and Councillor's Oath.

The Clerk remarked there were 15 new Councillors and fewer J.'s P. than heretofore, and stated the Council to be duly sworn.

He asked for nominations of Warden and Deputy Warden.

Ex-Warden Shatford declined nomination.

Moved by Councillors C. E. Smith and Walsh-

That W. C. Henley be Warden.

Moved by Councillors Negus and Flemming—

That B. C. Wilson be elected Warden.

The Clerk named Councillors Negus and Bartlett to count and register the ballots.

On the ballots being counted, there was found for B. C.

Wilson 17, W. C. Henley—13 votes.

The Clerk declared Councillor Wilson duly elected Warden for the term of the Council.

The Warden was sworn into office and took the chair. After thanking the Council for the honor conferred on him, he said he hoped to perform, with their co-operation, the duties of the office satisfactorily.

Councillor Maddill was unanimously elected Deputy Warden, and thanked the Council for this expression of their confidence.

On motion, Councillors C. E. Smith, Fleming, Henley, Negus, Stewart and Walsh, were named a Committee to nominate the Standing Committees for the year. In amendment some other names were proposed, but withdrawn.

The Council adjourned to 2.30 p.m.

Afternoon Session.

JANUARY 10TH.

The Council met at 2.30. Present, the Warden and 29 Councillors.

Councillor Thompson, referring to those absent, hoped that the Rule regarding absentees would be strictly followed, and those over an hour late be not paid for that day.

The Minutes of Morning Session were read and confirmed. Councillor Shatford referred to the custom of reading the Minutes of the last day of Semi-Annual Session previously.

The Clerk read the same as on pages 91-95 of the Minutes of 1898.

Councillor Shatford took exception to the Minutes as not giving the Clerk's commendation of the ex-Warden's satisfactory transaction of the County business, while in office.

The Clerk said neither had he reported the complimentary remarks of the several Councillors who had then spoken, as no written resolutions were passed. The Session had ended, and the whole proceeding was informal, but he would now repeat what he had then said in praise of the Warden, and did so.

Read, a letter from Judge Johnston, permitting the use of the Court Room until Thursday, when he would require it.


Some of the Councillors asked if he owned the Court House, and said a definite understanding should be had regarding the Council Room and the matter settled now.

The following Resolution was moved by Councillors Shatford and McCallum—

Whereas, it has been industriously circulated in a newspaper called the "Atlantic Weekly," and also in one of the city papers, by H. C. Congdon, that the Court House Commissioners, in repairing that building, exercised the most wasteful extravagance in performing the work, which cost thousands of dollars more than the work could be economically performed for;

And Whereas, a copy of the paper containing the above charges was sent to each Councillor elect, with a view to prejudice the new Council-





Therefore Resolved, that this Council appoint a Committee of five of its members to investigate the charges so made, with power to send for persons and papers, and to report to this Council at an early date.

Ex-Warden Shatford defended the expenditure in a forcible manner. He said he hoped the Council would do him the justice of giving him an opportunity of answering the charges of having been extravagant. He had always endeavored to do his duty as Warden and Councillor. He then read the charges that had been made against him by the paper mentioned above. The object of the writer, he said, was to unduly influence the new Councillors, or that the statements were made in gross ignorance of the facts. had obtained the written opinion of the Attorney-General as to whether he was legally qualified to act as Councillor. The letter was produced by him, and the opinion expressed was that his position was perfectly legal and proper until a legal tribunal had decided that he was disqualified. Under the opinion he claimed his right to sit and vote just the same as any other Councillor. He strongly urged that the Committee asked for be given the fullest privileges of inquiring into the charges of gross extravagance. He also submitted -a letter from Judge Townsend, stating that he had not charged the Commission with extravagance in connection -with the repairs to the Court House. He called the attention of the Council to the last report of the Court House That report, he said, recommended that Commissioners. certain repairs be made and the Council unanimously adopted the report. As Warden, he said, he was bound to act as one of the Commission. The Court House was in a wretched condition; room was absolutely needed for the Prothonotary to file his papers, and the sanitary condition was foul. The Commission obtained the services of a competent architect and the work was done by days work under his direction. No unnecessary work had been done. The members of the Commission visited the Court House almost every day, and he had come from his home every week to examine the work. He stood on his record during all these years as Councillor He had always opposed extravagance, and instanced several matters where he had saved the County many hundreds of dollars. He had succeeded while War--den in settling the difficulty which arose between the County and City of Halifax and Town of Dartmouth. He had been instrumental also in settling with the Government the claim

against the County. What was the expense? The City of Halifax would pay 9-11ths of the total cost of the repairs, so that the County would only have to pay 2-11ths of the amount. In the face of this fact the statements of the "Atlantic Weekly" were extravagant and outrageous. The bills were carefully examined when work was done-every item was scrutinized. The Commission had not handled any of the money borrowed for repairs. The money was borrowed on debentures at 4 per cent. The County's share for interest on the expenditure was \$52 annually-about four cents on every \$1,000 valuation. The Court House is now in a sanitary condition as required by the Board of Health. The work has been commended by the Board and by representatives of the City Council. The Court House is not a modern building, and on that account the expenditure was He concluded by again asking the appointment of a Committee to investigate the charges made by the paper, and the Commission would then have a chance of showing that everything was fair and above board.

Councillor McCallum, in seconding the resolution, said that as an active member of the commission he would urge the appointment of the committee asked for. He had not read the articles published in the papers until lately. He regretted he had not done so before, as he could have corrected many mis-statements. He then spoke of the repairs, and said that if the work had been let by contract it would

have cost much more.

The resolution passed, and the following were appointed to constitute the Committee, viz.: Councillors Bartlett, C. E.

Smith, Sellars, Hall, and Thompson.

County License Inspector Reid reported on the applications for liquor licenses in the County. He recommended the following:—

John Ahearn, hotel, Riverside House, St. Margaret's Bay

Road, District 13.

Norah Hurley, shop, Upper Prospect, District 10.

Arthur Wyatt, hotel, Lakeview House, St. Margaret's Bay

Road. District 13.

The petitions and certificates of all the above were strictly in accordance with License Act, and there were no objections made to their applications. He recommended the granting of all of them.

Councillor Walsh opposed the granting on various grounds of Mrs. Hurley's license, but on being put to a vote the

Council granted it.

The Council granted Ahern's and Wyatt's licenses without opposition.

Read; a note from Councillor Vaughan, stating he was

too ill to be present.

Councillor Walsh gave notice of reconsideration of the vote in favor of license to Mrs. Hurley.

Councillor Shatford read a letter from N. P. Christian, J. P., Upper Prospect, approving of granting her a license.

Council adjourned to Wednesday at 10.30 a.m.

SECOND DAY.

WEDNESDAY, JAN 11TH, 1899.

The Council met at 10.30. Warden and 29 Councillors present. The previous Minutes were read.

The reconsideration of Mrs. Hurley's license succeeded. After discussion the vote was again taken, and names asked to be recorded as follows:—

For granting — Councillors Shatford, Bartlett, Burris, Thompson, A. F. Smith, O'Leary, Hayes, Cole, Munro, Johnson, Wilson, 11.

Against — Councillors Scott, Negus, Lydiard, Fleming, Walsh, Lapierre, Gladwin, Raine, J. Dauphiney, O. Dauphiney, 10.

The Warden submitted a letter from the Board of Trade of Dartmouth, relative to the advisability of a division of the County as regards representation in the Federal and Local Parliament, and stating that a committee would be glad to meet a committee of the County Council, or in a body, to discuss the matter. The letter was fyled for future action.

Moved by Councillors Shatford and O. Dauphiney, and-

Resolved, That Councillors Bartlett and Scott be the two Court House Commissioners. Passed.

Moved by Councillors Shatford and O. Dauphiney-

That Harry Wright be a County Constable for the present year Passed.

The Treasurer laid on the table his account of receipts and expenditure for the year ended December 31, 1898, with the Auditors' report thereon.

The account was recommended to be printed and distributed as heretofore, and the Auditor's report was received and adopted on motion of Councillors Partlett and Madill.

On motion, Deputy Warden Maddill and Councillor O'Leary were added to the Investigating Court House Com-

mittee.

Applications were received from the former Auditors, from Janitor Smith, Coroner's Constable Spencer, Dr. Trenaman, Physician to the Jail, Chief Constable Burbridge, Deputy Chief Constable Smith, all for reappointment. Also from D. McDougall, for County Constable, Geo. S. Innes for Chief Constable, R. C. Purcell. Deputy Chief Constable, A. W. Purcell, Coroner's Constable, J. W. Turner, Keeper of Poor's Farm.

Moved by Councillors Shatford and Butler-

That the appointment of Auditors be deferred till Saturday.

Councillor Shatford explained that this was to ascertain what the duties of an Auditor were. He thought about one evening had been given to the work. The Clerk said they had a monthly audit and final balance of accounts, in all 14 attendances. The resolution passed.

Read, the Report of the Revisors of Assessments, and a tabulated statement of each District's valuation compared

with those of 1898.

Moved by Councillors Smith and Gladwin-

That the report be referred to a Committee to report on before further action, etc.

This was withdrawn, and it was moved by Councillors Madill and Negus-

That the report of the Board of Revisors of Assessments be received and adopted. Passed.

Moved by Councillors Shatford and Negus-

That Alex. W. Smith be appointed janitor of the Court House at the usual salary. Passed.

By Councillors Shatford and Bartlett-

That Joseph Spencer be Coroner's Constable. Passed.

The Clerk, in reply to enquiry whether another Coroner's Constable was required, said it was neither necessary nor

advisable. When more than one held office there was apt to be an unseemly squabble for possession of the body on which a Coroner's inquest was held, and referred to the Herring Cove inquest. Mr. A. W. Purcell, who was neither Coroner's nor County Constable, went there without authority accompanied by two strangers and demanded the bodies. The Coroner refused, unless the expenses incurred for inter-

ment were paid. Purcell returned, and next day got an order from the Clerk for the bodies, and had received them with the coffins, etc., to be sent to Cape Breton, but had not yet paid for the latter.

Moved by Councillors Shatford and Bartlett-

That Richard Burbidge be appointed Chief Constable for ensuing year at same salary. Passed.

Councillor Sellars stated, that in order to complete the Report and Accounts of the Committee of Public Property, it would be necessary for him and Councillor Negus to go to the Poor Farm.

The Council adjourned to 2.30 p.m.

Afternoon Session.

WEDNESDAY, JAN. 11.

The Council met at 2.30. Present, the Warden and 28 Councillors.

The Minutes of the Morning Session were read and passed.
Submitted a letter and circulars from Cragg Brothers,
respecting the Typewriter as an efficient machine
should the Committee require one.

The Clerk said that it would be of no use unless a person were engaged to operate it.

Moved by Councillors Bartlett and Madill—

That D. McDougall be appointed a County Constable for this year.

Passed.

Moved by Councillors Madill and Bartlett-

That Janitor Smith be re-appointed for present year Deputy Chief Constable at the same salary as last year.

The motion was strongly opposed by Councillor Shatford. Reference was made to the same office as held by Haverstock and which proved ineffective, and that the salary might be saved. Councillor Shatford also considered that the Janitor should attend solely to Court House duties.

Moved by Councillors McCallum and Butler-

That Reuben C. Purcell be appointed Deputy Chief County Constable for present year at salary of \$50.

Moved by Councillors Shatford and Madill in amendment—

That Purcell be a County Constable without salary.

Passed.

Submitted the Annual Report of W. L. Malcolm, Keeper of the County Jail, with Schedule of Commitments for the year, stating the offences, number of persons committed, etc.

Moved by Councillors O'Leary and Lydiard-

That the Jailor's Report be referred to the Committee on Public Property. Passed.

Read, the Report of Jas. F. Turner, Supt. of the Poor's Farm, stating the crops raised in the year 1898, the stock and materials on hand and health of inmates, &c. Referred to Public Property Committee.

Moved by Councillors Bartlett and Shatford-

That Councillors Sellars and Negus be authorized to visit the Poor's Farm to-morrow, with the view of receiving from the Supt. of that Institution all information possible respecting the finances, &c., and report upon its condition. The Council to furnish the visitors with team.

Passed.

Read, Report of Dr. Trenaman, Physician to the County Jail for the year ended Dec. 31st., 1898.

Moved by Councillors Madill and Thompson-

That the Report be received and adopted.

Passed.

Moved by Councillors Bartlett and C. E. Smith-

That Dr. Trenaman be re-appointed Surgeon to the County Jail for ensuing year, at the usual salary (\$75.00). Passed.

Read, the Report for year 1898 of Dr. N. F. Cunningham, Physician to the County Poor's Farm. Referred to Public Property Committee.

Moved by Councillors Lydiard and Negus-

That Dr. Cunningham be appointed Physician to the Poor's Farm for the present year, at the usual salary (\$90).

Passed.



Moved by Councillors Bartlett and Walsh-

That in view of the absence of John Jollimore (the present Collector) from District 23, Zachariah Jollimore be appointed Collector for said District for present year, with power to collect the balance of rates for 1898.

Passed.

Moved by Councillors A. F. Smith and Lydiard-

That the South Line of Road Section No. 3 in District 24 be changed from the School House to P. H. Moser's Barn, South. Passed.

Read, the Report of Joseph Lloy, Custodian of Rocky Run Draw Bridge between Districts 28-29, that it is much in need of repairs, especially the approaches. Its present condition is dangerous. The water is so high that boats cannot pass under it. Councillor Sellars' end is all right. Referred to the Councillor for District 28.

The Committee on Nominating Standing Committees for 1899 submitted their Report, which was read each separately and passed as follows:—

A letter from Judge Johnston was read, expressing his readiness to meet the wishes of the Council for the use of his Court Room if another room was provided in which to hold his Court.

The Council appreciated his offer, and it was decided to offer him the Admiralty Court Room as fitted up.

The Warden called attention to the daily use of gas in

the Book Vault of the Registrar of Deeds, and it was moved by Councillors Thomson and Butler—

That in the opinion of this Council it is judicious that the Records Vault be lighted by electricity or some light other than gas, and that this resolution be communicated to the Court House Commissioners. Passed.

The Clerk remarked that at present there was no proper means of combating fire in the Court House, Jail or Poor Farm, and the Insurance Companies granting the Policies had frequently referred to this want, especially in respect to the Poor Farm.

Read, a letter from John Eckersley to Councillor Flemming, referring to the necessity of better Road facilities between Bedford and Lake View, District 17. A Bridge at Rocky Lake was approved by the Council, but no money voted, and a road suggested and approved by Provincial Engineer two miles long from Lake View to the Rifle Range, as the Cobequid Road was impassible, and it was stated that \$1000 was available for the purpose. In the discussion thereon it was not made clear where or in whose keeping this \$1000 was at present.

. Moved by Councillors Negus and Scott-

That the matter of a new Road in District 17 be referred to the Road and Bridge Committee. Passed.

Submitted Report of the Arbitrators with plan of new Road from a point on the Seward Road to the new Cole Harbour Road in District 33, and giving the measurements of land of owners through which it runs, and the cost with fencing as follows:—



Moved by Councillorc Negus and A. F. Smith-

That the Report of the Arbitrators on the Seward Road be referred to the Road and Br dge Committee.

The following Petitions for Roads were submitted and read, viz.:—

Distriat 22, for a Precept for a short piece of Road from Main Coach Road to David Brown's, about half a mile along the east side of Blackie Dean's lands—22 names.



District 24, a Petition from George Cameron and Thomas Englehutt, of Moser's River, endorsed by 32 of the Ratepayers, for a right-of-way from their dwellings through lands of Solomon Fancy and others along the Lake Road at pre-

sent used as a winter road.

District 35, for the renovation of the Bridge between the Grant Road and the Main Post Road, and called Rourke's Bridge, which is in an unsafe and dangerous condition, and property owners on each side of the river are deprived of the means of communication in consequence. Signed by 31 Ratepayers, who ask that the Council refer the matter to the Government for immediate completion.

District 26, Petition from inhabitants of Mooseland and Moose River Mines for a grant by the Council of \$1,000 for the construction of a Carriage Road to connect those two Sections in a direct line, being 3 miles. At present the distance between the two points is nine miles. The Petition has 125 names to it.

All the foregoing were referred to Committee on Roads and Bridges.

Moved by Councillors Flemming and Henley—

Resolved, That this Council request the Provincial Government to borrow a sum not to exceed One Thousand Dollars for the construction of the Road between Lake View and Bedford, said sum to be borrowed and expended under the terms and conditions which applied to the special loan procured by the County Council through the Provincial Government in the year 1897.

Moved by Councillors Walsh and C. E. Smith-

That three hundred dollars be added to the Resolution of Councillor Flemming for the opening of a new Road in District No. 10.

On motion, both resolutions were referred to the Road and Bridge Committee.

Submitted and read a letter from R. T. Smith, of Musquodoboit Harbour, claiming \$100 damages for loss of Horse, Wagon and Harness, and narrow escape from drowning of Mrs. Smith and child at the Iron Bridge in District 36. He states that the horse took fright at the holes in the Bridge, and backed against the rail, which gave way, and the



team and occupants were thrown into the water 10 feet below. The bridge was unsafe, and the Committee had neglected to have it repaired till next day, 28th April, 1898.

Referred to Road and Bridge Committee.

Read, a letter from J. A. Knight, solicitor for Wm, Willis, Bedford, asking payment for gravel supplied to Jas. Rolfe, Overseer of Highways in 1895, who confirms the bill, amounting to \$14.25, but at the time stated that there were no funds left to pay it. Councillor Donaldson also agreed to have it paid. Referred to Road and Bridge Committee.

The Council adjourned to Thursday, 10.30 a.m.

THIRD DAY.

THURSDAY, JAN. 12TH, 1899.

The Council met at 10.30 a. m. The Warden and 29 Councillors present. Minutes of last meeting confirmed.

Read, a petition from a large number of inhabitants of Districts 29 and 33, in regard to the road over Cole Harbour Dyke, which, if constructed, would be a great convenience to the public. That in 1878 the Dyke Company, at their own expense, spanned the open space with a bridge, and kindly, with other property owners, allowed the people the privilege of using this route. A few years ago the bridge became unsafe, and the present owner removed the planking, thus the benefit to the people of saving about 12 to 15 miles travel to reach either district ceased. By the Dyke Road only 5 miles need be traversed to reach the same points. The present owner of the Dyke, and the property owners through which the road would pass, would grant a free right of way. Length of the road less than a mile. They ask the Committee to have the matter placed under the Bridge Act, so that the Government may build the bridge. motion, it was referred to the Road and Bridge Committee.

Read, a letter from A. B. Gray, District 15, stating that Alex. Hefler, Overseer of Roads, had trespassed on his property last year, in June, by opening gravel pits and damaging and disfiguring the front of said property. He was notified verbally and in writing to desist from removing the material to repair the highway to Bedford, but continued to do so. Gray claims to be recompensed for the damage. On motion, referred to Road and Bridge Committee.

Moved by Councillors A. F. Smith and Lydiard-

That the south line of Road Section No. 3, in District 24, be changed from the school house to P. H. Moser's barn, south.

Passed.

Submitted and read a Memorial from a number of the principal property-owners in Bedford, District No. 15, calling the attention of the Council to the fact that many and continual encroachments, (some quite recent) have been made on the public roads in and near Bedford, and that nothing has been done to remedy the evil. They request that necessary steps be taken to have the lines of these roads rectified and the roads restored to their proper width. Reference was made to the Statutes, which showed that the width of the Great Roads was 66 feet, and other highways, except where less width was specially allowed, 60 feet.

Councillor Butler strongly supported the petition, and seconded by Councillor C. E. Smith, moved the following resolution:—

Whereas, The present condition of the Great Roads of the Municipality of the County of Halifax as regards the location of boundaries are in a pitiable condition;

And Whereas, encroachments are continually made to an alarming extent, so that in many parts it is impossible for two teams to pass;

And Whereas, the Road Overseers cannot report these encroachments, having nothing to guide them in arriving at exact measurements,

Therefore Resolved, That this Council appoint a Committee, with power to employ the proper person or persons to accurately define the said Roads.

- Be it also Resolved, That Councillors C. E. Smith, O'Leary and Butler, be the Committee for attending to this matter. Passed.

Moved by Councillors Isaac Dauphinee and Walsh-

That the portion of Road in District 12 leading from Main Post Road to James Redmond's house be made a Road Section, and be named Section 1½.

Passed.

The Treasurer presented Accounts connected with the Medical Examination Commitment and conveyance from Amherst to Mount Hope of Miss Annie Hamilton, who is insane, of Sackville, District 17, viz., Dr. Bliss and Dr. McQueen, \$8.00 each, Constable's fees and expenses, \$13.17, and Magistrate's fees, 75c.

On motion, these charges were referred to the Committee on Insane for enquiry.

The Council adjourned to 2.30 p.m.

Afternoon Session.

JANUARY 12TH.

The Council met at 2.30 p.m. The Warden and 29 Councillors present. The Minutes of Morning Session were

adopted.

Read, a letter from A. C. Johnstone, Secretary of the Board of Trade, Dartmouth, relative to the desirability of a change in the representation of the County of Halifax in the Local and Federal Legislatures, by which a better division of East and West Halifax could be secured, and suggesting a conference either of the County and Town Councils, or of a Committee of each to discuss and report on the subject.

Moved by Councillors Lydiard and O'Leary-

That a Committee of five Councillors be appointed to meet with a Committee from the Dartmouth Board of Trade to discuss the question of separate representation for the Eastern portion of Halifax County in our Parliaments.

Passed.

Moved by Councillors O'Leary and A. F. Smith-

Resolved, That Councillors C. E. Smith, Hall, Lydiard, Shatford and Stewart, be a Committee to confer with the Dartmouth Committee on County representation.

Passed.

The Warden said he had had a conference with Judge Johnston about the use of the Court Room, and the Judge has agreed to allow the Council the use of the room whenever required at this session.


The following resolution, moved by Councillors Bartlett and Thompson, was unanimously passed:—

Whereas, The Warden having advised this Council that he has succeeded in making very amicable arrangements with Judge Johnston in reference to the occupation of the County Court Room by the County Council during its present session, and has assured us that the Judge expressed his desire to accommodate us even at discomfort to himself,

Therefore Resolved, That this Council desires to express its appreciation of the courtesy and consideration exercised by Judge Johnston, and further that a copy of this resolution be communicated to his honor.

The following Resolution, moved by Councillors Walsh and O. Dauphinee, was passed:—

Resolved, That a padded room be fitted up in the County Jail for the purpose of temporarily placing insane persons from Halifax County until they can be transferred to Mount Hope Asylum.



That the bridge between the Guysboro Road and Meagher's Grant Road be placed under the Bridge Act of 1883 and the amendments thereto.

Rejected.

Moved by Councillors Bartlett and Burris-

That Dennis Brophy be Revisor for District 23 in place of John Jollimore, present Revisor, who has left the District. Said D. Brophy to do the duty of Revisor for present year.

Passed.

Councillor Henley introduced the subject of the new Road Act (Chap. 67, 1898,) and commented adversely on a number of the sections as being unworkable and requiring amendment. The discussion occupied the remainder of the afternoon by Councillors Shatford (who wished an explanation of what the "balance" in section 3 referred to meant) and Thompson, Madill, C. E. Smith, Bartlett, Burris, and others. The Warden explained several of the sections.

Some of the Councillors said that changes had been made in the original act by the Legislature which were not sanctioned by the Council. Those changes were made in sections 8, 12, 15, 29, 30, and 31 of the Act.

The Council adjourned to 10.30 a.m., the roll to be called,

and then adjourn for committee work till Saturday.

FOURTH DAY.

FRIDAY, JANUARY 13, 1899.

The Council met at 10 30, the Warden and 28 Councillors present. The Minutes of last meeting were read and accepted.

The Council then adjourned to Saturday at 10.30 a.m.

About 23 of the Councillors were conveyed by teams to the Poor Farm on a visit of inspection, returning in the afternoon.

FIFTH DAY.

SATURDAY, JAN. 14, 1899.

The Council met at 10.30 a.m., the Warden and 29 Coun-

cillors present.

Read, the Financial Report of D. W. B. Reid, License Inspector, shewing Receipts and expenses of his Office for the year 18.18, and Tabulated Statement of Prosecutions.

Moved by Councillors Butler and O'Leary-

That the License Inspector's Report be adopted.

Passed.

With reference to the uncollected fines. Mr. Reid said the greater part would probably be collected.

Mr. Reid tendered his resignation of the office as follows:

HALIFAX, JAN. 14TH, 1899.

To the Warden of the County of Halifax.

SIR,-By the Liquor License Act of 1886, under which I was appointed to the office of Chief Inspector of License, my appointment was during good behaviour, and I was liable to be removed only for cause shown and

on a majority vote of the Council.

As you are aware, a resolution was passed at the last Session of the Council, asking me to resign. Although no specific charges of any kind were then or have ever been made against me in regard to my performance of the duties of my office, and no opportunity has ever been given me of meeting any charges, I have deemed it undesirable that I should continue to hold the office against the wishes of the Council.

Its duties are of such a character as to require the moral support of the best men in the County, and I feel that I should be greatly hampered were

the attitude of the Council hostile to me.

Whoever fills the office honestly and fairly, as I have endeavored to do,

requires the fullest support of every member of the Council.

In view of the resolution above referred to, I may possibly not be able to count upon such support. I beg therefore to place in your hands my resignation of the office of Chief Inspector of Licenses for the Municipality of the County of Halifax, to be dealt with as the Council may deem best.

Believe me, very obediently yours,

On motion, the consideration of the resignation was deferred by the Council till Monday next.

Moved by Councillors Fleming and Gladwin-

That in consideration of the proposal for the new Road from Lake View to Bedford, be it *Resolved*, that this Council recognize the desirability of said Road and authorize a Precept to be granted to lay out said Road. And as it is reported the sum of \$1000 is somewhere available under the



authority of Engineer Murphy, this Council expresses its willingness (if said sum is available) that it be appropriated for the building of said Road, provided that such money does not come out of the County Grant.

Moved by Councillors Flemming and Lydiard-

That the application for the sanction of the Council for the new Road from Lake View to Bedford bo deferred to a later date, in order to consult Engineer Murphy.

Passed.

Moved by Councillors Shatford and Thompson-

That George Wilson be a County Constable for the year 1899. Passed.

By Councillors Negus and Scott-

That George S. Innes be a County Constable for the present year.

Passed.

By Councillors Shatford and Bartlett-

Resolved, That we appoint no more County Constables this session.

Passed.

Moved by Councillors Munro and Bartlett-

That Dennis Purcell be appointed Revisor in District No. 8 for this year, to enter on his duties as soon as required, in place of Wm. Johnston, who has left the District.

Passed.

Read, the Report of Charles Murphy, custodian of the Canterbury draw bridge, between Districts 28 and 29. The bridge is in a dangerous condition. The under timbers are rotten. The south side of the bridge has sagged 8 inches. The planking is gone in many places, and a team broke through last spring. The custodian says the bridge should be rebuilt. On motion, referred to Road and Bridge Committee.

The following communication was read from Messrs. Wade and Paton, of Bridgewater—

We wish to inform you that at the approaching session of the Legislature we jurpose applying for an act incorporating certain parties into a joint stock company for the purpose, amongst others, of generating and distributing electricity for lighting, power, etc., through the counties of Annapolis, Kings, Hants, and Halifax, from a central station or stations operated by water power, and that we will ask that said company be given the right of operating and maintaining lines of wire through said counties for the transmission of their current; also for such rights for the creation and maintenance of their water power as may be found necessary.

Moved by Councillors Bartlett and Walsh, and-

Resolved, That the communication re privileges for electrical transmission, etc., on being read to the Council, said Council do hereby express their willingness to further consider the matter when brought before them in a more intelligible light.

Submitted, the Report of the Committee on Public Property relating to over charges in contract supplies, 1898. It was read as a whole and passed.

Moved by Councillors Fleming and Henley-

Resolved, That this Council request the Provincial Government to borrow a sum not to exceed \$1000 for the construction of the road between Lakeview and Bedford, said sum to be borrowed and expended under the terms and conditions which applied to the special loan procured by this County Council through the Provincial Government in the year 1887.

On motion, referred to the Road and Bridge Committee.

Moved by Councillors Walsh and Madill-

That Councillor Walsh's resolution regarding the borrowing of \$300 be referred to the Road and Bridge Committee. Passed.

Submitted, Return of Precept for the road round Publicover's Hill in District 24, with report and plan of the Committee, who state that the cost of right-of-way through property of Matthew Publicover's—

The Report of the Committee on Public Property for the year ended Dec. 31st, 1898, was submitted and read. Also Financial Statement for the Poor Farm.

On motion, the report was unanimously adopted.

The Clerk reported that only a few Lists of District Officers to be appointed on Monday had been handed in.



JANUARY 14.

The Council met at 2.30. Present, the Warden and 29 Councillors. The Minutes of the Morning Session were read and confirmed.

The appointment of County Auditors, deferred to this day, was taken up. The Applications already received, were from Jno. E. Albro, T. G. Wainwright (former Auditors), W. C. Bishop, S. S. Scott, J. W. Bennett and W. H. Studd.

The Clerk said as this matter had been deferred in order that information as to Auditors' duties could be had, those of County Auditors were plainly set forth in County Incorporation Act, Sections 44, 45, viz:—

It shall be the duty of the municipality auditors to examine and audit the accounts of the treasurer, and all other accounts of the council or corporation, or in which the municipality is concerned; and all such accounts as may be referred to them by the council for special examination, and report as instructed; and it shall be the duty of the council to refer to them all such accounts, and their duty faithfully to report thereon without needless delay.—R. S., cap. 56, s. 45.

The municipality auditors shall have authority to call for all books and vouchers they may deem necessary for elucidating any account laid before them. No account shall be allowed or passed by the council until the same is audited and reported upon by the municipality auditors. The council may make such compensation to the municipality auditors as they may think right and proper from time to time. The auditors shall perform the duties required by this section in the office of the municipal treasurer, or in such other place as the council may direct.

Moved by Councillors Hall and Butler-

That the applications for auditors be referred to a select committee composed of Councillors Shatford, Butler, Lydiard, and I. Dauphiney.

Passed.

Read, application of Jas. F. Turner, Superintendent of the Poor Farm, for re-appointment to that position, and Mrs. Turner as Matron, for the present year. On motion, referred to Public Property Committee.

The Treasurer submitted an account from S. A. Marshall for sundry repairs to the exterior of the County Jail last Fall, \$110.10; also an account from Farquhar Bros. of \$131.14 for plumbers' work at the Jail. They had not been paid, not being certified. The Warden explained that the work was necessary, and had been done under sanction of Committee of Public Property. Referred to Finance Committee.

In reference to action taken respecting the Pedler's License By-Law, passed last year, the Clerk said that he had transmitted it to the Governor and Council, who sanctioned it. But in a test case brought by Mr. Hart, of Sambro, it was shewn to be defective, and could not be legally enforced. Three Licenses had been issued only, which may have to be cancelled and the fee returned.

Moved by Councillors Henley and C. E. Smith, and

Resolved, That in view of the Pedlers' Act of 1898, which was printed in the Minutes of Council. Believing the said Act to be defective, and having proved abortive, conflicting with the Statutes, be it

Resolved, That the amount of the License Pees paid by James Davis

and other claimants be refunded.

The Treasurer said Davis had not yet applied for a return of the License fee. Possibly, the parties may have had some advantage over others by having the License in their keep-

ing for a year.

Read, a Memorial, signed by Judge Johnstone and all the principal legal firms in the city, asking and recommending an increase of pay for the County Court Crier. The Memorial states that the large volume of Criminal business now delegated to the County Court necessitates the almost daily attendance of the Crier, and so interferes with his time as to render it impossible to undertake any other means of That his work is equal to and indeed in excess of income. that of the Criers of the Supreme Court, who are each paid \$450 and fees; and they consider it would only be justice to Mr. Naylor to place him on a par as regards salary with them, in order that he may have means of support.

It was moved by Councillors Negus and Henley-

That the Petition or Memorial of the Barristers of this city, as well as a further recommendation from Judge Johnstone, be not received. Passed.

The Council adjourned to Monday, 16th, at 10.30 a.m.

SIXTH DAY.

Monday, Jan. 16th, 1899.

The Council met at 10.30 a.m. Present, the Warden and 29 Councillors. Saturday p. m. minutes were read and confirmed.

The Warden referred to the Pedlers' License Act being

unworkable, and commended it to the attention of the Law Amendment Committee so as to have a new measure framed which would obviate the difficulties in the last one. The law relative to Revisors' of Assessments demanded some changes also. At present it had to be carried out.

The resignation of Inspector Reid was considered.

Moved by Councillors Butler and J. Dauphiney—

That Mr. Reid's resignation be accepted.

This and an amendment were both lost.

Then moved by Councillors Henley and C. E. Smith-

That the resignation of D. W. B. Reid, License Inspector for the County of Halifax, be accepted, but in view of the duties to be by him completed, said resignation not to take effect until the first day of April next, and in the meantime applications for said position be received by the County Clerk, to be dealt with at the next session of Council.

Passed.

On motion of Councillors Hayes and Gladwin-

John Brown was appointed Fence Viewer for District No. 7 for 1899.

Councillor Butler referred to the unprotected state of property in his District from tramps and bad characters. The owners of houses, who left them to reside in the city in winter, were subject to have them broken into and furniture, etc, stolen or destroyed.

City Recorder W. F. McCoy asked permission to speak on the same matter, and shewed that the properties temporalily vacated, especially in the lower part of the District, had been burglarized. There was no certain protection, and from time to time robberies had taken place and the robbers got away with their booty before a constable could be got quickly to trace and follow them. The local constables in fact

would not act, because no provision was made for their expenses and time. He urged that a special constable be appointed, with a salary, who would watch for and secure the depredators.

Moved by Councillors Butler and McCallum-

That R. Purcell be paid the sum of Fifty Dollars as Deputy Chief County Constable for the current year. Passed.

Submitted and read, the Report of County Stipendiary McDougall for the year 1898, with memo. of fees and fines. Also, his Report as Clerk of License, same period. Passed.

The Clerk said that the Reports do not show by any means all the work the Stipendiary performed, such as giving legal instructions to County Officials as to their duty and in cases of prosecution, in saving the Municipality the expenses of appeals. There had also been from 30 to 50 per cent. reduction in civil causes, making the office fees less.

Read, a letter from J. A. McKinnon, Attorney for A. W. Purcell, to the County Clerk and Treasurer, claiming that in remarks made by the latter in rethe Herring Cove Coroner's inquest, he had stated that Mr. Purcell was not competent to hold the office of Coroner's Constable, as he and his assistants were under the influence of liquor and caused a disturbance, and were refused the bodies on that account; and further stated that he went without authority, though Mr. Purcell went there as Undertaker at the request of relatives in Halifax, etc.

Request was made that the letter be laid before the Council and the statements which prejudiced them against appointing him withdrawn. Unless the slanderous state-

ents were withdrawn an action would be brought.

The Clerk explained that he did not say that Purcell was drunk, but that the Coroner there had stated that the men who went with him were partly so, and they demanded the bodies and were refused, because they would not pay the expense of coffins provided. Purcell had no order, as he admits that he had none, but had to come to the Clerk next day for it, etc. As the Council fully understood the case, it was moved by Councillors O'Leary and Negus—

That the letter to the Clerk from J. A. McKinnon, Esq., be laid on the table.

Passed.



The Committee on appointment of County Auditors reported recommending Messrs. S. S. Scott and W. C. Bishop as suitable persons for the office. The report was adopted.

Some remarks were made as to the amount to be paid for their services.

Councillor Thompson said the amount was stated in the By-Laws not to exceed \$20 each per annum, which was accordingly decided to be their fee.



Afternoon Session.

JAN. 17th.

The Council met, the Warden and 29 Councillors present. After roll-call, the Council adjourned to 10.30 a.m. Wednesday, to allow the several Committees to meet and prepare their Reports.

SEVENTH DAY.

WEDNESDAY, JAN. 18TH, A. M.

The Council met at 10.30 a.m. All present.

Councillors Thomson and Fleming moved the following resolution—

Whereas, A resolution was passed in this Council in March last, as recorded on page 95 of the Reports, to the effect that the Warden and Clerk be authorized to confer with the authorities of Dartmouth regarding the debt due by said Corporation to this Municipality;

the debt due by said Corporation to this Municipality;

- Therefore resolved, That the late Warden and Clerk be called upon to report to this Council the result of their efforts in this respect.

The Clerk said he had notified the Mayor and Clerk of Dartmouth of the appointment named above, and read a letter to the Mayor and one to the Town Clerk of Dartmouth stating the amount as \$3,302.30 without interest, and requesting speedy settlement of the same.

Moved by Councillors Butler and Fleming-

That a Committee be appointed to confer with the Dartmouth authorities about the settlement of our claim, and that Councillors Negus, Lydiard, and Thompson be the Committee, with power to make settlement, and report at next session of this Council.

Passed.

Submitted, the Report of the Finance Committee, which was read clause by clause and passed. Also, the Estimates

for next assessment on joint account of City, County, and Dartmouth, and for County separately for 1899.

On motion, the report was received and adopted.

The Committee appointed to confer with the Dartmouth Board of Trade on the matter of a change in County representation, etc., reported as follows:—

Your Committee appointed to confer with the Dartmouth Board of Trade to discuss the advisability of having representation in the Dominion Parliament and Local Legislature, by a County representative independent

of the City of Halifax,

Wish to say that after most carefully considering the matter they would recommend to this Council their most favorable opinion on such representation, and would further recommend that this Council take such action as will bring this matter before the proper tribunal, and that a Committee from this Council be appointed to confer with a Committee from the Dartmouth Town Council, to prepare such memorial as said. Committee may in their opinion deem most essential to the said interests.

The subject of reduction of the license fees in the Liquor License Act was discussed freely, and it was moved by Councillor Walsh, seconded by Councillor Bartlett—

Resolved, That in the opinion of this Council, Section 6 of Chapter 2 of the Acts of 1895, should be amended, so far as the same relates to

the Municipality of Halifax County, as follows :-

That the words "one hundred and fifty dollars" in sub-section I of said section be struck out, and the following words added thereto: "Not less than seventy-five dollars nor more than one hundred and fifty dollars, as the County Council may determine."

That the words "one hundred dollars" in sub-section 2 of said section be struck out and the following words added thereto: "Not less than fifty dollars nor more than one hundred dollars, as the County

Council may determine."

Further resolved, That application be made at the next meeting of the Legislature of Nova Scotia for an Act to amend the said sections as herein provided.

The motion was put and lost.
Submitted the Report of the new Committee on Public

Property dealing with matters of the Poor Farm, which was read and passed clause by clause.

Moved by Councillors Fleming and Gladwin-

That the Report of Committee on Public Property be accepted as a whole.

Passed.

In regard to Telephone connection, it was stated that a Line to the Farm might be constructed for \$50 or \$60 a mile. Fire extinguishers would cost about \$15 or \$17.50 each.

Councillor Shatford commented on the condition and management of affairs at the Poor Farm as unsatisfactory, according to complaints from time to time, and moved, seconded by Councillor Thompson, as follows:—

Resolved, That the Committee on Public Property be authorized to negotiate a sale of the Poor Farm at Cole Harbour and report to this Council at its next meeting what progress they have made if any in effecting a sale.

Passed.

In reference to the Bridge asked for by people of Districts 29 and 33, and petition for a right of way in connection, it was moved by Councillors Negus and Sellars—

That the Bridge across the outlet at Cole Harbour Dyke be placed under the Bridge Act of 1883 and amendments thereto. Passed.

The Petition was referred to the Road and Bridge Committee.

The Committee on Investigation of the expenditure by the Commissioners of the Court House of \$7,000 upon repairs, etc., submitted their report, which was adopted.

Moved by Councillors C. E. Smith and Henley-

That the new Statute Labor Act be read clause by clause and fully discussed, so that some action be taken to rid this County of an Act that is most disastrous and not at all commendable to this County's interest, and is so bungled that no decided legal opinion can be given.


The motion led to a prolonged discussion by different Councillors, terminating in the presentation by Councillor Henley of certain amendments to the Road Act of 1898, viz.:

An Act to Amend Chap. 67 of the Acts of 1898, entitled an Act to Amend Chapter 47 Revised Statutes of Highway Labor, so far as it relates to the County of Halifax.

Be it enacted by the Governor, Council and Assembly as

follows:—

1. Section 8 of chapter 67 of the Acts of 1898 is hereby amended by striking out the words beginning with "Supervisor" on the second line of said section, and ending with the word "one" on the third line.



3. Section 12 of said Act is hereby amended by striking out the word "Supervisor" on the third line, and the word "Supervisors" on the seventh line of said section and substituting therefor the words "Municipal Councillors."

4. Section 13 of said Act is hereby amended by striking out the word "Supervisors" in the first line thereof and substituting therefor the words "Municipal Councillors."

5. Section 14 of said Act is hereby amended by striking out the word "Supervisors" on the first line of said section and substituting therefor the words "Municipal Councillors."

"Supervisor" in the first line thereof and substituting therefor the words "Municipal Councillor," and striking out the word "County" in the second line and substituting therefor the word "County," and striking out the word "Supervisor" in the seventh line of said section, and substituting therefor the words "Road Master," and also by striking out all the words in said section after and including the word " and" in the thirteenth line thereof.

7. Section 16 of said Act is hereby amended by striking out the word "Supervisor" in the first line thereof, and substituting the words "Road Master."

8. Section 17 of said Act is hereby repealed.

9. Section 20 is hereby amended by striking out the word "Supervisor" in the first line thereof, and substituting therefor the words "Municipal Councillor," and striking out the word "Council" in the eleventh line of said section, and substituting therefor the words "Municipal Councillor," and by striking out the words "and Supervisor" in the eleventh and twelfth lines of said section.

10. Section 23 of said Act is hereby amended by striking out the

words "and Supervisor" in the third line thereof.

"Supervisor" on the first line, and substituting therefor the words "Municipal Councillor," and by striking out the word "Supervisor" in the eighth and tenth lines of said section, and substituting therefor the words "Road Master."

12. Section 29 of the said Act is hereby amended by striking out the word "Supervisor" in the second and third lines, and substituting the

words "Road Master" therefor.

13. Section 29 of said Act is hereby repealed.

14. Section 30 of said Act is hereby amended by striking out the word "Supervisor" on the first and last lines thereof, and substituting the words "Municipal Councillor" therefor.

15. Section 32 of said Act is hereby repealed.

16. The duties which by the said Act are to be performed by the Supervisor of Roads for each District within the Municipality of Halifax County shall hereafter be performed by the Municipal Councillor of each District.

Moved by Councillor Henley, and seconded-

Whereas, in the opinion of this Council the Municipal Councillors should have control of all monies expended on the roads of their respec-

tive Districts, they being able to expend and control the same in a more judicious and economical manner than can be done by Supervisors;

Therefore resolved, That this Council request the members of the Local Legislature for the County of Halifax to introduce and have passed the accompanying proposed Act at the next session of the Legislature of Nova Scotia.

Further resolved, That the said proposed Act, or a copy thereof, be sent to the members for this County in said Legislature, with a copy of this resolution.

- Moved by Councillors O'Leary and Sellars-

Resolved, That the Provincial Legislature be asked to repeal Sections 2 and 3, Chapter 21, of amended Statutes of Nova Scotia, 1898, respecting Aldermen and Councillors' qualification relating to the signing of Liquor Licenses, etc.

Referred to the Law Amendment Committee. Moved by Councillors Negus and Butler in amendment—

That the matter of amendments to the new Road Act be deferred till next year, and thus afford a year's practical trial of the Act before asking the Legislature to make any changes or amendments.

The amendment was lost 16 to 10. The resolution carried 17 to 10.

The Council adjourned to 2.30 p. m.

Afternoon Session.

Jan. 18th, 1899.

The Council met at 2.30. The Warden and 29 Councillors present. The Morning Minutes were adopted.

The following report was received from the Chairman of the Joint Committee of this Council and Dartmouth Board of Trade—

At the meeting of the Joint Committee of the City Council and Dartmouth Board of Trade, held to-day to consider a change in the mode of representation of this County in the Federal and Provincial Parliaments, the following resolution was adopted unanimously:—

Resolved, That in the opinion of the Joint Committee it is desirable that a change in the mode of representation of the City and County of Halifax in both Local and Federal Parliaments be made, and that the change should give to the Municipality of the County of Halifax and Dartmouth representation independent of the City of Halifax.

Further resolved, That copies of this resolution be sent to the Municipal Council, and to the Dartmouth Board of Trade and the Council of the Town of Dartmouth.

Adopted.

Read, a long letter from Judge Johnston, expressing surprise at the refusal of the Council to give an increase of salary to the Crier of the County Court, W. G. Naylor, notwithstanding the request and recommendation of himself and all the barristers in the city. Also stating the services and constant attendance of the Crier and the satisfaction he gives. The salary is too small to support his family, and his court duties so arduous that he is precluded from any other employment. The judge asks the Council to reconsider their action, and place Naylor on the same financial footing as the other Criers.

It was decided that the Warden reply to the letter. Moved by Councillors Negus and Oswald Dauphiney—

That henceforth no application from any County official for increase of pay be considered by this Council, unless made by such official in writing, and the written resignation of such official, which may be accepted in case the application for increase is not favorably considered. Passed.

Moved by Councillors Shatford and O. Dauphinee-

Whereas, The sum of seven thousand dollars has been incurred in repairs to the County Court House at Halifax during the past year;

And whereas, It is necessary that legislation be obtained for the purpose of authorizing the borrowing of said sum in order to pay the said indebtedness so incurred;

Therefore resolved, That this Council request the Governor-in-Council of Nova Scotia to pass an Act authorizing the borrowing of said sum for the purpose of paying the said indebtedness in connection with said repairs.

Passed.

Read, the Report of A. Stewart Innes, custodian of draw bridge at Porter's Lake, who says the draw is in good order, but the approaches to the bridge have been washed away by heavy freshets, and should be attended to early next spring. Referred to Road and Bridge Committee.

The Treasurer reported that he had been repeatedly asked to pay the Special Jurors referred to in 1898, and that since this session the foreman had notified him that they would wait upon the judges in a body and obtain an order to compel the Municipality to pay the fees. Action deferred to next day.

The Council adjourned to Thursday, 19th January.

EIGHTH DAY.

THURSDAY, JAN. 19, 1899.

The Council met at 10.30 a.m., the Warden and 29 Councillors present.

The Minutes of last meeting were read and passed.

In regard to Special Jurors fees, it was moved by Councillors Butler and Lydiard—

That the claims against the County for Special Jurors be paid and thereby save the County the costs of litigation.

Passed.

Submitted the Report of Committee on Licenses. Moved by Councillors C. E. Smith and Negus—

That the Report of the Committee on Licenses be referred to the Law Amendment Committee, with recommendation of having amendments made to the Pedlers' Act.

Passed.

Submitted and read the Report of the Committee on Insane, which was read clause by clause. On clause 4—Moved by Councillors Bartlett and Madill—

That the Clerk enquire as to the correctness of the Bill from Cumberland County for Insane Patient.

On clause 5-Moved by Councillors Butler and Henley-

That the authorities at Mount Hope be instructed not to admit any Patient without the authority of the Committee named by the Council.

The Report then passed as a whole.

Moved by Councillors O'Leary and Stewart—







ANNUAL REPORT OF THE JAILOR OF THE COUNTY OF HALIFAX FOR THE YEAR 1898.

To the Warden and Councillors of the Municipality of Halifax Connty.

GENTLEMEN,-

I beg herewith to submit my Report of the Commitments for the County Jail during the year ending December 31st, 1898.

For the year beginning January 1st and ending this date, there were—Criminals, 266; Debtors, 69, showing an increase of 56 Criminals, and 1 Debtor, making a total increase of 57 more than the previous year.

At the present date, there are 20 Criminals and I Debtor in the Jail. The largest number of Prisoners in the Jail at one time during the year was 33.

There were also a number of Prisoners committed in 1897 who were not discharged until 1898.

The Jail has been kept full the greater part of the year, so many Prisoners having been sentenced for Petty Larceny and other crimes. I would again ask your honorable body to consider some way of employing those undergoing sentence in Jail.

Annexed are statements showing the various crimes for which Prisoners were committed during the year.

During the year there were 335 persons committed to Jail, for which there were from

The amount of monies received for Room Rent and Boarding Deserters from ships was \$24.90.

The Sanitary condition of the Jail has been generally good, and little sickness, excepting among those committed temporarily for drunkenness and insanity; these, with other cases of sickness of various forms, were always promptly looked after by the attending physician.

The conduct of the prisoners has been generally good.

REPORT OF THE JAIL PHYSICIAN.

I beg to submit my Report as Physician to the County Jail, for the year

1898, just ended.

There has been the usual number of cases of ordinary indisposition requiring treatment to a greater or less extent, but fortunately, few cases of serious sickness occurred during the year. The subjects of alcohol sm, though not so many as in some previous years, yet supplied the cases needing most attention. All did well under treatment, and no bad results followed in any

There were two persons of unsound mind committed to the Jail for safe keeping. One of these was sent to the Hospital for the Insane at Mount Hope, the other to the County Poor Farm, as best suiting their particular needs.

In the month of March, a prisoner, far advanced in pregnancy, was

removed, by consent, to the Lying-in-Wards of the Halifax Poor Asylum.

With all the convicted prisoners, committed to Dorchester Penitentiary, must go forward "Clean Bills of Health," certificates of their freedom from any contagious or infectious sickness. I have accordingly supplied such certificates as follows :--

April 5th, to Owen Russell and Norman Thompson.

May 24th, "William Wilson. July 11th, "Frederick Churchill.

Aug. 19th, " Edward Connors, Henry Birkenhead, Alex. Fraser, Thos. McCormick, and

During the year, the Sanitary condition of the Jail building and its surroundings has been good. The new plumbing fixtures of last year have proved their efficiency and utility, and the automatic closets then introduced work most satisfactorily.

The wards, cells and corridors have been kept clean and well limewashed; the food supplied has been of good quality and well cooked, and the resident officers have been considerate of and attentive to the needs of the prisoners.

To the Jailor, Mr. Malcom; the Matron, Mrs. Chambers; and Turnkey, Mr. Gaetz; my thanks are due for intelligent assistance in the care of the

There has been a decrease in the number of weeks' board from Districts, but

an increase from Dartmouth. The annexed sheets will give you the Income and Expenditure for the year, all of which we are happy to say, will show a nice balance to the credit of the County.

REPORT OF THE KEEPER OF THE POORS' FARM, 1898.

I beg leave to submit my report for the past year: There are 65 patients at the Poors' Farm, of which thirty are males, thirty-five females, three boys and three girls. There has been no sickness. The report of health has been good There were three deaths—one insane and two sane. There are five employees—two males, three females. The crops have been fair. The potatoes rotted, but we had a large increase of produce, which the following will show: 18 tons of hay, 2 tons of straw, 350 bushels of turnips, 150 bushels parsnips, two barrels of sour krout; corn, peas, beans, cucumbers, used green off the farm in abundance. Live stock—Five cows, three pigs, one pair oxen, one horse. Land improved—One acre: quantity of rock is large, but still some remain. Yoke of oxen, \$94.00, sold; 1 yoke bought, \$74.00. Shoes on hand, none; women's undergarments 26, shirts 16 pairs, pillow cases 29, sheets 13 pairs, 10 pairs pants, jumpers none, 6 straight jackets, 20 pairs blankets, 10 yards flannel, 8 yards apron goods, straw sacks, 6 women's underclothing, 20 pairs women's hose, 1 piece fleecy cotton, 12 pairs socks, 12 pairs mittens.

Further, your Committee feel that, in deference to Janitor Smith, they can not close their report without stating that after diligent enquiry, they exonerate the said janitor from the charge of interference with the workmen engaged on the said Court House, as has been a leged.

REPORT OF LAW AMENDMENT COMMITTEE, 1899.

Your Committee on Law Amendments beg leave to submit the following Report:—

That the communication from Wade & Paton, of Bridgewater, which was read before the Council, was considered by your Committee, and they would recommend to the Council that the Clerk acknowledge receipt of the same.

That certain amendments to the new Road Act having passed the Council, your Committee would recommend the proposed amendments be

sent to the Legislature for consideration.

We submit with this Report a draft of a Bye-Law in regard to Pedlars' Licenses, which your Committee would recommend to be substituted

for the Bye-Law now in force.

In the opinion of the Committee, the Bye-Laws are in a very unsatisfactory state, and they would earnestly recommend that a Committee be appointed to thoroughly revise the same and report at the April meeting of the Council; and that the Committee so appointed be empowered to employ Counsel to assist them in their work.

It is also recommended that Sec. 10 of Chapter 35 of the Revised Statutes of N. S. be amended by inserting the word "brother" after the

word "mother" on the first line of said section.

Also, that Sec. 1 of Chapter 21 of the Acts of 1898 be repealed at the next Session of the Legislature.

REPORT OF COMMITTEE ON ROADS AND BRIDGES.

That in reference to the Canterbury Draw Bridge, Districts 28 and 29, no information being obtainable by the Committee, we refer the same to the Councillors of said Districts.

That the Petition from District 22, re the granting of a Precept for

laying out a piece of new road, be granted.

That the Petition from District 24, asking that a Precept be granted for the laying out of new road be complied with, and that the parties named by the Councillor of said District be empowered to lay out said road.

That the Petition from District 17, asking for a Precept to lay out a piece of new road, be granted, and that the parties to lay out such road be appointed by the Councillor of the District.

That with reference to the Petition from Little River, we, the Committee, feel that it is not in our jurisdiction to deal with the matter, and refer the matter to the Councillors and Government.

That with reference to the Report of Joseph Lloy, Custodian of Rocky Run Draw Bridge, we, your Committee, consider it the duty of the Councillor of District 28 to attend to the matter, and make all necessary repairs.



That the Communication from R. K. Smith, Musquodoboit, with Bill attached, be not considered.

That the Report of Stuart Innes, Porter's Lake, re the approaches to

Bridge, be attended to by the Councillor of the District.

That the Communication of A. B. Gray, re the Removal of road material from District 15, we advise the said A. B. Gray to consult the Law, as in such cases provided.

Also, the Communication of J. A. Knight, re Claim for material taken for Road purposes. We would recommend the said J. A. Knight to refer to the Law in such matters, and to consult the Councillor, as we consider all such claims should be paid by the District out of their Provincial allotment.

That the Petition from Districts 26, 21 and 22, having been consided by this Committee, we cannot recommend the prayer of said Petition, unless the amount asked for be provided by the Government, independently of the County Road Grant.

That the Report of the Arbitrators, re the Laying out Road in District 33, be passed by this Council, and your Committee would recommend the expense, incurred to be paid by the Government.

That in reference to Memorial from District 15, re Encroachments on Roads, we would refer the parties interested to the Revised Statutes for the Preservation of Roads, etc., etc.

That in respect to the Petition from Districts 29 and 33, we would recommend the Precept being granted on the following conditions: That a free right-of-way (in writing) be given by owners of land, without any charge for fencing, and that as soon as the Government guarantee the building of the Bridge required across the outlet at Cole Harbour, the Roads will be laid out, and that Freeman Sellars and Thomas A. Nogle be appointed to lay out said Road.

With respect to Statute Labor Returns, your Committee beg to state, that we cannot complete our Report without saying that more attention and care should be taken by the majority of Councillors before Statute Labor Returns are brought before the Council.

That the Requisition from District 17, re the Opening up of Lake-View Roads, be deferred and reported on by the Committee at the next meeting of Council.

Also, that the \$300 asked for District 10 by Councillor Walsh be similarly dealt with.
