The monthly Session of the Council of the Municipality of the County of Halifax convened at 10:00 A.M., Tuesday, January 15th, 1974, with Warden Ira S. Settle presiding.

Following the Lord's Prayer, the Municipal Clerk called the roll.

It was moved by Councillor Nicholson; seconded by Councillor Anderson:

"THAT Mrs. Elizabeth Beaupre be appointed as Recording Secretary." Motion carried.

It was agreed by Council to hold the Public Hearings, as advertised. The first item, an application re undersized lot at East Ship Harbour, Daniel Monk property.

Following no report of correspondence being received, and no response from the gallery, it was moved by Councillor MacKenzie; seconded by Councillor Smith:

Municipality of the County of Halifax Temporary Borrowing Resolution \$350,000.00 - Elementary School Ashlee District

WHEREAS by Section 6 of Chapter 193 of the Revised Statues of Nova Scotia, 1967, the Municipal Affairs Act, it is enacted among other things in effect, that subject to the provisions of Section 8 of said Act every municipality of a county or district shall have full power and authority to borrow or raise by way of loan from time to time on the credit of the municipality such sum or sums as the Council thereof deems necessary for the purpose of erecting, acquiring, purchasing or improving lands for an Elementary School, in the Ashlee District.

AND WHEREAS by Section 8 of said the Municipal Affairs Act, it is enacted among other things, in effect, that no money shall be borrowed under the provisions of the said Act until such proposed borrowing has been approved by the Minister of Municipal Affairs: AND WHEREAS the Municipal Council of the Municipality of the County of Halifax deems it necessary to borrow a sum not exceeding Three Hundred and Fifty Thousand. Dollars (\$350,000.00) for the purpose of erecting, acquiring, purchasing, altering, adding to, improving, furnishing or equipping buildings for school purposes, and erecting or purchasing or improving lands for a Elementary School, in the Ashlee District.

AND WHEREAS by the Municipal Affairs Act such sum shall in the discretion of the Municipal Council be borrowed or raised in one sum at one time or in installments at different times and the sum required shall be borrowed or raised by the issue and sale of debentures of the Municipality to such an amount as the Council thereof deems necessary to raise such sum;

AND WHEREAS it is deemed expedient to postpone the issue of debentures and to borrow such sum for the purpose aforesaid from the Royal Bank of Canada at Halifax the sum so borrowed to be repaid to said Bank from the proceeds of the debentures when sold;

<u>EE IT THEREFORE RESOLVED</u> that under and by virtue of said the Municipal Affairs Act the Municipality of the County of Halifax do, subject to the approval of the Minister of Municipal Affairs, borrow or raise by way of loan on the credit of the Municipality a sum not exceeding Three Hundred and Fifty Thousand Dollars (\$350,000.00) for the purpose aforesaid;

THAT under and in accordance with said the Municipal Affairs Act such sum be borrowed or raised by the issue and sale of debentures of the Municipality to such an amount as the Council deems necessary to raise such sum;

THAT the issue of such debentures be postponed and the said Municipality do, under and by virtue of the provisions of Section 147 of the Municipal Act and subject to the approval of the Minister of Municipal Affairs, borrow by way of loan on the credit of the Municipality a sum or sums of money not exceeding Three Hundred and Fifty Thousand Dollars (\$350,000.00) from the Royal Bank of Canada at Halifax.

THAT such sum or sums be borrowed from said Bank for a period not exceeding twelve months from the date on which this resolution shall have been approved by the Minister of Municipal Affairs, with interest thereon to be paid said Bank at such rate as shall be agreed upon and that the amount so borrowed be repaid the said Bank from the proceeds of the debentures when sold.

It was moved by Councillor Slauenwhite; seconded by Councillor Anderson, that:

WHEREAS the Municipality of the County of Halifax owns certain real property situate in Lower Sackville and known as the Acadia School property on which is situate the Sackville Elementary School.

AND WHEREAS the Department of Highways is desirous of widening Trunk Highway No. 1 in fromt of the said property and requires for the purposes of such widening a five foot (5') strip of land along the front of the said property.

AND WHEREAS the Council of the Municipality of the County of Halifax has determined that it would be in the public interest that it convey the said five foot (5') strip of land to the Department of Highways for such purposes for the sum of One Dollar (\$1.00) provided that the Department of Highways at its own cost provide an exit and entrance to and from the said property in order to allow school buses to enter and exit from the said property in a safe and convenient manner.

WHEREAS the Municipality of the County of Halifax owns certain real property situate in Lower Sackville and known as the Acadia School property on which is situate the Sackville Elementary School.

AND WHEREAS the Department of Highways is desirous of widening Trunk Highway No. 1 in front of the said property and requires for the purposes of such widening a five foot (5') strip of land along the front of the said property.

<u>AND WHEREAS</u> the Council of the Municipality of the County of Halifax has determined that it would be in the public interest that it convey the said five foot (5') strip of land to the Department of Highways for such purposes for the sum of One Dollar (\$1.00) provided that the Department of Highways at its own cost provide an exit and entrance to and from the said property in order to allow school buses to enter and exit from the said property in a safe and convenient manner. BE IT RESOLVED that the Municipality of the County of Halifax convey the said lands to Her Majesty the Queen in the right of Her Province of Nova Scotia as represented by the Honourable the Minister of Highways provided Her Majesty enter into an agreement satisfactory to the Municipality to provide the said entrance and exit at no cost to the Municipality.

AND BE IT FURTHER RESOLVED that the Warden and the Clerk be and they are hereby authorized and instructed to execute all documents necessary to carry out the intent of this resolution.

MINUTES OF THE FEBRUARY COUNCIL SESSION

OF THE FIRST YEAR OF THE THIRTY-EIGHTH COUNCIL OF THE

MUNICIPALITY OF THE COUNTY OF HALIFAX

The monthly Session of the Council of the Municipality of the County of Halifax convened at the Municipal Administration Building at 10:00 a.m. Tuesday, February 19th, 1974, with Warden Ira S. Settle presiding.

Following the Lord's Prayer, the Municipal Clerk called the Roll.

It was moved by Councillor Slauenwhite, seconded by Councillor Moser:

"THAT Miss Doris Leonard be appointed Recording Secretary for this Council Session." Motion carried.

The Municipal Clerk, Mr. Bensted, announced that at the Public Hearing regarding the Clam Harbour Beach Development by Glen M. Hilchie which was held at the January Council Session, several submissions had been received and Council, by Resolution, were continuing the Public Hearing today. Since the last Session of Council some correspondence had been received and this correspondence was contained in the Agenda Book for the February Session. It was moved by Councillor Slauenwhite, seconded by Councillor Nicholson:

> "THAT letters re Application No. 73-1 Planned Unit by-law as contained in the Agneda be received." Motion carried.

An Item received this morning with regard to the Clam Harbour Beach Development, which the Municipal Clerk understood had been brought in by Councillor Smith, was read by Mr. Bensted.

Narden Settle asked if anyone in the gallery wished to speak in favour of the Clam Harbour Beach proposal.

Mr. Bensted said that he understood that there was to be representation here this morning from the Department of Lands and Forests.

As there was no response to the invitation of the from anyone in the gallery to speak, he asked if any of the Councillors would like to speak on the proposal.

Councillor Deveaux read a statement that had been issued by Premier Regan (along with a map of the Eastern Shore), and he was wondering if Mr. Hilchie had had any discussion with the Provincial Authorities with regard to this development. Mr. Harold Jackson stated that they had had discussions with various Departments - and the Department of Highways had given them their blessing. They had not contacted Premier Regan with regard to this layout. Councillor Deveaux thought that if Mr. Hilchie did not have sufficient funds to finish the project he should go to the Provincial Government.

Councillor Williams stated that we have no authority to state how much money a man should have - that is his own business.

It had been suggested to Mr. Hilchie that he should contact Councillor MacKenzie and Councillor Smith to get the concensus of opinion of the people in the area, and meetings had been held.

It was moved by Councillor Smith; seconded by Councillor Nicholson:

"THAT WHEREAS the Council or the Municipality of the County of Halifax has caused to be passed a Planned Unit Development By-law by the said County;'

AND WHEREAS application has been made by Glen M. Milchie under the said By-law for approval of a development scheme for lands situate at Clam Harbour Beach in the County of Halifax;

AND WHEREAS Council held a Public Hearing on the said development scheme, its approval, amendment or rejection at the Municipal Administration Building, Dutch Village Road, Halifax, on Tuesday, the 15th day of January, 1974, and adjourned the said Hearing to the 19th, day of February, 1974;

AND WHEREAS all representations for and against the said scheme were duly considered by Council;

AND BE IT FURTHER RESOLVED that the Warden and the Clerk be and they are hereby instructed and authorized to negotiate and enter into such Agreement.

AND BE IT FURTHER RESOLVED that the Warden and the Clerk be and they are hereby authorized to take all necessary steps under the relevant legislation and By-laws to implement the said development scheme and Agreement."

Motion carried.

Councillor Streatch stated that at the last Session of Council it was suggested that more people have a look at the proposal and give their opinions - pros and cons. We did request information. "I spoke in favour of the proposal which, in my opinion, is a good proposal. One of the things we feel is lacking is the fact we have very little in the area of facilities and the Provincial Government has indicated that they are prepared to develop Provincial Parks."

Councillor Smith stated that in the Agreement he would like to see notwithstanding any reference to the existing By-laws of the County of Halifax it is explicity understood that all or any of the above conditions shall apply to any further purchasers, authority or descriptions of this project.

Mr. Cox, Municipal Solicitor, stated that any Agreement is registered in the Registry and would effect the land, if sold, to anyone else.

Councillor Dunbar replied that as Councillor Nicholson had already stated - this plan has been before the Planning Advisory Committee and the Finance & Executive Committee for some length of time now. He felt that Mr. Hilchie had been unnecessarily held up in this project. As far as the ability to finance - that is irrelevant. The program is to continue in phases and each phase to be completed before the next phase is commenced. With all due respect to Provincial Parks, they certainly lack enough facilities for the travelling public. In Mr. Hilchie's project all this is covered so that adequate facilities are covered.

Replying to a question, Mr. Cox advised that if the Provincial Government acquire property they are not bound by the terms of our By-law.

Representatives of the Department of Lands and Forests arrived at the meeting at this point. Spokesman for the group was Mr. Harry Grant, Director of Parks and Recreation Division. Mr. Grant presented a submission on behalf of the Department of Lands and Forests.

The Warden thanked Mr. Grant for his statement and asked if there were any questions.

Councillor Gaetz asked if we were trying to stall this off. He stated that the Provincial Government had had plenty of time to inspect this.

Councillor Deveaux asked if it was felt that it would be more logical for Mr. Hilchie to confer further with the Government before Council gave its approval.

Councillor Nicholson stated that this comes under the Planned Development. He thought we had covered all phases. Mr. Hilchie should do one phase at a time. The Councillors and Solicitor must be convinced that phases are satisfactory before the next one would be passed.

Councillor MacKenzie commented on one point made by Mr. Grant re the Department of Lands and Forests not being contacted by Mr. Hilchie. The Councillor was under the impression that several Departments had been contacted. It also appeared to the Councillor that the Department of Lands and Forests are encouraging this sort of development and they do want to see property developed and this is good in itself and he hopes they will see that Clam Harbour Beach is developed in the proper manner.

Councillor Killmm stated that in no way was he against private enterprises. What he would like to ask Mr. Hilchie or to see take place, is that Mr. Hilchie and his associates take the statements and the findings of the Department of Lands and Forests. This Council agreed last month that we would wait until the Department made their views known and he felt he would be inclined to support it if it goes along with the guide lines as shown by Mr. Grant.

Mr. Cox stated that the Agreement called for the project to be done in phases and that each phase must be approved before the next one is started.

Deputy Warden Hudson asked whether Mr. Hilchie would be agreeable to relocating the parking area on the Beach.

Councillor Nicholson asked if we were going to tear his plan apart.

Mr. Hilchie advised that they had designated on the plan parking for one thousand cars at the Beach. As far as the Departments of the Provincial Government were concerned he stated that he was anxious to co-operate with them.

Councillor MacKenzie asked if approval was given to the proposal could Mr. Hilchie give any indication as to when he intended to start. Mr. Hilchie stated that there was a thirty-day waiting period - then they had to submit detailed plans for the first phase. He estimated it would be about three months - perhaps June or July.

This proposal was unanimously passed with all being in favour except Councillor Deveaux.

The next item on the Agenda was the Public Hearing with regard to the undersized Lot, being property of Kathleen Galbraith at Herring Cove. This had been referred back to the Planning Advisory Committee from the January Council Session. The Warden asked if there was anyone who wished to speak on this item. Brian Fleming spoke at some length with regard to this matter on behalf of the applicant.

Councillor Dunbar, Chairman of the Planning Advisory Committee, stated that even if this lot were approved it would have no bearing on where the title to these boundaries lies.

Councillor Anderson said he knew the property well, having been the Assessor for the area for twenty-three years. When the plan was submitted to the Planning Advisory Committee he recognized that it was part of the property and suggested that it go for Public Hearing. He said that as a member of the Planning Advisory Committee he was not in favour of the plan.

Speaking against the proposal was Mr. Carl Doubleday who spoke on a mix-up regarding the deeds. Mrs. Forhan also spoke against the plan.

Councillor Slauenwhite stated that we were not here to be judge and jury. Our only decision is to give or not give approval to the lot.

The Warden expressed the opinion that this seems to be a piece of land in contention. Councillors can only approve or not approve lots and cannot settle any civil matters.

Councillor Dunbar stated it had not been brought out why this application for lot approval had been requested. According to the drawing there is a dwelling on Lot B, and he wondered if this was for mortgage purposes or re-sale.

Councillor Gaetz stated that we can approve or not approve land - but cannot give legal views on property under dispute.

Mr. Cox stated that the question to be decided is whether this lot is to be approved or not. It is not necessary to determine other legal questions.

It was moved by Councillor Nicholson; seconded by Councillor Gaetz:

"THAT Lot B of Kathleen Galbraith at Herring Cove be and the same is hereby approved under the 1966 legislation." Motion defeated.
