## Dartmouth, N. 8.

Monday, Jenuary 14, 1907.

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councillors Tuttle, Wisdom, Stevens, Regarm Tobin and White, also Town Solicitor Foster.

Minutes of meetings of Dec. 10th, 18th and 28th were read and confirmed.

Notice of motion tabled by Councrs. White and Tuttle was taken up as follows; - "Resolved that this Council amend By-law 184 by striking out all the words after "and" and substituting the following therefor, "on every day except Saturday at ten o'clock p.m. and on Saturday at seven o'clock p.m. and shall not open until nine o'clock a.m."

After some discussion, Cr. Regan moved, seconded by Councr. Stevens; - "That the opinion of Town Solicitor Foster be obtained as to whether the proposed by-law would affect clubs and other organizations conducting pool or billiard tables, and which are open to use by the public."

This was adopted.

The Committee on Water and Sewerage reported that they had carefully considered the account received from Messrs. Stairs, Son & Morrow, contractors for the water pipe for the new main and the north end extension, and found that the balance due them as per statement herewith, was \$2973.96, and recommended that they be paid that amount in settlement of their account. The Committee had taken the account as to the number of pipes received by the Inspector's report, which number was confirmed by Supt. Bishop's account. As to the 16 inch pipe, the account of Stairs, Son & Morrow showed 864 pipe, while the ather reports only showed 860. Their account of the 10 inch, 6 inch and specials, agree.

The Committee also reported that they had considered the letter received from Mr. Jas. A. Calder, asking for a reduction of water rates charged on his grist mill, and recommended that the rate of \$50. be reduced from the 1st of May, next, to \$30. per annum, this rate to be subject to change when special rates to manufacturers are reconsidered. The committee were led to

to this decision owning to extra water rates, now collected from additional families on this pipe line. The committee also recommended that the water and sewer mains on Victoria Road, be extended to the northern boundary of Alfred Elliot's property, as requested by him. This report was also adopted.

The Auditors reported that they had examined the books and accounts of the Town Treasurer to December 31, 1908, and found the same in order and correct. Attached thereto were the usual financial statements. On motion the report was received.

The following letters were read; - From Alex. Hutt, resigning his position as Ferry Commissioner and pointing out that there were a number of leaks in the management of the Ferry Commission. Councr. White moved, seconded by Councr. Regan "That the resignation of Mr. Hutt be accepted, and that he be requested to inform the Chairman of the Ferry Commission, at once, where the leaks are that he speaks of in his letter of resignation." Councrs. Tuttle and Wisdom moved in amendment "That the resignation of Commr. Hutt be accepted." The amendment was put and negatived, two to four, Tuttle and Wisdom for, Stevens, Regan, White and Tobin against. The motion was then put and carried on the same vote reversed.

From N. Keddy, claiming \$10. damages for injury done to his fence by earth excavated from the trenches on P. A. Road. Referred to Water Committee with other complaints of a similar character previously made.

From Dr. Reid, Prov. Health Officer, calling attention to the law respecting public health. Ordered to be filed.

From N. S. Building Society, claiming that they were entitled to the surplus proceeds from the sale of the Maurice Dunn property, Thistle Street. Referred to Town Solicitor to report upon.

From Henry Romans, agent for G. E. Francklyn, stating that that main water pipe line ran through certain lots belonging to the Cottage Hill Property, of which Mr. Francklyn was the owner. Referred to Town Solicitor to report.

From F. W. W. Doane, Hon. Secy. of the Union of Nova Scotia Municipalities, asking the Town Council to become a member of that organization. Referred to the delegates appointed to the convention held last August as a committee, to deal with.

From the Assessors, asking for extra remuneration for the work of assessing the outside school district. Referred to Finance Committee with power to deal with the case.

Report was read from A. G. Gates and Thos. Leahy, appraisers appointed to value the damage done to Mrs. Drysdale's house on Fairbanks Street, by blasting done at water trenches last summer. On motion of Councr. Regan, seconded by Councr. Tobin "Resolved that the report of the appraisers be referred to the Town Solicitor, and that he consult with the Water Committee in reference to the matter."

Supt. Bishop submitted a report with designs for iron fence proposed to be put up at the Lower Canal Bridge. The Committee on Streets and Public Property recommended that the plan, No. 2., as presented by the Supt. be adopted, and that the Committee be authorized to ask for tenders for the iron pipe, eto, required. Adopted.

Letter was read from Secy. Weldon, of the Halifax Board of Trade enclosing a bill for \$25. as the Town's share for the expenses in connection with printing and distributing throughout Canada a pMamphlet re. Bonusing Steel Shipbuilding in Canada. Referred to Finance Committee.

The Mayor called attention again to the advisability of establishing a Veteran Firemen's Association, to be composed of honorary members of the Engine Co who were willing to organize as an auxillary body for fire protection, also to the apparent need in the Engine House of a place to store a reel kept specially decorated for funerals, owing to increased accommodation recently given to the Axe & Ladder Co. there was now no place to keep this reel.

Considerable discussion took place in reference to the enforcement of the Pedlar's By-Law and the recent revision of the Town By-laws.

A number of accounts were passed for payment and the Council adjourned.

Friday, January 24th, 1907.

Special meeting of the Town Council was held this day at 9 a.m. Present Mayor Williams, Councillors Tuttle, Wisdom, Regan, Stevens, Tobin and White, also Town Solicitor Foster.

Letter was read from Standard Drain Pipe Co. of New Glasgow, offering to allow a deduction from their account of \$125. in full settlement of the Town's claim against them for inferior quality of pipe. On motion of Councr. Stevens, seconded by Councr. Tobin, "Resolved that the offer of the Standard Drain Pipe Co. to settle their account for \$125. be accepted."

Letter was read from Jas. R. Douglass stating that he had been requested to offer as councillor for the ensuing election for Ward Three, and that there was an account of Douglass & Co. due him, more than enough to cover his taxes, which he understood should be paid ten days before nomination day, to qualify him. He wished to know, under these circumstances, whether he was eligible for the office. The point being referred to the Town Schicitor he stated that Mr. Douglass had asked him, last evening, the same question, and he had informed him that he was disqualified.

The Committee on Police and Licenses reported as follows;-

Your Com., to whom was referred the complaint of ex-policeman Trider against the Chief of Police, of an alleged unwarranted interference with him on theplatform in front of the Reading Room on the 27th of October, last, have investigated the matter and report as follows;— We obtained an opinion from His Honor the Recorder as to the duties of the police in regard to the place mentioned in the complaint, which opinion is attached to this report. From this it will be seen that it is the duty of the police to see that this platform is not obstructed. The evidence shows that there was a disturbance on the sidewalk at the time and that Mr. Trider was standing with others on the sidewalk and lower step of the Reading Room platform. We consider that

the Chief was justified in ordering all parties standing on the sidewalk and platform to move off. Regarding the return of the Chief to speak to Mr. Trider, and what then transpired we have no evidence other than that given by Mr. Trider and the Chief, which is somewhat conflicting. The Chief claiming that he was cautioning him regarding his general habit about the Reading Room platform on previous occasions, while Mr. Trider claims that he was abused and ordered off the platform when he was alone. With the evidence at hand there is nothing upon which the committee could ground a charge of misconduct against the Chief. The evidence was also read, and after some

discussion, on motion of Councrs. Tuttle and Regan the report was adopted, Councr, Tobin dissenting.

The Auditors reported that they had audited all the books vouchers and accounts of the Town Clerk and Treasurer, including the books, vouchers and accounts of the Board of School Commissioners of Dartmouth, for the year emiling December 31/06. They found all in order and correct, The securities belonging to the Town were placed before them for their inspection. which they found agreed with the details as set forth in Account #4. Accompanying the report were certified statements showing the different services of the Town , also a list of the current liabilities of the Town and a statement of the Consolidated and Bonded Debts as shown by the Ledger Accounts and sundry documents placed in their Mands for inspection, also a list of the vouchers for payments made during the year 1908. of Councrs. Regan and Wisdom, "Resolved that the accounts of the Town Clerk and Treasurer, having been audited and found correct by the Town Auditors, the same are hereby passed and allowed, and that five hundred copies of the Mayor's Report, with the Auditors! Report and Statements, be printed and distributed to the ratepayers. "

On motion of Councrs. Regan and Stevens, "Resolved, that the time for the Court of Appeal, which meets on the 26th day of February, next, be 7.30 p.m. and the place, the Town Hall."

On motion of Councrs. Regan and White, "Resolved, that the places for the polling booths for the Municipal Election to be

held on February 5th, next, be as follows;-Ward 1. At or near W.J. Naus' shop, Prince Street.

Ward 2. At the Town Hall.

Ward 3. At the Engine House.

On motion of Councr. Tobin, seconded by Councr. Regan, "Resolved, that Mr. W. G. Foster be appointed arbitrator for the Town to act in the Misener case."

Town Solo. Foster's opinion re. Maurice Dunn was read as follows; - "Sec. 38 of the Town Act provides as an alternative that surplus proceeds may be retained in the Treasury of the Town until applied for by the parties entitled thereto and may be paid out on resolution of the Council on application therefor. I advise that the Council should pass such a resolution Mand pay over the money to the Nova Scotia Building Society."

This was received, and after some discussion, Councr. Tuttle moved, seconded by Councr. Stevens, "That the amount of surplus proceeds of sale of Maurice Dunn property be handed over to the Nova Scotia Building Society, amount \$157.64." This was put and lost, the mover and seconder voting for and the other councillors against. The dissenters thought it would be establishing a bad precedent to pay over the surplus proceeds until the expiration of one year from the date of the sale.

Town Rolr. Foster's opinion re. Pool Rooms was read as follows; - "I am of opinion that any club and other organization conducting pool or billiard tables which is open to use by the public, that is, where the public have the right to use the tables on payment of a fee therefor, will come under the proposed by-law. " Councr. White's motion, notice of which was given at meeting of Dec. 10th, last, was then taken up and the matter discussed at some length, Councr. Tobian then moved, seconded by Counor. Regan, "That the matter of pool rooms be referred to the Police Committee to report on. " This was put and lost, the mover and seconder voting for and the other councillors against. Counors. Regan and Tobin then moved the following, "Resolved, that the question regarding pool rooms be postponed and that Councr. White's resolution pe lie on the table. " This was carried, Crs. Regan, Tobin and Stevens voting for, Tuttle, Wisdom and White against, and the Mayor gave his casting vote in favor of the motion.

The Committee appointed to ascertain the probable cost of acquiring the properties on Quarrell Street lying east of the

Central School, reported that they had ascertained that the owners of the property, the assessed value thereof, and the amount that would be accepted therefor as follows;

This report was received and after some discussion, on motion of Councr. Tuttle, seconded by Councr. Tobin, "Resolved, that the report of the committee re. properties adjoining Central School be referred back to them requesting them to get options on said properties for three months."

The Council then adjourned.

Wednesday, January 30, 1907.

Special meeting of the Town Council was held this day at 9 a.m. Present Mayor Williams, Councillors Tuttle, Wisdom, Stevens, Regan, Tobin and White.

Letter was read from Starr Manufacturing Co., stating that it was proposed to amalgamate the businesses of the Rolling Mills and the Starr Manufacturing Co., the object being to greatly enlarge the operations of both companies and to engage in branches of manufacture other than those in which they were now. They asked that the taxes on additions made to their plant for new properties purchased for extensions, be not increased over that new projection works. After discussion, on motion of Councr. Tuttle, seconded by Councr. Wisdom, the following resolution was unanimously adopted.

Commr. Regan called attention the fact that the names of R.L. Wambolt, A.C. Young and others assessed on real estate, were omitted from the Revisors' List of Municipal Electors, and they were entitled to a vote at the ensuing municipal election. After some discussion, on motion of Councr. White, seconded by Councr. Tobin, "Resolved, that all names of qualified persons that have been omitted from the Voters' List for Ward 11, shall, on application by them, be placed there by the clerk, so that they can vote on Tuesday the 5th day of February, 1907."

On motion of Councr. Stevens, seconded by Councr. Wisdom, "Resolved, that Dr. Simpson be appointed Presiding Officer in Ward 11 for the election of councillor, and Spencer Sutherland as Poll Clerk."

The Finance Committee reported as follows; Your committee have considered the application of William James concerning sewer rates on his property, Brenton Street, and would recommend that in respect to the property referred to, that he be not held liable for any frontage which is more than sixty feet distant from the public sewer. Your committee would further recommend that Supt. Bishop be requested to measure off the property and ascertain the number of feet of frontage liable within the recommendation of this report. Adopted.

Letter was read from Henry O'Toole, stating that he had

notified the Town Clerk to turn the water off at two of his houses on Boggs Street, which had not been attended to at the time. Referred to Water Committee to report upon.

Monday, February 4, 1907.

Special meeting of the Town Council was held this day at 8 p.m. Present Mayor Williams, Councillors Tuttle, Wisdom, Regan, Stevens, Tobin and White.

The Mayor stated that the meeting was called to receive the opinion of the Town Solicitor with regard to the Revisors' List of Municipal Voters.

The opinion was read as follows; "The Towns' Incorporation Act, R.S. Cap. 71, Sees 128 and 129 provide for the appointment of Revisors and declares their duty: 'They shall at the time and in the manner provided by the Nova Scotia Franchise Act (R.S.1900 Cap. 4) prepare and revise the list of voters qualified to vote at town elections. This list when so revised and completed shall be signed by the Revisors and countersigned by the Mayor, and filed with the Town Clerk, on or before the 15th day of March in each year, and shall thereafter, until a new revision is made, be the list of voters qualified to vote at an election of Mayor and Councillors for the Town. Under sec. 130 of the Town Act (Towns' Inc. Act) the Town Clerk shall prepare copies of this list for each presiding officer, etc, and sub-sec. 2 provides, 'Every voter whose name has been inadvertently omitted by the Town Clerkmay have his name inserted on the list of voters on making application to the Town Clerk at any time before the close of the poll, and the clerk on application therefor at any time shall give to any person whose name has been inadvertently omitted from the list for any ward a certificate that such person is entitled to be placed on the list of voters for the Town, ward or polling division, and such certificate shall entitle the voter named therein to vote at such election.' My reading of this section is that the Town Clerk can not alter or amend the Revisors' List. The language of the section is "inadvertently omitted by the Revisors" All the Clerk is authorized to do is to rectify any mistakes which he himself has made in transcribing the list. If otherwise you make the Town Clerk a Court of Appeal, which in my opinion the law does not contemplate."

Considerable discussion ensued in reference to the list and the failure of the Revisors' to insert a number of names of grate-payers entitled to vote on the list for Ward Two.

Letter was read from the County Clerk enclosing agreement with the Fown re. the pipe line on the Old Preston Road. This was received and the agreement was referred to the Town Solr. for approval.

Copies, in duplicate, of leases from the I. C. R. to the Town of the right to lay down a main sewer pipe across the railway track on King Street, were read and the Mayor and Town Clerk were authorized to execute the same on behalf of the Town.

A number of accounts were passed for payment and the Council adjourned.

A special meeting of the Town Council was held this day at 7.30 p.m. Present Mayor Williams, Councillors Tuttle, Ritchie, Regan, Stevens, Tobin and White, also Town Solr. Foster.

The estimates were submitted from the several standing committees for the current year, also a notice from the School Board asking that the sum of \$11314. be assessed and collected and paid over to that Board as provided by law, also a further request from the Board that Town Bonds be issued to the extent of \$2500. the

proceeds to be expended for the installation of lavatories with buildings required and plumbing connected therewith to be fitted

up in Greenvale, Central and Park Schools. All the estimates were referred to the Finance Committee to report upon, and the application for the issue of bonds was referred to the Committee on Legislation.

Draft of agreement submitted by the Town Solr. between the Town and Mr. S. A. Hiseler, in connection with the land recently dedicated by him through his property for the extension of Hawthorne Street, was read and approved, and the Mayor and Town Clerk were authorized to execute the same on behalf of the Town.

A petition was read from a number of ratepayers residing on Prince and Cunard Streets asking for an electric light for that locality. Referred to Committee on Public Property.

The award made by the arbitrators re. claim of Mrs. Annie Misener against the Town for property taken for sewerage purposes on Portland Street was read as follows; - together with bill for fees therefor amounting to \$45.; -

"Whereas we have examined the property taken by the Town of Dartmouth for sewerage purposes, and have also gone fully into all all the facts and circumstances and documents relating to the expropriation of said Annie Misener's property by said Town, and have given due notice to the parties concerned to produce such evidence before us, as they may deem admissable. It is hereby agreed by and between us that the Town of Dartmouth having already paid to one Myers, a tenant, of said Annie Misener, the sum of Twenty-five Dollars for any actual or prospective damage done by reason of or in connection with said expropriation, that said Town shall be allowed said sum by us. It is further agreed that the said Annie Misener having already paid sewerage rates due on the sewer now passing in front of her property from which she has derived no benefit, shall hemceforth for all time be exempt from sewerage rates on sewer in rear of her said property. The award of the arbitrators is as follows;-

of the arbitrators is as follows; 
1. The Town of Dertmouth shall pay the said Annie Misener the sum of One Hundred and Seventy-five Dollars (\$175.) as the value of the land so taken for sewerage purposes.

2. The said Annie Misener shall be exempt for all time from all sewerage rates on sewer passing in rear of her properties on said Portland Street.

3. The Town of Dartmouth shall, as soon as the weather permits connect the said two houses of said Annie Misener with the sewer in rear of said houses, free of cost to said Annie Misener.

4. The said Annie Misener shall at all reasonable times, without further compensation, allow the said Town to enter upon her said properties for all necessary sewerage purposes.

5. In accordance with section 58 of Chapter 56, Acts 1902, we hereby certify that the said Town of Dartmouth claims that it is doubtful that Annie Misener is the sole person entitled to compensation.

This was received and on motion of Councrs. Tuttle and Regan referred back to the arbitrators to include the cash value of connecting

her two houses with the sewer, referred to in clause 3.

The Mayor called attention to legislation required, especially the amendments deemed necessary to the Pedlars' By-Law, which he thought should be asked for similar to the Halifax By-Law on that subject. He also recommended that the following amendment to the Towns Consolidated Act be applied for;— "Every person, firm or corporation, who within the Town or School Section of Dartmouth employs in his trade, manufacture, enterprize, business or calling one ord more persons between the ages of eighteen and sixty years

or corporation, who within the Town or School Section of Dartmouth employs in his trade, manufacture, enterprize, business or calling one ord more persons between the ages of eighteen and sixty years resident in the Town, and between the ages of twenty-one and sixty years resident within the School Section of Dartmouth, shall each year, within ten days after demand therefor, furnish to the assessors or to the town clerk, in writing, the name and address of each such employee. Every person, firm or corporation, who fails to furnish the names and addresses of their employees as required by section 1 of this act, shall be liable to a penalty not exceeding twenty dollars for each such offence."

On motion of Councrs. Regan and White, "Resolved that a committee be appointed to draft a bill to include the above. The Mayor was asked to appoint the committee and he appointed Counrs. Regan, Stevens and Tuttle as such committee.

On motion of Councrs. Stevens and Tobin, "Resolved, that the Public Property Committee be authorized to proceed with the erection of the stone crusher on the town property on P. A. Road (known as the Walker Property.)"

A number of bills were passed for payment and the Council adjourned and met immediately after as the Board of Health.

The following report was read from Dr. Milsom, Town Health officer; - "I beg to state that there are no reported cases of diphtheria at present. The house on Water Street has been reported three times, notwithstanding the effective fumigation so far as is possible, which has been done. I want to bring before the Board that it is an impossibility to fumigate a house with the people in it, also that a large number have not a second supply of articles that can be fumigated and used at the same time, then there are a number of families who carry infected things all over the house and would not destroy anything that was saturated with diphtheria, for this class of people some place is always required so soon as the present family are in a condition to be moved and the notice removed, I would suggest as clean a sweep internally be made of the house as possible."

On motion of Councrs. Tuttle and Ritchie, "Resolved, that in reply to Health Officer Milsom's report regarding fumigation of diphtheria infected house on Water Street, that this Board direct the clerk to instruct the Health Officer to take immediate steps to have the house referred to thoroughly fumigated and clothing therein disinfected.

Town Council met this day at 7.30 p.m. Present Mayor Williams Councillors Tuttle, Ritchie, Regan, Stevens, Tobin and White, also Town Solicitor Foster.

Minutes of meetings of February 11th, 15th, 27th, 28th and March 4th were read and confirmed.

The Water Committee reported as follows;—
1. Your committee have considered the letter received from Mr.
Henry O'Toole, dated Jan. 10/07, referred to them, complaining
that the water had not been turned off his premises on Boggs St.
in response to a notice sent by him to the town, and find that
Supt. Bishop was notified, in writing by the Town Clerk, on the
28th of Nov, 1906, to turn off the water and he reports thereon
asfollows;— "Turn Off Notice No. 286 was turned off on receipt of
same. One of the services was leaking badly when turned off. If
any damage has been done to the property by water from the service
pipe it must have happened before the notice to turn off was
issued. I have visited the property in question to-day (Jan. 18/07)
and find no water running, which indicates that the water was
properly turned off. Had the water not been wholly turned off it
would still be running as it would not freeze while discharging
under pressure. No notice has been received from Mr. O'Toole
to have the water turned on again.
2. Your committee recommend that tenders be asked for 400 ft. of
8 inch C.I. Water Pipe for the extension of the water mains from
P.A. Road southerly along Hawthorne Street extension, through the
Hiseler property, and also for 100 ft. of 10 inch C.I. Water Pipe
to furnish water to the motor proposed to be established on the
Walker Property to run the town stone breaker with.

On motion of Councrs. White and Regan the first clause of the report was referred back to the committee for further information. The second clause was adopted.

The Finance Committee reported as follows;—

1. In reference to application from Mr. Wm. James for a reduction on seweraged, referred to them, they gave instructions to Supt. Bishop to re-measure all his property and ascertain the number of feet of frontage he is liable for. Supt. Bishop reports as follows; "I have measured the frontage as directed and find the former measurements correct, that is, 73 ft. is the total width of Mr. James' lot. His property only extends 53 ft. past the end of the sewer, and the sewer overlaps his property 20 ft. "(see sketch) In accordance with this report your committee find that Mr. James' is not entitled to any deduction and recommend that he be so notified in reply to his letter.

2. Your committee recommend, that there being now over \$1000. cash on hand in the Union Bank to the credit of the Sinking Fund (W.& S) Debentures) that a \$1000. 4% Town of Hantsport bond, maturing 1930 offered at the rate of 96% of par, yielding about 4.30% be purchased Adopted.

Letter was read from John Debay asking for a release of common lots held by him. On motion the Town Solr. was instructed to prepare the usual deed on payment of the commutation money due for said lots.

On motion of Councr. White, seconded by Councr. Ritchie, "Resolved, that Harris Congdon be appointed presiding Officer at the election to be held on Saturday next, March 16th, and Vincent Regan, Poll Clerk." Councr. Regan dissented.

On motion of Councr. Regan, seconded by Councr. Stevens, "Resolved, that a bill containing the following provision be submitted to the legislature; - "Section 72 of Chapter 52 of the Revised Statutes 1900, as amended by Chapter 6, section 7 of the Acts of 1903, is hereby amended as follows; - Before the words 'incorporated towns' wherever the same occur in sub-sections 1,3 and 4, shall be inserted the words 'cities and' and before the words 'incorporated towns' in any of said sub-sections shall be inserted the words 'city and.'"

Councr. Regan moved, seconded by Councr. Tobin, the following;- "Resolved that a bill containing the following provision
be introduced at the present session of the Legislature;- Notwithstanding any statute in force in Nova Scotia, all officials
of the Town of Dartmouth shall hold office during the pleasure of
the Town Council and may be dismissed at pleasure by that body.
This provision shall apply to the present as well as all future
incumbents, and without restricting the generality of the foregoing, the word 'official' shall be held to apply to the Town
Clerk, Town Solicitor, Supt. of Streets and Supt. of Water Works."

Councrs. Tuttle and Ritchie moved in amendment that the resolution lie on the table until the next meeting. This was carried, four to two.

On motion of Councr. Regan, seconded by Councr. Tobin, "Resolved, that a bill be introduced before the Legislature to empower the Town golicitor to inquire into, upon oath, and compel witnesses to attend before him, touching any matter in reference to the origin of incendiary fires, the conduct of officials

and other matters in connection with town affairs in which an examination is requested by a majority of all the members of the Council. Passed, Councr. Tuttle dissenting.

A number of accounts were passed for payment and the Council adjourned and met immediately afterwards as the Board of Health, when the following report from Health Officer Milsom was read, dated March 11, 1907;-

"In regard to the house on Water Street occupied by the Gloucester family, I am of opinion that the late cases of diphtheria are the result of a drain leading from the kitchen sink, and through the yard, and into the harbor. It was blocked up when the present family moved in and now flows over the cellar and yard, there is no vent of any description near the sink, so everything is diffused kitchen and cellar. I telephoned to Mr. J. Warner to attend to it but have heard nothing from him. There have been no further cases and the father has been trying to get another house but he finds it very difficult to obtain one. 

So soon as the drain is repaired measures will be taken to render the house habitable."

This report was received, and the Board adjourned.

The amendment was put and lost, the mover and seconder voting for, Councrs. White, Stevens and Ritchie against. The resolution was then put and passed on the same vote reversed. Councr. Regan gave notice of reconsideration.

On motion of Councrs. White and Stevens, "Resolved, That the Assessment Roll as finally passed by the Court of Appeal and completed and now laid before this meeting, be and the same is hereby confirmed, and that the Council authorize the levying and collection of rates for the current year of ONE DOLLAR AND FIFTY-SIX CENTS per \$100. on the assessed value, as per the Assessment Roll which Assessment Roll and Rate are hereby confirmed. Further resolved, that the rate to be levied and collected for the current year on property in the City of Halifax and Outside School Sections be SIXTY-RIGHT CENTS per \$100. Further resolved, that the Poll

Tax of \$2.00 as provided by law, be ordered to be levied and collected. This was carried three to two, the mover and with Councr. Ritchie seconder voting for, Councrs. Tuttle and Regan against.

On motion of Councrs. White and Stevens, "Resolved, that the 18th day of May, 1907, be fixed as the date for the payment of taxes and the usual discount of two and one-half per cent be allowed up to that date."

Letter was read from E. H. McElmon asking the town to grant him the followsing;-

- 1. Twenty-five years lease foot of Mott Street, south of rail-road, for the sum of One Dollar per year.
- 2. Right to use the side or bank on Water Street opposite Scarfe's Mill property, in no way to block said street, time say about two months.
- 3. Right to put up temporary office, upper corner Water and Mott Streets, subject to removal at ten days notice.
- 4. No increase in taxes on said property for term of ten years.
  This was received and ordered to lie on the table.

Letter was read from F. F. Mathers, Deputy Prov. Secy. stating that he was directed to inform the Council, that the Attorney General had reported that the by-law passed by the Council on the 27th ult. seemed to be insufficient in form, it having been passed in the form of a resolution instead of a by-law, and that the boundaries mentioned in the petition enclosed with the by-law should be incorporated in the by-law and made part of it. The Prov. Secy. was in receipt of a communication from the Co. of Halifax requesting them not to take action regarding the matter of extending the boundaries of the Town until the municipal authorities had an opportunity of being heard, iand no action would be taken in the matter until the municipal authorities had presented their views.

On motion of Councr. Tuttle, seconded by Councr. the following by-law was adopted;-

"Whereas a petition has been presented to this Council asking that a certain area lying to the south of the Town of Dartmouth, as hereinafter particularly described, be added and incorporated in

the said Town. And whereas, said petition is signed by at least two-thirds of the owners of real estate in the district so proposed to be added. Therefore resolved, in accordance with the provisions of Section 47 of the Towns' Incorporation Act, Chap. 71, Revised Statutes of Nova Scotia, 1900, that the following by-law be and the same is hereby adopted; - "The boundaries of the Town of Dartmouth are extended so as to take in and include all that tract and parcel of land immediately adjoining the Town of Dartmouth on the south, bounded and described as follows, Commencing at a point on the Gaston Road where the southern boundary of the Town of Dartmouth meets said road, thence southerly parallel to the Eastern Passage Road to a point on a line drawn at right angles; to the Asylum Road at the point where Herbert's Brook crosses the said Asylum Road, thence by said line westerly to the Eastern Passage Road, thence following Herbert's Brook to a point 300 feet into Halifax Harbor, thence northerly parallel to the shore of Halifax Harbor till it strikes the southern boundary of the Town of Dartmouth, thence by the southern boundary of the Town of Dartmouth to the place of beginning. " Adjourned

Town Council met this day at 7.30 p.m. Present Mayor Williams Councillors Tuttle, Ritchie, Regan, Stevens, Tobin and White, also Town Solicitor Foster.

Minutes of meetings of March 18th, 19th, 27th, April 2nd and 4th, were read and confirmed, subject to the minutes of April 2nd being amended by recording that Councr. Regan gave notice of reconsideration respecting the resolution fixing the tax rate.

A petition was read from a number of ratopayers asking for the extension of Eaton Avenue to Erskine Street. Referred to Street Committee to report upon.

The Town Solr. reported re. Henry Romans! letter, referred to

him in regard to the old main water pipe running through the old Green Road, so called, which he claimed was the Francklyn property as follows;- "Sec. 57 of the Cons. Town Act, Chap.56,1902, provides as follows; - "For the purpose of constructing a suitable system of sewerage the town council shall have power in the name and on behalf of the town, through such officer as they shall designate, and by their servants and agents to enter upon any lands, public or private, within the town of Dartmouth, and to open and excavate the same and lay sewerage pipes thereunder, and to occupy such lands and use the same so long and in such manner as may be necessary for such purpose, or for the purpose of repairing such sewers, doing no unnecessary damage to such lands, and restoring the same as nearly as may be to the condition in which the same were before being so entered upon, occupied and used! Section 58 provides that any person claiming damages shall proceed by giving notice to the town clerk, when arbitrators shall be appointed as therein provided, whose award "shall be and be taken to be in full satisfaction for all injury, present or prospective, in consequence of such operations, and no action, suit, or other proceeding either at law or in equity, shall lie, or be brought against the said town or any officer, agent, or servant thereof, or any person acting under the authority of the said town council, for any act or thing done under the authority of this act." Section 60 provides that "No claim shall be entertained for any such damages or compensation as provided in section 58 unless the same is made within three years from the same accruing; provided that in the case of any claimant being an infant, or being at the time of the claim accruing absent from the Province, such claim may be made at any time within one year after such claimant shall become of age, or return to the Province, as the case may be." In view of the law as stated, I am of opinion that the above claimant has no case against the Town."

The Public Property Committee reported that the watering cart was in need of repairs and asked for authority to obtain and award tenders in accordance with a specification prepared by Supt. Bishop which they submitted. Adopted/

Re. Mrs. Miseners! award, the arbitrators reported that they had reconsidered the third clause in their award and recommended that the following be substituted therefor;—"In addition to the sum of \$175. already awarded as value of land taken for sewerage purposes, we hereby further award the sum of \$50. to be used for the purpose of connecting the said two houses of Annie Misener with the sewer in rear of her said properties, said sewerage connection is to be completed by June 15, 1907." On motion of Councr. Tuttle, seconded by Councr. Stevens, Resolved, "That the award of the arbitrators re. Mrs. Annie Miseners! property be accepted, and that the amount of the award, \$225. be paid into the court, for the estate of the late G. A. Misener." Cr. Regan dissented.

E. H. McElmon's letter, read at meeting of April 2nd, was taken up and read again. On motion his request as per clause 1 was not granted. Councr. Tuttle dissented from this motion. Clause 2 was granted on condition that the obstruction he places on the street be kept lighted. Clause 3 was granted subject to location and terms approved by the Street Committee. Clause 4 he will be allowed the exemption the law provides. Councr. Stevens objected to clauses two and three.

Letter was read from Jas. R. Douglass calling attention to the fact that the town was badly in need of a plumbing inspector. Referred to Water Committee to report upon.

Letter was read from Jas. W. Stairs executor estate late W.J. Stairs, stating that the property assessed to them in Ward Three had been sold to the Consumers Cordage Co. Ordered to be acknowledged and the Consumers Cordage Co. notified.

Letter was read from Mrs. Lettie Elliot, Fairbanks Street, complaining of the injury done to the fence in front of her house when the trenching for the water works was being done. Referred to Water Committee to report upon.

Letter was read from A. E. King, Halifax, asking if the town wished to sell the piece of property corner of Water and Boggs Sts. Referred to Water Committee.

Letter was read from J. L. Colter calling attention to a petition sent in by a number of ratepayers last July asking for the extension of the water system along Thistle Street. He urged that the petition be favorably considered at an early date. Referred to Water Committee to report upon.

On motion of Councr. Tobin, seconded by Councr. Stevens, "Resolved, that a bill be prepared by the Town Solicitor to hand to the Legislature now in session, authorizing the Town to lease half of Lyle Street dock to the North Star Rowing Club for a term of ten years."

The following Bill was then read and agreed to; - "An Act to amend the Acts to Consolidate the Acts relating to the Town of Dartmouth, Chapter 52, Acts of 1902. Be it enacted by the Governor, Council and Assembly as follows; - (The following section is added to Chapter 52, Acts of 1902) "The Town Council shall have power to lease the northern half of the public dock at the foot of Lyle street to the North Star Rowing Club, Limited, for a term of ten years."

Letter was read from Mrs. Hannah Walker and R. S. Brown, complaining of the noise caused by the working of a steam derrick for smashing iron on Chas. Brister's property, adjoining theirs. The clerkwas instructed to advise the complainants to forward their complaint to Mr. Brister, and also to notify Mr. Brister.

On motion of Councr. Tobin, seconded by Councr. Stevens, "Resolved, that Mr. Nathl. Keddy be paid the sum of \$10. amount requested to repair his fence."

On motion of the same, "Resolved that this council accept to offer of J.M.MoGrath & Co. whereby that firm agrees to take the bay horse off the town and replace the same by another horse meeting with the Bublic Property Committee's approval, for the sum of \$80. which said amount is to include the sum of \$30. now due by the town to said firm."

Passed, Councrs. Ritchie and Tuttle dissenting.

On motion of the same, "Resolved, that the date for turning off the water from the premises of delinquent water rate payers be

the 30th day of April instant. The usual one week's notice to be first given. "

Councr. Ritchie moved, seconded by Councr. Tuttle, the following, "Whereas it has been unsatisfactory to this Council the way the horses owned by the town have been handled in the past, Therefore resolved, that the Superintendent of Streets be given the same authority over the teams owned by the town, and the teamsters, as he has over the men that work on the streets, also that he be held responsible to this Council for their proper use. " Accepted as notice of motion.

The Town Clerk reported that a number of the town officers appointed at the meeting of February 11th, had not been sworn in, altho duly notified to do so. On motion the Council ordered that they be notified again to attend within three days and be sworn into office.

A number of bills were passed for payment and the Council adjourned and met immediately after as the Board of Health.

The following report was read and adopted; - "Re. the recent letter from Mr. Henry O'Toole relative to papering on walls of his house, Boggs Street, in which there were cases of smallpox in the year 1902, referred to us (Dr. Milsom and Town Clerk) we beg to report that we do not consider it necessary to do any more fumigating or papering to said house, as said house was thoroughly fumigated and disinfected at the time, under the supervision of Dr. Doyle, the physician in charge of the cases. In proof of this we annex his report thereon as well as a statement signed by Mrs. Ethel Brown, the then tenant of the place in question."

3. Your Committee would recommend that they be authorized to purchase ten lengths of \$\frac{1}{2}\$ inch lead lined iron pipe, one dozen \$\frac{1}{2}\$ inch elbows, and six \$\frac{1}{2}\$ inch T fittings. This new make of pipe is highly recommended and your Committee would like to give it a trial, It is manufactured at Wakefield, Mass.

On motion this report was adopted.

On motion a vote of thanks was passed to the Board of Fire Wards of the City of Halifax, and to Chief Broderick, of the Halifax Fire Department, for their promptness in loaning the use of one of the Halifax Steam Fire Engines to the town while the Dartmouth Steam Fire Engine was being repaired. The Board of Trade offered to supply the trees if the town would bear the expense of planting them. After some discussion this was agreed to and the matter referred to the Street Committee.

The Committee on Water and Sewerage reported that they had asked for tenders for standpipe tops and received two, from Douglass & Co. and the Dart. Iron Foundry Co. and recommended that the tender of Douglass & Co., being the lowest at  $.03\phi$  per lb. be accepted. They also recommended the acceptance of the tender received from the Standard Drain Pipe Co., for inch sewer pipe required, at  $.19\phi$  per foot, delivered at Dartmouth. Adopted.

The Committee on Police and Licenses, to whom was referred the letter from residents of Prince Street complaining of teams being placed in front of their dwellings, reported and recommended that a bye-law be prepared by His Honor the Town Solicitor, providing as follows;-

The question of revision of Town Bye-Laws was taken up and on motion was left in the hands of the License Committee to report upon at the next meeting.

The Mayor called attention to the suit of Boland vs Elliot and recommended that the Council pass a resolution to re-imburse the Town Clerk for the expenses paid by him in connection with On motion of Councr. Regan, seconded by Councr. this suit. Tobin, "Resolved, that the bill of costs of Town Solr. Foster against Town Clerk Elliot, amounting to the sum of \$70. be paid by the town." Councr. Tuttle moved, seconded by Councr. Stevens, "Resolved, that Mr. Elliot be refunded the amount of costs, \$90. already paid by him in the Boland case." question being raised that it would not be legal to do this without rescinding the resolution upon this subject passed by the Council, Dec. 21, 1905, Councr. A number of accounts were passed for payment, and the Council adjourned and met immediately after as the Board of Health.

A letter was read from Mrs. E. Wilson offering to rent a house owned by her on the Cole Harbor Road for the purpose of receiving part of the DeYoung family now quarantined on Brenton Street, at a rental of \$8.00 per month.; the Board to make all necessary repairs and leave the premises clean and fumigated.

Action on this letter was deferred and the matter of making all necessary arrangements in connection with the smallpox case was referred to a committee consisting of the Mayor, Councr. Stevens and the Town Clerk.

Special meeting of the Town Council was held this day at 9 a.m. Present Mayor Williams, Councillors Tuttle, Ritchie, Regan, Stevens, Tobin and White, also Town Solicitor Foster.

The Mayor called attention to the recent fire at the old Woolen Mill near the First Lake, and recommended that an investigation be held. Councr. Regan moved, seconded by Councr. White, "Resolved, that a reward of \$1000. be offered by the town for information that will lead to the apprehension and conviction of the party or parties guilty of recently setting fire to St. Peter's Hall or the old Woolen Mill at the foot of First Lake, or for information leading to the apprehension and conviction of any person setting fires within the town during the next two months. Councrs. Tuttle and White moved "That His Worship the Mayor be hereby requested to cause investigations to be made, before His Honor the Stipendiary Magistrate, as to the cause or origin of all fires which took place during 1906, suspected of being of incendiary origin. " Councrs. Regan and Tobin moved in amendment "That His Worship the Mayor be requested to hold an investigation at which the origin of all the fires occurring during 1906 will be inquired into. This investigation to be held as provided by law." After some discussion the amendment was put, and it appeared that Councrs. Regan, Tobin and Stevens voted for, Councrs. Tuttle, White and Ritchie against. The motion was then put, resulting in the same vote reversed, and the Mayor gave his casting vote for the amendment.

Letter was read from A. C. Pyke, President of Dartmouth Board of Trade, suggesting that the Town should take the opportunity of extending an invitation to the Governor General to visit Dartmouth on the occasion of his visit to Halifax the latter part of July, and as the 25th of July is likely to be the date fixed for the celebration of Natal Day, he thought that the Governor General might be invited to be the guest of the Town on that day. After some

discussion thereon, it was moved by Councr. Tuttle, seconded by Councr. Regan, "that the Council form a committee of the whole to arrange, in conjunction with the Board of Trade, to invite and entertain Earl Grey, Governor General of Canada, in Dartmouth."

Minutes of meetings of Mgy 13th, 16th and 29th, were read and confirmed.

The motion, moved by Councr. Tuttle, seconded by Councr. Stevens, re. rescinding the motion passed Dec. 21, 1905, accepted as notice of motion at the last meeting, was taken up and ruled as not necessary by Town Solr. Foster. Councrs. The Water Committee reported as follows; - Your Committee beg to submit their estimates for the maintenance of the water system for the year commencing May 1, 1907, with an estimate of the revenue expected. The sum of \$5976. is required to be levied on property fronting on pipe lines, of which \$2818. would be raised on property other than dwellings, and \$3192. on property containing a dwelling or dwellings, which gives \$34. more than the actual amount required. The rates required on the valuations as set out in the estimates would be .30¢ per \$100. as a Domestic Rate and .18¢ per \$100. as a Pipe Rate, being the same rates as last year. Your committee would further recommend that the usual Hydgant Rate of .10¢ per \$100. be levied on property liable therefor.

2. Your committee submit herewith for your information, a statement of the Receipts and Expenditures of the Water Maintenance Account for the year ended May 1, 1907.

The Town Clerk has recently requested your committee to redommend that some change be made in the method of sending notices in connection with the collection of the Walter Rates, in order to reduce the enormous number of notices both for Water Rates and Turn Off Notices, which under the system now in vogue have to be The method now in operation is as follows; -Besides the regular water rate bill, sent out each half-year, turn off written notices are sent to nearly three-fourths of the water users every half-year, and the number requiring a turn off notice seems to be increasing year by year. This means the This means the sending of four differment notices within twelve months for the collection of water rates averaging \$5. or \$6. In view of this your committee would strongly recommend that from and after the beginning of the present water year, vix, May 1, 1907, the usual two half-yearly water bills be sent, as heretofore, in May and November, with a plainly stamped notice in red ink on the face of the bill that the water will be turned off without further notice at the expiration of the then half-year, vix, October 31st and April 30th, if the rates are not previously paid, provided that notice thereof is given in the newspapers; and thus the sending Your committee would of the turn off notice will be abolished. recommend that any resolution of Council inconsistent with this be rescinded.

The Public Property Committee, to whom the petition of the Ratepayers for the extension of Eaton Avenue was referred, reported that they authorized the clerk to write the several owners of land on Eaton Avenue, and herewith attach the replies. Messrs. Short and Whebby, and Mrs. Smith refuse to convey any rights that they have to the town. Mr. Eaton offers to deed to the town a strip of land 15 x 338 ft. for the sum of \$400. and exemption from sewer rates, which would amount to \$338. additional. In view of the above your committee cannot recommend that any further steps for the extension of this street be taken, and recommend that the petitioners be so informed. This was adopted.

On motion of Councr. Tuttle; seconded by Councr. Tobin, "Resolved, that the Street Committee be instructed to confer with Mr. D. M. Thompson, who opened the street from Erskine St. thru his property with a view to the town taking over that portion of the street."

The Public Property Committee also reported that they consider it necessary to construct a shelter shed for the town waggons and carts. At present they are being injured by exposure to the weather, and your committee would recommend that Supt. Bishop be

instructed to prepare plan and specification for a suitable building to be erected in the yard adjoining the stable, and that tenders be asked for the work and submitted to the Council for On a motion to adopt this report it appeared that approval. Councrs · Stevens, Tuttle and Regan voted for, Councrs. White, Tobin and Ritchie against and the Mayor gave his casting vote against the adoption of the report.

The Committee on Police and Licenses reported recommending that Messrs. W. R. Foster and Frank W. Russell be engaged to revise the town By-Laws, and prepare same for publication, and that the sum of One Hundred Dollars be paid them for that purpose. Adopted.

The Committee on Fire reported as follows;-

That the formation of a Veteran Firemen's Association be approved, and that when organized the rules and regulations covering that body shall be submitted to the Council for approval. Your committee would also recommend, in order that the Veteran's may have a place in which to meet, that a one-story addition be built to the north side of the Town Workshop, on Wentworth Street in accordance with plans and specification hereafter to be submitted to the Council.

2. That whereas, there will be this year \$1000. in the Firements: Insurance Fund, and that no provision having been made for the payment of benefits thereunder, that the following rules be established; -

1. That in the event of the death of a married member of the Fire Dept. resulting from injuries or other causes sustained in going to, working at, or coming from a fire in the Town of Dartmouth, or in performance of such other duties as may be assigned to him by the rules of the said company, that his family or legal representatives

shall be paid an annual sum of \$60. for a period of eight years.

2. In the event of a member of the Fire Dept. being injured so as to incapacitate him from following his usual occupation, he shall received out of the said Fund the sum of \$5. for every week he is so incapacitated but not for a longer period than ten weeks, provided that no such payment shall be made except under certificate of the Capt. or Secy. of the Company that the man received the injuries while bona fide engaged in his duties as a fireman, also

a Doctor's certificate.
3. In the event of the death of a single member of the Fire Dept. resulting from injuries or other sauses sustained in going to, working at or coming from a fire in the Town of Dartmouth, or in the performance of such other duties as may be assigned to him by the rules of the said company, there shall be paid out of the said fund to his father, or mother, or other representative, the sum of (continued below) **\$**50.

Your committee would recommend that the estimate for this year be paid into the Firemen's Insurance Fund.

3. In the event of a single member becoming injured then he shall receive \$2.50 per week for a period of ten weeks. This report was ordered to lie on the table until the next

meeting.

The Committee appointed re. Management of Town Horses reported recommending that the horses owned by the Town, when employed on

the streets for any purpose except for fire, shall be under the control of the Superintendent of Streets, who shall employ two drivers and shall be responsible for their actions, the said drivers to attend all fires as at present arranged for, the drivers when at stable shall be under the control of the caretaker of the horses, and when at fires to be under the control of the officer in charge. After some discussion this report was received and on motion of Counor. Regan, seconded by Counor. Tobin, "Resolved that the question of the management of the Town Horses be referred to a special committee. Counors. Ritchie, White and Tuttle were appointed as such committee.

Letter was read from Starr Mfg. Co., stating that they would draw the water off Sullivan's Pond during the construction of the new bridge over the canal at the head of Ochterlony Street, upon payment to them of the sum of \$105. owing to the necessity of running their works by steam during the period the water would be shut off. Referred to Street Committee.

Letter was read from Policeman Nichols requesting an increase in his salary. Referred to Police Committee.

Letter was read from Jas. Simmonds & Co. making application for a concrete sidewalk in front of their premises on Water St. and asking under what condition this could be done. Referred to Street Committee.

Report of apparatus in charge of the Engine Co. on June 1/07 was read and ordered to be filed.

Letter was read from H. O'C. Baker, calling attention to the depositing of ashes, etc, on Dahlia Street, and asking that it is stopped. Referred to Police Committee.

Letter was read from Mrs. S. Robson, asking to be allowed the full amount of the widow's exemption. Referred to Town Solr. Foster.

Letter was read from City Clerk stating that on the 16th of
May last the City Council appointed a committee on "Greater Halifax"
consisting of the Mayor, Aldermen Murray, Cawsey and McKenzie. On
motion a committee on the same subject was appointed, consisting

7

of the Mayor, Councillors, White and Regan.

Letter was read from Union of Canadian Municipalities, Montreal, asking the Council to become a member of their organization and to pay the fee for the year 1907, \$15. Ordered filed.

Draft of petition from the residents of Dartmouth to the Lieut. Governor-in-Council praying that the Government approve of the By-Law passed by the Town Council on April 2nd, last, re. the incorporation of Woodside District into the Town of Dartmouth, was read, and adopted.

The Mayor, Chairman of Finance Committee, and Town Clerk were appointed a committee to destroy two Ferry Bonds of \$1000. each recently paid off.

Councr. Tobin, Chairman of the Water Committee reported that a bill recently rendered to the Dartmouth Rolling Mills for water used at their works, per meter, was disputed by them. After some discussion the committee were instructed to confer with the Starr Mfg. Co., with a view to arranging a settlement of the matter.

On motion of Councrs. Tobin and Regan, "Resolved, that the Water Committee, with the Supt. and Town Solicitor, be instructed to attend to the work of preparing plans and specifications, and all work necessary for the northend extension, and submit same for approval of Council so that the work may be started as early in the spring as possible."

On motion of Councrs. Tobin and Tuttle, "Resolved that the work of repairing the road along the south side of Topsail and Lamont Lake, with a view to making better sanitary arrangements, be carried out."

On motion of Councrs. Regan and White, "Resolved, that the Mayor be requested to proclaim a half holiday on the 21st of June, the Natal Day of Halifax."

A number of accounts were passed for payment and the Council adjourned.

Monday, July 8th, 1907.

Town Council met this day at 7.30 p.m. Present Mayor Williams Councillors Tuttle, Ritchie, Regan, Stevens, Tobin and White, also Town Solicitor Foster.

Minutes of last meeting were read and confirmed.

The Fire Committee's report of May 20th, read at the last meeting, was taken up and the first clause passed four to two, Councrs. Tuttle and Ritchie dissenting. The second clause was referred back to the Committee for further consideration, and the other clauses of the report were adopted.

The report of the committee on Management of Town Horses was read clause by clause, and adopted in full on the casting vote of the Mayor, Councrs. White, Ritchie and Tuttle voting for, the other councillors against;

"Your Committee beg to report as follows and make the following recommendations;-

1. That, the Supt. of Streets be incharge of horses and drivers at all times, and to everything pertaining to this department.

2. That an order be posted in the stable that the men must, on the alarm of fire, go to the fire station immediately hitching up their horses to the apparatus designated by the person in authority and proceed to the fire with all possible speed and report to the person in charge at the fire.

3. In the event of horses and drivers working at the town water service outside the limits of the town, provision must be made by the Supt. For other horses and drivers to take the fire apparatus in case of an alarm of fire.

- 4. The Supt. shall have the hiring and discharging of all drivers but he may dismiss the caretaker only with the approval of the Council. He shall see that the horses are properly fed and
- cared for.

  5. All requisitions for feed and other requirements must be made to the Town Clerk in writing.
- 6. The Supt. of Streets shall report to the Council every month on the condition of the horses and gear, also the standing of the drivers.
- 7. The drivers must be kept at work in any capacity in the town the Supt. deems necessary, always keeping in mind the alarm of fire. 8. Your Committee would suggest that Mr. Thos. Knox be made foreman in this department."

The Water Committee reported as follows; - Your Committee beg to report that after interviewing Mr. Henry O'Toole and his solr. Mr. R.E. Finn, with reference to water pipes burst in his house on Boggs Street thru water not being turned off, as claimed by him, would recommend that a plumber be engaged to make the necessary repairs to such water pipes.

2. Your Committee would also recommend that the temporary water pipe at present on Fairbanks Street be removed, as this district is now supplied with water.

2. Your Committee would further recommend that a drinking trough be placed at the top of Synott's Hill.
3. Your Committee would recommend that the tender of Jas. Simmonds & Co., being the lowest tender received, be accepted for English Pig Lead, & inch lead pipe, corporation and machine cocks, required also that the tender of the Canada Foundry Co. for one 6 inch water gate valve, at \$13.20 be accepted. This report was adopted.

The Street Committee reported as follows; - "Your Committee have considered the letter recently received from Jas. Simmonds & Co. referred to them, asking that a permanent sidewalk be laid along Water Street in front of their property and the properties of the Dominion Government and the Dartmouth Ferry Commission. Your Committee cannnot recommend that this be done, as nothing was placed in the estimates this year to cover the cost of such an improvement." This report was adopted, Councr. Tuttle dissenting.

The Committee on Bonds reported that on the 5th day of July, instant, they had destroyed two Town of Dartmouth, ten year, four per cent, Ferry Bonds, issued June 1, 1897, Nos. 14 and 15. Received

The Poor Committee reported that they had considered the letter received from the S.P.C. in reference to the house kept by Mrs. Elizabeth Day on Victoria Road, and having considered the whole matter, in conjunction with the Town Health Officer, Dr. Milsom, strongly recommended that His Worship the Mayor be requested to revoke the license to keep infants. granted to Mrs. Day by the late Mayor Scarfe. They also submitted Dr. Milsom's written oppnion in regard to the matter. Adopted.

The Police Committee reported that they had considered the application from Policeman Nichols for an increase in his salary, referred to them, and as no amount was placed in the estimates for any increases, and owing to large inforeseen expenses this year, they could not see their way clear to grant his request this year but would recommend that his application receive favorable consideration next year. Adopted.

The following letters were read; -

From Dartmouth Engine Co., asking for two more controlling nozzles and for some more ladder straps. Referred to Fire Committee.

From Miss Emily Scarfe, complaining of the overflow of drainage upon her property, Crichton Avenue. Referred to Water Com. to report upon.

Town Council met this day at 7.80 p.m. Present Mayor Williams Councillors Tuttle, Ritchie, Stevens, Regan, and Tobin, also Town Solicitor Foster.

Minutes of meetings of July 8th and 10th were read and confirmed.

The Committee on Police and Licenses, to whom was referred the letter of Mr. McPhee, regarding the carrying on of his business on Sunday, reported that they had deemed it advisable to ask the Town Bolr. his opinion regarding what it was legal for Mr. McPhee to do on Sundays, under sec. 12, sub-sec. o of the Lord's Day Act and submitted his opinion as follows; - "As I understand the question to be if 'Is it lawful for any person to hire out boats on the Sabbath Day? At the last session of the Dominion Legislature an act was passed which is now known as the 'Lord's Bay Act' This act does not repeal or conflict with our own local law which provides. 'Any person who employs or hires, or procures any other person to perform servile labor (works of necessity and mercy excepted) on Sunday, or who directs, allows, permits or produces any one or more of his servants, workmen or employees to perform servile labor on Sunday ### shall for the first offence forfeit not less than the sum of two dollars,&c. ' The great difficulty with this legis-lation was the definition of 'servile labor' and there has always been such a disinclination on the part of legislatures to temper with Sunday laws that there is no statutory definition of the words The Dominion Statute avoids the words so far as I am aware. entirely and is therefore more understandable and far less stringent than our local law. Chap. 153, Dominion Statutes 1906, sec. 5 provides; - "It shall not be lawful for any person on the Lord's Day, except as herein provided, or in any Provincial Act or law now or hereinafter in force, to sell or offer for sale or purchase any goods, chattels, or other personal property or any real estate or to carry on or transact any business of his ordinary calling, or in connection with such calling, or for gain to do or employ any other person to do, on that day, any work, business or labor." Sec. 8: "It shall not be lawful for any person on the Lord's Day except as provided by any Provincial Act or law now or hereafter in force, to run, conduct or convey by any mode of conveyance any excursion on which passengers are conveyed for hire, and having for its principal or only object the carriage on that day of such passengers for amusement or pleasure and passengers so conveyed shall not be deemed to be travellers within the meaning of this Act. Under the heading "Works of necessity and mercy excepted" Sec. 12 sub-sec (o) provides; the hiring of horses and carriages or small boats for the personal use of the hirer or his family for any purpose not prhibited by this Act " do not come within the prohibi-In view of this it appears that the Dominion Act does not. cover this case. In the event, if proceeding under the Dominion Statute, the leave of the Attorney General of the Province must first be obtained, the discretion resting wholly with him, and it is very doubtful if he would interfere in such a small matter, even if it were possible to make out a case. I would not advise any proceedings under the local law on account of the difficulty of proving "servile Labor" After some discussion this was adopted Councr. Tuttle dissenting.

The Committee on Water and Sewerage reported having met Messrs. Goudge, Hill and Simmonds with reference to the charge of \$409. made against the Dartmouth Rolling Mills for water, and found that there was a quantity of water used by the Company to run their plant, owing to the delay in getting their 8 inch pipe, which they laid in place of the 4 inch, through which they use their own water. The Com. recommended that owing to the Co. withdrawing the amount of \$750. for allowing the town sewers to remain on their property while the sewer was being changed to the public dock, and also for permitting the town to take up the old sewer on the Rolling Mill property that the above charge be cancelled. The Com. also reported as follows; Having considered the application of Mr. E.H.McElmon for water for the steam boiler at his Lumber Mill, and would recommend that he be charged the sum of \$50. per annum.

Having interviewed Mr. Robt. Moseley with reference to bill of \$574.68 due the town for water per meter, and considered the report of the Supt. to the effect that the pipe between the meter and the building had burst, wasteing a large quantity of water, would recommend that this charge be cancelled.

Having considered the letter from Miss Scarfe re. drainage from gutters, report progress.

Adopted.

Supt. Bishop reported re. Town Horses, as follows; In comliance with a resolution passed on July 8th, I beg to report as
follows; On taking charge of the horses as directed by you, I found
that the gray horse had a bad show boil. I had it attended to by
Dr. McFatridge and it is now recovering nicely, other than this the
horses are in good condition. I have had to make some changes in
the harness for the comfort of the horses and the convenience of the
drivers. The balance of the gear is in about the same condition as
it was a month ago. With regard to the drivers I have to say that
they are doing their work very satisfactory. I would advise that
some changes be made in the barn. In its present condition there
is not sufficient room in the hay loft and there is no ventilation
in the stable. The upper floor should be lovered and the stable
ventilated, also that the mangers be altered as the horses are at
present eating the most of their feed from the floor. There are
also some other minor changes to be made but they are not off sufficient importance to be mentioned here. If you decide to have
the above changes made I would advise that they be done as soon as
possible, as we cannot feed economically under the present conditions.

After some discussion, and on a motion to adopt same, the report was objected to by Councr. Regan as being new matter, whereupon notice of motion was given by Councr. to deal with the report at the next meeting.

The Auditors reported that they had examined and audited the books and accounts of the Town Treasurer to June Soth, last, and found everything in order and correct, and submitted duly certified statements of the several services of the town to that date.

Ordered to be filed.

From W. L. Barss, revoking and withdrawing the offer of land to extend Rose Street, made by him on the 9th of April last. Rec'd.

From T. F. Tobin, solicitor for C. E. Neville, asking for a refund of a portion of the fee paid in by him for an Exhibition license. Referred to Town Solicitor to report upon.

From Wing Kee Co. requesting that all Chinese Laundries be required to pay a tax before starting business in the town, and stating that they would be willing to pay a license fee of \$200. per year. Referred to Town Solicitor to report upon.

From M. U. Lenoir, solicitor for C. A. Fraser, demanding damages on account of the dutting off of the water from a well on his property fronting on Fairbanks Street. Referred to Water Com.

From City Clerk, Halifax, giving notice that Alderman Davison had been appointed a member of the Special Committee on Greater Halifax. Ordered to be filed.

From Jeremiah Gray, calling attention to the need of a sidewalk in front of his property on Dahlia Street, as owing to absence of a sidewalk the water flowed on to his property. Referred to Street Committee. From William Gammon, giving notice that if his claim for damages to his property, caused by the overflow of water from a brook running through it, was not settled within ten days he would take legal proceedings. Referred to Water Com. with Town Solr.

From Mr. John White, stating that on account of being Pres. of the Dartmouth Electric Light Co., he understood that he was not entitled to his seat in the Council, and asking that a legal opinion be obtained on the question. Referred to Town Solr. for his opinion.

From William Wilson, calling attention to the fact that Councr. John White was not entitled to him eat at the Council Board on account of being President of the Dartmouth Electric Light Co., which company contracts with the town for electric lighting. Ordered to be filed.

Town Council met this day at 7.80 p.m. Present Mayor Williams Councillors Tuttle, Ritchie, Regan, Stevens, Tobin and Barss, also Town Solicitor Foster.

Minutes of last two meetings were read and confirmed.

The Fire Committee reported that they had considered the application of the firemen to have electric tappers placed in their houses, and while recognizing the importance of having an improved fire system so that the firemen could more expeditiously reach the scene of sction, atill as the present year has about expired and noprovision was made in the estimates, they could only recommend that no action be taken this year, but that the incoming Council take the matter up with a view to either installing a complete fire alarm system, or the erection of a second fire tower and bell in the northend of the town. Adopted.

Town Solicitor Foster reported re. case of Miss E. Billard, that from the data furnished him, the Town of New Glasgow is her settlement, unless it can be shown that she was under an agreement there for service for more than one year. Referred to Poor Committee to deal with.

The Auditors reported that they had examined and audited the books and accounts of the Town Treasurer to the 80th of Nov. last, and found same in order and correct, and submitted duly certified statements of the several services of the Town to that date. Ordered to be filed.

The following letters were read;-

From A. C. Pyke, as follows; "One of the greatest attractions of the Town of Dartmouth, both for visitors and our own people, are the beautiful Dartmouth Lakes. It is only within the last few years that we have realized what a restful and delightful spot it is, and how necessary it is that all its beauties, particularly along its shores should be well preserved. With this end in view, I wish to bring to the attention of your honorable body the advisability of the Town purchasing the property on the shores of first lake known as "Birch Gove" The property referred to is owned by the Crichton Estate and others and consists of about 8½ acres, stretching from Crichton Avenue to the shores of the Lake and from what is known as the Lloy Farm to the Keelor property. It contains a grove of hard wood trees and with a very small expenditure could be made into a very beautiful Park. It could be made part of the Park System of Dartmouth and be placed under the control of the Park Commission This property can be purchased by the Town for \$1470., half this amount to be paid in 1908 and the balance in 1909. I have secured an option at the above price, good until Jan. \$1, 1908 and if the Town decide to purchase I will be pleased to hand same over to them."

Referred to Public Property Committee to report upon.

From Dominion Securities Corporation, Montreal, offering \$4000. Town of Glace Bay debenture for the investment of the Binking Fund, at 90.40. Ordered to be filed.

From Mrs. A.M.Beck, complaining of the noise and edor arising from the Electric Light Plant on Ochterlony St. opposite her property, and stating that she understood the Council had the power to have the nuisance abatted, and asked that this be done, otherwise she would be compelled to take action against the Town to have same suppressed, claiming that her property was being damaged thereby.

Petition signed by a number of ratepayers residing in the vicinity to the same effect was read, and both letter and petition were referred to a special committee, consisting of Councrs. Barss, Regan and Stevens to investigate and report upon.

Lengthy letter from A. W. Trider, in reference to his dismissal from the Police Force last year and the recent fire

investigation, which cleared him from the charge of incendiarism which had been made against him, and asked that the Council pass a resolution of exoneration, also claiming the sum of \$250. to reimburse him for expenses incurred by him in his defense.

After considerable discussion the following resolution, moved by Councr. Tobin, seconded by Councr. Barss, was adopted; - "Resolved, that the Stipendiary Magistrate be asked to complete the fire investigation and hand to the Council a report by the end of this month, and that the letter of Mr. Trider be considered at the same time.

Supt. of Streets reported that the town horses were in good condition and well, the gear in good order, and drivers doing fairly well. He called attention to the clause in the notice posted in the stable requiring the drivers to make all possible speed to fires, which he thought should read "to make reasonable speed to fires" It would readily be seen that one of these heavy reels with several men on it was too much for any one horse to be driven up these hills with at full speed, as has been done, and for fear of injuring the horses suggested that the clause be altered to read as above. Referred to Fire Committee.

The Engine Co., reported up the list of apparatus in their charge on the 4th of November, last. Ordered to be filed.

The Water Committee reported up draft of specification and quantity sheet of pipe, etc, required for the proposed northend water and sewer extension, and on motion of Councr. Wobin, seconded by Councr. Regan, "Resolved, that the Clerk be instructed to have forms printed of specification and quantity sheet asking for tenders for C.I. Pipe and fittings required for northend extension also to ask for tenders for sewer pipe required, as soon as possible
