Friday, January 15th, 1915.

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councrs. Russell, Mosher, Lynch, Tobin and Carter.

Minutes of last meeting were read and confirmed.

The notice of motion tabled at the last meeting was taken up and on motion of Councrs. Lynch and Carter, adopted as follows; Resolved, that in the opinion of this Council it is advisable that the Town of Dartmouth should have power to govern and regulate the erection of buildings within the town. Further resolved, that a committee be appointed to draft a "Building Act" and submit it to the Council for approval. Councrs. Lynch, Carter and Mosher were appointed as the committee.

Consideration of the proposed new Hackney Byelaws was taken up and on motion of Councrs. Lynch and Russell, Resolved that the Byelaws be read clause by clause. After some discussion, on motion of the same, it was resolved that consideration of these byelaws be postponed and taken up at

a special meeting of the Council to be held on Wednesday next at 7.30 p.m. and that the Town Solicitor be requested to be present.

Tender was read from the Dartmouth Printing and Publishing Co. for printing the Town Report for 1914, at \$1.35 per printed page, this price to include the publication of the financial statements in the "Patriot". On motion their tender was accepted.

The letter from the Board of Trade re. Electric Lighting was taken up and referred to the incoming Council.

The Street Committee reported as follows; - 1. With reference to the claim of Alex. Hutchinson, referred to your committee with the Town Solr. we find that the basket referred to was put in place one week previous to the date of the accident, and that there is no evidence to show that it had been removed previous to the day on which the accident occurred, and therefore the Town is not liable for the damages sustained by Mr. Hutchinson.

- 2. With reference to the matter of the boundary lines at the north and south ends of the town, your committee beg to submit tender of Mr. John Congdon for doing this work for the sum of \$25. and recommend its acceptance. Consideration of the first clause was deferred until a written opinion of the Town Solr. could be obtained. Second clause was adopted.
- The Auditors submitted their annual financial statement for the year ended December 31, 1914, and reported the accounts in order and correct. On motion of Councrs. Russell and Mosher, Resolved, that the accounts of the Town Clerk and Treasurer for the financial year ended December 31, 1914 having all been reported in order and correct by the Town Auditors, to the satisfaction of this Council, are hereby passed and allowed, and that 400 copies of the Mayors' Report with the Auditors' Report and Statements, be printed and distributed to the ratepayers.

The Mayor reported that the issue of \$17000. Consolidated Debt Bonds which were payable December 2, 1914, had been paid off to the extent of \$15500. the remainder of \$1500. not having been presented yet for redemption. On motion the Mayor and Town Treasurer were appointed a committee to destroy the said bonds.

A number of accounts were passed for payment.

On motion of Counces. Russell and Mosher Resolved, that for the purpose of defraying the annual current expenditure of the Town of Dartmouth, which has been duly authorized by the Council, the Council do effect a temporary loan from the Royal Bank of Canada, for the sum of \$12000. and that the Mayor and the Town Treasurer be and they are hereby authorized to execute in the name and under the corporate seal of the said Town the agreement with the said Bank in relation to said loan which has been presented to this meeting and is hereby approved.

On motion of Counces. Lynch and Carter, Resolved that the polling places for the election to be held in the Town of Dartmouth on the 2nd day of February, 1915, be as follows;-

Ward One. At or near Wambolt's shop, Portland Street. Ward Two. At the Town Hall. Ward Three. At the Engine House.

On motion of Couriers. Mosher and Lynch, Resolved, that the Assessment Court of Appeal, which is to meet on February 23, 1915, be held at the Town Hall at 7.30 p.m.

Wednesday, January 20th, 1915/

Special meeting of the Town Council was held this day at 7.30 p.m. Present Mayor Williams, Councillors Mosher, Russell, VanBuskirk, Lynch, Tobin and Carter, also Town Solicitor Foster.

The Water Committee reported, recommending that the Supt. be instructed to ascertain the cause of so much waste of water which affects the supply of water to consumers on the high levels, also the unnecessary running of taps through the town, and report to the Council immediately.

Letter was read from James O'Toole, Sr. complaining that the water from the roof of the Ladder House flowed into his cellar, filling it at every rain storm, and asked that the metter be remedied, as it was causing him damage. Referred to Street Committee.

Letter was read from S. P. C. calling attention to the condition of the Lockup Building and alleging that the same was not in a fit condition to have prisoners placed therein. Referred to Police Committee to inquire into and report.

The proposed new Hackney Byelaws were taken up, and on motion of Councrs. Lynch and Russell, resolved that the byelaws be read clause by clause. Clauses 1 to 6 were passed without change.

Clause 7 was struck out and clause 131 of the old byelaws substituted therefor with the addition of the following; "No such license shall be issued to any person under the age of sixteen years or to any person in the judgment of the committee not a fit and proper person to be liabler a driver" Clause 8 passed, substituting the word "used" instead of "license" Clauses 9, 10, 11 and 18 passed.

Clause 13 was amended by striking out all the words in the 9th and 10th lines after the word "prosecution" in the 9th line.

Clauses 14, 15 and 16 were passed.

Clause 17 was struck out.

Clause 18 was amended by striking out the word "grant" in the first line and substituting the word "recommend" also by inserting the words "recommend to" between the words "to" and "renew" in the 2nd line.

Clauses 19 and 20 were passed.

On motion the byelaws as amended were adopted and the Clerk was instructed to forward same to the Governor-in-Council for approval.

On motion of Councrs. Lynch and Russell, Resolved, that the clerk be instructed to notify the Town Solicitor to report at the next meeting of Council as to what action he has taken in order to compel Mr. Brister to remove the obstruction on North Street.

The petitioners asked for certain repairs to be done to the square of land north of Dawson Street known as "Victoria Park", as the same was nor in a very unsanitary condition. On motion of Councrs. Tobin and Russell, the petition was referred to the Street Committee to report.

Letter was read from John H. Congdon, stating that he had located the northern boundary of the town west of Windmill Road and the southern boundary west of the Eastern Passage Road, and had erected temporary marks on the

same of which Sunt. of Streets Nichols had been advised, and presented the town with a plan of the southern boundary, and if the town wished a plan of the northern line, showing the property effected he would be pleased After a long discussion in reference to the location to do the work. od the exact position of the northern boundary line of the town, Councr. Lynch moved, seconded by Councr. Russell, that John H. Congdon be instructed to prepare a plan of the northern boundary of the town showling the adjoining Councrs. Tobin and Mosher moved in amendment that the Public Property Committee and Engineer Congdon, with the Nayor, look over the property at the northern boundary and define the town line and report The amendment was put and carried, the mover and same to the Council. seconder with Councrs. Carter and Herman voting for, Councrs. Lynch and Russell against. The motion was then put and negatived on the same vote reversed.

Letter was read from Union N. S. Nunicipalities, pointing out certain objectionable features in the Assessment Law and Education Act with regard to exemptions enjoyed by widows and others, and suggesting that the same be inquired into and an effort made at the present session of the Legislature to remedy the same. Referred to Committee on Legislation.

Letter was read from Dartmouth Board of Trade, requesting the Council to appoint a committee to consider the question of acquiring the present electric light plant for the town, the committee to confer with a committee of the Board of Trade and report back to the Council. Councrs.

Tobin, Herman and Russell were appointed as the committee.

Letter was read from Dartmouth Engine Co. requesting the Council to make them a grant of \$200. towards the funds of their company. They also asked that the mayyer of improving the fire alarm system of the town be considered. Capt. Conrod and J.J.O'Toole of the Co. were heard in support of their proposition. Referred to Fire Committee to report.

Letter was read from publishers of the Canadian Municipal Journal requesting the town to subscribe for copies of their paper. Ordered filed.

Councrs. Tobin and Herman moved the following which was adopted;-

"Whereas, the railway from Dean's Settlement in the Musquodoboit Valley of to Dartmouth is now nearing completion, and will be open for the carrying of both freight and passengers this year; and Whereas, there are at present no adequate facilities in the Town of Dartmouth for the handling of such traffic as may legimately expected from the opening of said line, and Whereas, the carrying of freight to Halifax either by crossing the Harbor or by way of Windsor Junction, particularly with regard to the shipment of lumber, would be inconvenient for the shipper and positively injurious to the Town of Dartmouth, the people of the town having been led to believe that Dartmouth was to be the terminus of said line in fact as well as in name, Therefore
Resolved, that this Council strongly urge upon the Dominion Government the importance of providing Dartmouth with proper equipment for the handling of this traffic, and that the Government is requested to make provision this year for the construction in Dartmouth of a Public Wharf to be used in the shipment of lumber and other freight brought over the railway, and further
Resolved, that copies of this resolution be forwarded to The Right Hon. Sir. Robert L. Borden, G.C.M.C., M.P. and the Hon. Frank Cochrane, M.P. Minister of Railways and Canals, Ottawa.

Councrs. Russell and Carter moved the following, which was adopted;—
"Resolved, that a copy of the resolution passed by the Council regarding
railway facilities at Dartmouth be sent to the Dartmouth Board of Trade
with the request that the Board endorse same and forward it to the
persons mentioned therein.

The Police and License Committee reported as follows;-

"On the 2nd day of February, 1915, Percy Richardson, a resident of the Town of Dartmouth laid before the Police Committee a series of charges against Alfred Wirrell, a police officer of the Town of Dartmouth. The charges were of such a grave character that the Police Committee deemed it advisable to hold an investigation. A copy of the charges w to Mr. Wirrell and he was given ample time to prepare a defence. A copy of the charges were sen-t committee held two sessions at which several witnesses were examined, their evidence being taken in the form of a signed declaration, as provided by Both Mr. Wirrell and Mr. Richardson had solicitors appearing The scope of the inquiry was broad, yevery opportunity in their behalf. being given both parties concerned to call all the witnesses they deemed No objections were taken by either solicitor as to the methods necessary. pursued by the committee during the investigation. The witnesses for the prosecution, (8 in number) were all subjected to a severe cross examination by the solicitor for the defendant, but in the opinion of the committee their evidence remained absolutely intact and unimpeached. committee deem it their duty to report to the Council that during the progress of the investigation Wirrell attempted to interfere with the committee while on their way to examine a witness. The statement of Carl Otto to the effect that Wirrell telephoned a message for him to carry to Elsie Rayment to notify her to "beware of the rope on the door" led the committee to believe that Wirrell tried to place obstacles in the way of the committee securing the evidence of the said Elsie Rayment. The dec ation of Robert McElmon that Wirrell told him that he was not compelled to give evidence is also suggestive.

On motion of Councrs. Lynch and Mosher, Resolved, That whereas the charges preferred by Percy Richardson, night watchman of the Nova Scotia Hospital, against Alfred Wirrell, Policeman of the Town of Dartmouth, having been duly investigated by the Committee on Police and Licenses, whose action therein is duly confirmed and ratified, and the said Alfred

Wirrell being present at the investigation and being afforded full opportunity to disprove the charges preferred against him, and witnesses having been fully examined, and having read the evidence given at the said investigation and the report thereon and it appearing in the opinion of this Council that the said Alfred Wirrell is not a fit and proper person to act as a police officer for the Town of Dartmouth, Resolved that the said Alfred Wirrell be and he is hereby dismissed from the police force of the Town of Dartmouth.

Special meeting of the Town Council was held this day at 7 p.m.

Present Mayor Williams, Councillors Russell, Mosher, Lynch, Herman, Carter and Tobin, also Town Solicitor Foster.

Mrs. W. R. Foster and Mrs. Rosenburg, representing the Dartmouth
Branch of the S.P.C. were present and on motion business was suspended,
and they were given a hearing. They asked that the grant of \$100. voted
by the Council last year towards the Cahmen's Shelter be continued and
made an annual grant. Referred to Finance Committee to report upon.

On motion of Councrs. Tobin and Lynch, the Clerk was authorized to send circulars to bankers and others asking for offers for \$150000. of Town of Dartmouth Ferry Bonds, \$6500. of School Bonds (new) and \$1530. of Consolidated Debt Bonds, and give up to the 31st instant for the same to be sent in.

The Town Solicitor was instructed to prepare draft of legislation required by the Town to be submitted to the present session of the Legislature, and submit same to the Council at a meeting to be called shortly.

A discussion took place with regard to the amendment asked for to the law respecting exemptions granted to widows and others, as placed before the Council in a letter from the Town Council of Annapolis Royal. In connection with this the Mayor called attention to the case of Mrs.

John S. Elliot, widow, in regard to whose case he thought the law could be amended so that she could obtain the exemption allowed to widows.

Referred to the Town Solicitor to report upon.

On motion of Councrs. Lynch and Carter, W. R. Foster was appointed Court House Commissioner for the ensuing year.

Councrs. A letter of the Shipbuilding Investment Co. dated Feb. 24,1915, protesting against the valuation of \$24000. on their property, was read. They claimed that they had nor received a valuation notice in time to lay their case before the Appeal Court, and asked that some concession be made them. Received and deferred.

Draft of proposed legislation was again taken up and considered and deferred in order that a meeting of the Committee on Legislation might be held to complete same.

Lynch and Mosher, Resolved, that the Mayor of the Town of Dartmouth, as authorized by Chapter 52, Acts of 1915, whenever thereto requested by the Dartmouth Ferry Commission, shall issue under the seal of the Town, in the form as given in the Municipal Debentures Act of 1914, debentures to such an amount as the Board of Ferry Commissioners shall name, but not exceeding in the aggregate the sum of \$160000. such debentures to be for the sum of One Hundred Bollars each, or any multiple thereof, and to bear interest at such a rate, not exceeding five per centum

per annum, as the said Commission shall determine, and be redeemable in twenty-five years from the date thereof, and such debentures when so issued shall form a lien and be a charge upon all the real and personal property of the Town and upon all the revenues thereof. The said debentures when so issued shall be handed over to the Chairman of the Commission and shall be sold by the said Commission for the highest price that can be obtained therefor, and the proceeds thereof shall be placed in some chartered Bank to the credit of the said Dartmouth Ferry Commission, and shall be drawn as directed by resolution of the Commission on the cheque of the Secretary countersigned by the Chairman. Such debentures shall be used for the purpose of discharging and paying off certain bonds of the said Commission, namely, bonds to the extent of \$110000. falling due June 2, 1915, and bonds to the extent of \$40000. falling due July 1, 1915, and for no other purpose whenever.

The following letters were read; - From Deputy Prov. Secy. transmitting a copy of Provincial War Tax Act passed by the Provincial Legislature at its last session and requesting that the Council be governed thereby. This Act provided for the levying and collection of a special rate of one mill on the dollar on all rateable property within the town, during the current year 1915. After some discussion the matter was referred to the Mayor and Finance Committee to consider and report upon.

From Halifax Breweries, Limited, requesting that they be granted the usual Brewers' License for the ensuing year, and enclosing the license fee, \$150. therefor. On motion of Councrs. Carter and Nosher, Resolved, that the license as requested be granted.

From Revisors of Electoral Lists asking for re-appointment. On motion of Councrs. Lynch and Carter, Resolved, that Messrs. C.W. Waterfield, Jas. S. Warner and Fred. W. Bailey be appointed Revisors of Electoral Lists for the Town of Dartmouth for the year 1914-15, at the same salary as last year.

From Dr. G. G. Gandier, complaining that his assessment had been largely increased for the present year, and as the value of his property had not increased he was unable to understand why such a bill was sent him.

Referred, to Finance Committee to report upon.

From Mrs. Margaret Hunt, complaining that on the night of the 10th of April, last, her horse, driven by George Arnold, licensed hack driver, had its foot caught in a hole thru the bridge on Portland Street near the eastern boundary of the town, and as a result the horse had to be shot. She valued the animal at \$200, and asked for compensation for that amount. Referred to Street Committee with Town Solicitor, to report upon.

The Street Committee reported verbally that the town find the material for the line fence as requested by Frank S. Walker between his property and that of the town.

Adjourned.

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councillors Russell, Mosher, Herman, Lynch, Carter and Tobin, also Town Solr. Foster.

Minutes of meetings of April 7th, 9th and 15th were read and confirmed.

List of names of Estates of deceased persons, heirs of which had not been placed in the Assessment Roll for the current year by the Assessors, was submitted by the Mayor. Referred to Town Solicitor to report upon.

Town Solr. Foster reported re. case of Alfred Wirrell, as under; -

"In re. changes made by Percy Richardson, night attendant at the Hospital for the Insane, against Alfred Wirrell, Policeman.
On the 2nd day of February now last past certain charges made by the above named Percy Richardson against the said above named Alfred Wirrell were laid before the Police Committee with a request that the same should be fully investigated. In accordance therewith an investigation was duly held and both parties were present and represented by counsel. Quite a lot of evidence was taken on behalf of the complainant all in support of the charges. I do not attach importance to the evidence for the respondent. There is nothing more uncertain and treacherous then dates, and so long as facts are indisputable and undisputed they are stronger than dates. Certain acts of the respondent have been positively proved under eath and no attempt was made to deny them while every opportunity seems to have been given him to do so if possible. The presumption must therefore be that he could not. On the 2nd day of March the Police Committee made their report which fully covered the evidence and was strongly against the respondent, finding that the evidence against him "remained absolutely intact and unimpeched." On the same day the report was submitted to the Council and unanimously adopted. In my judgment this should have ended the matter--but it did not-- and subsequently, by a resolution of the Council, it was referred to me to examine the evidence and report back to the Council. Now I have gi Now I have given this evidence long and careful consideration and am of the opinion that the findings of the Police Committee are the only findings they could honestly make in the view of the evidence, and I fully concur with them in finding the charges against the respondent, Alfred Wirrell, substantially sustained. *

On motion of Councrs. Russell and Carter this report was adopted.

The Committee on Streets and Public Property, to whom was referred the petition of Percy G. Austen for permission to erect a bay window on his house, Church Street, recommended that the same be granted, providing Mr. Austen enter into an agreement with the Town to move same when so desired by the Town. Adopted.

The order of business was here suspended and a hearing given to S. A. Heisler, who stated that the Appeal Court had transferred to him, thru the appeal of R. H. Patterson, two lots of land on Hawthorne Street which he was not the owner of. After some consideration the case was referred to the Town Clerk and the Assessors to inquire into and report upon.

A delegation being present from the Inter-Church League re. sports,
Rev. Mr. Woodroofe spoke on their behalf and asked that the large field
on the Park grounds be set apart for the several baseball clubs of Dartmouth
as they were unable to use the Chebucto Grounds, that being pre-empted by
the men's club. After some discussion this matter was referred to the

Park Commission to deal with.

Rev. J. W. A. Nicholson being present, spoke on behalf of the Civic Improvement League and asked for a better organization of charity work than now existed in the town, in order that the same might be unified and centralized in the interests of efficiency. He also referred to "Clean Up Week" and thanked the Street Committee for their efforts in assisting in this work. On motion of Councrs. Mosher and Lynch, Resolved, that the Charities Committee be requested to confer with the representatives of the various charitable organizations referred to by Mr. Nicholson.

The Committee on Fire Apparatus reported as follows;-

- 1. Your Committee have examined samples and prices of hose submitted and beg to recommend the acceptance of the Dunlop Tire and Rubber Goods Co. for 250 feet "Dunlop" 21 rubber covered hose. @ \$1.10 per foot, coupled.
- 2. Your Committee recommend that the present counterweight and arm be removed from the fire bell and that a wheel be substituted therefor, in order to improve the facilities for ringing the bell.
- 3. Tour Committee recommend that the clerk be asked to confer with the Manager of the Bank of Nova Scotia re. Fireman's Insurance Fund, with the view of obtaining a higher rate of interest on the amount deposited at the bank.
- 4. Your Committee recommend the acceptance of the Canadian Consolidated Rubber Co's tender for one Eastman Outfit, at \$52.00.

 This report was adopted with the exception of clause 3, which on motion of Councr. Russell was struck out.

The report of the Police Committee of April 7th, recommending the appointment of Elvin W. Mackay to fill the vacancy on the police force at the salary of \$550. per annum, inclusive of \$50. per annum for clothing, was adopted, Councr. Tobin objecting.

On motion of Councrs. Lynch and Mosher, Resolved, that Elvin W. Mackay be and is hereby appointed Sanitary Inspector for the Town of Dartmouth for the current year at the salary of Forty-five Dollars (\$45.) per annum."

The following letters were read; - From Wm. Sullivan, Wm. Smith and F. S. Coombs, all complaining with regard to street matters. Referred to Street Committee to report upon.

At this point the Mayor called attention to a gully near the Railway

Station that needed to be filled in, and that a drain should beconstructed to carry off storm water at the foot of Stairs Street. Referred to Street Committee.

From Dartmouth Rod and Gun Club, complaining of excessive assessment in view of the small piece of land within the town limits. On motion resolved that they be given a hearing before the Council.

On motion of Councrs. Russell and Lynch, Resolved, that the Street and Public Property Committee be authorized to communicate with the County Council with a view to having the boundary line between the Town and County properly defined, and report to the Council.

From Geo. A. Findlay, complaining that his name had been wrongfully included in the Jury Lists, as he was a member of the Dartmouth Fire Co.

and exempt from jury duty. He had been notified to attend on two occasions as a juryman and lost time in so doing, amounting to \$7.50, and claimed that he should be re-imbursed this amount. Referred to Revisors of Jury Lists to report.

From North Star Civic Improvement League thanking the Council for their efforts to improve the Victoria Park grounds.

On motion of Councr. Tobin the Street Committee were authorized to purchase 40 additional posts at .40¢ each for street fences.

The Bye-laws re. Bill Posting and Trespassing on Streets, as under, were read a second time and the Clerk was instructed to send same to the Lieut.Governor-in-Council for approval;

Bye-law re. Bill Posting.

- 1. No person shall do business as a bill poster or post any bills or placards who has not first taken out a license to carry on business as a bill poster.
- 2. The license shall be granted by the Council and signed by the Mayor and Town Clerk.
- 3. The fee payable for each license or renewal shall be Twenty-five Dollars.
 4. No person shall erect, maintain or make use of any bill board, boarding fence, building, wood frame or construction of wood, metal or other material for the display of advertising matter, bills or placards, whether on his own property or the property of other persons, who has not obtained a permit from the Town Council for the erection, maintenance and use thereof.
- No bill board shall be erected on or facing any public park, playground or municipal property.
- 6. No person shall post any bills or placards containing advertisements of intoxicating liquors of any kind.

 Where any sidewalk has been partly covered with sod in the town, no person shall walk upon the part of the sidewalk so covered.

person shall walk upon the part of the sidewalk so covered.

The person in charge of any horse shall not permit such horse to go upon any sidewalk or any portion of a street so covered with sod.

upon any sidewalk or any portion of a street so covered with sod.

3. No person shall dump, unload, deposit or move any coal or heavy article upon any concrete sidewalk or sidewalk covered with sod, unless such sidewalk has been first protected by boards not less than one inch thick and placed close together over the surface where such coal or heavy article is to be deposited.

On motion of Councrs. Lynch and Mosher, Resolved, that a street light be installed on Bolton Terrace.

The Council then adjourned and met as the Board of Health,

Letter was read from Health Officer Dr. Payzant, stating that several complaints had been made to him of closets proving a nuisance to neighbors and the only way to remedy this was to pass an order making the houses connect with the main sewer. He appended a list of places requiring immediate attention. He also reported a drain opening on the shore near Boggs St. which was not covered by the salt water, coming from the property of Heirs G. W. Young. The clerk was instructed to notify the owners to have this repaired at once or the work would be done by the Board and the cost charged to the owners.

After some discussion, on motion of Councrs. Lynch and Tobin, Resolved, that the clerk be instructed to notify the owners of properties named in the letter from the Nedical Officer, that if the sewer connections are not made within sixty days the Board of Health will have the work done and the cost of same placed as a lien on the property.

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councillors Russell, Mosher, Lynch, Herman, Tobin and Carter, also Town Solicitor Foster.

Minutes of last meeting were read and confirmed.

Gounce. Lynch's notice of motion re. installing meters at works of large water consumers of the town was taken up, and at his request deferred until the next meeting.

The Street Committee reported making the following recommendations;—

1. That the wall at Wm. Sullivan's, Rose Street, be repaired and a fence placed on same. 2. That the property of Wm. Smith, Eaton Avenue, be drained or filled in. 3. That the drain in front of F. S. Coombs' property, Crichton Avenue, be filled in and the water carried down the west side of the street. Report adopted.

The report of the Street Committee re. resolution to change the name of Quarrell Street to Queen Street was read as follows; - "Your Committee find that Quarrell Street was named after Colonel Quarrell, an officer of the British Army who lived in Dartmouth from the year 1793 to 1796. The practice of naming streets after men prominent in the history of the town, your committee think is a excellent one, and in view of the historical associations connected with the name Quarrell we cannot recommend that it be changed." This report was received.

The Auditors reported that they had examined the books and accounts of the Town Clerk and Treasurer to May 1st, and found everything in order and correct, and submitted duly certified statements of the several services of the town to that date. Ordered filed.

A petition was read from Jos. A. Nickerson and other ratepayers on Upper Water Street requesting that the sewer main be extended north as far as Mott Street. Referred to Water Committee to report upon.

The following letters were read; - From Miss Bessie M. Hutt, tendering her resignation as Deputy Clerk, to take effect July 15th, next. On

motion of Councrs. Lynch and Carter, the following was adopted;—
"Whereas, this Council has been apprised of the fact that Miss Hutt is soon
to resign her position as Deputy Clerk, and whereas, it is with a feeling
of deep regret that this Council has to accept the resignation, Therefore
Resolved, that this Council tender to Miss Hutt their high appreciation of
the valuable services rendered by her during her occupancy of the office."

From Resident Engineer, Canadian Govt. Railways, Truro, asking to be advised of the name of the street at which the town were laying sewer and water pipes, which were to cross under the railway track. After some discussion, on motion, resolved that the street referred to be known as "Tupper" Street, this action to be subject to deed of dedication to the town being given by the owners of the land.

From C. W. Rowlings, Halifax, complaining of being overcharged cab fare by a licensed cabman, No. 19. (John Myers). Referred to License 7. Committee to report upon.

The report of the Street Committee re. Quarrell Street was taken up and Councrs. Lynch and Russell moved that the report be adopted. Councrs. Herman and Carter moved in amendment "That the street now known as Quarrell Street be changed to Queen Street, and that signs be placed at convenient places on said street." The amendment was put and carried on the casting vote of the Mayor, the mover and seconder with Councr. Tobin voting for, the other councillors against.

The lease submitted by Mrs. W. L. Malcolm, of Halifax, owner of the property known as the "Cabmen's Shelter" was read, the terms being that the property would be rented for twelve months to May 1, 1916 for a Cabmen's Shelter at a monthly rental of \$8.33. After some discussion, Councrs. Tobin and Herman moved the following; - "Resolved, that the sum of \$100. be paid in twelve equal payments to Mrs. Malcolm for rent of Cabmen's Shelter, thru the Town Treasurer." Councrs. Lynch and Russell moved in amendment the following; - "Resolved, that the expenditure of \$100. authorized for the upkeep of the Cabmen's Shelter be left in the hands of the Police and License Committee to be used for the purpose named, provided suitable arrangements are made by the cabmen for the further maintenance and upkeep of the Shelter. The amendment being put was lost on the casting vote of

Mayor, the mover and seconder with Councr. Mosher voting for, the others against, and the motion being put, passed on the same vote reversed.

George Findlay's letter, submitted at last meeting, was taken up and referred to the Revisors of Jury Lists to report upon.

On motion of Councrs. Lynch and Carter, Resolved, that the clerk be instructed to write the Maritime Telephone Co. and the Dartmouth Electric Light Co. to have their poles painted at first opportunity.

On motion of Councrs. Lynch and Carter, Resolved, that the clerk be instructed to communicate with the department of Railways calling their attention to the dangerous condition of their fence on Upper Water Street and asking that it be repaired immediately.

On motion of Councrs. Lynch and Russell, Resolved that the vacancy soon to occur in the Town Clerk's Office be referred to the Finance Com. with the Mayor and Town Clerk to consider and report upon.

On motion of Councrs. Russell and Lynch, Resolved, that the Mayor of the Town of Dartmouth be authorized to issue debentures, under the seal of the Town, in the form as given in the Municipal Debentures Act 1914, under the provisions of Chap. 52, Acts of 1915, and subsequently to dispose of the same as the Council may direct, as follows;

Eight debenturesm each \$500. to be numbered from one to eight, both inclusive, in all the sum of \$4000. for the construction and equipment of Greenvale and Hawthorne Schools.

Three debentures, each \$500. to be numbered from one to three, both inclusive, for making up the loan on the new Consolidated Debt Bonds, for \$17000. issued December 2, 1914, under the authority of Chap. 97, Acts 1914.

Ten debentures, each \$500. to be numbered from one to ten, both inclusive, for the purpose of extending the water and sewer system in the Town of Dartmouth.

Ten debentures, each \$500. to be numbered from ten to twenty, both inclusive, for the purpose of extending the water and sewer system in the Town of Dartmouth as authorized by section 105, chap. 52, Acts of 1902.

Said debentures to be dated May 1, 1915, to bear interest at the rate of five per centum per annum, payable in twenty years from the date thereof, at the office of the Town Clerk, Dartmouth.

A number of bills were passed for payment and the Council adjourned. Approved

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councillors Russell, Mosher, Lynch, Herman, Tobin and Carter, also Town Solicitor Foster.

Minutes of last meeting were read and objected to by the Mayor on the ground that the minutes showed that the resignation of Miss Hutt was accepted as "Deputy Town Clerk". and it being the Mayor's view that the title should be "Assistant Town Clerk." On motion the minutes were deferred until the next meeting for confirmation.

The appointment to fill the vacancy in the Town Clerk's Office was laid over and the Town Solr. requested to furnish his written opinion thereon.

Councr. Lynch's notice of motion, deferred at last meeting, was taken up and deferred until the next meeting.

Petition was read from a number of ratepayers on Erskine Street, praying that the water and sewer mains be extended up that street to serve houses which they were about building. Referred to Water Com. to report.

The Finance Committee reported as follows; - -

- Re. Dr. Gandier's assessment. In view of the fact that the Assessors report that the \$800. assessed to him was a clerical error, your committee recommend that his assessment be reduced from \$800. to \$400. this being the usual amount assessed to him for personal property.
- 2. Re. Rev. G. S. Carson's assessment. Your committee cannot recommend any change in the assessment in this case as Mr. Carson was a resident of the Town and owner of personal property when the assessment was made.
- Re. notice from the Provincial Government that the Town's share of the War Tax would be .10¢ per \$100. on the total assessed valuations of the town,

your committee recommend that the town's share, viz, \$2644. be borrowed from the Royal Bank and paid not later than the 31st of December, 1915, and that the amount be assessed for next year.

- 4. In reference to increase in salary asked for by Messenger Loundes, your committee recommend that his pay be increased by \$1.00 per week, to date from June 1, 1915.
- 5. Your Committee are of the opinion, in view of representations made to them re. janitorship of the Town Hall, that one person be appointed to do the cleaning and furnace work, and recommend that Edward Borden be engaged for that service to date from July 1, 1915, at \$14. per month.

 This report was adopted.

The Street Committee reported as follows:-

- 1. Your committee, to whom were referred the tenders for cement, recommend the acceptance of the tender of Jas. Simmonds, Limited, at \$2.00 per bbl.
- 2. That the street now owned by Mr. S. A. Hiseler, running off Hawthorne St. be taken over by the town and the ground used for grading Beresford Avenue.
- 3. That the eastern end of Erskine Street be opened up and graded.

 The first clause of the report was adopted. The second and third clauses were referred back to the committee to consider further and report.

The Water Committee reported as follows;-

1. Your Committee submit herewith statement showing Receipts and Expenditure of the Water Maintenance Account for the year ending May 1, 1915, which shows a balance to the credit of this account of \$1505.02. We also submit the estimates for the year ending May 1, 1916, by which it will be seen that the net amount to be assessed on property, after deducting Special Rates, Interest etc, is \$6558. and on a basis of the same rates as last year, viz, Dom. Rate .40¢, Pipe Rate .15¢ and Hydrant Rate .10¢ there will be received \$6241. being In view of this small balance and the \$317. less than the amount required. probable increases expected during the coming year from Special Rates, your committee advise that no increase be made in the water rates this year, and recommend that the above rates be levied for the current year ending May 1/16. 2. Your Committee would recommend that the sewer extension asked for by E. H. McElmon and others be made to start from Upper Water Street at the foot of Best St. southerly to houses owned by John Forsyth, also easterly along

Nott Street 125 feet to E.H. McElmon's new house, also that a 6 inch water pipe

be laid from Upper Water Street along Mott Street easterly to Mr. McElmon's house. The cost of this work is estimated by the Supt. at \$1527. Sewer Rates to be received from the property fronting on the east side of Upper Water Street and both sides of Mott St. will be \$800. after deducting interest on the cost and allowing for sewer rates there will be a deficiency of \$18. annually to make up, and your committee recommend that this amount be charged to Mr. McElmon and the other four users on Upper Water Street until the same can be reduced by the revenue received, as other dwellings are constructed on this line.

- 3. Your Committee recommend that a two inch galvanized iron water pipe be laid down on Crichton Avenue to extend from the termination of the present six inch pipe at Mr. Nottings' property, 300 feet to supply the residence of F. S. Coombs. The estimated cost is \$225. and your committee recommend that Mr. Coombs be charged \$20. per year for the service until such time as other dwellings are erected on this line.
- 4. Your Committee recommend that the Town Solr. be instructed to draw up the necessary agreements with the Town to be entered into between Messrs. Coombs. McElmon and others in the above connection.
- 5. There is pipe on hand sufficient for the above extensions with the exception of the two inch galvanized iron pipe, which will have to be ordered.

 Further supplies required will be 200 feet of 1 inch wrought iron water pipe for standpipes and one two inch valve.

John Myers being present, the order of business was suspended and he was given a hearing. He complained that the gutter fronting his property on Water Street was in such a condition that he found it difficult to get his teams in and out of his yard. Referred to Street Committee.

The following letters were read; From M. T. Murphy, representing the Dartmouth Water Supply Co. asking to be given a rate for a water boat supply. Referred to Water Committee.

From E. L. Ruddy Co. Halifax, asking for a license to post bills in the town. Referred to License Committee.

From Mrs. Grace L. Hiltz, complaining that the boundary post between her property and the Town was knocked down by some of the town employees. Referred to Street Committee.

From Secy. Halifax Board of Trade, stating that a conference would be held shortly to discuss the proposed "Daylight Saving Scheme" and requesting the Council to appoint delegates. On motion the Mayor and Councr. Tobin were appointed delegates.

From School Board asking for payment of the proportion of the School Estimate due to June 30, 1915. Ordered paid.

THEREFORE BE IT RESOLVED that this Council deem it necessary and expedient that debentures be issued for the sum of Ten Thousand Dollars, being the total amount authorized, for the purpose aforesaid, by said Section 105, and by said Section 8; that such debentures be numbered from 11 to 20 inclusive; be each of the denomination of \$1000.; bear date the first day of May 1915; be made payable twenty years from the said date at the office of the Town Clerk Dartmouth; bear interest at the rate of five per centum per annum, and be otherwise in the form required by the Municipal Debentures Act, 1914. And BE IT RESOLVED FURTHER that all of said debentures be prepared in the form and according to the terms required by the respective statutes in that behalf and as hereinbefore set out, and that the Mayor and Town Clerk be authorized to sign and countersign the same and to affix the corporate seal of the Town thereto, and subsequently to dispose of the same as the Council may direct.

Tenders for coal required for Town Buildings were laid on the table, and Councr. Tobin moved, seconded by Councr. Carter, that in view of the fact that the tenders included prices for the supply of coal for the schools, that the same be returned, to the tenderers. Noved in amdnement by Councrs.

Lynch and Russell, that the tenders be now opened. The amendment being put was carried and the tenders were opened. On motion of Councrs. Lynch and Russell the following was adopted; - Resolved that the tender of the Dartmouth Coal & Supply Co. be accepted for hard coal at \$7.25 per ton, and the tender of Thos Lahey for Reserve Screened Coal at \$5.14 per ton of 2240 lbs. for town purposes.

On motion of Councrs. Lynch and Carter, Resolved, that whereas it has been brought to the notice of this Council that efforts are being made to induce the Government to remove the Marine and Fisheries Dept. from Dartmouth to Halifax, and Whereas, this Council is of the opinion that the present location of the Dept. is an excellent one and its removal would seriously affect the best interests of the town. Resolved, that this Council strenuously protests against the removal of the Marine and Fisheries Dept. to Halifax. Further Resolved, that copies of this resolution be forwarded to Sir. Robt. Bordon, and Hon. Mr. Hazen, Minister of Marine and Fisheries.

A number of accounts were passed for payment.

At the suggestion of the Mayor it was agreed that he proclaim next Monday, June 21st, a Public Holiday in the town.

Town Council met this day at 7.30 p.m. Present Mayor Williams, Councrs. Russell, Mosher, Lynch, Tobin and Carter, also Town Solicitor Foster.

The following opinion of the Town Solicitor was read;-

Duties and Rights of the Mayor.

As the legal advisor of the Town I have been asked to give my opinion as to the duties and rights of the Mayor. In response I beg to cite the Towns' Incorporation Act, my reading of which is that the Mayor, by virtue of his office, is the chief executive officer of the Town, and I cannot come to any other conclusion than that all the other officers of the Town are under him and subject to his orders. (See. Chapter 71, section 34.)

Section 113 provides that the Town Clerk may, with the concurrence of the Council, appoint a deputy to perform any or all of his duties, and he shall be responsible for the acts of such deputy. This must be read to mean that the initiative must come from the Town Clerk. There is no special provision for the appointment of an "assistant" but I have no doubt but that he may temporarily engage such help as he needs.

Other Town Officers.

Sanitary Inspectors, Superintendents of Streets, and of Common and Public Property, Firewards, Fire Constables, Firemen, Policemen, Constables, Fence Viewers, Clerks of Marks, Measurers and Weighers, Surveyors and Inspectors of Lumber and Wood, Auditors, Assessors, Revisors of Electoral Lists within the Town, and all such officers as are necessary for the carrying out of the purposes of this Chapter. Chapter 71, sec. 126. These must be appointed by the Council. Special constables for the space of seven days may in certain cases be appointed in writing by the Mayor, Stipendiary Magistrate or any one or more of the Councillors. Chap. 71, sec. 250.

Received, and on motion of Councrs. Tobin and Mosher ordered to lie on the table until the next meeting, and the Clerk was instructed to send a copy to each councillor.

The report of the Chief Assessor and Town Clerk was read as follows

and adopted; Re. S.A. Hiseler's assessment. We find that the lots assessed to R. H. Smith, of Dartmouth, as Deputy Town Clerk, to date from July 15, 1915, and now ask you respectfully to be pleased to concur in said appointment. Mr. Smith informs me he is willing to accept the office."

Moved by Councr. Lynch, seconded by Councr. Russell, "That this Council concur in the appointment of William T. Smith as Deputy Town Clerk." Passed four to one, Councr. Tobin objecting. Councr. Tobin gave verbal notice of reconsideration.

On motion of Councrs. Russell and Lynch, Resolved, that the salary of the Deputy Town Clerk be fixed at \$800. per annum. Passed four to one councr. Tobin objecting.

Letter was read from E. J. Tobin, withdrawing his application as assistant in the Town Clerk's Office. Ordered filed.

Letter was read from Premier Borden stating that he was not aware of any movement to change the offices of the Marine and Fisheries Dept. from

Dartmouth to Halifax. If the Dept. were considering such action they would no doubt have communicated with him. Ordered filed.

Petition was read from ratepayers on Tulip Street, praying for the putting down of the main sewer along that street west from Oak Street. Referred to Water Committee to report upon.

Number of bills were passed for payment and the Council adjourned. Approved.

Town Council met this day at 7.30.p.m. Present Nayor Williams, Councillors Russell, Mosher, Lynch, Herman, Tobin, and Carter, also Town Solicitor Foster.

Mayor Williams read the following message to the Council;-

Town Council of the Town of Dartmouth, Gentlemen; -

The practice of formally addressing the Council by way of a message to Council has not often been resorted to by Mayors of this Town, although the practice is common enough in the City of Halifax and in other places. A situation has arisen, however, with respect to the affairs of the Town, which I deem sufficent justification for now communicating to you this formal message.

The Meetings of this Council have not, of late, proceeded with that degree of decorum which, in my judgment, it is not only reasonable, but necessary should prevail at meetings of those who are charged with the conduct of the affairs of a Town of the importance of Dartmouth.

Sharp differences of opinion have arisen and been expressed. Sharp language has been used upon the floors of this Council. I am not attempting to put the blame in any particular place, nor am I attempting to say that the blame lies entirely on those who occupy the seats on the floor of this Council. I am merely stating conditions which in my judgment it would be well that all of us should immediately set out to remedy.

it would be well that all of us should immediately set out to remedy.

As a step towards this object, it is my intention to formally state my stand upon certain matters of difference, so that these matters may be taken up forthwith and disposed of. Thereafter the Town Council will be better able to address itself to new matters which are constantly arising and which the interests of the Town should have attention.

and which the interests of the Town should have attention.

I shall in the first place, refer to the difference respecting the school assessment. I mention this merely to congratulate the Council that, notwithstanding the rather acrimonious discussion respecting this matter, it stands settled. It is not of any importance whether or not it was settled to the satisfaction of any or all of us. The point for congratulation is that it has been settled and is out of the way and no longer troubles our deliberations.

Another cause of difference was the action of the Chief of Police in refusing to abide by my directions, contending, as he did, that he had been notified by the Police Committee not to do so. The Recorder, having been appealed to for an opinion as to the obligations of the Chief in that connection, has ruled that the Chief of Police is subject to the directions of the Mayor, and I am assuming that he will in future obey these directions. If he shall so do the past will be as if it had never been. If he shall not do so I shall suspend him, recommend his dismissal, and rely upon the Council, that, in the interests of good government of the Town and to insure the future proper conduct of the Town's officials, it will support my action. All that I shall ever demand of the Chief of Police or of any other official of the Town is that he obey the lawful orders of his superior and do his best within his sphere in the interest of the Town.

Another subject matter of difference was the recent appointment by the Police Committee of a Town constable or extra policeman. For a long time I was doubtful as to what was this appointee's status. The Towns Incorporation Act does not justify or permit the appointment of a policeman except upon a vote of the Council. A man was appointed by the Police Committee to perform the duties of a policeman. He might have been appointed by the Mayor or any other member of the Council in an emergency to act as a constable for a week. If he was appointed as other than a constable for a week his appointment was illegal. He acted for a period and demanded payment for his services. Considering the appointment illegal, I refused and shall continue to refuse to sign acheque upon the Town's finances for his payment. He has recently been legally and properly appointed by the Council as an extra policeman and is now legally acting as such. I shall sign cheques for payment for his services since his legal appointment, I cannot go further on his behalf. I have consulted counsel and have been independently advised that I cannot without incurring personal liability, sign any cheque for payment for the man's services during the period when he was illegally acting. My personal desire is to pay the man but I can only pay him out of town funds when so authorized by the Act of the Province of Nova Scotia. To indicate to the Council that my stand, as respects this matter, has not been from mere stubborness, or any aversion to the man being paid, I now express my opinion that the Town could, with propriety and, in fact, aught to approach the Legislature at its next session and ask for special authority to rate upon the Town and to pay the amount which the Police Committee agreed that they would pay the man during the period that he was illegally acting.

The last matter of difference to which I shall refer is that of the appointment of a deputy Town Clerk. The Clerk of this Town, assuming to act under Sec. 113 of the Towns Incorporation Act, which provides that the Town Clerk may, with the concurrence of the Council, appoint a deputy to perform any or all of hid duties and he shall be responsible for the acts of such deputy, has appointed a deputy with the concurrence of a majority of the Council, and the Council, by a majority, has resolved that this deputy be paid a salary of \$800. per annum. I took the stand in Council that the Town could not lawfully pay a salary to a deputy clerk; that a deputy clerk could only demand payment from the Town Clerk personally. I realized as fully as any member of the Council that the Town Clerk needed assistance and I was willing that the Town should pay for such assistance. But, as in the other cases already mentioned, in this Message to Council, T was of opinion that there existed a legal difficulty. I contended that the proper course for the Council was to spooint not a deputy but an assistant to the Town Clerk within his office.

However, realizing that within a short time I would be faced with a demand to sign a cheque or cheques for the payment of the salary of the Deputy Clerk appointed by the Council, and not being desirous of being subjected to a suit at the instance of any citizen because of having illegally paid such a salary, for my own personal protection I have taken a legal opinion to myself personally as to the legality of the appointment by the Council of a deputy Clerk who is to be paid out of Town finances. I have been advised that the stand taken by me in Council was correct. The opinion given me is as follows:-

 the Town Clerk may, with the concurrance of the Council, appointa
 deputy to perform any or all of hid duties, and he shall be

 All that the preceding section authorizes is the substitution by the Town Clerk, with the expressed consent of the Council, of a Clerk who shall act in place of the Town Clerk, performing the auties of the Town Clerk and subject to him and payable by him.

 It is the familiar statutory provision authorizing one person to

" act for another. It does not give authority to either the Town
" Clerk or the Town to appoint an additional officer of the town,
" The Deputy, when appointed, is not, strictly speaking, the Town's man.
" He is the town clerk's man. The Towns Incorporation act nowhere

" authorizes the payment of a salary by the Town to such deputy. If

"the deputy is to be paid he must be paid by the town clerk.

"By virtue of Section 126, however the Council may appoint

other officers where the appointment is necessary for the carrying

out of the purposes, of the Towns Incorporated Act. Within these

purposes of course would be included the provision of necessary

assistants in the various town offices. Accordingly we are of

opinion that the appointment of an assistant in the Town Clerk's

office would be legal if the necessity mentioned exists, and the

Town is in funds to pay. The Town Clerk would not be under any

obligation to pay the salary of an assistant. Neither would the

Town Clerk have the privilege of nominating or appointing such

assistant. The matter would be wholly under the control of the

Council.

"There is avery clear and reasonable distinction between "Secs.113 and 126 of the Towns Incorporation Act. Under the first "mentioned section the town clerk pays the deputy's salary. Under "Section 126 the Council is itself the appointing power and pays the "salary.

"We have said that, even as pespects the appointment of an assistant town clerk, such can only be appointed by the Council when there is a fund out of which the officer can be paid.

"By Section 132 of the Towns Incorporation Act the salaries
"of officers and servants of the town are raised by way of a rating
"of the town inhabitants. If in your last assessment there was rated
", and remains unexpended, a sufficent sum to pay any salary agreed to
"be paid to any Council-appointed assistant town clerk the appointment

" would be legal- otherwise not.

In view of the foregoing I have considered it necessary to place the situation fully before the Council and to advise the Council that I cannot, and will not sign any cheque for the payment of any salary to the deputy town clerk as such. I do not object to the present appointee to the office. If the Council will expunge from the Town's records the appointment of the official mentioned and will, in conformity with the law, appoint the same man as an assistant to the Town Clerk, thus constituting the appointee an officer of the Town as distinguished from an employee of the town clerk payable by the town clerk, I will, as in law bound, recognize the appointment and sign cheques for the agreed salary. Otherwise, for my own protection, I must follow out the legal opinion given me.

All of the preceding is put before the Council in the spirit mentioned in the earlier portion of this message and I bespeak for this same

message your calm and careful consideration.

Application read from Alfred J. Day for a Taxi-Cab license to run one Automobile in the Town of Dartmouth for year ending March 1st, 1916. On motion same was granted, fee to be \$8.00.

Councillor Russell gave notice of motion as follows, Resolved; -That the resolution passed at the meeting of June 25th, fixing the salary of Deputy Town Clerk at \$800 be rescinded,

On motion of Councrs Lynch and Mosher the following was

In the opinion of the Town Council of Dartmouth the passenger service on the Dartmouth Branch of the Intercolonial Railway is very unsatisfactory to the citizens of the Town, on account of the early hour of departure of the morning train, and also on account of the impossibility of making connections with the outgoing trains from the City of Halifax.

This Council is of the opinion that the needs of the Town so far

as they relate to train service were better served under the old schedule.

The suburban traffic which under the old schedule had increased to a large extent, has under the present time-table been almost completely eliminated, thus causing not only an inconvenience to people residing along the line of railway, but a serious loss to the business men of Dartmouth.

This Council is also of the opinion that citizens of Dartmouth were discriminated against and treated very unfairly by the Department of Railways when they caused the train which under the old schedule did service only on the Dartmouth Branch of the I.R.C., to be transferred during certain periods of the day to operate suburban traffic to and from the City of Halifax. This Council is of the opinion that if the Dartmouth train were released from performing suburban service to the City of Halifax, the Town of Dartmouth would then secure a better train service.

Resolved:— That the Clerk be instructed to communicate to the Department of Railways, asking the Department to change the schedule at present in force on the Dartmouth Branch of the Intercolonial Railway, and putting in operation a time-table that will give a more reasonable hour for the departure of the morning train, better connection with outgoing trains from the City of Halifax, and one that will give a more convienent suburban service to and from the Town of Dartmouth. Further Resolved:—That a copy of the resolution be forwarded to Sir Robert L. Borden, and the Minister of Railways.

The clerk was instructed to write the Provincial Secretary, and ask whether the new by-laws in regard to Hackney Carriages and Bill Posting had yet been approved by the Lieut-Governor-in-Council.

Councillor Lynch moved that the Council adjorn to Monday next at

Opinion of Town Solicitor Foster was read re Police Committed's report as follows ;-

By Sec. 37 of the Towns Incorporation Act, standing committees may report to Council any "special circumstances in respect to the services under their charge".

The report of the Police Committee, aside from the objections raised by the Mayor as to the tenor thereof, is unquestionably authorized by said Sec. 37.

The Mayor has ruled it out of order on the ground that it

contains improper reflections upon himself.

Council has asked for a ruling from the Recorder as to the

Mayor's decision.

The ruling desired, of course, is a ruling as to the law. A chairman of any meeting may rule out of order any report or motion containing scandalous, scurrilous, defamatory or such What is such matter can only be decided by the chairman. It is a matter of fact and not a matter of law. That would be objectionable to one chairman might not be objectionable to another The safe course is to so provide that the language shall not be open to reasonable objection.

The ruling therefore is-

(1) According to law the Police Committee may report the

matters reported.

(2) Whether in so reporting they have used exceptionable language is not a matter of law for decision by the Recorder, but a matter of fact for decision by the Mayor. If in his judgment the report comtains offensive matter he may, for that reason, rule the report out of order. If a majority of Council shall thereupon require of him in writing to put a motion that the report be read the report must be read, and the Mayor's only recourse is to leave the chair which, if he desires to avoid taking part in what he may deem to be a vote of censure directed against himself, he may properly do.

Report of Police Committee was read, including legal opinions of

T. Notting and T. S. Rogers as under: -

His Worship the Mayor and Town Council. Gentlemen: -

The Police and License Committee deem it to be their duty to present to Council a synopsis of the different matters dealt with by the Committee during the past few months. The Committee feel that this is especially necessary in view of the discouraging criticism and costigations cast upon the committee by His Worship Mayor Williams.

In the month of February Alfred Wirrell, a policeman officer, vacated his position, and the Police and License Committee, following a practise that has been in vogue in the Town for the past thirty years appointed Arthur Emery as temporary of ficer, Mr Emery served about one month, and resigned. The Committee following the usual practice appointed Elwin McKay as temporary officer. In order to prove that the judgment of the committee was good in this appointment, I might state that McKay was afterwards made a permanent official by Council. Now although McKay was appointed by the Police Committee and not by Council, I feel convinced that every individual member of Council knew of the appointment. The Committee cannot understand what process of reasoning induced the Mayor Committee cannot understand what process of touseness and committee to sign a cheque for Emery's services and refuse to sign a cheque for touse to sign a cheque for Emery's services and refuse to sign a cheque for the same manner. I would McKay's, both appointments were made in exactly the same manner. I would like to point out to Council, that in appointing McKay the Committee did not contract an expenditure for which no provision had been made.

In respect to the controversy between His Worship the Mayor and this Committee in regard to control of police officials, the Committee beg to report as follows;-In the year 1897 the Police Committee drew up.a set of regulations defining the duties of the police officials, and section 2 of these regulations places the control of the officials in the hands of Police Committee, These regulations were adopted by the Council of that date, and have the same force and effect as if approved by the Governor-in-Council, the Committee with all due deference to His Worship cannot and will not relinquish control of the Police, unless the

resolution of 1897 is resoinded

In regard to the attendance of an Officer at meetings of Council, the Committee consider that the ratepayers of the Town will be better served if the officer performs his regular duty of patrolling the Town, and seeing that the laws are not violated.

The Committee in order to accrtain if their stand was correct decided to secure legal opinions. The opinions of Messrs Rogers and Notting should be sufficent to convince the Council that the Committee are perfectly justified in the stand they are taking (Opinions annexed to Report). We would ask Council to endorse this report, and confirm the opinions of Messrs Rogers and Notting.

Dear Sir:-

I understand you are a town councillor of the Town of Dartmouth and a member of the police committee and you desire my opinion as to the powers of the police committee over the police of the Town, with particular reference to the powers of the Mayor over the police force.

The Town's Incorporation Act(section 244) empowers the Town Council from time to time to appoint a sufficient number of fit, and able men as police officers of the Town and there follows certain provisions (section245-249) conferring upon the police very ample powers enabling them to discharge their various duties.

Section 36 of the Act enables the Council to appoint

standing committees from amongst its members for such purposes as the

Council by by-law determines.

Under the By-laws provision is made for the appointment of various standing committees and among them a committee on police and licenses. (By-law 18)
By-law # 98 provides:
"The Police Committee shall make all such rules and regulations
"The Police Committee shall make all such rules and regulations

" as shall in their judgment br necessary from time to time for

the direction of the police constables with respect to the duties

" of their office, and may amend and repeal such rules and " regulations from time to time as may in their judgment be deemed

"advisable, provided that such rules and regulations shall be subject to the approval of the Council and may at any time be altered, amended, added to or repealed by the Council.

Under this by-law the police committee some years ago enacted such rules; and regulations as they thought necessary for the

of the police with respect to their duties. By section 34 of the Town's Incorporation Act the Mayor is declared to be chief executive officer of the Town and he is required to be active in causing the laws of the Town to be duly executed, to cause all carelessness in violation of duty to be punished and to communicate to the Council information in this regard, and to recommend all such measures as may tend to the improvement among other things of the police of the Town. This section hardly confers upon the Mayor any greater powers than would be implied from his office even if there

was no statutory provision in that regard.

I have considered the Act carefully, and I do not find any specific powers conferred upon the Mayor which would enable him to direct the Chief of Police or other police of the Town in a manner not in accord with the regulations of the police committee from time

to time.

Generally speaking the duties of the police are provided for by the sections of the Town's Incorporation Act already referred to Consistently with these requirements and with any specific duties imposed upon the police at the time of their appointment, the police committee must have power to direct the police force in relation to their various duties as officers of the Town.

Should there be any conflict between the action of the Mayor in relation to the police force on the one side and the action of the police committee on the other I can hardly think of circumstances which would justify the Mayor in overruling the direction of the police committee. Of course, you will understand that it is difficult to decide every conceivable case without having the exact circumstances submitted. In any event it is quite clear that in case of any such conflict of authority the Town Council itself is the statutory body with which the ultimate decision must rest.

Section 36 of the Town's Incorporation Act provides that the Council shall appoint from its members standing committees for such

purposes as the Council by by-law determines.

A by-law, (No. 18), was adopted requiring the appointment annually of a committee on police and licenses; and a further by-law,

(No. 196), provide as follows:The Police Committee shall make all such rules and "regulations as shall in their judgment be necessary from time "to time for the direction of the police constables with respect "to the duties of their office, and may amend and repeal such "rules and regulations from time to time as may in their judgment "be deemed advisable, provided that such rules and regulations "shall be subject to the approval of the Council and may at any "time be altered, amended, added to or repealed by the Council".

Under the last mentioned by-law regulations for the direction of the police were made by the police committee and approved by the Council; one of these regulations provides for the control of the

police by the police committee.

Section 34 of the Town's Incorporation Act declares the Mayor to be the chief executive officer of the Town and requires him to be vigilant at all times in causing the law for the Government of the Town to be put in force, to inspect the conduct of subordinate officers, cause violation of duty to be punished and to communicate to the Council from time to time information with respect to same and recommend such measures as may tend to the improvement of the different I do not think it can be successfully contended services of the Town. that this section gives to the Mayor control of the police nor do I find anything in the Act which gives the Mayor that power. Re Widows exemption: Section 9. of Chapter 52, Acts of 1915, was intended to extend the exemption from taxes to widows residing upon property within the Town of Dartmouth in cases where no son or other male person of the full age of twenty one years resides with her, and was not intended to apply to such a case as cited by Mr. Congdon in his letter of the 24th, inst. Section 11. Chapter 56, Acts of 1902 provides "The assessors shall also insert on the roll the names of all yearly tenants in occupation of real property assessed". Mr. Congdon states that "the practice has been to assess all property to the owners" which is a good rule to work under, but I would suggest that the assessors use such judgment as will as far as possible carry out the spirit of the law.

Re Saunders and Duffus:— I am of the opinion that the Town is liable for cost of glass broken in R.H. Bissett's Shop by Town workmen.

On motion same was received and clerk instructed to send copy of the clause re Assessment to the Assessors.

The Street Committee were authorized to have glass broken in Bissett's Shop replaced.

Hetter read from Fred Walker complaining that S. Williams and family, tenants in his house on Windmill Road were in poverty and that the place was in a very dirty condition, and requesting that the Town remove the tenants. Referred to Committee on Charities and Dr. Payzant, Health Officer to deal with.

This would cost \$300. As there are three properties the charge would be \$6. per year each, to decrease as enough houses are built to pay interest on cost of installing the regular water & Sewer Mains.

- That the following special rates be fixed, Viz,
 - A. In the case of houses using town water where the house is not connected with the Water Mains. \$2. per year.
 - B. For the Marine and Fisheries Works, 10φ per ¥ gals, with a minnimum rate of \$100. per year. (including fixtures in their building now connected on their property)
 - C. For the Williston Steel Foundry Company. 15¢ per # gals, with a minnimum rate of \$25. per year.
 - D. For E.H.McElmon's Mill. 15 ϕ per M gals, with a minnimum rate of \$30. per year.
 - E. For Calder Fraser & Co's Mill, 15¢ per M gals, with a minnimum rate of \$30. per year.
 - F. That the rate for W.C's be reduced from \$2.50 to \$2.00 per year from May 1.1916.
- 3. In view of the fact that the valuation of property not fronting on a Water pipe line, but within 750 feet of a Fire Hydrant is now only \$53.800, and the revenue but \$53. per year; Your Committee recommend that the collection of a Water rate on such properties be suspended this year.
- 4. Halifax Breweries, Ltd, As the meter attached to the pipe supplying Water to the Company's Brewery broke down during the half year ended May 1.1916., the water used did not register. The Company offer to pay for the quantity of water used for a similar period in previous years, this amount would be \$180., and your committee advise that the same be accepted.
- 5. That the DGMINION MOLASSES COMPANY'S bill for water \$239.55 supplied them thru a meter for the half year ended May1.1916 be reduced to \$120. as the Company have protested against the charge made them; The large quantity registered, your Committee are convinced was caused by a leaky pipe.
- 6. Your Committee herewith submit statement showing Receipts and Expenditure of the Water Maintenance Account for the year ended May 1.1916., showing a credit balance of \$2967. We also submit an estimate of the Revenue and Expenditure for the year ending May 1.1917., by which it will be seen that the net amount to be assessed on property after deducting Special rates, Interest, etc. is \$3243. In view of the reduction in the amount required this year, Your Committee are pleased to report that a reduction in the rates can be made, besides the reduction of 50ϕ per year for W.C's, and Your Committee recommend that the Domestic rate be 25ϕ this year, and the pipe rate 10ϕ per year, in all 35ϕ ; this rate gives a minimum charge of \$2.80, with W.C. added \$2.00. in all \$4.80, the lowest yet in force

Your Committee recommend that the above rates be levied for the Water year ending May 1.1917.

Report adopted with the exception of Clause 1. which was deferred .

TOWN BOUNDARIES , Town Solicitor Foster's opinion re the letters

received from the County Clerk on this subject was read as

follows:- On or about the 26th of October, 1915, William B.Nokenzie, Consulting Engineer, was employed by the County of Halifax and the Town of partmouth to define the boundaries between the County of Halifax and the Town of Dartmouth. It appears that some difficulty was experienced in deciding upon the man and it was finally suggested by Warden Smith on behalf of the County, that Mr.Nokenzie should be employed, and this was agreed to Mr.Elliot, Town Clerk, by telephone, on behalf of the Town. These are the facts as far as I can learn.

Mr.McKenzie appears to have performed the work as far as he was able, has made his report, and has presented his account for services rendered and expenses incident thereto. This account amounts to the sum of \$666.80 and it has been paid in full by the County without question. The County now asks the Town of Dartmouth to pay its half, namely \$333.40.

I am of opinion that there was a clear contract between the County of Halifax and the Town of Dartmouth of the one part and William B. McKenzie of the other part and therefore the Town is laible to pay its proportion. As to whether the report has been accepted by the Council or not matters not, it does not affect the question at all, Nr. McKenzie was

engaged to do certain work, which he did presumably to the best of his ability, and is entitled to be paid.
