#### 1.0 1990 BUDGET PROPOSAL REVIEW

BUDGET REVIEW

REVENUES

Council began the 1990 operating budget review, beginning with section B., the Revenue section. Mr. Corrigan was present to provide additional information, along with Mr. Walsh and Mr. Smith.

Pages B-1-1 and B-1-2 (Residential, Commercial & Business Occupancy Taxes) received considerable attention, in relation to the concerns of Council about the impact of assessment appeals and the adequacy of the \$500,000. allowance for 1990 appeals. Several members were in favour of increasing this amount to 1.5 million dollars, which they considered to be a more realistic figure, taking into account that 1990 appeals amount to almost a billion dollars. They asked

\*\* to come back to a decision on the allowance figure before any decision is made on the 1990 tax rate.

(Ald. Connors was present from this point in the meeting.)

Page B-3-3: Mr. Corrigan advised that the figure shown on page B-3-3 (\$725,000.) should be increased by \$15,000. A motion to make this change was presented.

MOTION: To change the 1990 estimate on page B-3-3 (Grant in lieu of Taxes: Province of Nova Scotia) to read \$740,000.

Concerns that this revenue item exceeds the matching expenditure in the Engineering Dept. budget, were discussed with Mr. Smith and Mr. Corrigan.

\*\* Page B-6-13: Additional information was requested by Ald. Hawley from the Planning Dept. on the figures shown for the revenue item Other Planning, page B-6-13. He questioned both the 1990 estimate and the 1989 budget figure, asking why they are so low.

Page B-7-2: Ald. Billard noted the considerable difference between the cost of dog services and the revenue received by the City in fines and license fees. He asked that this item be given further attention before the tax rate is decided, to determine whether or not license fees need to be increased this year; also, to take into account the tenders for animal services, which are likely to come to Council in the meantime.

Page B-9-1: A recommended \$10. increase was noted for Tax Certificates, page B-9-1, and a motion was presented to approve the increase.

\*\* Page B-9-3: Ald. Billard asked to see the Marina Fee schedule, and suggested that fee increases for the marina should be considered, to bring them in line with other locations on the harbour.

Page B-10-1: Parking rate increases have not been recommended for 1990. The question of the rate paid by City employees was raised by Ald. Pye, and Mr. Smith suggested that Mr. Muzzin or Mr. Burke could provide further information on the collective agreement provision that covers employee parking rates. Ald. Billard and Connors asked to have this item given

\*\* further attention at a later point in the budget discussions.

The meeting was chaired by Mayor Savage from this point onward in the meeting.

Page B-16-2: Ald. Pye felt the City is not receiving the revenue warranted for Firearms Acquisition Certificates, as reflected in the \$5,000. budget estimate on page B-16-2. He requested that the Deputy Police Chief and the Mayor discuss the item further.

Page B-16-4 & B-16-5: Ald. Hawley felt the City should be receiving more than we presently are for the Highway Maintenance Grant and the Conditional Snow Removal Grant (applicable to Provincial highway sections), and <u>asked</u> \*\* that the Mayor forward a letter, seeking to have these

grants increased for Dartmouth.

At the conclusion of the Revenue section review, Ald. Connors stated his concerns about additional budget requirements that Council is likely going to have to deal with, such as the assessment appeal allowance, the cap for Social Services, and the projected School Board deficit. He considered a tax rate increase of no more than 4% to be acceptable, even taking these

BUDGET REVIEW

At the opening of the meeting, Ald. Connors rose on a point of information, to advise Council of a change in the City deficit figure for 1989, resulting from the payment of grants in lieu of taxes, owed by the Federal Government, in the amount of \$1,107,532. The two-million-dollar deficit figure for 1989, as reflected originally in the Financial Statement for that year, is therefore reduced by the amount of the payments received, to a figure of \$911,155.

In this report to Council, on behalf of the Audit Committee, Ald. Connors noted the considerably improved financial picture for the City, in relation to the 1990 budget discussions, because of this reduction in the deficit. The 1989 Financial Statement, with this change, will be presented by the auditors at the March 27th meeting of Council.

In view of the information that has been received on the City's 1989 deficit position, Mr. Burke requested permission to make certain adjustments to his report of March 16/90, setting out tax increase scenarios requested by Council at the March 6th meeting.

Ald. Connors picked out a number of estimates throughout the Engineering budget for items such as supplies, tools, conferences, contract services and so on, suggesting that it would have been preferable to see these items in a consolidated form, so they could be assessed more effectively by Council. He asked to \*\* have a consolidation of this information, if possible.

Page C-5-8: Technical Services: Ald. Rodgers asked for a follow-up by Mr. Burke to his question about a 12½% salary adjustment reflected in these estimates He raised similar questions about the percentage increase projected in the page C-5-10 (Inspection) estimates.

Page C-5-12: Building Services: Ald. Hawley suggested that maybe Council should look at increasing rental rates again, and Ald. Woods asked about the follow-up report that was to come to Council on the condition of City-owned buildings and repairs required to them.

\*\* The Mayor asked Mr. Rix to have the report to Council by July of this year.

Page C-5-17: Solid Waste Collection (Contract):Ald. Levandier objected to the termination of garbage collection services for merchants in the downtown. Ald. Connors had information on possible arrangements for reinstating this service, to be discussed with Ald. Levandier further.

Ald. McCluskey and Connors were concerned about the garbage collection policy for condo units, since the new tipping fee was implemented, and felt it should be looked at again; they considered that people living in these units are now being treated unfairly.

Ald. McCluskey suggested that paper could be saved by the City if new Internal Directories were not printed each time in their entirety, but instead, a single correction page of changes could be printed and attached to existing directories. She asked that \*\* consideration be given to this suggestion.

Page C-5-19: Solid Waste Street Cleaning: Ald. Rodgers had questions about the street cleaning program in the City and its effectiveness. He felt there should be better service over a broader area of the City, rather than concentrating so much of the service in the downtown. Mr. Murray explained the program that is planned to address some of the concerns raised.

Ald. Connors asked for a break-down of the 2,419 km. figure shown on page C-5-19 for street sweeping. He also felt the City should be reimbursed for expenses that will be incurred as a result of the new tipping fee policy, and that a request for reimbursement should go forward to the Metropolitan Authority. He said that at some future point in the budget discussions, he would present a motion to this effect. Mayor Savage said he would be willing to bring the matter to the attention of the Authority.

At the hour of 10:30 p.m., Council went in camera, on motion of Ald. Greenough and Thompson.

REVIEW OF FINANCIAL STATEMENTS Present for the Auditors' review of the 1989 Financial Statements for the City, were: Mr. R. Jamieson, Mr. J. Mullowney, and Mr. M. DuPlessis. The Statements had been previously circulated, and at this time, the Auditors circulated a presentation summary for Council to follow as the review proceeded.

Introductory remarks were made by Ald. Connors, Chairman of the Audit Committee. He advised that the Committee has met and dealt with the Statements in detail, and he asked for Council's approval of them.

> <u>MOTION</u>: That the Financial Statements for the City for 1989, be approved as presented.

Moved: Ald. Connors Second: Ald. Billard

During his presentation, Mr. Mullowney indicated to Council that the deficit position of the ferry operation will require further attention, and this point was raised in debate by Ald. Levandier and Hetherington. It was suggested that the feasibility of integrating the ferry service into the metropolitan transit system should be considered, also, possible service modifications that would reduce operating costs. Ald. Levandier suggested that the Transit Advisory Board begin to study these suggestions and make recommendations back to Council for discussion.

Ald. Pye made the suggestion that in future Financial Statements, the Pollution Control item be given a separate page, as a means of highlighting the fund and interest revenue being accrued by it. This suggestion was noted by Mr. Mullowney.

In response to a question from Ald. MacFarlane, regarding the Water Utility surplus, Mr. Mullowney explained that these surplus funds could be returned to the City in the form of a dividend, especially in view of the fact that funds were previously taken from the City's operating account to assist the Water Utility, and a return of funds would represent a repayment to the City by the Utility.

The Mayor proposed that Council spend a meeting in May or June, discussing the subject of cross-harbour traffic and transit in its entirety.

After the motion on the floor was defeated, Council resumed their page-by-page review of the Engineering & Works Dept. budget, beginning at page C-5-21. Members of the Department, who attended the March 20th meeting of Council, were present again to assist with the review.

<u>Page C-5-27</u>: Streets (Paved) Bridges: Ald. Hawley asked when paving of the MicMac Parclo will begin, and the Mayor requested that Mr. Fougere find out about the completion of this project, including the work required on Braemar Drive, the sidewalks, and landscaping, for a report to Council.

Ald. Greenough noted that there is still work to be completed at the Caledonia/Main Street intersection. He requested an update on the schedule for completing the project. Page C-5-30: Streets - Sidewalks, Walkways, Curb Repairs: Ald. Thompson requested that some provision be made to assist a resident on Bellevista Drive, in a wheelchair, who is having trouble getting onto and off of streets in that area; Mr. Fougere noted the request.

(Ald. Rodgers was present from this point in the meeting.)

Several Aldermen were concerned about any cutback in the page C-5-30 activity, this being one of the areas listed in Mr. Burke's original report to Council; the reduction proposed is in the amount of \$20,000. for brick sidewalk repairs. There was quite a number of questions about the problems with brick sidewalks and the on-going maintenance costs associated with them. Ald. Connors asked to have this item flagged \*\* for Council's further consideration at a later point.

Page C-5-31: Ald. MacFarlane and other members felt that greater attention should be focused on the present street repair backlog (sidewalks, curbs, etc.). He \*\* requested information from the compilation of infrastructure conditions, for his own ward. Ald. Connors said he would like to see a report, based on the infrastructure assessment, giving information details on a street-by-street basis, so that the condition of sidewalks on individual streets could be pinpointed more accurately.

While this subject of infrastructure assessment was under discussion, Mr. Fougere provided information on the Infrastructure Management System, and explained the importance of the Capital-out-of-Revenue item on page 1-23 of his budget, in this connection. Ald. Billard had previously questioned the merits of this item, suggesting the budget allocation of \$15,000. could be used to better advantage under the page C-5-30 activity.

Ald. Walton asked about City liability in the case of streets that need repair, and also, resulting from a lack of adequate snow and/or ice control. The Mayor \*\* asked that this question of liability be referred to the Solicitor for comment.

Ald. Levandier suggested that level 3 on page C-5-30 should be flagged, to be reconsidered, in order to be able to carry out all of the backlogged work referred to on this page.

Page C-5-34: Waste Water (Sanitary) Sewer Maintenance: Ald. Woods had questions about the adequacy of City response to citizen requests for assistance under conditions of residential flooding. He felt the Works Dept. should have wet/dry vacs. to assist with clean-ups after flooding. Mr. Murray advised that the operational policy to be followed in these situations

will be coming to Council for discussion and approval.

Ald. Connors asked for an explanation of the 24% increase in the figure for contract services on page C-5-34. Mr. Murray said the new tree-root policy has resulted in this increase. He responded to further questions from Ald. Connors about the use of contractors in these projects, which cannot be done entirely by the City. Ald. Connors continued to indicate his concern about this budget item and was not satisfied with the information provided.

Ald. Pye requested a rationalization of the figures representing money that is being collected through the waste water management charge, as compared with money being spent. The Mayor asked Mr. Fougere to bring a report, with this information, sometime in \*\* April.

Page C-5-45: Emergency Coordination (Winter) Snow Removal: Ald. McCluskey indicated her objection to the order of priority shown on page C-5-45 for snow removal; she felt that locations such as bus stops and crosswalks should be given a higher priority than City-owned parking lots. Mr. Murray explained the priority listing in further detail, but since there were further objections from members, the Mayor suggested that this item be looked

\*\* at and discussed further by Council at a meeting in June or July, separate and apart from budget considerations.

Ald. Connors had several questions about information compiled by the Works Dept. on snow removal and control costs for individual storms, and the use that is being made of this information to improve efficiency and reduce costs. Mr. Murray provided information on areas where the information has been made use of already, and agreed to provide a subsequent report

\*\* to Council in May, in response to the request of Ald. Connors.

Page C-5-53: Special Events: It was noted that an amount of \$5,000. has been reinstated for this activity, representing half of the reduction proposed in Mr. Burke's report of Feb. 5/90. The figure for Special Events now stands at \$14,000.

Ald. Billard presented a motion to have this item deleted in the amount of \$14,000., but the motion did not receive a seconder.
