

THIS AGREEMENT, made this tenth day of July, in the year of our Lord One thousand nine hundred and four, between John S. Parker, Senior and John S. Parker, Junior, both of the City of Halifax, Mill Owners, doing business under the name of J. S. Parker and Son, of the First Part; and the City of Halifax, a Municipal Corporation, of the Second Part;

WHEREAS, The said J. S. Parker and Son have made an application to the City of Halifax to lay a service pipe from the main water pipe running through the City field on Kempt Road to their premises on Longard Road;

NOW THIS AGREEMENT WITNESSETH, That the said Parties of the First Part will lay the service pipe from the main pipe aforesaid at sufficient depth to their premises on Longard Road at their own cost and charges and keep and maintain the same at their own expense, and the said Party of the Second Part will place a meter upon the service pipe in order to register the quantity of water to be used through the same by the said Parties of the First Part, they the said parties of the First Part hereby agreeing to pay the said Party of the Second Part the usual water meter rates for all water passed through the said meter to their premises.

AND IT IS UNDERSTOOD AND AGREED, By and between the parties hereto and the permission to tap the said main water pipe is upon this express condition that the Committee on Works of the City of Halifax, may at any and all times cut off said supply of water and discontinue the same whenever the said committee shall from time to time think proper or discontinue the same entirely, and it is understood and agreed that the said City of Halifax shall not be in any way responsible for any cost, loss, damages or expenses in supplying said water or discontinuing the same or from any cause whatever if the City fails to supply water from the said main through the said service pipe.

AND IT IS FURTHER AGREED That the said parties of the first part shall pay for the use of the meter and that the said parties of the first part will abide by and conform to any law relating to the City of Halifax or any rule, ordinance or regulation of the said committee of the City Council relating to the use of water by the citizens.

AND IT IS FURTHER UNDERSTOOD AND AGREED That if in the opinion of the City Engineer it is in the interests of the City to

remove said meter or to turn the water off he shall be at liberty to do so.

Properties Acquired During 1904-05.

LOWER WATER STREET.—Extract from Minutes of City Council, May 26th, 1904 :—

Whereas, The City of Halifax requires the land and rights hereinafter described for the purpose of widening Water Street on the east side, between Duke Street and George Street, and the City Engineer duly prepared a plan of the land required together with a description of the said land and submitted the said plan and description to the City Council for its approval, and the said plan and description were duly approved by the said Council on the 28th day of April, 1904, and a copy of the said plan has been duly filed in the City Engineer's office, as required by law, and duly certified by him ;

And Whereas, No agreement can be made or come to with the owners of the land or rights required for the purpose aforesaid ;

And Whereas, A notice containing the description of the land or rights required for said purpose and a notice of the intention of the City Council to expropriate said land after the expiration of the time required by law for publishing said notice were duly published for ten days in two newspapers published in the City of Halifax ;

Therefore Resolved, that the said land be and the same is expropriated for the purpose aforesaid, which said land is described as follows:—

All that lot, piece or parcel of land situate, lying and being at the south west corner of Duke Street and Water Street, the said lot being more particularly described as follows:—Beginning at a point formed by the intersection of the south side line of Duke Street with the west side line of Water Street; thence to run southerly by the said west side line of Water Street for a distance of 24.17 feet, more or less, or until it comes to the northern boundary line of property now or formerly owned by the trustees of Mrs. Fane; thence westerly along the said northern boundary line for a distance of 17.5 feet, more or less, thence in a northerly direction for a distance of 25 feet, more or less, or until it strikes the south side line of Duke St.; thence in an easterly direction by the said south side line of Duke Street for a distance of 19.9 feet, more or less, to the place of beginning. The said lot being all that portion of property said to belong to J. W. Allison, lying to the eastward of proposed new western side line of Water Street, as shewn by the red line on Plan entitled, "Plan of properties corner of Duke and Water Streets, shewing proposed new street line," dated April 19th, 1904, and filed in the City Engineer's office at Halifax, N. S., as Plan Number 1527.

All that lot, piece or parcel of land situate, lying and being on the west side of Water Street in the City and County of Halifax, the said lot being more particularly described as follows:—Beginning at a point on the west side line of Water Street distant 24.17 feet southerly from the south side line of Duke Street; thence to run in a southerly direction by the said west side line of Water Street for a distance of 17.5 feet or until it meets the northern boundary line of the Muir Estate; thence in a westerly direction by the said northern boundary line for a distance of 15.66 feet; thence in a northerly direction for a distance of 18 feet, more or less, or until it meets the southern boundary line of property owned by J. W. Allison; thence in an easterly direction by said southern boundary line for a distance of 17.5 feet to the place of beginning. The said lot being all that portion of land said to belong to the trustees of Mrs. Fane lying to the eastward of the proposed new western side line of Water Street; as shewn by the red line on Plan entitled, "Plan of properties corner Duke and Water Streets shewing proposed new street line," dated April 19th, 1904, and filed in the City Engineer's office at Halifax, N. S., as Plan Number 1527.

All that lot, piece or parcel of land situate, lying and being on the west side of Water Street, in the City and County of Halifax, the said lot being more particularly described as follows:—Beginning at a point on the west side line of Water Street, distant 41.67 feet, southerly from the south side line of Duke Street; thence to run in a southerly direction by the said west side line of Water Street for a distance of 16.33 feet, more or less, or until it meets the northern boundary line of property owned by Miss Catherine Ryan; thence in a westerly direction by said north boundary line for a distance of 13.93 feet; thence in a northerly direction for a distance of 17 feet more or less, or until it meets the southern boundary line of property owned by the trustees of Mrs. Fane; thence in an easterly direction by said southern boundary line for a distance of 15.66 feet to the place of beginning. The said lot being all that portion of the property said to belong to the Muir Estate, lying to the eastward of the proposed new western side line of Water Street as shewn by the red line on Plan entitled, "Plan of properties, corner Duke and Water Streets, shewing proposed new street line," dated April 19th, 1904, and filed in the the City Engineer's office at Halifax, N. S., as Plan Number 1527.

All that lot, piece or parcel of land situate, lying and being on the west side of Water Street in the City and County of Halifax, the said lot being more particularly described as follows:—Beginning at a point on the west side line of Water Street distant 58 feet, more or less, from the south side line of Duke Street; thence to run in a southerly direction by the said west side line of Water Street for a distance of 25.5 feet, more or less, or until it comes to the northern boundary line of property owned by the Governors of Acadia College; thence in a westerly direction by the said northern boundary line for a distance of 11.5 feet; thence in a northerly direction for a distance of 26 feet, more or less, or until it comes to the southern boundary line of property belonging to the Muir Estate; thence in an easterly direction by the said southern boundary line for a distance of 13.93 feet, to the place of beginning. The said lot being all that portion of the property said to belong to Miss Catherine Ryan lying to the eastward of the proposed new western side line of Water Street, as shewn by the red line on Plan entitled, "Plan of properties corner of Duke and Water Streets shewing proposed new street line," dated April 19th, 1904, and filed in the City Engineer's office at Halifax, N. S., as Plan Number 1527.

All that lot, piece or parcel of land situate, lying and being on

the west side of Water Street, in the City and County of Halifax, the said lot being more particularly described as follows:—Beginning at a point on the west side line of Water Street distant 83.5 feet southerly from the south side line of Duke Street; thence to run in a southerly direction by the said west side line of Water Street for a distance of 18.34 feet, more or less or until it comes to the northern boundary line of property owned by the Misses Kearney; thence in a westerly direction by the said northern boundary line for a distance of 6 feet; thence in a northerly direction for a distance of 18.5 feet, more or less, or until it strikes the southern boundary line of property belonging to Miss Catherine Ryan; thence in an easterly direction by the said southern boundary line for a distance of 11.5 feet to the place of beginning. The said lot being all that portion of the property said to belong to the Governors of Acadia College, lying to the eastward of the proposed new western side line of Water Street, as shewn by the red line on Plan entitled, "Plan of properties, corner Duke and Water Streets, shewing proposed new street line, dated April 19th, 1904, and filed in City Engineers office at Halifax, N. S., as Plan Number 1527.

All that lot, piece or parcel of land situate, lying and being on the west side of Water Street, in the City and County of Halifax, the said lot being more particularly described as follows:—Beginning at a point on the west side line of Water Street distant 101.84 feet, more or less, southerly, from the south side line of Duke Street; thence to run in a southerly direction by the said west side line of Water Street for a distance of 20.6 feet, more or less, or until it comes to the southern boundary line of the said Kearney property; thence in a northerly direction for a distance of 20.6 feet more or less or until it comes to the southern boundary line of property owned by the Governors of Acadia College; thence in an easterly direction by said southern boundary line for a distance of 6 ft. to the place of beginning. The said lot being all that portion of the property said to belong to the Misses Kearney lying to the eastward of the proposed new western side line of Water Street as shewn by the red line on Plan entitled, "Plan of properties corner Duke and Water Streets shewing proposed new street line," dated April 19th, 1904, and filed in the City Engineer's office at Halifax, N. S., as Plan Number 1527.

Be it Further Resolved, That the City Clerk is hereby authorized to pay into the Supreme Court of Halifax the sum of \$830.00 for the lot of land above described said to belong to J. W. Allison: the sum of \$464.00 for the lot of land above described said to belong to

the trustees of Mrs. Fane; the sum of \$387.00 for the lot of land above described said to belong to the Muir estate; the sum of \$560.00 for the lot of land above described said to belong to Miss Catherine Ryan; the sum of \$608.00 for the lot of land above described said to belong to the Governors of Acadia College; the sum of \$424.00, for the lot of land above described, said to belong to the Misses Kearney; the said respective sums being in the judgment of this Council a reasonable value of said respective lands; and that the City Clerk notify said owners of said payments, and that if said sum is not in the opinion of the respective owners, sufficient for the value of the said respective lands they are to be at liberty to have the value ascertained by award and require them in such case to name an arbitrator in one month from the date of the service of said notice on them.

With the exception of the Governors of Acadia College the above amounts were refused by the owners. Arbitrators were appointed and made an award on November 21st, 1904, increasing the amount to be paid to the Muir Estate by twenty-two dollars, and the amount to be paid the Misses Kearney by two hundred dollars, and leaving the other amounts as shewn above.

When the City was first incorporated, and until April 12th 1849, the Corporation consisted of the Mayor, six Alderman and twelve Common Councillors, the Mayor being elected by the Alderman and Common Councillors from among the Alderman. In 1849 the office of Common Councilman was abolished. From 1850 to 1853 the Mayors were elected by the citizens from the members of the City Council, or from gentlemen who had previously served as Alderman or Common Councilman. Wm. Caldwell was the first Mayor elected by the citizens under this system. In 1854 the Act in relation to the election of Mayor was further amended by providing that the people should not be restricted to persons who had served in the City Council in their choice for Mayor. The only occasion on which this privilege was availed of was in 1870, in the election of Hon. W. A. Henry. From 1841 to 1882 the general civic elections were held in October of each year. From April, 1883, to date, the general elections have been held annually in April. The civic year extends from 1st May in any one year to 30th April in the year following.

CITY COUNCIL.

The Act of Incorporation of the City of Halifax passed the House of Assembly April 10th, 1841. On May 12th, 1841, an election was held in each of the wards of the City for three Common Councilmen for each ward. The first meeting of the City Council was held in the County Court House May 13th, 1841. The Council from 1841 to 1849 consisted of six Aldermen and twelve Common Councillors. The following table shows the dates of election and the names of the gentlemen composing the City Council between those years, designating the Aldermen and Common Councilmen respectively and the wards they represented. The first Common Councillors were elected by the citizens. Subsequently the Common Councillors were elected by the ratepayers. The Common Councillors from among themselves chose the Aldermen; and the Aldermen and Common Councilmen from out of the Aldermen elected the Mayors. Each year six senior Common Councilmen and three senior Aldermen retired, the order of seniority being fixed by the Council. The following lists do not contain the names of gentlemen who were elected but did not serve in the City Council because of unwillingness to serve, disqualification, irregularity of election, or other reasons.
