EXCESSIVE STREET MILEAGE.

Before getting away from this question of our debt perhaps it would be well to point out that no city with the population of Halifax has anything like the same street mileage that we have. Though the increase in population during the past ten years has been only about 3,500, the street mileage has increased in the same time from 83.5 miles to 94 miles, and water extension from 511 miles to This is largely brought about by people who have been living in the older parts of the city building dwelling houses in the outlying portions. The construction of houses, as pointed out by the city auditor in his last annual report, has proceeded much more rapidly than the demand for them and much faster than the increase of population warranted, with the result that street, sewerage, lighting and water extension has apparently had to follow, while the houses vacated, and in many cases still vacant, were already supplied with these services. The Board of Health has the power, when houses are located in the outlying portions of the city and not provided with drainage, to order sewer construction when they deem it in the interests of the public health. The better course would seem to be to empower the Board of Health to prevent houses being built in unhealthy or swampy localities instead of ordering sewer construction to remedy the evil thus making a further addition to the debt. While citizens know they can have water and sewerage extended to their houses, in no matter how out-of-the-way place they may locate them, the building in such places will continue.

SINKING FUND.

While our gross debt, (not including floating debt which amounts to \$22,922.00) is \$3,481,590, our sinking fund at the present time is exceedingly small in comparison. It is made up as follows:

By the operation of the 1896 General fund \$28,000 of debt has been paid off.

It would seem desirable to establish a general sinking fund into which should be placed the collections from permanent sidewalks and sewerage referred to above, the premiums received from loans and all the unexpended balances after the sum of \$75,000 to be used as a "Reserve Fund," referred to below, has first been allowed to accumulate from unexpected balances. These sinking funds should be hedged around with the strictest regulations in order that the money may only be used for the purpose of paying off our public debt and for no other purpose whatever. In this connection, it would seem desirable that the fund should be vested in trustees, as one of our sinking funds is now, and taken away a together from the control of the Council, the trustees only having the power to use it for the purpose above indicated. One other matter with reference to the sinking fund-At the present time we are required by the Legislature to either invest our fund, with the exception of the 1882 fund, in Dominion Government debentures, or to deposit the same in some chartered bank at a rate of interest not lower than 4 per cent. It is needless to point out the impossibility of securing 4 per cent. interest on Dominion Government debentures, and it is only a matter of time when the banks will refuse as the money market becomes less stringent to allow 4 per cent. interest on deposits. As it is the Treasurer has had some difficulty in securing this rate of interest. Therefore it would seem advisable that the "4 per cent." should be struck out of the act and the words "highest rate of interest obtainable" substituted. Unless this is done a day will come when we will be unable to legally invest our sinking funds. The City should also have the power to invest its sinking fund in its own debentures. This is done in several of the larger cities of Great Britain, Canada and the United States, the sinking fund of Buffalo being altogether invested in this way and the greater portion of the Sinking Fund of Albany, N. Y., being also so invested. By this means the sinking fund would secure the benefit of any premium and at the same time where the City issued a loan for a long period at 4 per cent. and in a few years found that the same money could be obtained at $3\frac{1}{2}$ per cent. instead of losing the ½ per cent. by paying the 4 per cent. to an outside purchaser, they would have the satisfaction of knowing that the sum was going into their own sinking fund.

RESERVE FUND.

At the present time it is the practice, when sufficient taxes are not collected to meet expenditure, to go to some one of the banks and borrow money at 6 per cent., which borrowing is in the shape of an overdraft. At the present time this overdraft amounts to about

\$100,000, and at a certain period of the year reaches the sum of \$120,-This sum is borrowed in anticipation of the payment of taxes outstanding and interest paid on the same at 6 per cent. While the city does not lose anything by the payment of interest on the overdraft, as it charges the delinquent taxpayer 6 per cent. interest on his overdue taxes, it must be plain that we are practically only doing business for the banks. I would suggest that the unexpended balances should be taken from year to year and invested until the sum of \$75,000 is reached, which fund could be known as the "Reserve Fund," and from which the city could borrow on account of overdrafts. While not being used by the city the fund could be placed on deposit and draw interest, and while being used by the city we would not be compelled to pay 6 per cent. interest on an overdraft to the bank, as we would have the money in this reserve fund of our own to draw from; and which would, of course, be repaid to the "Reserve Fund "as outstanding taxes would be collected. After said amount of \$75,000 is accumulated, I would suggest that the unexpended balances should be paid from year to year into the Sinking Fund and not taken, as at present, for the purpose of reducing taxation.

Under section 287 of the City Charter the Recorder has given a written opinion to the effect that money drawn from the bank as overdraft is illegal. It will be necessary, as these overdrafts are indispensable to the proper government of the city, to have this section of the Charter amended so as to empower the Council to borrow money in anticipation of the year's taxes, paying it back when taxes are collected. This course is followed in Massachusetts where Chap. 29, sec. 6, of the Public Statutes enacts that cities by ordinary vote may incur debts for temporary loans in anticipation of year's taxes and requires repayment of such loans to be made when such taxes are collected.

SCHOOL DEBT SINKING FUND.

The school debt at the present time amounts to \$292,600, for which no sinking fund up to last year was provided. At last session of the Legislature an Act was passed requiring the Board to assess not less than 1 per cent. of the total debenture debt for a sinking fund from year to year. This appears in this year's estimates for the first time, and amounts to the sum of \$3,000.

In this connection it is well to notice that the School Board, under Section 14 of the Acts of 1901, Chap. 57, has power to borrow money and issue debentures for the same for such sums as they decide upon, payable with interest in 25 years from the date thereof free from taxation, and such debentures are a charge on the City of Halifax. Though the City of Halifax has no control over this power of the School Board to borrow money, still the city is liable; and it is a matter well worthy of consideration whether or not the City should endeavor to control in some manner such borrowing power.

EXHIBITION DEFICITS.

The City's proportion of the Exhibition deficits from the year 1897 down are as follows:—

This is an expenditure over which the Council has no control, being required by statute to pay one-half of the deficit of the Provincial Exhibition. These payments are spread over periods of from 3 to 6 years.

MEDICAL EXAMINER.

Under Chap. 37 R. S., 1900, a Medical Examiner was appointed for the City of Halifax, whose duty it is to enquire into sudden deaths and to perform other duties set out in the Act. The City is called upon to pay the fees of this officer, which amount yearly to an average sum of \$500. The only part the City plays is to pay the bill. It has nothing to do with the appointment of the official.

It is a matter of opinion whether or not our own Medical Officer should not be able to perform the duties of this officer without any additional salary, and thus save to the City the sum paid to the Medical Examiner.

VALUATION OF PERSONAL PROPERTY.

As the increase of taxable property does not keep pace apparently with the growing demands of the city, it would not appear to be possible, under the present method of assessment to prevent an annual increase in the rate per centum unless the strictest economy is practised. At the same time, I desire to say that it must be plain to any one, who will stop to consider, that a very large portion of personal property is escaping taxation. As appears by the tables of comparison, which I have already given,

The assessors state that this decrease in the valuation of personal property represents the reduction of 25 per cent. which they were required to make in the value of stocks of merchandise. If this is correct, and supposing the value of personal property to have remained stationary for 17 years, the value of stocks of merchandise must be \$2,770,520, leaving the sum of \$1,536,280 as the value of all other personal property. When one considers what the term "personal

property" covers under the act, the smallness of the valuation is apparent. The section reads as follows:

306. "Under the term personal property shall be included all household furniture, moneys, goods, chattels, wares, merchandise and effects wheresover situate within the city, owned by any citizen, company or corporation, and all ships and vessels shall be assessed at one quarter their value. . . The term personal property shall also include all moneys belonging to the inhabitants of the city, invested in public or private securities within the city; and all bullion and coin of gold and silver, all Dominion notes, and notes of solvent banks, in the province or elsewhere, which may be in the possession and the property of any citizen, or in the custody of a bank, or other party except money deposited on deposit eccept, shall be considered as his money, and be assessed accordingly."

As, at the present time, there is a committee consisting of six members of this council and three prominent business men of Halifax—one, the President of the Board of Trade—considering the question of taxation, I will refrain from going into it further and from offering any suggestions, as to do so would be to attempt to anticipate the report of that committee.

Now, sir, while there are many other points which we could profitably consider, I do not propose to deal with them at this time, but with your permission I desire to offer the following suggestions for the consideration of Council:

SUGGESTIONS.

Take balance due Permanent Pavement Fund as collected and balance on hand in that fund and put into a general sinking fund.

Take the balance due on Sewerage extensions as collected, and

Appoint trustees for sinking fund and hedge it with safeguards so that it can only be used for the purpose of reducing the debt, and for no other purpose whatever, making the trustees personally liable for the diversion of any of the moneys.

Put into sinking fund all unexpended balances after the sum of \$75,000 has first accumulated for the establishment of the "Reserve

Fund," and also premiums secured or obtained on loans.

Permit the City to invest this sinking fund in its own bonds as

well as in Dominion of Canada debentures and bank deposits.

Amend the law which requires sinking fund to be invested at not less than 4 per cent. to read "the highest interest which can be obtained."

Amend the law so as to legalize overdrafts to meet current expenditure, i. e. empower the City to borrow in anticipation of the year's taxes, which is merely legalizing the course which has been followed illegally for years, such overdrafts to be repaid as taxes are collected.

Establish "Reserve Fund" made up from unexpended balances and throw around it every possible limitation to prevent it being used for any other purpose than to meet temporary loans (i. e. over-

drafts) made in anticipation of year's taxes, in other words place it in exactly the same position as the bank, requiring repayment to it of loan with interest out of taxes as same are collected.

As reserve fund exceeds amount fixed i. e. \$75,000, by accumu-

lations of interest, &c., pay the excess into the sinking fund.

Cease adding to debt until (less water debt) it has been reduced to a limit not exceeding 10 per cent. of the valuation of real estate, that is to say, make our debt limit 10 per cent. of the valuation of real estate, any bonds issued in excess of such amount to be void, bonds now outstanding in excess of this amount not to be affected.

On the present valuation of real estate this would fix our debt limit at \$1,704,337, which of course would not include our water debt

or floating debt for the reasons already given.

These suggestions are offered in the hope that they may lead to a discussion of the financial affairs of our city and cause the Council and our citizens generally to take a more intelligent and deeper interest in this most vital matter of our credit. To sum up in a few words let me say that it seems to me the heroic way is to face our debt; to provide a sinking fund to extinguish it, not all at once but a little at a time; to stop borrowing for street, water and sewer extensions and to live within our appropriations.

ESTIMATES 1902--03.

Now sir, I come to the estimates for the ensuing year and I propose to deal very briefly with them as each item will be fully discussed as

it is taken up.

I desire to say that while the majority of the committee recommend increases in the salary list amounting to \$250.00, I cannot agree with them with the exception of one increase of \$50.00 to the stenographer which I feel must be granted.

CITY WORKS DEPARTMENT.

Our streets speak for themselves The increased amount for horses and drivers is called for on account of the removal of ashes, the Board having decided to remove ashes all the year round and to have the men remove the barrels from the yards. To accomplish this work three additional carts with horses and drivers are required.

COUNTY OF HALIFAX-\$500.00

The county clerk notifies us that this additional sum will be required for this account next year. It is beyond our control, but we are required to assess for it.

[Extract from Minutes of a Meeting of the City Health Board, Held Sept. 25th, 1901.]

Read an opinion of His Honor the Recorder relating to the Duties of the City Medical Officer, as follows:

"In answer to your letter enquiring whether the City Medical Officer is bound to attend the small-pox patients in the Small-pox Hospital, that officer, as well as all the health officers of the City, are under the control and orders of the Board, and if they direct him to attend patients in the hospital he is bound to

do so.

He is also, by section 559, bound to perform the services now or formerly performed by the City Medical Officer and the Surgeon of the City Prison. The former duties of the City Medical Officer required him to attend to all small-pox patients, and the same duty devolves upon the present officer. There are other duties required to be performed by the City Medical Officer outside of that, such as attending the sick at the Poors' Asylum, City Prison and Sanitary matters. Whether it would be in the best interest of the City to permit him to attend to these duties, or employ another officer, is entirely at the decision of the Board. If the Board decides to require the City Medical Officer to attend and be quarantined at the Small-pox Hospital, it will be well for the chairman of your Board to consult with the Mayor as regards obtaining an Assistant Medical Officer to attend to these outside duties; but the matter is entirely in the hands of the Board, and they have full and ample power to take all steps necessary for the suppression of any infectious or contagious disease."

IN RE CITY MEDICAL OFFICER.

COMMITTEE ROOM, City Hall, Halifax, N. S., Jan. 23rd, 1902.

To His Worship the Mayor and City Council:

GENTLEMEN.—Your Committee on Laws and Privileges have had under consideration account of Dr. J. M. Purcell for \$200 for services as resident physician at the Small-pox Hospital, and also a letter from the Secretary of the Board of Health, enclosing a resolution by that body and bearing on the appointment of Dr. Purcell, together with an opinion of His Honor the Recorder thereon, all of which papers are hereto annexed.

After hearing Dr. Trenaman, your Committee find that the duties of the City Me lical Officer are defined by Section 559 of the City Churter. Among other things he is required to perform the services now or formerly performed by the

City Medical Officer and of the Surgeon of the City Prison. It appears that the previous incumbent of the office, Dr. Lawson, attended the Small-pox Hospital, and under the law as it stood at that time was also able to perform the other duties attached to his office. In 1891 the City Health Board passed a rule which required the physician in attendance at the Hospital to be quarantined there, which rule would make it quite impossible for an officer to attend to the other duties required of him by the Charter to be performed. This would make it necessary in order that the City Medical Officer should perform all the duties at the present time laid down by the Charter to either go into quarantine himself at the Small-pox Hospital and engage a medical man to perform the other numerous duties which he is required to do outside of that institution, or on the other hand, to follow the course which Dr. Trenaman has followed on this occasion of sending a medical man to the Small-pox Hospital and attending to the outside duties himself. Under the Chart r as it stood in 1876 the salary of the officer was fixed at a sum not less than \$600 and not exceeding \$1,000. Dr. Trenaman was appointed at a salary of \$1,00 and there appears to be no record of the duties which he should perform other than as laid down in the Charter. As the present state of affairs in this department has been brought about by circumstances over which Dr. Trenaman has had no control, namely: a resolution of the Board of Health which makes it impossible for him to act as physician at the Small-pox Hospital, and also to perform the duties outside-if it were physically possible for one man to perform them, your Committee feel that it would steary possible for the man to perform them, your committee feet that is would be unfair and not within the spirit of the Charter to require him to pay for the services of the physician now resident at the Small-pox Hospital. It may be further pointed out that by section 562 of the Charter the only case where the City Medical Officer is required to pay for the fees of another medical practitioner is where owing to his absence from the City without leave or neglect or other misconduct on his part it is necessary to call in such medical practitioner. As the law stands at present the City Medical Officer appears to be under the absolute control of the Board of Health and it is a question whether or not such control should not be vested in the City Council he being an officer appointed by that body.

Your committee would recommend:

1st. That Dr. Purcell's bill for services be paid by the City, and as this extra expenditure has been made necessary owing to the presence of small-pox in the city, the Board of Health having the power to ask for funds in the case of epidemics, should ask for the necessary funds to pay it, the Council having no

fund so far as your committee knows to draw upon.

2nd. That as the committee feels that the salary of the C. M. O. was fixed at \$1000, apparently with the expectation of his being able to attend to small-pox cases, his duties should be referred to a committee of Council to revise the same, and the clause requiring him to attend small-pox cases should be dropped and his salary reduced to a sum of about \$500 which would be sufficient salary for the services he would then be called up in to render.

That when small-pox or any other epidemic should break out the Board

of Health should employ a special physician to attend to the same.

EXPROPRIATION OF GRAHAM PROPERTY QUINPOOL ROAD.

Your Committee have investigated this case and find that Mrs. Graham's complaint arose through the negligence of one of the solicitors conducting the matter; but that the case had been settled about three months ago by payment to Mrs. Graham of the amount due her.

NOISE MADE BY VEHICLES.

The Board of Trade petitioned the Council to take steps to minimise the noise made by vehicles, and the petition was referred to this Committee. Your Committee beg to report that this is a matter which comes more properly within the jurisdiction of the Commissioners of Cabs, and recommend that it be referred to them.

R. N. McDonald's Claim for Damages.

Your Committee's former report on this matter was referred back to ascertain if there had been any delay on the part of the city officials after Mr. McDonald had complained of the leak into his cellar from a City water pipe. The Committee heard the evidence of Mr. McDonald and of the City Engineer and the foreman and a sub-foreman of water works on this point, and find that there was no undue delay.

Read report of Special Committee relative to the construction of hospital at the Poor's Asylum grounds.

COMMITTEE ROOM, CITY HALL, January 24th, 1902.

The Special Committee to whom was referred the petition in relation to the Hospital being fitted up in connection with the Poors' Asylum beg to report as follows:

The Committee met at the Poors' Asylum on Friday, January 17th.

There were present Aldermen Mitchell, Campbell, Creighton and Geldert.

On motion, Ald. Geldert was appointed Chairman of the Committee.

The Committee proceeded to inspect the proposed Hospital building and found the work in an advanced state.

On returning to the Committee room at the Asylum, Mr. Dow, Superintendent of the Asylum, was heard.

Mr. Dow stated that there is no vacant room in the Asylum building except in summer and that persons afflicted with consumption, cancer and other diseases of an offensive or objectionable character must be placed in the same wards with other inmates.

He admitted, however, that the number of such cases is small and that at ?he time the Committee met there was not a single case in the Asylum requiring to be so separated.

It appeared also that in one ward of the Asylum where there were formerly

53 inmates there are now at the present time only 26.

In view of the latter fact and especially in view of the fact that the number of inmates afflicted with diseases of the character mentioned and requiring to be separated from other inmates is at no time large the Committee are of the opinion that the expenditure involved in litting up a separate building for the accommodation of such cases was unneccessary, and that ample provision could have been made in the present building for the cases referred to.

The Committee are further of the opinion that in view of objections raised by residents and property owners in the neighborhood the work in connection with the proposed hospital should not have been proceeded with until after opportun-

ity had been afforded for enquiry and report.

The Committee are further of the opinion that if it had been shown after enquiry that additional accommodation was required in connection with the Asylum for cases of the character mentioned it would have been much better in the interests of the institution and of the persons requiring to be separated from other inmates that the required accommodation should have been provided either by the erection of a suitable addition to the present building, or by fitting up the outside building intended to be used as an hospital for the accommodation of officials who now occupy a considerable amount of space in the Ayslum, ?ither of which courses would have avoided the objections raised to the proposed hospital.

The Committee are strongly of the opinion that the policy adopted by the Charities Committee of extending the Asylum in the way they have done is an objectable one and is likely to lead to further extensions of a similar character.

They are further of the opinion that the building in course of alteration is not likely to proves satisfactory for the purpose for which it is intended and they would recommend in view of the expense already incurred that an effort be made to use the building for the accommodation of officials and that any cases requiring separation be provided for within the walls of the main building.

His Worship the Mayor:

Sin,—The Works Department are embarrassed each year by lack of funds during the winter and early spring. The working season closes about the first of December, and as long as there is money in the appropriation it is impossible to retain the amount required to provide material for next season's work and commence repairs as soon as the frost is out of the round. There is so much work to be done, and so small an appropriation to do it with, the fund is exhausted by the time the cold weather comes. It is necessary to provide the quantity of broken stone required for the season's work before the beginning of the civic year. In the past, part of the money for this work has been provided by the Poor Association by borrowing at the bank. The remainder has been taken from the Permanent Pave ne it Appropriation. The Permanent Pavement is about exhausted, and I would recommend that in order to provide funds for the purchase of material, breaking of stone and urgent repairs required in the month of April, a fund be created by borrowing \$5000 00 to be repaid in ten annual instalments, the annual payment and in erest to be taken from the street appropriation each year so that there will be no increase in the assessment; that the fund shall be placed on deposit in a chartered bank, and that no money shall be drawn from it except between the first of January and the first of May in each year, and that the amount used during that time shall be rep in from the street appropriation not later than the fir t of September in each year so that there shall always be at the first of September in each year not less than \$5000.00 to the credit of the fund. Further, that the Recorder be instructed to prepare an Act in accordance with this report.

His Worship The Mayor:

Sir,—about a year ago the Council had before them a communication from Hugh Cameron, representing the Waterous Engine Company, offering to sell to the City a Buffalo-Pitts roller for \$5,500. It was decided at that time to ascertain the cost of other rollers before purchasing. A tender has been received from the makers of the roller which we have been using for the last ten years which would make the cost delivered in Halifax about \$3,000.

As stated in reporting on the other tender, I have no hesitation in saying that the work to be performed each year cannot be overtaken by one roller. The rolling is only partially done and in many cases is unsatisfactory, as it is not always practicable to do the street work at such a time that the roller is available. As soon as each work is done stones placed on the street, especially along the car track, are often knocked about for some time before the surface can be compacted. The work during the first part of the season, after the frost comes out of the ground, requires two rollers to perform it satisfactorily. Every street which has been affected by the frost should be re-roiled, and it is obvious that with our great mileage of streets one roller cannot overtake it. If streets which have been upheaved by frost are rolled as soon as the frost comes out of the ground they do not require repairs provided there is sufficient wearing material on them and one day's rolling saves the expenditure of hundreds of dollars. While we should not keep two rollers in service during the whole season with our present street appropriation there is no question that a great saving would be effected by having a second roller available when required.

The Aveling & Porter roller has proved itself to be a first-class machine and a compound roller, with all latest improvements, can be landed in Halifax for

\$500 less than the Buffalo-Pitts roller.

I would recommend that the City Works Commission be authorized to make arrangements for the purchase of a roller and that the Recorder be instructed to prepare an Act empowering the Council to obtain the sum required (\$5,000), to be repaid in six annual instalments; the payments, with interest, to be taken from the street appropriation each year. There would thus ben o increase in the assessment and the amount taken each year from the street appropriation would be returned in the better value of work done and the increased amount.

WORK FOR SEWER LABORERS.

To the City Council:

Gentlemen,—In accordance with a resolution of council your commission heg to report on the accompanying petition from laboring men asking that the city provide employment for them during the winter months, also the resolution attached hereto with reference to sewer and water extension on Yale, Yukon and Beech Streets.

At a meeting of the City Works Commission held this day the City Engineer submitted the accompanying report declining to recommend that this work be carried cut; but suggesting that in order to provide employment for the sewer laborers a sewer be constructed in LeMarchant Street, between South Street and Coburg Road. Your Commission beg to recommend that said report be adopted.

His Worship the Mayor:

Sir,—I beg to report on the accompanying petition from sewer laborers asking for employment during the winter, and the resolution of the City Council with reference to the construction of sewers and water extension through Yale, Yukon and Beech Streets.

The construction of a sewer in Beech Street is out of the question, as the fall of the street is towards Quinpool Road, and the elevation of Quinpool Road at its junction with Beech Street is 25 feet lower than the elevation opposite the Engine House. It will therefore be manifest that it is impossible to drain Beech

Street into the present sewer system.

The property owners living on Yukon and Yale Streets have never petitioned for sewer construction, and it is not customary to construct sewers in any street until a majority of the property owners are in favor of it, except where the necessity is very urgent, the delay in construction would result in greater expense or the work is strongly recommended by the Board of Health. Neither of these conditions exists in these cases. While no surveys have been made of these two streets for sewer extension, it is probable that they would have to drain eastwardly and find an outlet through the proposed street which is not yet thrown open. Further, the construction of sewers in Yukon and Yale Streets
