whereas in the opinion of the Council it would enhance the value of Real
Estate, conduce to the general Health of the Inhabitants and in the ultimate
be found to have proved economical if without further procrastination all
the necessary sewerage was completed, and all the roads and Streets of
the City were substantially and thoroughly put in order so that they
might afterwards be kept up with small expense, and whereas
the means collected from the Road tax and Street appropriation are
inadequate to accomplish such contemplated repairs and improvements
and the Council recommend the expenditure of a sufficient sum of money
to carry out the design.
