Farquhar, Forrest & Co. offered \$5,000 at 4 per cent. per annum.

J. C. Mackintosh offered to give  $99.12\frac{1}{2}$  for debentures bearing 4 per cent. per annum, to take the \$30,000 or any portion thereof.

W. L. Lowell & Co. offered to give  $97\frac{3}{4}$  for 4 per cent. debentures, or  $102\frac{1}{2}$  for  $4\frac{1}{2}$  per cent. debentures—whole amount \$30,000.

J. H. Harvey offered 1 per cent. premium for  $4\frac{1}{2}$  per cent. debentures (whole amount \$30,000.

The letter from John Doull, Chairman of the Commissioners of Point Pleasant Park, in reference to certain sums that have been deducted from the years appropriation of the Park, (which he understood were granted additional to the yearly allowance) was read and considered and it was resolved to refer the letter to the Council, together with extracts of the Minutes of Council authorizing the

The Committee met on the 19th August, 1890, in the City Hall Committee Room. There were present the Chairman, Aldermen Dennis, Pickering, Foster and Mosher, when the matter of the office of City Treasurer was considered.

A letter from E. G. W. Creenwood, City Treasurer, tendering his resignation of the office of City Treasurer upon condition that the City grant him a retiring allowance, was read.

Resolved, That this Committee recommend that in view of the long services of Mr. E. G. W. Greenwood as City Treasurer, his great age and present illness, his resignation be accepted on the conditions pro-

posed by him and that the present acting treasurer be appointed treasurer on condition that he enters into an obligation to pay Mr. Greenwood eight hundred dollars per annum during the remainder of his life, and that an amendment to the Act concerning the Treasurer be secured, if possible, allowing the salary of the Treasurer to be \$1800 till the death of Mr. Greenwood. We also recommend that the bonds of the Treasurer be from a guarantee company.

#### WIDENING QUINPOOL ROAD.

#### CITY ENGINEER'S OFFICE,

#### 25th July, 1890.

On the 16th June last, your Board passed a resolution requiring me to report on the advisability of widening Quinpool Road. I have had a survey made and submit herewith a plan for widening the road to 70 feet, which I think highly desirable. Mr. Pickford has already given the necessary land from his property; the Rev. Mr. Cogswell, has intimated that Dr. Cogswell will also give whatever land is required for the purpose from him, and other owners if properly approached would no doubt do the same. By the plan it will be seen that there are a few buildings which will require to be moved, but they are of comparatively little value and cannot be avoided without ruining the general alignment of the road.

The following are the buildings requiring removal :--Mrs. C. Gumb, two old small one story dwellings of little value; Moses Stenhouse, verandah and steps; Mrs. C. Hosterman, one small dwelling; Archbishop O'Brien, two barns and one small house; N. Dauphney, one small house and shed; John Dixon, shop and small shed,

Proposed sewer in Maitland Street, from Prince William Street, northwardly, to House No. 118.

A sewer is required in this locality; there is none there at present. The distance is about 260 feet. There is at present a 15-inch earthenware pipe, laid from Prince William Street southwardly to Cornwallis Street. This pipe is too shallow to admit of the new sewer draining into it, and will require to be lifted for about 400 feet, and a sewer at a proper depth substituted.

The total length to be built will therefore be about 660 feet. A sewer 18 inches by 12 inches, will answer all purposes, and the depth will have to be from 9 to  $9\frac{1}{2}$  feet.

The estimated cost is \$1,800 and the sewerage rates will amount to about \$1,600, if the properties where the existing 15-inch pipe has to be lifted are fairly chargeable.

#### IN RE MAITLAND STREET SEWER.

The owners of property on each side of a street through which a sewer is built is liable, under the law, to pay one dollar and twentyfive cents per foot toward the cost of construction, unless they have previously paid their proportions of the cost of building a common sewer in the same street.

In that case the owner would not be bound to pay again. But the law requires the owner who claims he has been previously taxed and paid, to satisfy the Board of Works in writing they have so paid those proportions.

Proposed new Sewer on Cornwallis Street, from Water Street to Park Street, and in Gottingen Street from Cunard to Cornwallis Street.

#### CITY ENGINEER'S OFFICE,

#### 8th August, 1890.

The accompanying petition for the Cornwallis Street Sewer, and copy of Minute of Council thereon, having reference also to the Gottingen Street Sewer, having been referred to me, I beg to report as follows:

A new Sewer in Cornwallis Street, appears to be urgently need. From Water to Gottingen Street it should be 36 inches high by 24 inches in width. From Gottingen to Maynard 30 by 20 inches and from Maynard to Park Street 21 by 14. Total length about 2060 feet, and estimated cost \$8,500. The Sewerage rates will amount to about \$4,000.

It is not practicable to construct a Sewer along Gottingen Street from Falkland Street to connect with new Sewer on Cornwallis Street without incurring very heavy expense, which is quite unnecessary. The proper discharge for such a Sewer is down Brunswick Lane or Maitland Terrace.

Along Gottingen Street from Cunard to Cornwallis Street, there is an old shallow stone Sewer which is of no service to the houses on the lower side of the street. A new Sewer could be constructed for about \$2250 and the sewerage rates would amount to about \$1,100.

#### MAYNARD AND WEST STREET SEWERS.

#### CITY ENGINEER'S OFFICE,

#### August 13th, 1890.

I beg to report that the recent reconstruction of a sewer on Maynard Street has not remedied the complaints of cellars being flooded on West Street as it was hoped it would, and as it certainly would have done if the West Street Sewer had been properly built. This latter sewer is a 15 inch pipe laid before the existence of the Board of Works. It is shallow and the foreman reports that the pipes sag in the middle, so that the water cannot flow off freely. The whole matter will be found fully reported upon in my report, dated 26th August, 1886. There is only one thing remaining to be done to cure the trouble, and that is, to carry out the whole of the recommendation then made, and reconstruct the West Street Sewer from Maynard to Agricola, properly, and at a sufficient depth. Practically a new sewer will have to be built about 410 feet in length, 14 in. by 21 in. The estimated cost is \$1000 and estimated sewerage rates \$660.00, not including rates on the land proposed to be purchased by the City.

#### Memo. from City Engineer respecting claim of Thos. J. Mooney.

The Foreman of Streets informs me that the statement made in Mr. Russell's letter respecting the city having damaged "the connection between the house drain and the main drain" is incorrect. The change he states was made by the late Andrew Wood, who was employed to build a private drain from Jerusalem Warehouse about the time mentioned, and that Mr. Wood (acting for the owners of the Jerusalem Warehouse) connected Mooney's drain with the one he wes then laying, without the authority or knowledge of the city, and also that the said Wood connected the well referred to, which it is now claimed has caused the damage.

Mr. Mooney's cellar is about on a level with ordinary high water in the harbor and consequently must be flooded whenever the tide rises to or near mean high water. During spring tides the water from the harbor would reach into the cellar to a considerable depth.

For a great many years there have been complaints respecting the flooding of the said Mooney's cellar, but I do not know of any law, ordinance or obligation by which the City could be required to remedy such a complaint. Persons having cellars near tide level should take all necessary steps to prevent flooding at their own expense, and as to the private drain connection referred to, I would not think the City in any was responsible.

There is at present a 12 inch earthenware pipe sewer in this locality but it has been laid at an insufficient depth and the outlet at Fenwick Street is also too shallow and will have to be lowered. There has been a good deal of sickness in the locality this Summer and a few deaths which might be attributable to the defect in drainage. The new sewer on South Park Street in place of the existing pipe drain will be 18 inches by 12 inches and about 420 feet long. The existing old stone sewer on Fenwick Street will require to be taken out for nearly 500 feet in length and a proper *concrete* or brick sewer 36 inches in diameter substituted at a greater depth. This should effectually remedy the complaints of cellars being flooded on South Park Street.

The total estimated cost of the work is \$3,800.00, and the sewerage rates will amount to about \$1100 on South Park Street, and \$800 to \$900 on Fenwick Street.

By the general plan of drainage a Sewer 30 inches by 20 inches is required and in order to be of use for draining the adjoining district it, will have to be built at a greater depth than usual. At the deepest point it will be about 13 feet below the surface. The cutting will be

almost all through solid rock, so the work will be comparatively expensive. The length is about 460 feet and in order to obtain a proper outlet the new Sewer will have to be turned southerly along Young Street, from Bilby to Almon Street a further distance of 260 feet and discharged into the Almon Street Sewer. The total estimated cost of the work \$3800, and the sewerage rates will amount to about \$1000 on Bilby Street and \$450 on Young Street.

TO LIEUT. WILLIAM GRANT STAIRS, ROYAL ENGINEERS:

Sir,—We, the Mayor and Aldermen, representing the corporation and citizens of Halifax, are proud to avail ourselves of the opportunity to tender you a hearty welcome upon your return to your native land.

In common with the whole civilized world we have followed with the keenest interest the vaying fortunes of the Stanley expedition in Africa. an interest which we need not say, was to us greatly enhanced by the fact that one of the foremost actors in the enterprise was a fellowtownsman of our own. We do not forget that other brave and heroic men have in years past gained a well-deserved renown in the attempt to explore the recesses of the dark continent, and yet it will be conceded that to Stanley and his compeers has fallen a measure of success which may have been equalled, but which certainly has never been surpassed in the same line of action in the whole record of human achievement. We rejoice to know that in all the constantly recurring times of difficulty, of danger and privation which attended the progress of the great expedition you were ever ready to assume without murmur or hesitation the part allotted to you, and we have the testimony of the leader himself that your part was always executed faithfully and well.

We trust and believe that the great undertakings with which you have been so conspicuously associated—though accompanied as such enterprises generally are by costly sacrifices—will, nevertheless, bear large and satisfactory fruit in the abolition of the slave trade, the opening up of vast and populous regions to the advantages of commerce and civilization and, above all, to the blessings of Christianity.

The events of the Stanley expedition have already passed into history and, while it cannot be otherwise than pleasing to yourself, it is most gratifying to the community in which you were born and bred to know, that one of our own sons will have honorable mention in that history and will add another name to the roll of those who, in various walks of life, have shed lustre upon the land of the Mayflower.

As a slight token of our appreciation of your merits and services we ask your acceptance of a piece of plate to be formally presented to you on your return to England.

We again tender our congratulations and warmest welcome, coupled with the hope that your life and health may be prolonged, and that a career of usefulness so auspiciously begun may be marked in the future by continued and distinguished success.

To which Lieut. Stairs made the following reply :

### Mr. Mayor, Aldermen and Gentlemen. representing the Corporation and Citizens of Halifax:

It is with feelings of the greatest pride that I have heard the address which has just been read. Of all the receptions that could have been extended to me in any way, and by any people, none could have been more gratifying or more appreciated by me than this one coming as it does from the people of my own native town—Halifax.

I should like to say just one thing in connection with the late Emin Pacha Relief Expedition. In some quarters doubts have been thrown upon the sincere nature of the work performed by Mr. Stanley's expeditition. It is needless for me to say here what the objects of the work were in which we have been occupied for the past three years. I trust these are well known by everyone present here to-night, and feel sure that no one here will attribute motives to the relief expedition that are not founded on fact. Still to clear away any existing doubt I would say that though the expedition, as with most other African expeditions, was accompanied by great sacrifices and

must have to some extent changed the existing political condition of affairs among the tribes of Central Africa, still the benefits that have and will accrue to the British Empire and civilization generally are such as to have fully warranted the expenditure of life, money and labour necessary to its fulfilment. The openings that will be offered to the expansion of English and other trade, in supplying new markets for the goods of the world, the improved condition of the native that will ensue, the suppression of the slave trade, through the influence of the railway and telegraph lines, are only some of the benefits that will spring directly from such an undertaking as that of the Emin Pacha relief expedition.

Ladies and Gentlemen,—Again I thank you for the gratification the presentation of this piece of plate and such an address affords me. They will act as incentives to future good work, and will help me on in other duties and positions towards success. Through the three years of trial, sickness and dangers of all descriptions; through the black and dreary forests of West Central Africa, with their attendant famine and daily scenes of sadness, I can sincerely say that never for once did I forget the place I was born in and its people, and the keenest inducement to push onwards was the fact that I felt all of you were watching with sympathy our movements, and were eagerly expecting to hear of the success of the expedition.

As you have referred to Mr. Stanley, will you allow me, on his behalf, to express the gratification I am sure he will feel on hearing that one of his officers has been so honored this evening.

After the reply the Acting Mayor asked His Honor the Lieutenant-Governor to make a short address, after which the Aldermen present having been formally presented to Lieut. Stairs; it was

#### SEPTEMBER 22nd, 1890.

Read over proceedings of Council of the 11th and 18th inst., which were confirmed.

Alderman Lyons, Chairman of Committee of Laws and Privileges, submits a report from that Committee on several matters referred to them.

Alderman Pickering submits a report from the Board of Fire Wards and Fire Commissioners on several mattersreferred to them.

Alderman Foster submits a Petition from James Kearney and other residents of West Street, Ward No. Five, asking Sewerage.

The Acting Mayor submits a letter from Edward Walker, asking payment of an account due him by E. A. Milliken, on account of work done on New City Hall.

Also, a letter from Doctor DeWitt in reference to dangerous condition of Horse Car Rails on Hollis Street.

Also, a petition from G. A. Woodill and other residents of South Park Street, asking the construction of a Sewer between South and Fenwick Streets.

Also, a report from the City Clerk of sundry accounts for consideration of Committee of Public Accounts.

Moved by Alderman Keefe, seconded by Alderman Pickering, that the Order of the Day be suspended to read the papers handed in this day. Motion passed.

Read report from the Committee of Laws and Privileges in reference to complaint made by John Dillon against Robert Theakston, Collector, and also in reference to other matters.

#### COMMITTEE ROOM, Sept. 12th, 1890.

At a meeting of the Laws and Privileges Committee, held this evening:

(1). The Committee heard Mr. Dillon and his counsel in reference to his complaint against the Collector and Mr. Theakston in reply. There is such a complete contradiction between them as to the language used, and the exact amount of money tendered in payment of the taxes, that the Committee are unable to do more than return Mr. Dillon's complaint, and Mr. Theakston's rejoinder, without expressing any opinion on their conflicting statements. The Committee do not, however, consider that the Collector is to blame in any of the steps he took to collect the tax.

2. The Committee also investigated the matter of supplies furnished to Aldermen and find as follows:—That Alderman Pickering, while a

166

member of the Board of Works obtained from Alderman John's, on October 7th. 1889, an order for delivery to himself and Alderman Pearson, of a quantity of cement and sand and gravel. That this material was not delivered to the Aldermen, but was manufactured into concrete steps and combing at the Poors' Asylum by Mr. Dow the Engineer, and inmates of the Institution, under the instructions of Alderman Pickering, who was at the same time Chairman of the Charities Committee. The curbing and steps was removed when made and put into position before the Alderman's dwelling on South Park Street. The material was paid for by Alderman Pickering on the 25th November, 1889, at the contract price at which cement and sand are supplied to the Board of Works, and the labor at the rate of 7 cents per cubic foot of concrete, which is a rate fixed solely to cover the cost of pauper labor for the purpose of keeping accounts between the Charities Committee and the Board of Works; and would not be a fair basis to settle or adjust accounts between the city and third persons. The matter of the supplies, or work, or of price, never appears to have come before or to have been considered at a meeting of the Board of Works or Charities Committee at any time.

3. The Committee recommend that such transactions, as likely to lead to abuse, be prohibited in future. That if it should be necessary at any time for an Alderman to apply for any materials from the city, or require any work done by any of the civic departments, that he make application as an ordinary citizen and that the application be considered by his brother Aldermen in Council or in Committee and decided by them without the Alderman interested taking any part in discussion or voting thereon, and that hereafter no work be carried on by the Board of Works or Charities Department, for private persons, without a special resolution of the Council, Board of Works or Charities Committee, authorizing the same, and that the officials be notified accordingly.

4. It has also been brought to the notice of the Committee that no record or account is kept at the Poors' Asylum of the quantity of cement or other material sent out there by the Board of Works, or of the consumption or disposal of the same; nor did the storekeeper make any entry of the matter complained of on his books until the day of the investigation.

The Committee would therefore reccommend that the Charities Committee be instructed to see that the storekeeper keep a proper record of all material delivered on the premises, or received from the Board of Works, or any other source, and make entries of the disposal or consumption of the same.

Also, a report from Health Inspector Meagher on the matter, and also, in reference to drainage on Maynard Street, when it was resolved to forward the same to the City Council, with a recommendation that Sewers be built on Créighton and Maynard Streets, as suggested in said report.

The Committee would also rscommend that the Sewer ordered to be constructed on Fenwick and South Park Streets be built immediately, as the cellars in the vicinity are being flooded, and as usual deaths from diphtheria have occurred on South Park Street and in immediate vicinity.
