Alleged Inferior Concrete in Sewers.

October 18th, 1890.

A copy of a Minute of Council of the 7th inst., calling attention to a report that new Sewers are being built of Concrete as soft as bread having been sent to me with the request that I should report as to the quality of the material, and also, in what sewer unsuitable material has been used. I beg to say that it has been found expedient in several instances to construct the new sewers, or rather portions of them with green concrete placed directly in the trench. The concrete when so used is much softer than bread, in fact all concrete when new is exceedingly soft, but continues to harden day by day for a long period of time. The period when it reaches its ultimate strength depends on various circumstances unnecessary to mention here.

The greatest care is exercised in the selection of all the materials used in making the concrete, and I have no reason to doubt that Mr. Dow, who is in charge of the manufacture of the blocks at the Poor House, is equally careful in carrying out his instructions with reference to mixing materials and ramming it in the moulds. Occasionally the blocks have to be used when they are not as old as they should be which may have given rise to the report which has reached the Council, but with good well selected material, good cement and careful mixing, there is no danger in using comparatively new concrete, so long as it will stand handling, but, as a safeguard, all the different foremen have explicit orders in no case to use any concrete block, which is the least doubtful even in appearance. It is not practicable. under existing circumstances, to take any better precautions than have been adopted in this city. To exclude improper materials from being used in sewer construction, unless the Council is prepared to appoint special inspectors to watch the manufacture of each batch of concrete and others to examine each block as it is used in the sewers. I am not aware that any unsuitable material has so far been used, and if the

person who circulated the report is known, and can be got at, I would suggest that he point out the spot where he noticed such material used, and I would recommend that the place be dug up and thoroughly examined. If found to be true the only proper course to adopt will be at once to appoint trustworthy inspectors to supervise the manufacture of the concrete or to devise some other means for its production.

If it were restored to its original dimensions and kept in good order as required by the agreement, it would vent all the water it is required to carry as the whole sewerage flows down Gottingen Street except after heavy rainfall.

EMBANKMENTS AT QUEEN STREET AND FENWICK STREET.

The accompanying petition from Wm. J. Stewart and others, and the minute of council thereon referring to a hide and wool factory, at the south-end and to the condition of the embankments above referred to having being referred to me to report what steps ought to be taken to complete the works, I beg to say that it would be a desirable improvement to raise the Queen street embankment some 8 or 9 feet, and that at Fenwick street, three or four feet. The surface of the roadways might then be properly graded, macadamized and

finished and the slope neatly dressed off with good loam trimmed to an even and fair surface and then either sodded or The Queen street embankment is now being sown with grass seed. fenced as directed to protect the public. That at Fenwick street is quite as dangerous in its present state, and there is some risk in leaving it unfenced. Both embankments when finished will need to be kept fenced in order to prevent accidents, unless it should be decided to purchase the intervening grounds and fill in the whole valley, which however will involve a large expenditure. If the latter course should be adopted the large sewer which will thus be covered over to a great depth ought to be well secured and protected wherever it can now be got at by placing a good layer of concrete over the crown and at the haunches to prevent any possibility of its collapsing, which would lead to very serious results and most likely to the loss of life. Special attention was called to the necessity for this previous to the Queen street dump being commenced, but for some reason unknown to me the suggestion was not adopted.

The sidewalk from T. E. Kenny's to Prince street, is in need of attention, and I have no hesitation in recommending that the concrete sidewalk be extended to Prince street. The sidewalk on the west side of Hollis street is also in a bad state of repair on the northern half. Some portions of the southern half are in better condition, but it has settled in places and been thrown up with frost, and holds water in wet weather.

In re Railway fence on Upper Water Street.

The petition of John A. Thompson and others, having been referred to me to report upon, I beg leave to submit the following facts.

In 1881 delegates consisting of Messrs. John Doull, T. E. Kenny, Michael Dwyer and others, visited Ottawa, to urge the government to extend the Railway into Granite Wharf, and on their return recommended the Council to give the Dominion Government the Water lot at the north end and the right to bring the road in on the eastern side of Water street. In order to carry out that report an act was passed the same year to enable the Council to grant the water lot and authorizing the Dominion Government to extend the road, from any point on Upper Water Street, to the north of said water lot, along the eastern side of said street, to the wharf known as Granite Wharf, under such regulations as might be approved of by the City Council for the protection of the public.

On the 12th of September, 1882, at the request of the Board of Works, the City Engineer addressed a letter to P. S. Archibald, resident Engineer, calling his attention to the fact that the Railway department had taken fifteen feet more of Water street than was asked for by the plans submitted to the Council.

The Government claimed the right under the act referred to to take the additional quantity and their right to do so, was referred to His Honor the Recorder, who decided they had such right.

The Recorder was instructed to draw up in conjunction with the Railway authorities regulations, for the safety of the citizens, one of which was to be the erection and maintenance of a fence between the track and the remainder of the street by the Dominion Government.

The clerk has been unable to find those regulations, but I presume that in accordance with the wish of the Council one of the regulations was the erection and maintenance of the fence by the Government and it cannot now be removed by the City.
