There were five or six other lots scattered over the cemetery. These were being disposed of at the rate of three per week. The City has built a sewer along Granville Street, which ends within a short distance of his property, corner of Granville and George Streets, and Mr. Burton claims in as much as there is an old stone sewer built on George Street, and into which his corner property drains, he thinks he should be relieved of the sewer tax on the corner property, inasmuch as the property was taxed and paid its share of

the George Street sewer.

Mr. Burton, the Collector, and myself have more than once talked this matter over and what Mr. Burton means is that inasmuch as the George Street sewer built very many years ago out of the general revenues of the City, and this property in common with the rest of the citizens property having paid its share of taxes, it should not now be taxed. This piece of property was purchased by the City in December, 1883, from Mr. Carnell, and Mr. James Thomson holding a first mortgage on the land release the piece purchased, but no release was obtained from

Messrs McFatridge. I understand that \$80 was paid for the piece of land. If it is the intention of the Council to purchase it again, it would be wise to do so without delay.

CURB NORTH STREET.

Chairman Board of City Works.

SIR,—The accompanying petition having been referred to me, I beg to report:

The work objected to, embraces the laying of a granite curb and gutter on the north side of North street, from Lorne Terrace to the Railway Station, to replace the ragged and ugly looking cobble stone gutter. While I have not had the experience of the leading conservatory managers in the neighbourhood of the proposed improvement, I may point to a similar piece of work done on North Park Street, between Cogswell Street and Cornwallis Street, last season. There is a row of trees along this sidewalk, immediately inside the

curb, and much nearer than those on North Street will be. Only one tree in the whole row was seriously injured by the laying of the curb.

The old cobble stone gutter on North Street cannot carry off the water fast enough, and the consequence is that it floes over the street, cutting away the surface and carrying it into the sewer.

It is the first street seen by the stranger entering the City and the improvement should have been made long ago. I would recommend that the work be proceeded with as ordered by the Board.

The first change proposed is from 20c. to 13c. per 1000 gallons for

a daily consumption of 10000 gallons and under.

This is a sweeping reduction, as the consumption, with a few exceptions, would come under this rate. In my opinion, the Water Department cannot stand such a decrease in revenue as this change would cause, more especially, as large expenditures are being made to improve the service. I would recommend that no change be made in this part of the scale until the daily consumption, through meters, put on during the last twelve months, is determined. It will then be advisable to change the rates for small consumption, as under the present rates a daily average of 9000 gallons costs more than one of 14000 gallons.

The change recommended above 80,000 gallons, will put a premium on waste, for while 100,000 gallons a day \$8.00, 120,000 gallons only costs \$7.80, and 110,000 gallons \$7.70 a day. When the daily consumption is 100,000 gallons, a saving of 30c. a day or over \$90.00 a year will be effected by running 10,000 gallons into the harbor every day. This may be a good thing for the consumer, but is a bad measure to stop waste and should not be put in force. If the scale were continued indefinitely, and consumers could get a pipe large enough, they could get all the water they require for nothing.

I would respectfully recommend that the proposed scale be not adopted. If it is considered advisable by the Board or the Council, that the rate for any very large consumer should be reduced, it would

be better to fix a special meter rate for that particular case.

SIR,—In compliance with your request, I beg to submit the following report, respecting repairs, alterations and improvements necessary

at the Hospital for Infectious Diseases:

The roof of the barn is in a bad state and needs shingling, and in its present condition is unfit for storing hay or feed. The well should be deepened and a pipe laid to the kitchen where a pump should be placed, so that a supply of water would be available night and day. It would also be advisable to put in two water closets, and bath tub with an iron tank for supply, fed by force pump and pipes from rain water leaders. Down spouts are needed at the corners of the wings. A storm door is required at the main entrance, on the north side, and the steps should be repaired. A new floor should be put down at once in the cellar. The kitchen sink waste pipe should be trapped and vented, and a pantry built adjoining the dining room, as there is now no suitable place for this purpose. The walls of the corridors and rooms, except the male and female wards, should be painted. The ventilators on wings should be closed and the grounds should be graded and put in order. A rough estimate places the cost at about \$1600.00.

- 1. SIR,—In reply to your letter of 26th inst., I beg to inform you that the General Officer Commanding is willing to recommend to the War Office that the small piece of W. D. Ground at junction of Cogswell and Brunswick Streets, south corner, and a strip 6 feet wide on north side of Cogswell Street, between Brunswick and Gottingen Streets, under conditions detailed hereafter.
- 2. The General Officer Commanding cannot recommand recommend a grant of a strip 10 ft. wide, as such width would seriously interfere with a road in rear of the Military Hospital.

The conditions are as follows:

(a) That the fences of Hospital and Garrison Chapel enclosures be taken down and substantially re-erected at the cost of and by the city; any new timber that the removal may prove to be necessary being provided by the City; the work to be furnished by two coats of paint on all wood work.

(b) If found necessary by the Commanding Royal Engineer a new catch-pit to drain in Hospital enclosure, to be constructed to his

satisfaction inside the altered fence at the expense of the City.

(c) All legal expenses of necessary conveyancing to be borne by the

City.

(d) No action to be taken by the City in the matter until War Office approval be obtained, and the deed of conveyance duly completed.

4. On receipt of intimation that the City Council accepts these terms, steps will at once be taken to obtain War Office approval.

5. I take this opportunity of stating that no steps appear to have been taken by the City Council to carry out the requirements of the War Office in regard to transportation from War Department to the City of certain other small plots of land.

IN RE CAPT. O'BRYAN'S PURCHASE OF MARKET PROPERTY.

Sir,-In obedience to the request of your board, I give the follow-

ing facts in the above matter:

In 1890 a movement was made to purchase the Market Building, and representations were made—the purchaser would either erect a new buildings covering the whole ground or alter the old one, also covering the whole ground.

Mr. O'Bryan, by letter to the Council, asked upon what terms the property would be sold, and the matter was referred to the Board of

Works and His Worship the Mayor to report upon. They reported recommending the property be not sold, which was adopted by the Council, who instructed the Board to report what action should be taken to utilize and improve the property. The Board subsequently reported on the condition of the building, and the Council passed a resolution authorizing the Mayor, the Chairman of the Board of Works and the Recorder to negotiate for the sale of the property for a sum not less than \$20,000, said sale not to be completed until plans were submitted shewing the building or buildings to be erected, and a deposit of ten per cent. was required as a guarantee of good faith.

The committee advertized for tenders on the basis of the above resolution, and Mr. O'Bryan's tender was the highest, viz: \$20,200, and in his tender he informed the committee that the plans, &c., could

be seen at his office.

In December, 1890, the City Clerk informed Mr. Q'Bryan that his tender was the highest and requiring his plans and specification of the new building to be forwarded, in order to be submitted to the Council for approval, after which the Committee would be prepared to enter into a provisional contract of sale, and informing him that no binding contract could be made until the City obtained authority from the Legislature to sell the same.

I believe a subsequent plan was shewn the then Mayor, which was taken away by Mr. O'Bryan, and no plan or specification was ever sent by him or submitted to the Council for its approval, and no provisional contract was ever made for the sale of property, and no deposit, as required by the Council's resolution, was ever made.

Sometime after the tender was made, I understood from the then Mayor, that Mr. O'Bryan had sent a cheque for the amount of the deposit, but not certified by any bank, and when left with the Mayor, he informed Mr. O'Bryan that he would present it, draw the money and deposit it to the credit of the City. Mr. O'Bryan requested him not to present the cheque, and intimated that there were no funds to meet it and the leaving the cheque was only a matter of form, as the City could not then give a good title and the whole matter would have to remain until the Legislature met, in consequence of which, the cheque was never presented by the Mayor, and when the property was subsequently paid for, this cheque was not taken into consideration, but the whole amount of the purchase money was paid by the cheques of F. D. Corbett and J. C. Mackintosh, and a month after Mr. O'Bryan's cheque was returned to him.

It was well understood at the time the deed was given, and he repeatedly promised me as well as the then Mayor to pay his rent, and also wrote the Mayor to that effect, and it is only now he repudi-

ates the rent.

It is true that at one time he requested two of the City tenants to pay him their rent, but I demanded it from them and they sub-

sequently paid. It is too clear for argument that he ever owned or had the slightest claim to refuse to pay his rent.

He is indebted to the City of Halifax for rent and taxes in the sum of \$841.65.

A few days after the rent was due, and upon Mr. O'Bryan hearing that the rent, \$125.00, was not likely to be paid for the reasons stated in the report of Mr. O'Bryan, placed the Deputy-Sheriff in charge and levied on the fire apparatus contained in the Old Market Building referred to. He remained in charge for several hours, then left. At this time causing no inconvenience to the department other than anxiety. A few days after Mr. O'Bryan again levied on the apparatus, removing several lengths of hose from the hose carriage, and conveyed the hose carriage and several lengths of hose from the building and offered the same for sale, causing inconvenience to the department and an expense in providing for the loss of same. A day or two after His Honor the Recorder replevined the property, since which time the City has been in peacable possession of the same.

The petition and application of the Nova Scotia Telephone Co., Limited, humbly sheweth:—First. That on the 27th September, 1887, by a resolution of your honorable body, permission was given to your petitioner to erect poles upon and along the streets of the City of Halifax, for the purpose of its business, subject to the supervision or direction of the City Engineer, and subject to the control of the Board of Works.

Second. That under said resolution your petitioner has from time to time obtained from the City Engineer, upon application to the Board of Works, permission to erect poles in various streets of the City. Your petitioner begs leave to refer to the said resolution.

Third. On the 25th of January, 1892, your petitioner applied to the City Board of Works for permission to erect certain poles, a copy said application is enclosed herewith. In reply, your petitioner received from the City Board of Works, through the City Engineer, a letter granting permission to erect such poles, thereafter the City Engineer located and approved of the sites of all the said poles, including these on the north side of Spring Garden Road, between Pleasant Street and Dresden Row, and poles have been erected by your petioner on the said north side of Spring Garden Road, at the points located and approved by the City Engineer. All the poles in said application mentioned, have been erected, excepting about nine poles on Granville Street, and six poles on Barrington Street, and

they have been so erected under the supervision and direction of the

Your petitioner therefore prays that your honorable body may be pleased to grant the permission asked for in the said application of your petitioner, dated 25th January, 1892, and therein to ratify and confirm the permission already granted by the Board of Works and the City Engineer, and your petitioner as in duty bound will ever humbly pray.

Motion passed, and the following is introduced:—Resolved, And the City Engineer is hereby instructed to pave that portion of George Street sidewalk running west from the Ferry Wharf to Water Street, the same to be paid for out of the appropriation for permanent work. Moved by Alderman Pickering, seeonded by Alderman Lane, and on being put is passed.

Moved by Alderman Lane, seconded by Alderman Foster, that No.

32 on Order Paper be now considered. Motion passed.

Read No. 32, viz.: Report of Board of City Works relative to placing granite gutters and curbs on Barrington Street from Bells' Lane to Cornwallis Street, and report of City Engineer thereon.

The Board of Works beg to report that having had before them a resolution regarding the placing granite gutter stones and curbs on Barrington Street from Bell's Lane to Cornwallis Street, and a report from the City Engineer endorsing the proposition. CURB AND GUITERS, BARRINGTON STREET.

Chairman Board of City Works:

SIR,—At the last meeting of your Board a resolution was referred to me for report favouring the laying of granite curbs and gutters on both sides of Barrington Street, where required from Bell's Lane to Cornwallis Street, the cost to be charged to the Permanent Paving Fund. In considering the question of any expenditure or permanent paving account, I would strongly advocate the restriction of such expenditure at present to the principal business streets. There has always been a cry from the rate-payers that a great deal of money was spent, but there was nothing to show for it. The principal reason is because the money spent has been scattered about in allevs and bye-streets in the suburbs, while the requirements of streets in which the result of any expenditure would be seen were overlooked. This gave people the impression that the money was not spent to the best advantage.

I am of the opinion that the permanent pavement fund was intended for the improvement of our principal streets, and for that reason urge that the expenditure be restricted to certain districts.

Barrington Street seems destined to be our main street. If the railway is extended to Cornwallis Street the greater part of the traffic between the station and the centre of the City will be on that street. The street railway track takes the best part of the roadway and throws ordinary traffic into one rut on either side between the rails and the cobble stone gutter. This keeps the street in a bad condition the year round. A granite curb and gutter could not only greatly improve the appearance of the street, but would practically widen it, as the whole roadway from curb to curb, would be available for traffic. It is certainly advisable that the first impression of strangers should be favorable, and the improvement suggested on this street would, in my opinion, justify the expense. I therefore recommend that it be carried out, and the expense charged to permanent pavement.

Whereas, The piece of property at the corner of Pleasant Street and Spring Garden Road, commonly known as the old burying ground, though controlled by the parish of St. Paul's in this City, was used as a place of Sepulture by all religious denominations from the very foundation of Halifax down to the close of the century, and afterwards by all except the Roman Catholics and the Methodists until the year 1844, when the whole of the Cemeteries in the City, excepting those belonging to the Imperial Government, were closed by law.

And whereas, The old burying ground afore mentioned has remained since the closing, and is at present in a state of neglect and dilapidation surprising to strangers, and most discreditable to the Citizens of Halifax.

Resolved, That a committee of this Council be appointed to confer with the authorities of St. Paul's parish with a view to ascertain whether some arrangement satisfactory to all parties cannot be arrived at whereby the old burying ground, the last resting place of the forefathers of our Citizens for many generations, may be renovated and beautified, so as to become, as undoubtedly it would, an attractive place of resort to be ever open and free to all, and kept in order at the public expense.

Moved by Alderman Dennis, seconded by Alderman Hamilton, and

passed.

Moved by Alderman Hamilton, seconded by Alderman Pickering, that No. 8, viz: Report City Health Board, covering draft rules and regulations for Water Takers, Plumbers, &c., with letter from Secretary Board of Health, be struck from Order Paper. Motion passed.

Moved by Alderman Pickering, seconded by Alderman Hamilton, that the following items be struck from Order Paper, viz.:—No. 12, letter of E. L. Fenerty, County Councillor, asking the City Council to pay proportion of cost of keeping in repair the road leading from the head of the North-West Arm to 3-mile house, with letter of County Clerk on the subject. No. 3, report of City Engineer in re waste of water through Hopper Water Closets and otherwise. No. 4, report Board of City Works and City Engineer re sidewalks to be paved under paving act. No. 15, report of City Engineer on streets requiring macadamizing with estimated cost of same.
