### Chairman Board of Works:

#### SIR—The experience of this department during the last two years, shows the urgent need of a radical change in the method of keeping, (or rather neglecting to keep) street records and plans, by the aid of which, we could fix exactly the street lines and boundaries. I presume there was originally a town plot and that the lines, grades and boundaries were defined, but if any record or plan existed which would be of value to-day, it has long since vanished from the archives of the City. I have already reported in reference to new streets, and the Council have authorized the preparation of an Act placing the location and laying out of new streets in the proper hands. The proposed Act will not cover the old streets. When a street line is asked for we are often puzzled to know where the exact line is, and even when we do know we cannot always prove it. In a recent suit over a street line, the opposing Counsel admitted to me privately, that he knew I had given the correct line, but added, "Let me see you prove it." So long as the present state of affairs is allowed to continue, the City will be involved in expensive law-suits, or builders must be permitted to encroach on the streets, destroying their appearance and taking land which the City will be obliged to purchase in the future, at ten times its value. We may not be able to recover all we have lost, but we can at least prevent further loss. There should be an official plan, showing all streets and city property, and stone boundaries or monuments should be set at every corner, as is now being done in the Water Department. We would then be able to prove postively all lines and streets.

I would recommend that His Honor the Recorder be instructed to prepare an Act containing the following provisions and such others as he may deem necessary or advisable :--

1. In order to provide that, whenever in future it may be determined to open new streets, highways, squares or public places in the City of Halifax or to extend, widen, alter or locate anew those already in existence, such work may be carried out with a due regard to regularity and system, and for other purposes, the City Council of Halifax are authorized and empowered to cause to be prepared, under the supervision of the City Engineer, an official plan of such City, upon which shall be shown all existing public streets, highways, places and squares which have heretofore been dedicated to and accepted by the said city by resolution of said City Council or conveyed to said City or laid out under any statutes relating to said city or under any law of the province; also such proposed or contemplated extensions or other alterations of the same, and all such proposed or contemplated new streets, highways, places and squares, as the city council may think it desirable, on the recommendation of the City Engineer, to have set down or shown upon such plan.

2. The City Engineer, for the purpose of providing such plan, may employ such persons, if any, in addition to his usual staff of employees as may be necessary. The persons employed by the said City Engineer, shall under his supervision and direction, and under as uniform a system as circumstances may permit, proceed to lay out, fix and determine such contemplated new streets and alterations of existing streets, of such width, dimensions and extent as may appear to him nost desirable for the public interest 3. The City Engineer and any and all of his staff of employees engaged in the

3. The City Engineer and any and all of his staff of employees engaged in the discharge of the duties assigned to them, in and by the preceding sections, may and they are hereby authorized to enter in day time upon any property within the limits of such City; they shall under the directions and supervision aforesaid, make out a plan or map indicating the streets now existing, as well as those which they shall lay out and determine in virtue of this Act, and they shall designate upon such plan the new lines of the street or sections of streets that it may be deemed advisable in the interests of the public to widen, extend or otherwise alter.

4. When the plan hereinbefore provided for shall be completed, the City Council shall at a meeting thereof either confirm or alter or amend such plan. Public notice of the completion of such plan and of the contemplated confir-Lation thereof shall be given in at least two newspapers published in the City aforesaid, for at least four weeks previous to the meeting of the council at which such plan is to be confirmed. Such notice shall also state that such plan may be viewed or inspected by citizens at the office of the City Engineer (where it shall be deposited) up to the day of the date of such meeting, at such meeting or an adjournment thereof or at any subsequent meeting, the Council shall hear all objections to such plan, and shall thereafter confirm, alter or amend the same.

objections to such plan, and shall thereafter confirm, alter or amend the same. 5. When such plan shall have been either confirmed by the City Council as submitted to them or adopted in an amended or altered form, the same shall be transmitted with all convenient speed to the Governor-in-Council, by whom it shall be either confirmed or sent back to the City Council for amendment or alteration. If such plan is so sent back, the City Council shall, if they think proper, amend or alter it in whole or in part, as suggested by the Governor-in-Council, and again submit the same to the Governor-in-Council. If thirty days shall elapse from the date of the first or any subsequent transmitting of such plan to the Governor-in-Council without disapproval or sending back, the plan shall be deemed to have been approved and confirmed by the Governor-in-Council.

6. Such plan, when finally confirmed as aforesaid, shall be decisive and binding upon the City Council, the City, the property owners therein interested, and all other persons whomsoever, and no indemnity or damages shall be claimed, granted or allowed, at the time of or in consequence of the opening of any of the new streets shown on such plan, or at the time of or in consequence of the opening of any of the new streets shown on such plan, or at the time of or in consequence of widening, extending, altering or locating anew existing streets in accordance with such plan, for any building or improvement whatsoever, other than necessary repairs, that the proprietors or other persons whosever may have made or caused to be made, after the confirmation of such plan, upon any land or property reserved on such plan either for new streets or for the alterations of existing streets. No proprietor or any other person shall claim or receive any damages or indemnify for any right of way or other easement destroyed, injured or affected by the opening of any new street or of any alteration show on such plan; provided that nothing in this Act shall be construed as depriving the City Council of the right to exten ' or widen any of the streets or squares designated in such plan, after its confirmation, if it be deemed advisable so to do.

7. After such plan shall have been finally confirmed as aforesaid, no street not laid down or shown on such plan shall be dedicated to or for the public use of the citizens, or accepted by the City Council, unless the same shall be throughout fully graded, furnished with proper sidewalks, main sewer and gutters, and completed to the satisfaction of the Board of City Works and also that of the City Engineer, to be shown by his written certificate. Such work shall be planned by and carried out under the supervision of such City Engineer. No street whatever shall be so dedicated or accepted as aforesaid, unless the same shall open at both extremities upon streets shown upon such plan, or shall so open at one extremity and shall open at the other extremity upon the shore of the Peninsula not higher than the high water mark. Any person violating the provisions of this section shall incur a penalty of not less than one hundred dollars, nor more than one thousand dollars for each such offence.

8. Duplicates of such official plan, certified by the City Engineer, shall be deposited as soon as conveniently may be after its completion, in the offices of the City Engineer and City Clerk, and after the confirmation of the Governor in Council, in the City Engineer's office, the Crown Land office, and the office of the Registrar of Deeds for the County of Halifax.

9. The City Council shall have all the necessary powers to open to the public whenever they shall deem it advantageous to do so in the interest of the City, any new street, highway, public place or square, shown on such official plan; and also to extend, widen or alter any of the streets, highways, public places or squares, therein indicated as extended, widened or altered; after having adopted, however, the formalities and procedure prescribed by the law for the time being in force, with respect to the acquisition of land for such purposes in the City of Halifax.

10. No street whatever, not shown on the official plan, shall be opened by any person without the consent of the City Council opproved by the Governor in Council. A correct plan showing any such proposed street on a scale of thirty feet to the inch shall be furnished by the party interested to the City Engineer, who shall certify that such street is of the proper dimensions and otherwise satisfactory, before the consent of the City Council shall be given to open the same.

11. The City Council shall not be obliged to accept, on behalf of the citizens, any street heretofore laid out, which shall not at the time of the passing of this Act have been effectually dedicated to the public use and duly accepted, unless such street shall be shown on such official plan. Any such street not so shown, shall be closed up by order of the City Engineer, and fenced up by the party legally bound to fence the same.

12. In this Act, unless the context precludes such construction, the word "Street," shall include street, highway, public place and square; the word "Alter" shall include alter, widen and extend; the word "Alteration" shall include alteration, widening and extension; and the word "Plan" shall include plan and map.

13. The expense to be incurred in procuring the official plan herein provised for, and completing the same according to the provisions of this act, may be defrayed out of the street appropriation or such moneys as the City may appropriate for the purpose out of any sums at the disposal of such Council, or out of the unexpended residue of any sum borrowed for any other purpose whatsoever, under any other act of the Legislature.

Immediately after the confirmation of the official plan of the City by the Governor in Council, the City Engi eer shall set and fix such bounds and monuments as he may deem necessary on all streets and proposed streets and in such other places as he may think advisible, and such bounds and monuments when set and fixed as provided, shall determine the location and lines of all public streets and city property.

### TOWER ROAD SEWER.

### Chairman Board of Works:

SIR,-I beg to report on the accompanying letter from R. J. Wilson asking at whose instance and under what authority the Tower Road sewer was constructed.

It was ordered by the Council on the recommendation of the Engineer, on the 14th day of September, 1892, under the authority of Section 16 of Chapter 60 of the Acts of 1890.

I find on consulting the reports that the City Engineer was instructed to inspect the Tower Road School, and investigate the cause of complaints made to the Board of Works in August, 1892. In September, 1892, the Chairman of the Committee on School Sites requested me to report the urgency of the sewer to the Board of Health. In view of a possible visit of Cholera and the attendance of children at the school the Board of Health asked the Council to order the construction of the sewer, and their request was complied with.

#### WATER STREET PAVEMENT.

#### Halifax, N. S. December 18, 1893.

#### Chairman Board of Works:

SIR,—In passing over Water street this morning, I noticed several depressions in the pavement where trenches have been opened. The breaking up of the pavement is the ruination of the work, and to prevent the destruction of concrete sidewalks and further injury to the paving, I would recommend that the Recorder be instructed to prepare an Act providing that no permits be granted to break the street where it is paved or concrete sidewalks are laid. All necessary work should be done by the City, the person who requires the work done first depositing with the City Treasurer, the City Engineer's estimate of the cost of the work. The Gas Company are in the habit of breaking up the paving where they feel inclined, and the Act should include their work as well as private work. Possibly an Ordinance will be sufficient. However, that is a matter for His Honor the Recorder.

Mott, soap, 4.50; Black, Bros. & Co., brushes, fork, etc., 3.50; John O'Connell, horse shoeing, 17.46; John Foley, plasterers work, 5.15; George F. Harris, tinsmith work, 9.76; V. F. Farrell, oil, 8.87; Martin, Young & Co; painting, papering, etc., 139.76; John Connolly, feed, 426.57, Cragg, Bros. & Co. 17.50, 10.65, 4.80, 31.50, 29.88, total 94.33; James Monaghan & Son, mason work 16.80; A T Graves, repairs to engine, 97.50 —Total \$977.44. Your board also beg to report that a quantity of hose now in use by the department is on account of age becoming unservicable and in the event of an emergency arising where a very large quantity of hose would be required or in the case of a second fire occurring in winter before the hose used at the first fire was thawed out and again ready for use. Your Board feel that they would hardly be in a position to successfully cope with said second fire as they could not place any reliance upon the hose they would have to fall back upon. They therefore recommend that this council make provision for the purchase of an additiona 2000 ft. of hose to place the department in a thorough state of efficiency.

## EVENING SESSION.

### 8.10 o'clock.

### DECEMBER 26th, 1893.

A meeting of the City Council was held this evening. Present: His Worship the Mayor, Aldermen Allen, Morrow, Stewart, Wallace, Dennis, Hamilton, Duggan, Mitchell, Ryan, Hubley, O'Donnell, Foster, McFatridge and Mosher.

The Council was summoned to consider the estimates for the civic year 1894-5. to proceed with business standing over and the transaction of other business.

The minutes of last meeting are read and confirmed.

Alderman Dennis submits estimate for year 1894-5.

Alderman Mosher. Chairman Board of City works, submits a report from the City Engineer on cost of making an official plan of the City of Halifax.

Alderman Dennis, Chairman, submits a report from the Committee on Public Accounts on several matters.

His Worship the Mayor submits the following papers: A letter from the Citizen's Reform Association, giving outline of bill to be presented to the Legislature, *re* civic reform.

Letter from Archibald McKinnon re extension of time on his contract for trenching for new pipe line.

Report of Exhibition Committee on exhibition matters.

Letter from His Honor the Recorder re suit Pollet vs. The City of Halifax.

Report of Board of Fire Wards and Fire Commissioners for the year 1892-3.

Letter from William Woodill covering account of appraisers for appraising property re Extension of Agricola Street.

Cash 'Statements City Treasurer, "General and Water," for November, 1893.

Moved by Alderman Morrow, seconded by Alderman Mosher, that the Order of the Day be suspended to read the papers handed in. Motion passed.

Read report of the City Engineer giving an estimate of the probable cost of preparing an official plan of the City of Halifax. Placed on Order Paper.

Read letter from Hon. L. G. Power giving an outline of the Bill on Civic Reform proposed to be presented to the Legislature at its next session by the Citizens' Reform Association.

Moved by Alderman Foster, seconded by Alderman Hamilton, that the same be placed on the Order Paper, and the City Clerk instructed to acknowledge its receipt and request that the City Council may be furnished with a copy of the proposed Act as they do not deem it advisable to take any action in the matter until they have before them the entire Act. Motion passed.

Read report of the committee appointed to confer with a committee of the Halifax County Agricultural Society relative to the holding at Halifax of the Provincial Exhibition, 1894. Recommending that the Exhibition be held at Halifax, and offering certain suggestions respecting the management of the Exhibition.

#### To the Members of the City Council:

The committee appointed to confer with a committee of the Halifax County Agricultural Society with respect to the Provincial Exhibition of 1894, beg leave to report as follows:

The joint committee met in the City Hall, on Saturday afternoon, 23rd inst.

The joint committee were of opinion that the funds available for the Exhibition, namely, government grant, four thousand dollars (\$4,000) surplus from last exhibition, three thousand dollars (\$3,000) city grant for improvements to grounds, three thousand dollars (\$3,000), in all ten thousand dollars (\$10,000), together with a guarantee from the city, of two thousand dollars (\$2,000) if needed to make up any deficiency, were sufficient to warrant the undertaking of the Exhibition.

Your committee therefore recommend that the City Council notify the Provincial Secretary that the City of Halifax is prepared to undertake the holding of the Provincial Exhibition of 1894 under the conditions established by law.

The joint committee offered the following suggestions respecting the management of the Exhibition.

That a general committee be appointed to have full and complete control of all the affairs of the Exhibition, such committee to be composed as follows:— Eight aldermen to be no initiated by the Mayor, and approved by the City Council, and to continue on the committee so long as they remain in the Council, five citizens of Halifax to be chosen by the Provincial Government; five other citizens of Halifax, to be chosen by the Halifax County Agricultural Society.

The Mayor of the City of Halifax, the representatives of Halifax in the House of Commons and House of Assembly and also the Senators and Legislative Councillors who are citizens of Halifax, to be also members of the committee.

This general Committee to appoint a small executive committee of such number as may be determined on by the general committee, to have the general management of the exhibition, subject of course, to the general committee.

The general Committee to have power to appoint auxiliary sub-committees not confined to their own number, for the purpose of assisting i. the various departments of exhibition work.

That application be made to the Legislature, for an Act constituting the members of this General Committee and their successors in office, a permanent commission for the management of exhibitions in the City of Halifax.

That pending the enactment of Legislation creating the commission, the general committee above referred to be requested to proceed with all necessary work for holding the exhibition, and that the g neral committee have power to add to their number such persons as may be approved by the City Council.

Your Committee recommend that this outline plan for the management of the exhibition be approved by the Ctty Council.

### M. E. KEEFE, Chairman.

Moved by Alderman Dennis, seconded by Alderman Mosher, that said report be adopted and His Worship the Mayor requested to nominate the Councils' Committee at this meeting. Motion passed.

His Worship the Mayor names the following as the committee of the City Council on Provincial Exhibition, 1894, viz.:—Aldermen Allen, Dennis, Duggan, Ryan, McFatridge, Mosher, Hamilton and Morrow. On motion said nominations were confirmed.

Read letter from His Honor the Recorder announcing the judgment in the suit, Pollett vs. The City of Halifax, was given in favor of the City.

### POLLETT VS. THE CITY OF HALIFAX.

#### Halifax, N. S., December 26, 1893.

Halifax, N. S., Dec. 18, 1893.

This was an action brought by the Plaintiff against the City, for negilently piling brush near the sewer on Gottingen Street while building, in consequence of which it fell down it is alleged, and upset the plaintiffs carriage and injured his horce. It was tried before Judge Townshend a few days ago, who gave judgment for the City. WILLIAM F. MACCOY, Recorder.

#### His Worship the Mayor.

Read Annual Report of the Board of Fire Wards and Fire Commissioners for the Civic year, 1892-3. Moved by Alderman Mosher, seconded by Alderman Dennis, that said report be referred to the Committee on Publication of Annual Report, to be printed in said Annual Report. Motion passed.

Read letter from William Woodill covering an account from the appraisers appointed to appraise the property required in connection with the proposed extension of Agricola Street. Moved by Alderman Mosher, seconded by Alderman Duggan, that His Worship the Mayor be authorized to pay said account (\$30.00) out of any available fund. Motion passed.

Read report from the committee on Public Accounts on various matters referred to them by the Council. On motion the same is taken up clause by clause.

#### To the Mayor and City Council,

Gentlemen-Your (ommittee on Public Accounts beg to report as follows, on

various matters referred to them :--

1. With reference to the annexed account of George H. Fielding for \$45. for professional services in the police Court, etc.—Mr. Fielding says that he was employed be Policeman Louis Nickerson, and the bill was sent to the City by Nickerson's instructions. In another instance he was engaged by Policeman Watchhorn. Neither the Mayor or Recorder has any recollection of authorizing the employment of Mr. Fielding.

Your Committee count recommend the payment of accounts contracted by policemen without proper authority, and therefore suggest that the City Clerk write Mr. Fielding that the City does not hold itself liable for the amount.

His Honor the Recorder is the legal officer of the City, and your Committee recommend that hereafter when additional legal assistance is required that outside Counsel be employed upon the written instructions of the Mayor.

2. With reference to the appeal of the Directors of the "School of Art and Design" for a renewal of the Civic grant of  $$5^{(0.00)}$ , your Committee recommend that the same be granted for the next year. The existence of the school depends upon the Civic grant, and we believe that the work done by the Institution in instructing your mechanics in free-hand drawing, etc., is worth the money to the City. But your Committee believe that the grant to this school, as well as to the schools for the blind and deaf and dumb, should be dealt with by the School Board, and not by the Council; and recommend that in future the Directors of these Institutions be notified to ap ly to the School Board for Civic assistance.

3. In reference to the request of the Commissioners of Point Pleasant Park for \$1,000. for filling up Steeles' Pond, etc. Your Committee, while appreciating the efforts of the Chairman of that Board to improve and beautify the park, urge that the Commissioners be notified that they must keep their expenditure within their appropriation We recommend that the over expenditure by the Commissioners to the extent of \$500. be paid by the City, as authorized by the Legislature last year; and that any additional over-expenditure be paid out of the appropriation.

4. Your Committee have examined a number of old accounts referred to them for report. These liabilities were incurred by various Committees, without any moneys being provided to pay them. In some cases the accounts stand back for two and three years. These unprovided for accounts are another object lesson of the slip-shod manner in which the City business is sometimes transacted. But the liabilities having been incurred, the accounts must be paid, and your committee recommend that application be made to the Legislature to borrow the annual instalments. These accounts are :-

(a) For printing Electoral Lists, etc. :

These accounts are certified to by Alderman McFatridge, Chairman of the Revisors. Owing to the requirements of the Statute regarding the printing of the occupations and residences of voters. The revision of the lists last year cost the City over \$1,000.

(b) Amount due the Association for the Relief of the Poor, \$2,600.00. In order to provide employment during the winter months, the City has for a great many years purchased 20,000 to 30,000 bushels of broken stone from the Association for the Relief of the Poor. These stones were used on the streets and paid for out of the street funds, but it is found fully 20 per cent. cheaper to use broken stone from the Crusher (or Rockhead); therefore but comparatively title of the 65,000 bushels of stone purchased from the Association was used this year, and not being used, only about half was paid for from the usual fund. But the obligation having been incurred with the approval of the Council, the Council must provide the money to pay the balance due with interest.



Your committee on Public Accounts beg to report that they have examined the monthly returns referred to them :

2. Of the water rates collected by the City Collector.

3. The statement of the moneys received and paid by the City Treasurer for general civic purposes.

4. The statement of the moneys received and paid out by the City Treasurer for the Water Department.

5. The statement of monthlp cash balances at the credit of various departments.

These returns are signed by the Auditor as having been examined by him and compared with the books of the Collector and Treasurer. They are furnished to the Council as an exact copy of the books of these officials showing each entry of taxes received the day the ancunt from whom each payment made by the Treasurer the amount to whom and for what purpose. By examining these monthly returns each alderman and citizen may make and keep himself familiar with the detailed receipts of taxes and water rates and the purposes for which the moneys are disbursed.

Your committee had before them the report of the Board of City Works covering report from the City Engineer recommending the changing of the commencement of the civic year from May 1st to January 1st, and beg to report that while endorsing the recommendation of the City Engineer it is advisable the City work should commence as early in the season as possible. ### The following resolution is now introduced :---

Resolved, That His Honor prepare an Act to amend the present Act in respect to the Constitution of the City Council.

 The City Council shall consist of a Mayor, who shall be elected annuallyand who shall be paid a salary of \$1000.00 per year, and 18 Aldermen 2 representing each ward and 6 representing the whole city and called the Executive.
The term of office for the 12 Aldermen representing the 6 wards shall be 2

2. The term of office for the 12 Aldermen representing the 6 wards shall be 2 years unless he shall be elected to fill an extraordinary vacancy, in which case, he shall ser e for the unexpired term of nis predecessor, or unless he shall resign or become disqualified.

3. The term of office for the 6 Aldermen elected by the City, shall be 3 years unless he shall be elected to fill an extraordinary vacancy, as named in Clause 2 of this resolution, when the same course would be pursued.

4. Qualifications to be the same as mentioned in present constitution.

5. Election for the 12 Aldermen for the 6 wards to be conducted as it is at present for Aldermen, the election of the other six to be conducted and held the same as that for Mayor.

6. Vacancies, penalties, rules of Council, to be the same as they are at present. 7. Committees—The 6 Aldermen elected by the whole city shall do the work of the present named Committees in clause 105 of the City Charter.

Also serve as School Commissioners for the City of Halifax with 6 others, appointed by the Local Government.

8. City officers to be appointed as at present excepting the 2 Aldermen now elected by the Council to serve on the Board of Health who after the passing of this Act will be elected by the 6 Aldermen from their number.

9. The amount \$1:00.00, estimated for Commissioners of Bc ard of Works, also \$200.00, the sum paid the 2 Aldermen at present by the Board of Health and any other sum this Council may agree upon to be paid the 6 (Executive) Aldermen for their services and shall be apportioned amongst themselves at the close of the civic year according to the regularity and promptness of their attendance at their Committee meetings and the City Council.

Moved by Alderman Foster, seconded by Alderman McFatridge, and placed on Order Paper.

Read clause 2 re accounts for payment. The following resolution is now introduced:

Resolved, That the second clause of the report of the Board of Fire Wards and Fire Commissioners re accounts, be adopted and His Worship the Mayor authorized to sign warrants for the payment of the several accounts named therein.

Moved by Alderman Ryan seconded by Alderman Mosher and passed.

Read notice from George H. Fielding, solicitor of Sarah Smith that an action would be brought against the city in the City Civil Court at Halifax to recover the sum of four dollars amount of fine imposed upon the said Sarah Smith in the Police Court. Moved by Alderman Dennis seconded by Alderman Duggan that the same be referred to the committee on laws and privileges together with His Honor the Recorder for report. Motion passed.

Read letter from Robert Theakston, City Collector, covering lists in duplicate, of rate payers entitled to sign petitions for liquor licenses. Ordered to be filed.

Read letter from His Honor the Recorder, covering Draft Act to amend the City Charter, &c., also read said Draft Act."

Moved by Alderman Allen seconded by Alderman Dennis that the Order of the Day be further suspended to allow Alderman Dennis to introduce a resolution. Motion passed.

The following resolution is now introduced:

Whereas, On several ocassions, bills have been introduced into the Legislature, vitally affecting the interests of the City of Halifax and imposing additional taxation upon the citizens, without the consent or knowledge of the City Counci) the direct representatives of the citizens.

Resolved, That the Legislative Assembly and Legislative Council be and are hereby respectfully asked not to consider any bills relating to the City of Halifax emanating from any source other than the City Council, without first furnishing the Mayor with a copy of such bill and thus affording the Council an opportunity of considering and expressing its opinion on the same.

That copies of this resolution be forwarded to the Hon. Speakers of the Assembly and Legislative Council and the Hon. Provincial Secretary.

Moved by Alderman Dennis seconded by Alderman McFatridge and on being put is passed.

Moved by Alderman Dennis seconded by Alderman Ryan that clause 2 of the draft Act submitted by His Honor the Recorder and herein before referred to, be amended by substituting for the words "as heretofore to the City Clerk" the words "to the clerk of the Police and City Courts." Aldermen Hamilton, Duggan and O'Donnell, object to said clause 2 which is placed on Order Paper.

Moved by Alderman Dennis seconded by Alderman Ryan that said draft Act with the exception of said clause 2, be adopted, and His Honor the Recorder directed to forward it to the Legislature for enactment. Motion passed.

Moved by Alderman Wallace seconded by Alderman Dennis that His Honor the Recorder be directed to prepare a summary of the Acts relating to the City of Halifax emanating from the City Council and to be submitted to the Legislature at its present session and have them published in the newspapers advertising for the city. Motion passed.

Read petition of C. M. B. Manley and others against the erection of a Steam Saw and Planing Mill on property between Gottingen and Maitland streets. Moved by Alderman McFatridge seconded by Alderman Ryan that the same be forwarded to the Board of Fire Wards and Fire Commissioners with His Honor the Recorder for report. Motion passed.

Read report of committee on City Prison covering accounts, &c., for month of December.

City Prison, Jan. 2, 1894.

At a meeting of the City Prison Committee, held to-day these were present Aldermen Stewart, Hubley and Acting Chairman Alderman McFatridge.

Moved by Alderman McFatridge seconded by Alderman Hubley and passed.

Read City Collector's statements, of rates and water rates collected during the month of December.

Read City Treasurer's cash statements (general and water) and statement of balances to 31st December. Moved by Alderman Foster seconded by Alderman Dennis that said statements be referred to the Committee on Public Accounts for report. Motion passed.

Read suggested resolution from His Worship the Mayor re changes in civic government.

### JANUARY 9th, 1894.

Read letter from Hon. L. G. Power covering a draft Act entitled "An Act respecting the Government of the City of Halifax" and asking that representatives of the Citizens' Reform Association be heard in behalf of said Bill. Said Act is now read by its title.

Moved by Alderman Foster seconded by Alderman Hubley that Hon. Senator Power be heard by the council. Motion passed.

Having been invited by His Worship the Mayor to the floor of the Council, Senator Power now addresses the Council explaining the features of the Bill.

Moved by Alderman Allen seconded by Alderman Duggan that the further consideration of the various proposals concerning the government of the City be deferred to a meeting of the Council to be called by His Worship the Mayor at an early date for the special purpose of dealing therewith. Motion put and lost, 7 voting for the same and 8 against it.

His Worship the Mayor leaves the chair which is taken by Alderman Mosher.

The Mayor from the floor of the Chamber addresses the Council on the proposition submitted by him relative to change in system of Civic Government. After which His Worship the Mayor again resumes the chair.

Moved by Alderman Mosher seconded by Alderman Foster that the Council adjourn. Motion put and passed, 9 voting for the same and 6 against it.

Council adjourns 10.40 o'clock.
