IN Re CALDWELL ESTATE SEWERAGE RATES.

SIR,—In reference to the accompanying letter from the Naval Storekeeper, I have been unable to report until I could get a statement of the fixtures. Mr. Morrison has been so buisy that the statement has not been prepared until this week.

The agreement quoted is dated October 1st, 1881. The fittings were taken in 1883, and since that date there have been added without permission or knowledge of the City authorities 21 taps, 9 urinals, 3 water closets, 1 bath and 1 steam engine, for which no additional rate is paid. This is in direct violation of the agreement—clause 7 of which provides that no additions are to be made to the fittings without written permission from the City authorities.

I do not think the difference in consumption in the ships would be as much as the Naval Storekeeper estimates, and I am of the opinion that adjustment of the rates should be in the City's favor Under these circumstances there should be no reduction made at present in the rates charged the Naval Authorities for water.

I can add nothing that you one and all are not already familiar with as to his merits. I was personall acquainted with the deceased for a great many years. I knew him as John S. D. Thompson, an humble citizen; I knew him as John S. D. Thompson, an Alderman of the City of Halifax; I knew him as John S. D. Thompson, a member of our Provincial Parliament and a member of our Provincial Government; I knew him as a Judge of our Supreme Court; I knew him as a member of the Dominion Parliament and a member of the Dominion Government; and I knew him as the Prime Minister of Canada, and I am more than pleased to say, as all who chanced to know him will with me agree, that he was still only John S. D. Thompson in cordial greeting whenever his friends met him. Honors or titles did not turn his head or lead him to forget "auld acquaintance."

Now, while we all deplore his untimely end and the country's loss, a palliative to our grief is the reflection as death is our common lot he died as a general at the head of his army, with the honor of his sovereign attached to his breast and the respect and good will of his fellow countrymen forever attached to his name; and this, I hope, will in some degree assuage the grief of his beloved wife and children in this their hour of tribulation.

Alderman Wallace, after addressing the Council, moved the following resolution, which was seconded by Alderman Morrow.

Whereas, Sir John Thompson, Premier of Canada, and formerly for some years a valued member of the Council, has been stricken by the hand of death just as he had attained the high honor of admittance to Her Majesty's Imperial Council.

Resolved, That the City Council of Halifax deeply deplores the tragic event whereby our city has lost its most talented son, and our country its most distinguished statesman, a man who from the ranks of the ordinary citizen rose

with unique rapidity and serenity and by sheer force of intellect to the highest position possible to a Canadian statesman, and throughout his career devoted his eminent talents unsparingly to the service of his country.

The City Council desire to express sincere sympathy with Lady Thompson and her family in the great sorrow that has fallen upon their home.

Said motion being put is passed unanimously.

The following resolution is now moved by Alderman Mosher and seconded by Alderman Creighton.

Resolved, That a copy of the resolution just adopted be transmitted to Lady Thompson.

Further resolved, That His Worship the Mayor be requested to appoint a Committee from the Council to co-operate with the officials having in charge the arrangements for the funeral of the late Premier, and that the Council attend the funeral in a body.

Motion passed.

Moved by Alderman Stewart, seconded by Alderman Hamilton, that the same be referred to the Committee on Hacks and Trucks to deal with at their earliest convenience. Motion passed.

Read letter from City Clerk covering correspondence, etc., with the military authorities relative to the extension of Brunswick Street southwardly through Imperial property. Moved by Alderman O'Donnell, seconded by Alderman Dennis, that a Special Committee be appointed to take the matter of said extension into consideration and report thereon, and that the correspondence submitted be referred to them. Motion passed.

Read return of City Collector of persons entitled to sign Liquor Licenses for year 1894. Laid on the table.

His Worship the Mayor nominates the following named as a Committee to report on the advisability of establishing a public slaughter house to be operated by the city, viz., Aldermen Mosher, McFatridge, Duggan, Ryan, Dennis and Geldert.

Moved by Alderman Hamilton, seconded by Alderman Wallace, that said nominations be confirmed. Motion passed.

Moved by Alderman Dennis, seconded by Alderman Eden, that the name of Alderman Wallace be substituted for that of Alderman Dennis on the committee appointed to devise a scheme for the superannuation of civic officials. Motion passed.

The Council now proceeds to deal with the matter for which it was specially called, viz., to deal with all matters relating to the present system of assessment of real and personal estate, etc.

The following resolution is now introduced :

Whereas, The present system of assessment of personal property is inequitable and unsatisfactory, and calculated to hamper trade in the city, and fails to reach a large proportion of property that receives civic protection and benefit and should be made subject to civic taxation.

Resolved, That said system of assessment of personal property be abolished, and in lieu thereof a business tax, a household tax, an income tax and sundry license fees be imposed

Moved by Alderman Redden, seconded by Alderman Hamilton.

His Worship the Mayor ruled said resolution out of order and refuses to put it to the Council.

Moved by Alderman Dennis, seconded by Alderman Wallace, that No. 22 on Order Paper be now taken up. Motion passed.

Read No. 22, viz:-Report of Special Committee on Assessment, covering majority and minority reports of sub-Committee appointed to draft scheme of taxation.

Alderman McFatridge, submits to the Council a scheme of assessment signed by Aldermen McFatridge, Eden and Hubley to be substituted for the report referred to in No. 22 on order paper and signed by Aldermen Hubley, Eden and Creighton. Moved by Alderman McFatridge, seconded by Alderman Eden that said scheme of assessment submitted this evening by Alderman McFatridge, be received and concurred in.

The following amendment to said resolution is now moved by Alderman Redden, seconded by Alderman Duggan.

Whereas, the present system of assessment of personal property is inequitable and unsatisfactory and calculated to hamper trade in the city and fails to reach a large proportion of property that receives civic protection and benefits and should be made subject to civic taxation.

Resolved, That said system of assessment of personal property be abolished and in lieu thereof, a business tax, a household tax, and income tax and sundry license fees be imposed.

Whereas, The present system of assessing real estate is based upon an unsound principal and is calculated to prevent the erection of a better class of buildings and the improvement of existing buildings,

Resolved, That in future, all land in the city with the exception hereinafter mentioned, be assessed at its full value not including houses or buildings, if any, upon said land, the assessment of which shall not exceed one-half the assessed value of the said buildings.

Provided that in the case of surburban lands the rate of assessment shall not exceed that at present levied. Suburban lands are understood to mean all lands lying not less than 100 feet outside of the following limits, commencing on the shore of Halifax Harbor at a point near the north eastern corner of Miller's Fields, so called; thence by the north line of Miller's Fields to Tower Road; Tower Road to Inglis Street; Inglis Street to Robie Street; Robie Street to South Street; South Street to Le Marchant Street; Le Marchant Street to Coburg Road; Coburg Road to Oxford Street; Oxford Street to Young Street; Young Street to tottingen Street; Gottingen Street to Duffus Street; Duffus Street to the harbor.

Resolved, That the tax now levied upon goods, stocks of merchandise, machinery and similiar personal property be hereafter levied in the form of a business tax based upon rental. In determining the said rental the assessors shall not be

bound to accept the amount of rental actually paid, but shall have full power and discretion to fix a fair rental in each case. Said business tax shall be imposed as follows:

On all properties the rental of which is three hundred dollars or under, at the rate of five per cent. on said rental; on all properties the rental of which is over three hundred dollars and under six hundred dollars, at the rate of seven and a half per cent. on said rental, and on all premises the rental of which is six hundred dollars or upwards, at the rate of ten per cent or said rental. In the case of furniture or household effects now subject to taxation as personal property, the household tax to be substituted therefor shall be based upon the value of the houses occupied, but shall not exceed one-half per cent. on the assessed value of the buildings. No tax shall be levied where the rental is less than eighty dollars a year.

In the case of factories (not including breweries or distilleries) the business tax shall not exceed five per cent. on the rental.

Whereas, a large proportion of the personal property in the City escapes taxation in whole or in part under the present system of assessment, and whereas, a number of citizens who are in receipt of large incomes contribute unfairly small amounts to the City Taxation.

Resolved, That an Income Tax of one per cent. be imposed on all incomes from five hundred dollars upwards.

Provided, That such tax shall not be in addition to business tax. Where the income tax exceeds the business tax income alone shall pay.

Resolved, That all the persons and Corporations hereinafter enumerated be required to take out annually Licenses to do business in the City, and to pay therefor the following License fees :

Banks & per cent. on capital.

Commercial Travellers, \$25 00.

Non-resident Contractors, 12 per cent. on amount of Contracts.

Non-resident business men, a business tax based upon the yearly rental of the premises occupied, not to be less than \$75.00.

Fire Insurance Companies, \$200.00.

Marine, Life, Guarantee and Accident Companies, \$100.00.

Telephone Companies, \$1000.00.

Electric Light Companies, \$1000.00.

Gas Company, \$2500.00.

Street Railway, \$5000.00.

Cable Company, \$250.00.

Telegraph Companies, \$250.00.

Auctioneers (not to include consignments, etc.,) in lieu of License Tax, \$100.00. Auctioneers (for goods imported from foreign countries or consigned for sale) the same tax as that imposed above in relation to non-resident business men.

Junk dealers, \$80.00.

Ice Carts (each) \$10.00.

Milk Carts (each) \$5.00.

Peddlers and Truckmen, with horses, \$5.00.

Coal Hawkers, \$5.00.

Dog Tax, \$2.00.

Vessels retailing Goods, Wares and Merchandize (each) \$25.00 Boats, \$5.00.

His Worship the Mayor rules the said amendment out of order.

I herewith submit that as said resolutions did not have the required number, they are, as a consequence, null and void.

JOHN MURPHY'S SEWER ASSESSMENT.

December 26th, 1894.

His Worship the Mayor :

SIR,-In reference to sewer rates charged John Murphy, for property corner of Granville Street and Duke Street, I beg to report :-

The 477th Section of the City Charter provides that all properties situated at or near the upper end or termination of such proposed sewer shall pay the same rate as if the sever were to pass in front of such properties for their entire length, provided that in no case shall any such property be assessed for a greater length of frontage than sixty feet beyond the termination of the sever, measured along the side line of the street from a point directly opposite to the end of the sever. This energy is within throath function for the sever of Mr. Murpheric approximate

This sewer is within twenty-five feet of the corner of Mr. Murphy's property.

Section 504 provides that no property whatsoever liable for sewerage rates shall be relieved from payment of the same under any circumsrances. Under the law Mr. Murphy will be obliged to pay the amount assessed against him.

The Council now proceeds to the consideration of the estimates for the civic year 1895-6, as submitted by the Committee on Public Accounts.

Before proceeding to discuss the estimates Alderman Mosher, Chairman of the Committee on Public Accounts, said :

It is the usual custom for the chairman of the Committee on Public Accounts' in submitting the estimates for the ensuing year, to make a speech, however, that I shall not attempt, except to make a few observations and submit a few facts regarding the City's liabilities and assets.

On May 1st, on assuming the position of Chairman of the Committee, I almost immediately referred to the laws governing and defining the duties of the several Committees of the Council. To my surprise I found no law defining the duties of the Public Accounts Committee. In my opinion the Act should be amended defining such duties. Your Committee found that the only accounts submitted for investigation were those passing through the office of City Clerk and one or two small accounts from the City Collector's office, in all amounting to \$1,431.00 to present date.

It is the expressed opinion of the present Committee that all accounts from the several spending Committees, except progress estimates on contracts, should be submitted to the Public Accounts Committee for investigation including the accounts for final settlement of contracts. This proposition may be taken some exception to on the ground of inconvenience, but there would be none if a proper system were inaugerated to pay the several accounts monthly. They could be submitted to the Committee once a month, and if found correct recommended to the Council for payment.

I am pleased to inform you that, in the opinion of your Committee, the rate of taxation for the ensuing year will not exceed \$1.50 and may be less.

Your Committee is also desirous of recommending that the City should cease borrowing large sums of money, except such as may be considered absolutely necessary for sanitary purposes or otherwise.

The total indebtedness of the City to date is \$2,773,810.

The total assets, exclusive of sewerage and permanent surface street work, \$1,964,695.

Sewers constructed, 13 miles, at a cost of \$364,000.00.

To His Worship the Mayor and Members of the City Council :

1st. GENTLEMEN,—Having in view the proposal to establish a paid Fire Department which will of necessity increase the cost of running that service and finding it utterly impossible out of the limited amount of \$110,000.00 to place to the credit of the different Departments sufficient money to enable them to efficiently carry out the various services, and at the same time provide for the increased necessities of the Fire Department. Your Committee beg to recommend in the event of the establishment of a paid Fire Department, that application be made to the Legislature at its next session for authority to in future assess the citizens to the amount of \$120,000.00 instead of \$110,000.00 for ordinary purposes. 2nd. Your Committee had before them an application from the Monastery of

2nd. Your Committee had before them an application from the Monastery of the Good Shepherd for a civic grant for the maintenance of girls committed to that Institution from the Police Court, and also a protest against the voting of such subsidy signed by Rev. Dr. Lathern and Rev. Robert Murray. After full consideration of the same your Committee decided (Alderman Hublev dissenting) to include in the Estimates a grant of \$60.00 per head per annum for each girl sentenced from the Police Court to the Monastery, the number of girls to be so paid for not to exceed ten in any one year. This provision also to apply to the civic year 1894-95. Your Committee further recommend that the Council assert its willingness to provide a similar grant under the like conditions to any other Institution that has established or may in future establish a Reformatory for girls, which is in the opinion of the Council is equally deserving of a subsidy as a Reformatory.

3rd. As it is well known that a loan for a large amount of money can be effected on better terms than a loan for a smaller sum, your Committee beg to recommend that in future issues of debentures be so dated that a large sum may fall due at any one time whereby a material saving in inverset will be effected. At a meeting of the council held on the 31st December, last, from which I was unavoidably absent, and at which meeting Aldeman Stewart presided, the following resolution was introduced by Alderman Dennis :-

Resolved, "That inasmuch as the mayor has no authority whatever to veto the action of the majority of the City Council, except as regards the expenditure of money and inasmuch as the Mayor's message does not correctly state the facts ? Resolved, That the Minutes of the Council of December 27th, be amended by expunging all reference therefrom of the communication submitted by the Mayor, relative to the action of the Council on the amendments of the law relative to assessment of personal property."

Now, inasmuch as sections 4 and 44 of the rules of council, and sections 98 and 99 of the City Charter direct that the City Clerk shall take minutes of the minutes of the votes and proceedings of the council, entering therein all resolution and motions passed with the names of the movers and seconders, and shall notice therein reports, petitions and other papers submitted to the Council by their titles or a brief description of their purport; and all accepted reports shall be fairly copied into books of the council. I submit that said resolution of Alderman Dennis, requesting that any matter that was before council "be expunged" from its minutes is illegal and should not have been accepted by

the chair or put, as the council has no power or authority to obliterate or expunge from its minutes a record of any message or report that has been read before it; and said resolution can have no force or effect, being a proposed violation of the law by Alderman Dennis and a breach of rules and regulations governing this council.

OPINION RE EXPUNGING MINUTES.

It is no unprecedent thing to order the expunging of minutes from a record, although the effect of doing so is to make the record inadequate and in that sense incorrect. Such motions have carried in the House of Lords and in the English House of Commons, although the occasions have been rare. I am of opinion, however, having regard to the purposes for which the minutes of the City Council are kept, and the mandatary terms in which t e sections relating to them are drawn, that it is not competent to expunge a truthful record of the actual proceedings of the council, except in the special case which seems to have been specially provided for in rule 28-9 of the ordinance in reference to meetings and rules of council. I think that "the communication submitted by the Mayor relative to the action of the council on the amendments of the law relative to assessment of personal property," was within the meaning of Section 99 of the City Charter, a paper submitted to the Council that the Clerk was legally bound to enter it on the minutes in the manner pointed out in the section, and that the resolution to expunge the entry was irregular and should not have been accepted by the chair or put to the meeting.

WATER SUPPLY, WAR DEPARTMENT.

January 8th, 1895.

His Worship the Mayor :

SIR,—I have received a letter (a copy of which is enclosed) from the military authorities asking what the charge would be for proposed new fittings.

Pavillion Married Querters.—It is proposed to be proposed not normal. Pavillion Married Querters.—It is proposed to lay a 2 in. pipe from the north to the south end of the block on the east and west side of the square, each pipe connecting with the 3 in. pipe in the square. The 2 in. pipes are to be suspended under the second floor and a in branch taken up and down to each room. There will be 67 taps in all and the 3 hydrants will not be required. As these hydrants are to be removed the full rate should not be charged. I would recommend that an additional rate of eight shillings and six pence sterling be charged for each tap, provided that the new work is done to the approval of the forman of the City Water Department, and that valves and waste cocks be provided where directed by the foreman. The War Department shall also agree to turn off the water from the 2 in. pipes at or before eleven o'clock, p. m., in the winter to prevent waste.

Citadel.—Water is required for heating apparatus in ablution room, 23 casement. I would recommend that no additional charge be made.

Wellington Barracks.—2 baths, would recommend extra charge 8 shillings and six pence each.

Gymnasium, Cogswell Street, ½ in. bib cock, charge recommended, one pound.

Royal Artillery Park Urinals.—I would recommend that no urinals be supplied with water unless they are provided with self flushing cisterns or other approved flush.
