SIR, —In the accompanying letters residents of Robie Street south of Welsford Street complain of their cellars being flooded by water on the 17th December last. Complaints were received by telephone and otherwise at this office, on the day on which the flooding occurred and men were despatched at once to investigate. One of the City Foremen who visited these premises took off the manhole covers on the sewer on Robie Street and across the Common. The sewer in front of the house referred to was full of water; but the sewer going to the common was only two-thirds full. This matter has been reported on fully and is now before the Council. If the Council cannot see their way clear to carry out all the work recommended in connection with the common sewer, I would recommend that the sewer going down Williams Street be extended direct to the Common sewer in line with Williams Street and that the sewer on Quinpool Road be extended direct to the Common sever near the Egg Pond. This work with the proposed widening of the sewer where the water pipe crosses, would cost about seven thousand (\$7,000) dollars; and while I cannot advise that it will effect a complete remedy, I believe that it will lessen the danger of flooding cellars in the block from which the complaints have come.

The total number of inmates Dec. 31st, 1902, was 366, made up of 227 men, 137 women and 2 children.

His Worship the Mayor :

SIR, -Since the cold snap which we are now feeling the effects of, many and frequent complaints have been received respecting poor pressure or the entire absence of water supply in portions of the high service district. To-day the Citadel, Artiliery Park and the higher portions of Willow Park, North Street and Agricola Street are without water entirely. It is beyond question that this condition of the water service is caused solely by the cold weather and consequent waste of water. Before the cold snap in December the gauge in the Superintendent's house on Compton Avenue showed 35 lbs. pressure; after the first cold snap the gauge had dropped to 23 lbs., subsequently it fell to 22 lbs. We made a thorough examination of the whole high service system to discover, if possible, a leak in the main or some other cause for the enormous decrease in

pressure, but found the pipe system in good order. After the cold weather moderated the gauge rose until it again reached 35 lbs., and has remained at that pressure until the recent cold weather when it has again fallen in a few hours to 22 lbs. No doubt when the weather moderates it will rise again; but in the meantime many hundreds of people are without water, and there is danger of hor water boilers bursting and causing serious damage. This has become very a serious matter. In case of fire in these districts there would not be a single drop of water for the engines to say nothing of hose streams. I feel that it is my duty to again urge upon the Council the necessity of adopting a stringent remely that may be applied without fear or favor to prevent the enormous and unnecessary waste of water during these cold snaps.

Six,—During the last few years a considerable balance has accumulated to the credit of Water Maintenance Account. and I would recommend that legislation be obtained authorizing the transfer of the sum of \$10,000.00 to Construction Account for the coming year. I respectfully arge, however, that the balance should not be diverted from maintenance work as every dollar of it is required for renewal of old worn ont mains. There is a great deal of old 3 inch pipe throughout the City which is almost completely filled ap with rust, and the original shell of the pipe in many cases has nearly disappeared. It is very difficult to make connections with these pipes when laying new service pipes and the supply to householders is very unsatisfactory. It will require all the money that we can spare from water maintenance account to renew these old worn out pipes. There are many dead ends too throughout the City that should be connected to improve the circulation, prevent the deposit of rust and sediment and consequently give a better supply to householders in the neighborhood of them. Some of those requiring attention in the immediate future are :

Three inch pipe Argyle Street, from Buckingham to George Street.

" Jacob Street to Cumberland House.

" " South Street, connect between Pleasant and Queen Streets.

In re LIBRARY-ALDERMAN HUBLEY'S NOTICE OF MOTION.

Recorder's Office, City Hall, January 26, 1903.

To His Worship the Mayor and City Council :

GENTLEMEN,—Alderman Hubley's notice of motion has been referred to me as to whether it is a breach of the injunction granted by the Court herein. It must be remembered that the Contract entered into by the resolution of the City Council accepting Mr. (wnegie's gift on the 7th April 1902 provided that the City was to furnish a site for the erection of the library. The injunction granted prohibits the Council from seeking to rescind that resolution and from intimating the same to Mr. Carnegie or taking any further steps in *lineach of said resolution*. The notice of motion sets out "there is no suitable site the selection of which would be acceptable to the citizens generally and it is not advisable at present to add to the burden of the taxpayers by purchasing property for the purpose." This is practically repudiating the resolution accepting Mr. Carnegie's offer and intimates to him that although the City has undertaken to provide a site the City has no suitable site and that the Council will not assess the taxpayers for purchasing such a site and is a breach of the resolution passed in April 1902. Put the notice of motion goes further and states that there is a great diversity of opinion among the rate payers as to the wisdom of guaranteeing the \$7,000 to support a public library. And then comes the resolution that Mr. Carnegie "be requested to allow his offer to remain in abeyance until the ratepayers have an opportunity to vote up on the question" lst—whether they are in favor of accepting \$75,000; 2nd—whether they are in favor of guaranteeing \$7,000 for maintenance of the Library and 3rd—whether they are in favor of the City Council purchasing a site; and if Mr. Carnegie consents to this legislation is to be obtained. There is no outstanding offer of Mr. Carnegie. The offer he made has been turned into a contract and if the City Council to-morrow were to repeal the resolution accepting his offer it would not affect the contract unless Mr. Carnegie agreed to it. It is quite evident the intention of the

people as expressed at the polls and legislation is to be obtained to enable them to do so. The resolution asking Mr. Carnegie to allow his original offer to remain in abeyance, if he were to consent to the same, would be relieving the City of their acceptance of his ofter and allowing the original offer to stand as an offer, thereby evading the contract which now exists, and the Council would then decide upon the result of the vote upon the questions submitted and if the answer were in the negative the Council then would refuse to accept the offer of Mr. Carnegie. This resolution, to my mind, attempts to get clear of the resolution accepting Mr. Carnegie's offer and would destroy that contract if accepted by Mr. Carnegie and would be a breach of the resolution of April 1902 and a violation of the order of injunction. If there were any doubt about it I am sure that the Council (the citizens' parliament, the body that makes the laws and ordinances for the government of the citizens) would be the first to set the example of upholding the law. I have already advised the Council that the resolution accepting Mr. Carnegie's offer was a contract and cannot be rescinded except by mutual consent and I have the gravest doubts as to whether the present action can be maintained by the Attorney-General on the relation of Mr. Mackintosh. This matter will be argued before the full Court probably this week and an early decision arrived at, and it is more desirable even if the decision of the Court.

INDEXING BOARD OF WORKS MINUTES.

SIR, -One of the most important committees we have in dealing with civic matters is the Board of Works -expending large sums of money, dealing with public rights, the rights of citizens, with sewers, streets, lines of streets, properties and other questions vitally affecting not only the rights of the City but the citizens as well. The Board was established many years ago, and alchough the minutes settling these rights have been kept, yet none of these minutes have been indexed from 1872 to 1881, and only partially indexel from that to 1849. A regular index has been kept from February, 1890, to the present time. It is utterly impossible for the legal adviser of the City of Halifax to keep and protect the rights of the citizens and the City unless he is from time to time enabled to refer to the public records on any particular subject in order to determine the rights of the City and what rights the public have been given, and unless these records are indexed by subjects and properly kept up. I would call your attention to the above facts and ask that some effort may be made for having these books indexed, as they are of most vital importance to the interests of the City.

IN RE LEASE TO ALEXANDER GRANT.

Recorder's Office, City Hall,

Halifax, N. S., Jan. 20th, 1903.

To His Worship the Mayor and City Council:

GENTLEMEN,—One of the clauses in the lease to Mr. Grant was that he should not assign, transfer or set over or otherwise by any act or deed procure the said premises or any of them to be assigned, transferred, set over or sub-let without the consent of the City Board of Works in writing first had and obtained. I understand that the executor of Mr. Grant has assigned this lease to Mr. VanBuskirk, and he has assigned it to his other partners in business, who now hold the lease; and this was done by the

consent of the late Mayor. This, under the terms of the agreement, if it is proved, would forfeit the lease; but if proceedings were taken in the courts the judges would be very averse to forfeiting a person's rights under such circumstances, as the law does not favor forfeitures if the loss can be compensated for in another way. The lease is made for twenty-five years from the first of August, 1890; but by another clause in the lease the City has the right at any time after the expiration of fifteen years from the date thereof on giving at any time six months' notice, to terminate said lease, and after the expiration of the time mentioned in said notice, all the right, title and interest of Alexander Grant and his assigns shall cease; but the City would have to pay the proportionate amount without interest of the cost of the work performed in building the sewer, etc., in proportion to the number of years that Grant had possession of the property and the proportion of the cost of said work, which amount is to be fixed by the Engineer.

I would advise, under the circumstances, that the Board of Works give their assent to the assignment to the Baulds and Company, and that they undertake to remove the buildings now erected thereon at any time the City Council shall direct, and that they shall pay a nominal rental of eight (§S.00) dollars a year while the buildings remain, and that they shall be subject to all the terms and conditions in the lease which shall be binding on them. It is not advisable that the terms of the lease should be varied.

MISS ADA BRODIE'S CLAIM.

GENTLEMEN, -Your Committee on Laws and Privileges beg to report that at a meeting of the Committee held on the 19th inst., at which there were present Aldermen MacIlreith (Chairman) Hubley, Rogers and Spry, they had under consideration the claim of Miss Ada Broodie for damages for injuries received by falling over an obstruction on Kaye Street.

This matter having been submitted to His Honor the Recorder for his opinion as to the City's liability, he has filed his opinion that there is no liability on the part of the City (a copy of which opinion is hereto annexed.) Your Committee would therefore recommend that the opinion of His Honor the Recorder be concurred in.

Chairman Laws and Privileges Committee:

SIR,—It would appear from the facts submitted to me that Miss Broodlie was coming down Kaye Street in the day time—one of the steepest streets we have in the City of Halifax—and tripped against a brace which, it is said, projects above the ground of the street. It would appear that the post of the fence is fastened to a shoe with small braces from the shoe to the post This shoe was placed well under the ground of the street; but in the course of time by the wearing of the street the small braces from the shoe to the post became exposed and Miss Brodie tripped, it is said against this brace and fell injuring herself. Neither the post nor the braces were placed there by the City, and I am of the opinion that the City is not responsible for any loss or damages sustained by Miss Brodie in consequence of tripping over this brace. Your Committee while reporting that there was no liability on the part of the City, tecor mended the Council to pay Mr. Eaton seven hundred dollars (\$700), which was confirmed by the Council. This case of Miss Brodie's while in my opinion there is no liability by the City, is deserving of a great deal more sympathy and consideration than the other.
