The Contractor in question having never been in the City, it was impossible, as the law then stood, to collect the tax. Your Committee would recommend in connection with this matter that a further amendment of the law should be obtained at the next session under which the Building Inspector would be empowered to refuse the necessary building permit until such time as the license fee required by law has been paid.

There is no legislative authority for the making of such a grant to this institution, nor is there any fund from which such a grant could be made.

#### . TRAMWAY SERVICE.

COMMITTEE ROOM, CITY HALL, April 27th, 1903.

His Worship the Mayor and Members of City Council.

Gentlemen,—Under resolution of your body, the Committee on Laws and Privileges was instructed to enquire into the operation of the tram service in the City of Halifax and the powers of the Council relative thereto. Your Committee now begs to report as follows:—

The Halifax Electric Tramway Company, Limited, was incorporated under an Act of the Local Legislature passed in 1895, being Chapter - of the Acts of that year. The objects of the Company as set forth in this Act were, inter alia, (section 2 a) the construction, acquiring, maintaining and operating an electric tramway or railway in the City and County of Halifax, and by section 2 (d) the Company was empowered to purchase the interest of any other Company or persons in any other business similar in part or in whole to that authorized by this Company, provided such transfer should not confer any greater rights than heretofore enjoyed by any other Company with respect to such interest or contract so purchased. By section 3 the Company was empowered to construct, maintain and operate a line of track railway or tramway on certain streets in the City of Halifax and along such other streets as the City Council might determine on application to it for that purpose. By the same section the Council was empowered to authorize the Company to lay a double track in any of said streets or any portion thereof. Under section 6 and 23 the Company was required, before commencing any work in construction or extension of its line of railway, to prepare detailed plans and specifications of the work proposed to be done and the manner of doing the same and submit them to the City Engineer and on the same being approved by him the Company was entitled to commence the work of construction. The Company, in compliance with the terms of section 23, submitted such specifications for the approval of the City Engineer, which were approved of by that official on November 1st, 1895. Subsequently extensions of the railway were made and specifications submitted and approved in the regular way. So far as your Committee has been able to discover, none of the specifications submitted set out whether or not the track was to be paved, or specified the material with which the paving should be done.

The only resolutions of Council on the subject appear to be those of May 12th, 1897, (which required asphalt to be laid on Windsor Street between the rails) and August 10th, 1897, (wherein permission was granted to lay a double track on Cogswell and Gottingen Streets, provided the Company "blocked" a certain portion of the street.)

Your Committee is informed by the City Engineer that the Company, without any authorization or direction from himself or the City Council, paved the street between the rails with wooden paving, which, if a fact, was an illegal act, and the Company can be compelled to remove such paving unless the certificates granted under section 28 preclude the Council from taking action.

By section 28 it was enacted that no line of railway or extension should be open for trafic until the Company had obtained a certificate in writing from the City Engineer that the same had been constructed to his satisfaction and suck certificate would then be

conclusive evidence that the work had been done and constructed according to such plans and specifications. As the paving material had not been specified in the specifications submitted by the Company to the Engineer for approval, it would not seem that the certificate furnished by this official under section 28 which could only be a certificate that the work had been done and constructed according to the plans and specifications submitted could in any way be construed to be a permission to pave with wooden blocks.

Under rule 15 the Company is required to pave and keep in good repair all the spaces between the rails and tracts and two feet outside of each rail with such material and in such manner as the City Council shall approve on the recommendation of the City Engineer and on such streets and at such time or times as the said City Council shall determine by a two-third vote thereof. This rule goes on further to say that the Company shall not put or place any material whatever on its road bed between the tracks and for two feet outside each rail or any part thereof without the said material having been first approved by by the City Engineer in writing, whose decision thereon shall be final. In spite of the fact that the City Engineer never-made any recommendation to the Council as to the paving material to be used and that the Council never approved the use of any particular material, the Company took upon itself to pave a large portion of its roadbed with wooden blocks.

There appears to be no penalty fixed in the Act for breach of this rule and hence the common law remedy is the only one applicable to the case — It will therefore be necessary in order to have the wooden pavements removed to apply to the Courts for a declaration that such pavement has been illegally placed on the streets of the City by the Company and seek an order of the Court for the removal of the same.

The provision of the Charter relating to the running of the cars is contained in Rule 8, which reads as follows:—"The time table as to the rate of speed for running the cars and the tariff of rates shall be regulated by a table to be approved by the City Council of the City of Halifax, but the minimum rate of a single fare shall be five cents." \* \* \* This appears to be the only provision in the Charter dealing with the running of the cars and would seem to cover only the rate of speed at which cars may travel and not the frequency with which cars must pass any stated point. At the present time the main line service is supposed to be a 7½ minute service and on Coburg Road, Willow Park route a 10 minute service is provided. Under Rule 7 of Chapter 87 of the Acts of 1896, the Granville, Hollis Street service is required to be in all respects equal to that on the main line. Therefore, in respect to the Granville Street service your Committee have to report that the Company is not carrying out the provisions of its Charter and amending Acts.

#### UP-KEEP OF ROADBED.

The Company by its Charter (Rule 7 of Chapter 87 of the Acts of I896) is required to maintain and operate the street railway to the satisfaction of the Mayor and the City Engineer. If the Company fails to so keep up the roadbed the City is empowered to do the work and put the roadbed in a satisfactory condition, charging the Company for the work performed. The objection on the part of the City to this course is that if it undertakes and carries out this work the appropriation for streets is pro tanto reduced, the money so spent not being repaid by the Company perhaps until it is too late to perform further street work. It would seem desirable that legislation should be sought compelling the Company to deposit with the City Treasurer on the first of April in each year a sum sufficient to defray the cost of such work, to be repaid to the Company by the City Treasurer, if none of such sum has been expended by the City, on the first of November in each year. In other words—to require the Company to follow the same course with regard to providing a fund for the up-keep of its roadbed as it is required to deposit to indemnify the City in the case of the removal of snow from the tracks in the winter time (see rule 9.)

To sum up :--

A—PAVING.—If the Council desires it may take proceedings to compel the Company to remove the block paving and pave with such material as the Council may approve.

B-TIME TABLE. —As to the Time Table it will be necessary to get legislation to compel the Company to live up to a Time Table to be approved by the Council.

C-The Company may be required to make the Coburg Road and Willow Park service equal to the main line service;

D-ROADBED. Legislation should also be sought in reference to the up-keep or road-bed, as suggested above.

#### MORRIS STREET SEWER.

CITY ENGINEER'S OFFICE, May 15th, 1903.

His Worship the Mayor:

SIR,—In accordance with the accompanying resolution of Council, I beg to report on the letter attached hereto from R. I. Hart He complains, first, that the City Council passed a resolution in August, 1902, for the removal of the building at the foot of Morris-Street constructed over the sewer but that it has not been done. This matter is on the Order of the Day in the Council.

The second complaint is that he gave the City permission to drain down his wharf in 1865, and that in 1895 when the Water St. sewer was constructed the sewer running down Morris St., below Water St., was closed up and the sewage turned down his wharf. He requests that the sewer at the foot of Morris Street be opened so that the water will run in its original outlet. When the Water St. sewer was constructed an invert was laid seven inches below the mouth of the sewer flowing direct down Morris St. from Water St. to the Harbor so that seven inches of sewerage would flow along the Water St. sewer to keep it flushed: before it would overflow down the viorris Street outlet. This sewerage does not empty at Mr. Hart's wharf, but at Salter St., into the dock owned by the City. When the sewage rises more than seven inches in the Morris St. sewer in consequence of a rain storm it overflows down Morris St. to the Harbor. There is no sewage or storm water emptied down Mr. Hart's wharf until the sewer on Water St. is over half full as the lower part of the sewer at the outlet down his wharf is closed. The City has the right to send sewage overflow down his wharf, and has not only exercised the right to send the overflow down the wharf, but for many years emptied sewage there as well. Before the re-construction of the sewer in Water St. the Bishop St. sewer and drains in the neighborhood were emptied at Mr. Hart's wharf.

His last complaint is that about ten years ago an addition was put on the north end of a building on the east side of Water St. and south side of Morris St. and that the same should be removed. This complaint is well grounded. The late Mr. Grant built an encroachment on the north end of his house and it has never been removed and steps should be taken to secure the City's rights to the street.

#### TELEPHONE CONDUITS.

CITY ENGINEER'S OFFICE, May 14th, 1903.

His Worship the Magor:

SIR,—At the last meeting of Council a resolution was passed authorizing the granting of a permit to the Telephone Co. to lay conduit in certain streets provided that the route proposed should be changed to avoid Barrington St. and Jacob St. The Company have been permitted to go on with their work on Granville St. until the matter can be again brought before the Council. The object of the Company in doing the work now under construction is to carry their heavy lines under ground to North, Water and Barrington Sts. They are not particularly anxious to get to their Gottingen St. line, although that is a heavy line, and if they are prohibited from going along Barrington St. they will not lay their conduit farther north than Buckingham St. A conduit must be laid some time in Barrington St. to take the heavy lines going north, and I think the City should be more anxious than the Telephone Co. to have the work done at as early a date as possible. Although the work while under construction is a great inconvenience the improvement accomplished by it is of inestimable value to the city as it removes a large number of wires from the pole lines and there is not so much danger of pole lines being broken down by the wind and there is far less interference with the work of firemen, to

say nothing of the removal of the unsightly forest of wires. I would strongly recommend that the Company be allowed to proceed with the work as proposed in the form of permit submitted.

#### TRAMWAY PAVING SPRING GARDEN ROAD.

CITY ENGINEER'S OFFICE, May 14th, 1903.

His Worship the Mayor:

SIR,—The Halifax Electric Tramway Company have asked what the nature of the pavement would be for double track on Spring Garden Road. The matter has been referred to this Department by the Council for report. The Charter of the Tramway Company provides that they shall pave the track with such material as may be approved by two-thirds of the Council on the recommendation of the Engineer. This is the first time a report has been asked for on this matter. There seems to be no two opinions on the present wooden paving. It is not at all suitable on business streets or important residental streets. The Charter provides that the Company shall keep in repair or keep paved the space between the rails and two feet outside on each side of the track. On hills where the water runs along the rails it would be better for the City to require the Company to put in the paving as pavement of any material will withstand the action of the water better than the macadam.

Bituminous macadam, a new payment recently introduced in the United States, has been suggested; but on inquiry from street experts in the United States who are familiar with the method of laying it and use in American cities, I am of opinion that this material would not be a sati-factory payement for the track on Spring Garden Road. It cannot be laid properly without a plant specially fitted up for it and the Company putting down this kind of payement could not put up a plant here for the small quantity of paying to be laid.

The same remarks apply to asphalt.

Granite is to rough and noisy for a street like Spring Garden Road.

Vitrified Brick pavement when properly laid is one of the best pavements in use for streets like the one in question. If the City were going to pave the rest of the roadway, I would recommend that the pavement laid should be on a concrete foundation; but if the whole roadway is not to be paved I think it would be better to lay the pavement adopted on a broken stone or gravel foundation until the City paves the rest of the roadway, when it should be done in a permanent manner. The question of paving outside the rails is a matter for the Council to decide. I would recommend that the track allowance including the two feet outside from Pleasant Street to Park Street be paved and that the material to be adopted be vitrified brick laid on a gravel or broken stone foundation.

GENTLEMEN,—At the last meeting of your Council a request was made for a vote of money for the purchase of an ambulance for infectious diseases and a dump cart.

I am instructed by the Chairman of the City Health Board to ask your further consideration of same, and to say that while he appreciates the necessity of economizing the public services, yet an ambulance for the carriage of our cases of contagious diseases is of such an urgent necessity that I am impelled to ask you to reconsider the matter at a meeting of your Council this evening; and if you cannot see your way clear in granting the whole amount asked for, if you will grant an amount for payment of the ambulance the Board will endeavor to work along with their present system of night carts.

At the present time our efforts to control infectious diseases is greatly handicapped by the want of a proper conveyance. The means that we are compelled to use now are of the most primitive character and not always in the best interest of the public health.

SIR,—The accompanying extract from Minutes of Council asks for a report on the petition attached hereto from residents of Cork Street asking for a sidewalk, and also on the advisability of the city taking over Cork Street.

To deal with the latter point first, Cork Street is laid out from Windsor Street to Oxford Street, but has not been graded. If the city were to take it over they would be obliged under the Charter to keep it in repair and safe passable condition. As the

Council are well aware, we have too many streets now and the money available for street work is not sufficient to keep them up. If we take over streets such as this we must take the money from older streets to do the work and it is not fair to the older taxpayers that this should be done. Under the new law the street should be handed over to the city graded.

Under the circumstances, I cannot rocommend that the street should be taken over by the city at present. However, the prayer of the petitioners can be granted in another way. The ashes collected on the streets are being kept clear of all other material and are suitable for grading sidewalks and roadways. A good sidewalk can be made on the south side of Cork Street which will comply with the request of the petitioners, without any additional expense to the city, and instructions have been given that the ashes collected in Ward Six shall be deposited there instead of on the dumps. They were being deposited on Stairs Street, but that street is now passable and must be left for the present. In a very short time a good sidewalk can be made on the south side of Cork Street as suggested.

But it seems to be regarded with sentimental interest by the citizens of Halifax and visitors, possibly on account of the Royal Duke who designed it. So I am desired by the General Officer Commanding to ask you whether the municipal authorities would care to take it over. It is in too dilapidated a condition to take down and re-erect on another site, but the G. O. C. would be prepared to recommend for the sanction of the War Office, if you wish it, that the present site, with the approach to it, be let at a nominal rent to the town, who would, of course, undertake to maintain the building and required fenceing, etc.,
