the Company will be asked to make such repairs as will place it in a satisfactory condition

PERMANENT PAVING OF GRANVILLE STREET.

A step in advance which should be chronicled is the permanent payment of Granville Street. This important action was largely brought about by the perseverance of the merchants of Granville Street and their representatives in the City Council and they are to be congratulated on the outcome of their efforts. In the future such work will be done under the Act respecting permanent payment passed at the last session of the Legislature, and hereafter the Council should, if at all possible, lay a portion of permanent payment on our streets every year.

OFFICIAL PLAN OF THE CITY.

The Official Plan of the City which was commenced several years ago has had considerable work done on it during the past few years and at the present time Professor Dixon has the matter in hand. This plan will be of much benefit to the City in laying down and proving lines of streets, etc., in future and such a plan should have been prepared and possessed by the City years ago.

Among other matters to which your attention should be directed are the following:-

THE REMOVAL OF SNOW.

An effort should be made on the part of the City to take over the clearing of the snow from off the sidewalks of our principal streets and main thoughfares in the manner adopted in some of the cities of Upper Canada whose by-laws and ordinances on this subject I intend to lay before you.

PUBLICATION OF ANNUAL REPORT.

The delay in the publication of the annual report has been the cause of much complaint on the part of many of our citizens, and the desirability of issuing it at as early a day as possible should be inspressed upon those having the publication of this report in charge. No delay should be permitted in placing it before the ratepayers.

POLICE PROTECTION FOR THE WESTERN PORTION OF THE CITY.

I have discussed this matter with the Chief of Police and with the Chairman of the Board of Fire Wards and think that in course of a few weeks the Police Commission will be able to provide a mounted policeman for this district. In the meantime men have been detailed to cover as large a portion of the district as possible.

EXCAVATIONS IN OUR STREETS.

In the future where permission is sought by any corporation to make excavations on a large scale in our streets permission should only be given on condition that the work is to be done previous to the first of July or after the first of September in each year, thus preventing our streets from being in a state of upheavel through the summer and tourist season.

NATAL AND DOMINION DAYS.

For some years back the practice of having any proper celebration in connection with these days has fallen into desuetude, and as a result instead of our citizens and their families remaining in the City they hie themselves to the country or outlying town for want of amusement at home. During the past few days I have discussed the matter with some gentlemen identified with sport and public amusements of various kinds and have been assured of their help and assistance in arranging and carrying out a programme if the Council should see fit to lend its countenance and support and appoint a committee for the purpose. The General Officer Commanding has also very kindly promised his co-operation if you, gentlemen, decide to give effect to this suggestion. A Committee of Aldermen should be appointed to act with those willing to lend their assistance in

arranging a programme for either Natal Day or Dominion Day or both which would afford amusement for those of our people who are not very often able to share in such enjoyment

In conclusion, I would ask for all these matters your serious consideration, and would express the hope that at the end of the civic year we may be able to look back upon "something accomplished, something done," for the progress and good government of our City.

WATER SERVICE INVESTIGATION

TORONTO, May 11th, 1905.

R. T. MacIlreith, Esq , Mayor, Halifax. N. S.

Dear Sir,—On April 26th I arrived in Halifax, leaving there on May 6th. During my visit I inspected the several sources from which the City now obtains its water supply, also a number of lakes in the vicinity that have been suggested for supplementing the present supply.

I made a sufficient inspection of the water works system within the City to convince me that there is now an enormous waste of water, and that both the high service and the low service are unsatisfactory.

After consultation with you and your City Engineer, it was considered advisable to delay my report until additional data had been collected and certain plans prepared, as follows:—

- 1. A contoured plan of the City showing the elevations at each hydrant, above the sea, also the pressure reduced to feet. It is not necessary that this plan be a finished drawing. I would suggest that it be drawn upon a scale of about 200 feet to the inch.
- 2. Profiles of each of the force mains to be made, each on the same scale, these profiles to show gate valves, blow-offs, air valves, &c.
- 3. Plans of the property lying east of Lower Chain Lake, showing dams, sluices, pipes, valves, gate houses, roads, rock exposures, water ways, &c.
- 4. The flow in the main outfall sewers should be gauged in order to determine the dry weather flow. This should be checked upon the amount of water supplied.
- 5. Accurate pressure gauges should be provided for the Fire Halls, also at Chain Lake Gate House, to show pressure at any time, upon each of the large mains. At Fire Hall No. 5 the glass gauge showing the height of water in the low service may be lengthened instead of using a gauge.
- 6. Chemical analyses of the water from Long Lake, Chain Lake, and Spruce Hill Lake should be made now, and again during the low water in August. Samples should be collected at the lakes near the intakes and additional samples drawn from the high service and low service from taps in the City.
 - 7. Chemical analyses should be made of the deposits in the pipes.
- 8. The supply of water entering the City should be determined by meter. Venturimeters are accurate and simple. They have no working parts and offer no obstructions to the flow of water. The cost of these meters is approximately as follows:—

I am of opinion that a 12-inch meter would be of sufficient size for a 15-inch main; a 20-inch meter for a 24-inch main; 24-inch meter for a 27-inch main.

Each meter tube should be provided with a register and chart recorder which would record automatically the amount of water passing through the pipe per day. This register and chart would cost \$540.00 additional for each of the three meters.

9. In my opinion these meters should be set in the vicinity of the Chain Lakes dam, the three meters to be laid parallel to each other in a properly constructed building. This may require some changes in the pipe lines in the vicinity.

Your City Eingneer should be authorized to engage a draughtsman or assistant to prepare the necessary plans, profiles, etc., above mentioned. These plans will be of service to the City in the future and valuable at all times for reference. The profiles should have been completed immediately after the works were constructed as well as the plan showing the gate houses, pipes, etc., at the foot of Chain Lakes.

GENTLEMEN, -- The Board of Fire Wards beg to report as follows :-

Robert J. Foley, callman No. 1 steamer, having resigned, it is recommended that the resignation be accepted and that Joseph Whalen, supernumerary on No. 4 steamer, be appointed in his place.

At the last session of the Legislature the City was authorized to borrow \$10,000 for a new engine house to replace the present Queen Street house, and it is necessary that early steps be taken to erect the building. It was thought that a site could be found for this structure on the old Exhibition Grounds, but your Board believe that the City Council will agree with them that it would be better to leave this property intact. They therefore recommend that the Council allot a portion of the Poor's Asylum grounds, 150 feet square, at the south-east corner of Morris and Robie Streets, as a site for this engine house, to be approved of by the Engineer. By the conditions of lease, supplied by this office and of which due notice was given by advertisement, certain rights were reserved, repairs to be made and the names of sureties required.

The only tender complying with these terms and basing his offer on them is H. B. Clarke's tender, and the Committee recommends its acceptance.

WIDENING LOWER WATER STREET.

CITY WORKS OFFICE, June 8th, 1905.

To the City Council:

GENTLEMEN, -- At a meeting of the Committee on Works held this day the attached letters and City Engineer's report thereon, re the widening of Water Street at the foot of Salter Street were read.

Your Committee are of the opinion that this work is necessary, and recommend that if possible ways and means should be provided for its accomplishment.

His Worship the Mayor:

SIR,—In accordance with the instructions of your Committee, I have consulted an expert appraiser in reference to the value of the land required for the proposed widening of Water Street at the foot of Salter Street. I have also had the building examined by the City Carpenter and an estimate made of the cost of moving back the west wall, and beg to report that the estimated value of the land required and the removal and making good of the west side of the building is \$820.00.

Read report Committee on Works on Willis Chipman's interim report on water system investigation.

WATER SUPPLY INVESTIGATION.

CITY WORKS OFFICE, June 7th, 1905.

To the City Council:

S,

GENTLEMEN,—At a meeting held on the 6th June the Committee on Works considered the report of Mr. Willis Chipman, C. E., in connection with investigation of the water service, and beg to report on his recommendations, as follows:—

1. "A contoured plan of city showing the elevations of each hydrant, above the sea, also the pressure reduced to feet. It is not necessary that this plan be a finished drawing. I would suggest that it be drawn upon a scale of about 200 feet to the inch."

The plan described with the information asked for is necessary for a proper study of the water supply system in order to understand the conditions which exist in the city service, and your committee recommend this clause for approval.

"Profiles of each of the force mains to be made, each on the same scale, these profiles to show gate valves, blow-offs, air valves, etc." There are three mains supplying the city but only one profile in the City Engineer's office, namely: a profile of the 27" low service main laid about twelve years ago. When the old mains were put in no profile was deposited with the city and the City Engineer's office was not then in existence. While the city officials are familiar with the profile or the mains and the location of the valves, &c., it is impossible for Mr Chipman to carry all the information in his head when considering the whole question, and your Committee recommend this clause for approval.

"Plans of the property lying east of Lower Chain Lake, showing dams, sluices, pipes, valves, gate houses, roads, rock exposures, water ways, &c."

This plan is also necessary for consideration with the other plans so that Mr. Chipman may not be compelled to depend upon his memory, and your Committee recommend this clause for approval.

4. "The flow in the main outfall sewers should be gauged in order to determine the dry weather flow. This should be checked upon the amount of water supplied."

Mr. Chipman asks for this information to compare with the quantity of water delivered through the supply mains. The information will be important and your Committee recommend the approval of this clause

5. "Accurate pressure gauges should be provided for the fire halls, also at Chain Lake gate house, to show pressure at any time, upon each of the large mains. At fire hall No. 5 the glass gauge showing the height of water in the low service may be lengthened instead of using a gauge."

Your Committee are of opinion that gauges in the fire halls are not necessary; that any information that could be obtained from them can be obtained in the same way from the hydrants in the neighborhood. They would recommend that the gauge at Chain Lake gate house be put in perfect order, or, if this cannot be done, that a new gauge be provided, also that the glass gauge at No. 5. fire hall be extended.

- 6. "Chemical analyses of the water from Long Lake, Chain Lake and Spruce Hill Lake should be made now, and again during the low water in August. Samples should be collected at the lakes near the intakes and additional samples drawn from the high service and low service from taps in the city."
- 7. "Chemical analyses should be made of the deposits in the pipes."

The City has had the Long Lake, Chain Lake and Spruce Hill Lake water analyzed, also the deposits in the pipe, and your committee recommend that action on this clause be also deferred until Mr. Chipman is communicated with for the purpose of ascertaining if the analyses already made will not be sufficient for his purpose.

8. "The supply of water entering the City should be determined by meter. Venturi meters are accurate and simple. They have no working parts and offer no obstructions to the flow of water. The cost of these meters is approximately as follows:

I am of opinion that a 12-inch meter would be of sufficient size for a 15-inch main; a 20-inch meter for a 24-inch main; 24-inch meter for a 27-inch main."

"Each meter tube should be provided with a register and chart recorder which would record automatically the amount of water passing through the pipe per day. This register and chart would cost \$540.00 additional for each of the three meters."

The quantity of water delivered by the supply mains can only be estimated theoretically at present and at best the result is approximate only. It is important to know

beyond a doubt whether the mains are delivering the quantity of water that they are supposed to deliver theoretically. If they are not delivering the quantity that they should carry the cause should be discovered, so that a proper remedy can be recommended. The only accurate and sure method of determining the quantity of water delivered from the lakes is by the use of the meters recommended by Mr. Chipman, and your committee recommend the clause for approval

9. "In my opinion these meters should be set in the vicinity of the Chain Lake⁸ dam, the three meters to be laid parallel to each other in a properly constructed building. This may require some changes in the pipe lines in the vicinity."

The location mentioned by Mr. ('hipman is the only possible location that can be adopted so that the three registers may be in one building, and your committee recommend the clause for approval.

10. "Your City Engineer should be authorized to engage a daughtsman or assistant to prepare the necessary plans, profiles, etc., above mentioned. These plans will be of service to the City in the future, and valuable at all times for reference. The profiles should have been completed immediately after the works were constructed as well as the plan showing the gate houses, pipes etc., at the foot of Chain Lakes."

It is impossible for the City Engineer and his assistant to prepare the plans and other information asked for by Mr. Chipman, as at present they cannot keep up routine work and have not been able to keep up the records of underground work and similar valuable information since the staff was reduced. It will, therefore, be necessary to engage an assistant, and your committee recommend this clause for approval.

Read Clause 5 re pressure gauges.

Moved by Alderman Hawkins, seconded by Alderman Cawsey, that said clause be adopted. Motion passed.

Read Clauses 6 and 7, re chemical analyses.

Moved by Alderman Cawsey, seconded by Alderman Martin, that the same be adopted. Motion passed.

Read Clause 8, re Venturi meters.

Moved by Alderman Cawsey, seconded by Alderman Hawkins, that said clause be adopted. Motion passed.

Read Clause 9, re location of Venturi meters.

Moved by Alderman Cawsey, seconded by Alderman Martin that said clause be adopted. Motion passed.

Read Clause 10, re Assistance for City Engineer in preparing plans, &c.

Moved by Alderman Cawsey, seconded by Alderman Johnson, that said clause be adopted. Motion passed.

Moved by Alderman Cawsey, seconded by Alderman Hawkins, that the report of the Committee on Works on this matter be adopted as a whole. Motion passed.

Aldermen Hubley and Lamphier desired to be recorded as voting against the whole report.

Read report Commercial Committee re Terminal Facilities at Halifax.

TERMINAL FACILITIES.

HALIFAX, N. S., May 26th, 1905.

To the City Council and Board of Trade:

Gentlemen,—Your Commercial Committee beg to report that on the afternoon of the 22nd inst. the Committee met at North Street for the purpose of going over the terminal arrangements and railway facilities provided at this port, with a view to discovering, if possible, the causes of the delay and difficulty in handling freight here and for the purpose of suggesting what, to the Committee, might appear to be reforms.

- 1. At the outset, in justice to the Department, it must be said that considerable work has been done at this port and considerable improvement has resulted therefrom. The Immigration buildings are convenient, commodious and up-to-date in every particular, and in reference to them the only suggestion the Committee has to make is that the doors on the lower floor should o en outwards, according to law, so that in case of fire a means of hasty exit would be provided.
- 2. Your committee also wish to note with pleasure that the new freight shed on old piers 8 and 9, which Mr. Pottinger promised would be ready for occupancy last year, was on Mouday last opened for the handling and storage of goods. It is a most commodious and convenient building and will materially aid in handling the business to be done at Richmond.
- 3. In order that proper accommodiation for a steamer on the west side of pier 8 may be provided, it will be necessary to remove the large boulder lying between piers 7 and 8. At the present time only a portion of this dock can be utilized on account of this obstruction. The attention of the I. C. R. officials has been called to this matter repeatedly, but so far with very little effect
- 4. The old trestle to the north of the new freight shed on pier 8 is wholly unfit for use and in a tumble-down condition, and if not necessary there should be removed and an additional track laid in the space which the trestle now takes up. Your Committee are of the opinion that another trestle should be provided running right up to and along the roof of the new freight shed in order that vessels may take on bunker coal without moving away from the wharf to another berth. At the present time it is necessary for steamers loading cargo at Richmond to proceed after the cargo loading is completed to Deep Water Terminus for the purpose of coaling. In the winter time there is not sufficient wharf accommodation at Deep Water and it would seem desirable that instead of taking up space there with steamers requiring coal every foot of space should be reserved at Deep Water Terminus entirely for the purpose of loading and discharging cargo.
- 5. Messrs. Beazley Brothers, the contractors who have the contract for building the new crib work north of No. 9 pier, have commenced at the south end of the work and are building northwardly. When they have finished their contract, cars to unload at this pier will have to be brought in south thereof and then shunted north on to the pier, as no contract, your Committee is informed, has yet been let for the additional 750 feet to the north of Beazley Brothers' present contract. If the north part had been started first and completed, cars would go right in from the main line to the pier without any further shunting. It would seem desirable, therefor, that a contract should at ence be let for the remaining 750 feet of crib work in order that this drawback and evident oversight may be avoided.
- 6. At Richmond the workshops, etc., are situated in the midst of the car tracks in what should be the most valuable part of the yard for shunting purposes. No doubt at the time the buildings in question were constructed Richmond was not so pressed for room as it is at the present time. Now that the congestion of traffic has become so great and yard room so urgently needed, the carpenter shop, machine shop and mill should be removed in order that all possible accommodation for the handling of cars may be provided. The buildings are so old that they will not require very much pulling down as some of them are almost ready to fall, particularly the Round House.
- 7. The Round House, beside being in a tumble-down condition, is entirely too small and inadequate for the service which it is expected to perform. The congestion is very bad and the only surprise is that many more accidents have not resulted therefrom. The turn table is too short to accommodate the locomotives and is operated by some eight or ten men by hand instead of steam or electricity being used as a motive power. As a result, the process of turning the locomotive is a very slow and tedious one and a great deal of delay results from the system employed. The larger engines cannot be accommodated on this table. Cars with observation ends in order to be turned must be

sent to Windsor Junction to be turned on the "Y" there. The 75 ft. turn table which was sent here over three years ago was sent away from here a few weeks ago. The original intention was to set it up here. The day your Committee visited the Round House there were several locomotives in it and one on the turn table. The locomotives in the building were backed right up against the side walls and even then the cowcatcher of the locomotive on the turn table could not pass the cow-catchers of the locomotives stored in the building. This state of affairs would not be tolerated in many cities and your Committee feels that in justice to Halifax some action should be taken immediately in regard to this matter at least.

- 8. To provide further accomposation, your Committee is of opinion that the land lying between Campbell Road and the railway track from Roome Street north should be taken by the Department, the houses razed and the present curve in the railway modified.
- For some time the Department has promised to erect a flour shed at the Marine and Fisheries Wharf. At the present time flour brought to the City by rail remains in the cars for a period of five days and in many cases much longer if the importer is willing to pay demurrage, and the cars standing on the track occupy much needed accommodation. In conversation with an official of the Department of Marine and Fisheries here a few days ago one member of the Committee was informed that the Department would be ready to move to Dartmouth about September or October next and that in the meantime nothing could be done in the way of commencing the construction of the proposed flour shed The Committee feels that such a delay should not be tolerated, but the construction of the necessary pier and building should be begun immediately so as to be ready for next winter's trade. If the quarters for the Marine and Fisheries in Dartmouth are not ready permission might be obtained from the Naval Authorities for the use of the Dockyard, at the present time unoccapied; or the Ordnance Wharf or Lumber Yard, which on July 1st will be handed over to the Dominion Government, might be used for all purposes of the Marine and Fisheries Department until the premises at Dartmouth are ready for occupation. By following this course there would be nothing to hinder the construction of the flour shed being undertaken at once.
- 10. A general idea of the condition of the buildings at Richmond may be arrived at from the fact that a day or two previous to the visit of your Committee a portion of the 100f of one of the buildings in which men were employed and rolling stock stored fell through.
- 11. In order to afford proper accommodation to handle the cars going to and from Deep Water, it would seem indispensable that a second track should be provided from Richmond to the Terminus.
- 12. A promise was made by the Department some time ago that Mr. Pottinger would make monthly visits to Halifax on which occasions matters pertaining to the railway could be discussed with him. Mr. Pottinger has not yet commenced these long-promised monthly visits, and your Committee recommend that the Minister should be asked to instruct the General Manager to come to Halifax monthly. notifying the Chairman or Secretary of your Committee a few days in advance of each visit of the date he proposes to be here.
- 13. In order that your Committee may be in a position to place their suggestions intelligently before the Minister and the officials of the Department, it is necessary that they should have a rough plan of the location of the buildings and tracks at Richmond, North Street and Deep Water Terminus and also a plan of the improvements at the present time proposed by the Department.
- 14. In conclusion, your Committee have to state that the opinions and suggestions contained in this report are not only those of the members of your Committee, but are also shared in and endorsed by those officials who have the management of the affairs at this Terminal in their hands.

Your Committee understand that the present system in connection with the securing of supplies is that the head of the department wishing supplies, makes out a requisition for them and they are entered in the order book in the City Clerk's office. They would recommend that an account be opened for each department, showing the various items purchased in the year, and that no official in the city should have the right to order anything for use in the City Hall that is not specified in the regular accepted tenders. If he requires anything additional, that a requisition should be made to some one official having an authority to secure it or to the Council for such articles, and we would suggest that one official should be a Mailing Clerk, and that all letters sent out from the City Hall should be stamped by that clerk, and he should be held responsible for the postage purchased on account of the city.

Your Committee further report that under the Acts of 1905, Chapter 48, the city is authorized to borrow the sum of \$22,300 00 for different services on short term bonds and recommend the acceptance of the offer of the Trustees of the Sinking Fund, 1902, for \$12,000 00 at 4 per cent., short term bonds, and the balance, \$10,300.00, be borrowed from the Market House Fund, at the same rate, and that the City Treasurer be instructed to issue debentures in accordance with the said Act.

Your Committee further report that they had under consideration the matter of borrowing the sum of \$207,000.00, long term debentures, as authorized by the Acts of 1905, for the following purposes, viz:—

\$150,000.00 for construction of sewers. 30,000 00 for improvement of Fire Department. 27,000 00 for widening Agricola Street.

Your Committee reccommend that tenders be advertised for the whole or any part of this loan on debentures, payable in thirty-five years, bearing 4 per cent. interest per annum.

Your Committee further recommend that the tender of the Canada Bank Note Company, Ltd., H. B. Clarke & Son, Agents, for Lithographing 225 Debenture Bonds for \$105.00, and 1,000 Stock Certificater for \$68.00 be accepted, this being the lowest tender.

Your Committee further report that they had under consideration the banking account of the City and recommend that tenders be asked for from the chartered banks doing business in the City for the City banking account for three years from 1st September next.

Your Committee had also under consideration the matter of a current overdraft to meet expenditure until taxes for current year are collected, when the following resolution was adopted:

Rasolved, That this Committee recommend that the City Council authorize the Mayor and City Treasurer, on behalf of the City of Halifax, to borrow from any chartered bank of Canada doing business in Halifax the sum of \$100,000.00 to be applied for defraying expenditures for which taxes for the current year would if now collected be applied and to be repaid to the said bank out of the said taxes when collected, and that the City Treasurer be authorized on behalf of the City of Halifax to negotiate the said loan and to pledge the credit of the City of Halifax therefor.

Moved by Alderman Cawsey, seconded by Alderman Hawkins.

The Committee had also under consideration a report from City Auditor re taxes payable by People's Bank, a copy of which is herewith submitted Your Committee will make some reccommendation in connection with this matter when fuller information is obtained from other cities as to their mode of assessment of bank capital

Gentlemen,—At a meeting of the Committee on Works held this day the attached Minute of Council and City Engineer's report thereon re petition of C. A. Hawkin's for sewer Campbell Road, were read and the report of the City Engineer was recommended for adoption.

CITY ENGINEER'S OFFICE, June 6th, 1905.

His Worship the Mayor:

SIR,—The accompying communications, including petition from C. A. Hawkins for a sewer on Campbell Road, were received last year. When the matter first came before the City Health Board it was ordered to lie on the table as the premises owned by Mr. Hawkins had been reported by the Inspector of Plumbing to be in a good sanitary condi-

tion and a sewer not required. Subsequently it was referred to the City Works Department for report.

Mr. Hawkins has drained his properties to the rear connecting with the Young St. sewer. He would prefer to drain to the sewer in Campbell Road; but if a sewer is not built he would be obliged to repair or renew his drainage in the rear.

The sewer would be 850 feet long and the owners of a majority of the frontage in this block are not anxious to have a sewer constructed. If Mr. Hawkins had no means of drainage his claims for a sewer would be stronger, but as he has an alternative the construction of a sewer does not seem so urgent as it would otherwise. I have had several interviews with Mr. Hawkins in reference to the matter and have decided not to recommend the construction of a sewer at present. Mr. Hawkins asks that the Council give an undertaking that if a sewer is constructed in future he will be exempt from a proportionate cost of its construction. I do not think the Council has the power to give such an undertaking, as the law lays down the course that must be followed.

REPORT LAWS AND PRIVILEGES COMMITTEE.

COMMITTEE ROOM, CITY HALL, May 26th, 1905.

To His Worship the Mayor and City Council:

Gentlemen,—Your Committee on Laws and Privileges beg to report that at a meeting of the Committee, held this day, there being present Alderman Geldert, (Chairman), Johnson, Gastonguay, Hubley, Martin and Hawkins, they had under consideration a number of matters, as follows :-

- 1. Letter Ratepayers' Association re publishing list of taxpayers, showing value of real and personal property assessed and amount of taxes paid by each individual. After careful consideration of this matter, your Committee recommend that the request be not granted, as the city has not at presant any funds to meet the expenditure, your Committee estimating the cost to be not less than \$1000.00.
 - 2. Your Committee further report that they had under consideration an extract

from Minutes of City Council covering resolution of Alderman Johnson requesting the Committee to report upon the existing regulations regarding the office hours of officials at the City Hall. Your Committee find that the hours as now fixed are from 9-30 a. m to 4 p. m., and recommend that the Ordinance submitted and passed by the City Council May 1st, 1890, and disallowed by the Covernor-in-Council at that time be now adopted, with the amendment that the hours be from 9 o'clock a. m. to 5 o'clock p. m. from April 15th to October 15th, and from 9.30 a. m. to 4 p. m. from 16th October to 14th April : also that the amendment passed by this Jouncil December 16th, 1890, be added as an additional clause

- 3. Your Committee further reccommend that the Council obtain legislation at the next session of the Legislature so that it will only be necessary for two assessors to be on the street at any one time assessing, the third assessor to be on duty at the office.
- 4. Your Committee further reccommend that the applications of J. J. Richards and J. F. Meagher for refund of deposits made by them with their liquor license applications be granted and that the amount deposited in each case, less cost of advertising be refunded.
- 5. Your Committee further report that they had under consideration the resolution of Aldermen Johnson and Murray re notice of reconsideration, and recommend that the ordinance in re meetings and rules of City Council be so amended that notices of reconsideration shall require a two-thirds vote of the Council to be carried; His Honor the Recorder being instructed to prepare an amendment to said ordinance in line with this recommendation.
- 6. Your Committee further report that they had under consideration the resolutions of Council requesting the Committee to prepare ordinances governing billiard rooms, bowling alleys and dilapidated buildings and fences. These ordinances are being prepared by His Honor the Recorder.
- 7. Your Committee further report that they had under consideration the matter of appointment of 'lerk of Licenses; the Annual Report City Clerk, 1904-5; letter of the Halifax County Conservative Association preferring charges against Registrar of Voters; and petition of Thomas Sunderland for pecuniary assistance; but are not ready to report on same until next meeting.

Read Clause 1, republishing list of ratepayers.

Moved by Alderman Lamphier, seconded by Alderman Hayward, that the clause be adopted. Motion passed.

Read Clause 2 recommending the passage of an ordinance relating to the duties and office hours of city officials, covering draft ordinance.

Moved by Alderman Johnson, seconded by Alderman Hawkins, that said clause be adopted. Motion passed.

The said draft ordinance relating to duties and office hours of officials is now read.

Read Clause 3, re mode of assessing.

Moved by Alderman Martin, seconded by Alderman Hawkins, that the clause be adopted. Motion passed.

Read Clause 4, re refund of deposits made within certain applications for liquor licenses.

Moved by Ald rman Johnson, seconded by Alderman Hawkins, that the clause be adopted. Motion passed.

Read Clause 5 re notices of reconsideration.

Objected to by Aldermen Cawsey, Hubley and Taylor, and placed on the Order of the Day.

Clauses 6 and 7 are read and filed.

Moved by Alderman Johnson, seconded by Alderman Hawkins, that the report as amended be adopted as a whole. Motion passed.

Read letter Union of Canadian Municipalities re Conventions of 1905 and 1906, covering partial list of subjects for discussion at the 1905 Convention at Winnipeg.

Moved by Alderman Cawsey, seconded by Alderman Murray, that His Worship the Mayor be appointed as the delegate to represent the City of Halifax at the Winnipeg Convention, and that in the event of His Worship being unable to attend that he be authorized to appoint an Alderman to take his place.

The motion is put by Deputy-Mayor Johnson and passed.
