If he intended to charge a higher sum it was his duty to have said so at the time; but having submitted his plan on that express stipulation and having given an intimation to the City that he did not consider himself bound by it, I do not see how any contract can be implied to pay him any other fee than the one expressly agreed upon.

RE BRANDRAM-HENDERSON CO.'S BONUS, ETC.

COMMITTEE ROOM, CITY HALL, July 6th, 1906.

To His Worship the Mayor and Members of the City Council:

Gentlemen,—Your Committee on Laws and Privileges beg to report that at a meeting of the Committee held this day, there being present Aldermen Johnson (chairman), Archibald, Douglas, Hubley and Martin, and His Honor the Recorder, they had under consideration the matter of bonus and tax exemption to the Brandram-Henderson Company. Mr. Joseph R. Henderson, representing the Company, attended the meeting and conferred with your Committee on the different points of proposed Agreement, in which several amendments were made, which were agreed to by both Mr. Henderson and your Committee.

Your Committee recommend the attached memorandum of proposed Agreement between the City of Halifax and the Brandram-Henderson Company, Limited, for adoption by the City Council:—

MEMORANDUM OF PROPOSED AGREEMENT

Between The City of Halifax and the Brandram-Henderson Company, (Limited).

- 1. The City agrees to give the Company in consideration of its establishing new works in the City of Halifax the following:
- (a) A total exemption from taxation on its new works as hereinafter defined for the period of ten years, and undertakes that for a further period of ten years the taxation on such new works shall not exceed fifteen hundred (\$1,500) dollars per annum.
- (b) All the water required by the Company for its said new works at the rate of seven and one-half (7½c.) cents per one thousand gallons, in addition to the regular fire protection rate.
- (c) A bonus of ten thousand (\$10,000.00) dollars a year for ten years on the terms hereinafter set out.
- 2. The new works to be established by the Company to entitle it to any of the above privileges or the bonus are to consist of entirely new buildings and plant and are not to comprise any buildings or plant existing in the City at the date hereof.
- 3. The Company is to employ on an average for every day throughout the year, Sundays and statutory holidays excepted, not less than seventy-five workmen and to pay in each year not less than fifty thousand (\$50,000.00) dollars in wages, exclusive of salaries of manager, officials and office staff.
- 4. The said number of workmen is to be employed and the said amount of wages to be paid in connection with the buildings used in the branches of the business known as lead corroding, lead oxidizing, lead grinding in water and in oil, and the manufacture of other lead products from the pig, also the manufacturing of all packages for the articles produced in the new works and shall not include any workmen employed or wages paid in connection with any other business engaged in by the Company.
- 5. The Company is to keep separate books of account for the business done by it at the said new works and such books shall at all times be open for inspection by the Auditor of the City of Halifax or by any chartered accountant deputed by the City to inspect them.
- The Company will notify the City within two years from the date hereof of the date from which the first year for which a bonus shall be earned is to begin.
- 7. Except as is herein otherwise provided, if the Company in any year fails to employ such number of men and pay such amount of wages, it shall not be paid any sum for bonus in respect to that year, but it shall not thereby forfeit its right to earn a bonus in the succeeding years; but on such failure for two consecutive years, it shall forfeit all rights hereunder; but nothing in this clause shall extend the right to earn a

bonus to any period beyond ten years from the beginning of the year when the bonus was first earned.

- 8. If the Company in any year fails to employ the said number of workmen and to pay the said amount of wages solely because a strike of the workmen not caused by a reduction in the wages paid by the Company, the Company shall not on that account forfeit its rights to receive for that year a proportionate amount of bonus determined by the proportion which the wages actually paid in respect to the new works in that year bears to fifty thousand (\$50,000.00) dollars; provided:
- (a) That the amount of such wages is not less than thirty-thousand (\$30,000.00) dollars; and
- (b) That the average amount of such wages paid in each of the months in which the same is paid is not less than one-twelfth of fifty thousand (\$50,000.00) dollars.
- 9. This agreement, so far as it relates to the payment of the bonus, is conditional on legislation being obtained to authorize the payment of the same, and the City undertakes to do its utmost to secure such legislation.

UNION OF N. S. MUNICIPALITIES.

His Worshp the Mayor and Members City Council:

Gentlemen,—Pursuant to the invitation issued by the Mayor of the City of Halifax a meeting was held in the office of the Mayor on Wednesday, August 15th, for the consideration of a proposal to organize a Union of the Municipalities of Nova Scotia. At the meeting it was unamiously decided that it would be to the advantage of every municipality in Nova Scotia to organize such a Union and a resolution was passed accordingly. A Constitution was adopted which provided among other things as follows:—

"The membership shall consist of all municipalities of Nova Scotia which by vote of their Council declare their intention of joining the Union and upon payment of the the Annual fee."

"The following shall be the scale of yearly fees to be paid by members :-

Muninicipalites \$10 00 Cities and Towns 2 00

for every thousand of population, in no case to be more than fifty dollars nor less than ten dollars."

Upon the organization of the Union, R. T. MacIlreith, Mayor of Halifax, was elected President.

The town of Digby has already passed a resolution to become a member of the Union and has forwarded the fee provided by the Constitution.

As there has been no meeting of the City Council of Halifax since the organization meeting, I have had no oppurtunity of bringing the matter before the Council until to-day. May I ask that the City Council of Halifax will pass a resolution expressing its decision to become a member of the Union of N. S. Municipalities and authorizing the payment of the fee required by the Constitution? There is every evidence that the municipalities of Nova Scotia are in simpathy with the movement and will become members within a short time.
