GENTLEMEN, - The Charities Committee met this day, and beg to submit the following report:

During the month of December there were 35 persons admitted into the Poor's Asylum, 3 born, 17 discharged and 5 died. Of the number admitted 11 were chargeable to the Province and 24 to the City. The total number of inmates December 31st, 1906, was 374, made up of 231 men. 136 women and 7 children.

The Committee had under cansideration a letter from the Local Council of Women re changing the name of the Poor's Asylum, said letter having been referred to this Committee by the City Council for report. In petitioning for the change of name the Local Council of Women have shown good reasons why such should be made, and we understand many citizens are also in favor of it being done. We would therefore recommend that the request of the Local Council of Women be complied with and the name of the institution changed from "The Halifax Poor's Asylum" to that of "The City Home."

His Worship the Mayor and Aldermen, Halifax, N. S.:

DEAR SIRS,—Our Board of Trade has been informed that it is the intention of the Department of Railways to discontinue the "Fast" train from Saturday, the 12th inst., until the summer schedule again comes into operation.

Our Board considers that this will be an injustice to this section of the province and is strongly of the opinion that one express train a day to and from Cape Breton is wholly inadequate to the needs of the community, and that through lack of sufficient communication the commercial and industrial needs of all sections of the island must

materially suffer. The Executive of our Board is making the strongest possible protest to the Federal representatives for this Island against the cancellation of the mid-day express and urging their influence in behalf of the retention of the full service as it present.

Halifax and other sections of Nova Scotia have a large mercantile connection with Cape Breton, and so are vitally interested with us in this matter. May we ask your co-operation, and that you also make a strong protest against the removal of this train.

REPORT BOARD OF FIRE WARDS.

COMMITTEE ROOM, CITY HALL, February 11th, 1907.

His Worship the Mayor and City Council:

GENTLEMEN, - The Board of Fire Wards beg to report as follows.

1. Robert Walker, Hoseman on No. 2 steamer, ill five months; William Powello Driver, No. 2 Hose Waggon ill thirteen weeks and Thomas Healy. Hoseman No. 5 Steamer, ill one year, were all reported as having been paid during their illness.

It is recommended that in future no call-men be paid in such cases until instructions are given by the Board and that permanent men when sick be paid two weeks and no more until reported to the Board. In the case of Healy it is recommended that his pay be stopped during his continued illness and that a supernumerary be placed temporarily in his place and paid. The Board concurs in the action of the Chief in having paid these men full time

- 2. Richard Quirk, Driver No. 3 steamer, died December 8th, 1906
- 3. A. P. Calnen, Hoseman No. 4 steamer, resigned December 31st 1906, and James Doherty, Hoseman No. 5 steamer, resigned November 1st 1906. Resignations recommended for acceptance.
- 4. John Lomas Hoseman No. 3 steamer, and Lieutenant Robinson, No. 4 Hose Co., both suspended for missing a general alarm box 34 January 18th 1907.

It is recommended that these men be each fined two dollars in addition to the three dollars imposed by the rules and that they be reinstated with loss of pay during their suspension.

- 5. Frank O'Regan suspended for refusing to work after a fire at drying hose unless he was paid twenty cents an hour. After a hearing before the Board it was decided to permit O'Regan's reinstatement.
- 6. Robert Walker, Frank Lewin, Charles Merrtt, Lewis Brunt, Henry Wright, Robert Carnell and John Hennessey reported for refusing to sleep in West Street engine house when ordered to do so. Brunt, Wright and Hennessey appeared before the Board and said they still declined to "sleep in."

It was decided to recommend that such of the men as refuse to "sleep in" be requested to tender their resignations.

At a subsequent meeting Wright, Hennessey, Walker and Lewin wrote the Board requesting to be allowed to withdrew their resignations and agreeing to sleep in Quinpool Road engine house when ordered by the Chief.

The Board could not agree to this proposition of the men and adhered to the previous recommendation.

- 7. The following appointments are recommended :-

- (b) Edwin Pearson, Supernumeray No. 1 steamer, to be hoseman vice J. Whalen, promoted.

 - (d) Samuel Hayman to be Supernumerary on No. 5 steamer.
 - (e) James Doherty to be Supernumerary on No 5 steamer.
- 8. It is recommended that the application of W. E. Seagrave, Walkerville. Ont., January 9th 1907, for a further extension of time of a few days in shipping the combination chemical and ladder truck, owning to inability to obtain the copper tanks, be granted.
- 9. Owing to the difficulty experienced from time to time in securing suitable men for the different branches of the Department under thirty years of age, it is unanimously recommended that the rules be amended to permit the appointment of supernumeries. callmen and permanent men between the ages of twenty-one and thirty-five years

Resolve I, as the object of the resolution has been already attained by it being published in the press that any citizen can apply for a position in the Fire Department that this fact be reported back to the Council and in the opinion of the Committee no further action is necessary

- 11. The North British and Mercantile Insurance Company having refused to pay an account of fifty dollars for work performed in extinguishing a fire in a building outside the limits of the City, the Secretary was requested to endeavor to obtain an undertaking from the Nova Scotia B and of Fire Underwriters and also the non-tariff companies to contribute reasonable expenses incurred in such cases.

AWARD OF HOSE CONTRACT.

Macloed "Gazette:" At a special sitting of the Council last week the contract for the supply of 2,000 feet of hose was awarded to the Winnipeg Rubber company, which is allied with the Gutta Percha Rubber company, of Toronto. The hose selected is known as the Red Cross brand, and is guaranteed to stand a pressure of 400 pounds, the price is 75 cents per foot and delivery promised for Feb. 15, so that we shall have our hose on hand in ample time for use when the water supply is available.

The Winnipeg Rubber company to whom the contract was allotted have supplied their hose to most of the large cities and smaller towns in the west, including Calgary, Edmonton, Wetaskiwin, Lethbridge, Cardston. Coleman, Strathcona, Banff, and Vermillion. Judging from this alone we come to the conclusion that the Council have done well in adopting the resolution of the special committee advising the particular hose chosen.

V. W. Libby, the reprentative of the Canadian Rubber company, who also tendered for the contract produced a sample of hose which he claimed was identically the same as the article supplied by the Winnipeg company, but this statement was subsequently disapproved by W. G. Fowler, the manager of the Winnipeg company.

The corporation of Edmonton has also recently purchased from the Winnipeg Rubber company, 3,000 feet of their 2½ Paragon fire hose. This it understood to be the largest contract ever placed in Alberta for fire hose.

The following resolution is submitted :-

Resolved, That the report of the Board of Fire Wards, as amended, be received and

adopted and His Worship the Mayor authorized to sign warrants for payment of accounts therein recommended.

EXPENSES OF OFFICIALS GOING ABROAD.

RECORDER'S OFFICE, CITY HALL, Feb. 12th, 1907.

His Worship the Mayor and City Council:

Gentlemen,—I give my opinion in this matter with considerable diffidence because it is practically the question under deduction in the Supreme Court in the suit of Hart vs. MacIlreith. The learned judge before whom that case was tried expressed an opinion adverse to the power of the Council to send away. To Doane on a practically similar mission to that now proposed, but the decision has been appealed from and until it has been expressly confirmed by the Supreme Court I do not feel justified in departing from my own strong conviction in the matter. This is that the City in the exercise of its powers, of which the maintenance of the Fire Department is one, has the right to send its expert abroad for the purpose of acquiring information to the better enable him to discharge his duties, and that the Council is the proper judge to determine whether or not this expenditure is wise and within the scope of its powers.
