Read Annual Message from His Worship the Mayor.

ANNUAL MESSAGE HIS WORSHIP THE MAYOR.

MAYOR'S OFFICE, CITY HALL, May 16th 1907.

Members City Council:

GENTLEMEN,—It becomes my duty in entering upon the duties of the office of Mayor for the third time to address you on matters to which your attention should be specially directed.

Naturally, the question of

FINANCE.

comes first; but as this whole subject has been very fully dealt with by the Chairman of the Public Accounts Committee on a recent occasion I do not propose to do more than to refer to the larger items of our

BORROWING.

Last year the sum of \$264,800.00 was authorized to be borrowed, but owing to the unfavorable condition of the money market it was not considered advisable to place the bonds upon the market.

At the present Session of the Legislature the sum of \$558,000.00 was authorized to be borrowed.

Of this amount \$125,000 is the City's contribution to the establishment of the Silliker Car Works as security for which the City is to have a first mortgage on the property of the Company. Under the terms of the agreement the Company will provide a sinking fund to redeem the bonds at maturity and in the meantime will pay the interest thereon.

\$130,000 was authorized to be borrowed for the extension and improvement of the water service, to which reference will be made

later. Suffice it to say here that the interest on sinking fund for this amount will be paid out of the revenue received from the Water Department and does not affect the civic rate of taxation. The water rates will not be increased thereby and at the present time the rates paid by the citizens of Halifax are the lowest of any City in Canada.

Another large item of our borrowing is \$95,000 for Schools which the City is required to provide under instructions from the Governor-in-Council.

Among other items the following have been authorized :-

Sewerage Construction	\$50,000.00
Fire Department (land & buildings)	43,200.00
Purchase of sites for manufacturing industries (including Africville.	21,500.00
Paving Streets	25,000.00

The remainder of the sum authorized to be borrowed is made up of a number of smaller items, all of which expenditures appear to be necessary.

While it would be much more pleasant if we could obtain our much needed improvements without having recourse to borrowing, I am nevertheless convinced that the great majority of the ratepayers are desirous of seeing the City progress and are satisfied so long as full value is received for the money expended.

In my two previous addresses the following matters were fully referred to:-

Taxation.

Enforcement of Law.

The Revision of the City Charter,

Public Market.

Dominion Exhibition.

Meeting of the Union of Canadian Municipalities.

Permanent Pavement.

Official Plan.

The Encouragement of Manufacturing Industries.

The Improvement of Terminal Facilities.
and in various messages through the year I had the honor to direct
your attention to the

Fast Atlantic Mail Service and Running Rights of the C. P. R. over the Intercolonial.

All these matters have been before you, have received your best

consideration and I have to thank you for the time and attention which you have given to them. I think we may safely say that progress has been made in connection with every one of them and that we in common with all citizens of Halifax have reason to feel that our old City has at last awakened and taken a considerable step in advance.

As to

TAXATION

a committee was appointed at the last meeting of Council to further consider this difficult problem and to evolve if possible an equitable system of taxation. Its solution is a trying and serious matter and the gentlemen who compose the Committee that are grappling with the subject should, and no doubt will, have every assistance this Council can render them in their work.

With a Police Department which is second to none for a City of the size of Halifax, the

ENFORCEMENT OF LAW

is satisfactorily carried out and the Chief of Police, his officers and men are to be congratulated on the way their at all times unpleasant duties are performed. Their instructions are to enforce the laws and ordinances of the City using judgment and discretion and they are continually giving evidence of their ability to cope with the matters that arise in that department.

THE REVISION OF THE CITY CHARTER

has been completed and the Revisers are to be congratulated on the result of their labors. The revision has been a most thorough and careful one and the laws and ordinances of the City are now so plain that "He who runs may read."

The question of a

PUBLIC MARKET

which has been under consideration of the Council for a great many years is now about to become a reality. The Militia Council of Canada have recommended to the Army Council in England that the large Fuel Yard should be conveyed to the City on terms which you have already considered and agreed to and we now only await the approval of the Imperial Government which there appears to be every reason to believe will be granted. We have the funds on hand with which to erect a a market building and as soon as the transfer of property is made it will be possible to begin the erection of such a building as you may approve.

During the past year, the

DOMINION EXHIBITION

was held at Halifax and was a great success as an exhibition pure and simple, and I am glad to say the accounts show a small balance on the right side.

Toe Annual Convention of the

UNION OF CANADIAN MUNICIPALITIES

was also held at Halifax during the past year, was most successful in every way and resulted in advertising our City and affording those persons charged with the government of cities and towns of other parts of Canada a fuller knowledge of Halifax.

THE PERMANENT PAVEMENT

of our streets and some of our sidewalks speaks for itself. The improvement which it has made in the appearance of our City well warrents the expenditure entailed. Before the close of the year upon which we are now entering is reached and the work now ordered is completed the streets and sidewalks of Halifax will compare more than favorably with the leading cities of the Dominion.

The work on the

OFFICAL PLAN

has been going steadily forward and before the year closes several sections more will be completed and submitted for approval as required by law.

In my last annual message I referred at some length to the matter of

ENCOURAGING MANUFACTURING INDUSTRIES

to establish in our midst.

It is pleasing now to note that the attention and consideration which you have given this matter and the inducements which you were able to offer as well as the favorable situation of Halifax for certain industries have, with the hearty co-operation and hard work of the Board of Trade, resulted in considerable success.

The Silliker Car Works was the first important industry to establish here. A suitable site for this enterprise has been secured by the Company and work is rushed so that the buildings may be erected as speedily as possible.

Negotiations are now being carried on with the W. P. MacNeil

Company looking to the establishment of an iron works in Halifax, and a site is being expropriated for the purpose. The latest report from the gentlemen interested in this Company, is that your offer is acceptable, and that work will be commenced on the erection of the plant as soon as the land is available, provided certain negotiations they are carrying on with outside parties are successful.

Negotiations have also been begun with some other gentlemen looking to the establishment of a boiler works on a large scale, and present indications would lead one to believe that this industry will establish itself here.

All these industries, together with the new Round House and Car Shops of the Intercolonial Railway are to be established in the northern portion of our City which lends itself so admirably to such enterprises, and before long this section should become a veritable hive of industry, employing a very large number of men, a large proportion of whom will be skilled mechanics.

CITY WHARF.

An agreement was reached between the Dartmouth Ferry Commission and your Council looking to the improvement of the ferry accommodation on the Halifax side, but failed to meet with the approval of the ratepayers of Dartmouth. As you have decided to purchase the Stayner Wharf property, I am still in hopes that an arrangement fair alike to the town of Dartmouth and the City of Halifax will be reached whereby a much-needed improvement in ferry facilities on this side of the Harbor will take place.

IMPROVEMENT OF TERMINAL FACILITIES.

In view of the great trade that is springing up in the West, this is one of the greatest questions with which we have to deal. In the consideration of this matter we have had the hearty co-operation of the Board of Trade, and a great improvement is now going on. When the extension of the facilities for handling freight now under construction in Water Street is completed and the Railway Department has taken over the Cunard Wharf property, a shed for the storage of flour being then provided, and the Richmond Yard has been cleared of the obstructions, in the nature of tumble-down buildings, etc., which have so greatly cramped the proper handling of freight, our port will be in a far better position to take its place in the export and import business of Canada, a considerable portion of which we are assured must come to us.

Whether or not an expert on railway and steamship matters should be brought here to look over our facilities and advise us as to what further should be done to improve our port, is a question to which I would direct your earnest consideration.

THE FAST ATLANTIC MAIL SERVICE

came up before us in a very acute form during the past winter when the management of the C. P. R. steamships refused to land mails and passengers at this port. The strong representation which you were able to make on the question to the Government, ably supported by the Board of Trade, resulted in the steamers of the line in question coming to the wharf for the purpose of disembarking and embarking passengers and the landing and reception of the mails. Not only the Government, but I think I am safe in saying the Steamships Management, agreeing that this was the proper course to adopt in the best interest of the Dominion and of the Company.

A question closely allied to this is the matter of

RUNNING RIGHTS OF THE C. P. R. OVER THE INTERCOLONIAL RAILWAY.

At the time that the C. P. R. Company made the request for running rights I had the honor of presenting my views on this very important question to you, and the recommendations I made at that time you unanimously approved. The question is, I understand, still under consideration by the Department of Railways and the Government, and we should continue to press our policy on this question not only as being in the interest of Halifax, but in the interest of the whole Province of Nova Scotia and the Dominion.

One of the most difficult and pressing problems with which we have to deal during the coming year, and the consideration of which should not be delayed, is the matter of our

WATER SUPPLY.

The report of Mr. Willis Chipman, Consulting Engineer of Toronto, is before you, which shows beyond doubt the imperative necessity of at once taking some action.

You have also before you the report of our own City Engineer made to the Council in February, 1892, which is practically confirmed by the report of Mr. Chipman.

Mr. Doane's predecessor also presented several reports on the water question, and these three authorities and others who have examined our water service from time to time all agree that there is a volume of water being discharged into the City of Halifax daily which should be more than sufficient for the needs of double our present

population. Excessive waste is the main cause of the low pressure over the service generally, and on the higherel evations the total absence of water service. Mr. Chipman in his report makes various suggestions to remedy the difficulty. Mr. Doane and Mr. Keating did likewise. For these various reports I would ask your careful and immediate attention pointing out to you the risk which we are con. tinually running in the case of a large conflagration and also the serious inconvenience which the people of Willow Park and those on the other higher levels of the City are called upon to endure. Realizing the urgency of the matter, I presented a message to you when forwarding Mr. Chipman's report suggesting that authority should be obtained from the Legislature to borrow the sum of \$100,000.00 in order that you might be able to grapple with the difficulty as soon as you had had time to consider the report of the Consulting Engineer. You unanimously endorsed the suggestion then made and asked the Legislature for authority to borrow the sum named, which authority the Legislature has granted. I would now recommend that the matter should be referred at once to a special committee with instructions to report to a special meeting of the Council to be called at an early date.

Here let me remark upon the increased facilities which last year's Council have provided in the way of

FIRE FIGHTING APPARATUS

and the additional accommodation which is now been provided for further equipment. When the fire stations now under construction and in contemplation have been erected (the funds for which have already been authorized) and the increased equipment installed our Department should be not only satisfactory to our citizens but should meet the requirements of the most exacting Board of Fire Underwriters.

COUNTY COURT HOUSE,

Legislation was obtained at the 1906 session of the Legislature authorizing the borrowing of money for the extension and improvement of the County Court House. The Court House Commission at once approached the Government with a view to reaching an agreement as to the proportion to be paid by the Province. The Government has agreed to contribute one third of the cost on the understanding that its total contribution shall not exceed seven thousand dollars. The Grand Jury at the last sittings of the Supreme Court called attention to the state of the Court House and it is imperatively necessary that some steps should be taken in this matter at once.

CHANGE IN CIVIC YEAR

Each recurring spring brings to us all the usual and well founded complaints about dusty, dirty streets, and every year as soon as the snow and ice disappear repairs are needed which cannot be made on account of the appropriations not being available until the first of May. Another evil resulting from commencing the work late is that a great deal has to be done in a rush at the end of the season.

There are two remedies—either to change the commencement of the civic year to April 1st or to obtain legislation permitting the Council to anticipate a stated proportion of the coming year's appropriations on and ofter April 1st.

In conclusion, I desire to express my thanks to the members of last year's Council for their co-operation and assistance in the performance of the responsible duties of my office, and I would ask the same support and assistance from the Council of the present year in order that the programme of progressive government which we have entered upon may be in a large measure completed, and Halifax shall take its proper place as one of the progressive cities of Canada.

I would extend a cordial welcome to those members of our Council who are present for the first time this evening. Undoubtedly the part which they will take in the government of our City will make for its progress and development.

Amendment put and lost, 6 voting for the same and 8 against it, on a show of hands.

The original resolution is put and passed.

Alderman Hubley gives notice of reconsideration.

Alderman Douglas submits the following resolution:—

Resolved, that the Board of Works be authorized to lay a concrete sidewalk on the west side of Water Street between Jacob Street and Bell Street under the provisions of the Permanent Sidewalk Act.

Moved by Alderman Douglas, seconded by Alderman Taylor, and passed.

Alderman Kelly submits the following resolution :-

Resolved, That the books of the City Board of Works be kept so that it may be ascertained by reference to them what proportion of the appropriation for streets is expended in each of the six wards.

Moved by Alderman Kelly, seconded by Alderman Hubley. Resolution put and lost.

Alderman Hoben submits the following resolution:-

Resolved, That the City Engineer be requested to submit to the Council at an early date a list of streets and parts of streets in the west end of Ward Four that are now built upon but not taken over by the City and the number of houses on each street, also an estimate of the cost of necessary grading on each of these streets before they could be taken over by the City under the Act of 1907.

Moved by Alderman Hoben, seconded by Alderman Kelly. Resolution put and lost.

Moved by Alderman Johnson, seconded by Alderman Taylor, that the City Engineer be instructed to construct a concrete sidewalk on the west side of Hollis Street from the Bank of Nova Scotia to Duke Street under the provisions of the Permanent Sidewalk Act. Motion passed.

Moved by Alderman Martin, seconded by Alderman Taylor, that the Council adjourn. Motion passed.

Council adjourns 11.50 o'clock.

IN RE DAVIS & FRASER'S CLAIM FOR EXEMPTION.

OFFICE OF CITY SOLICITOR, June 4th, 1907.

To the Chairman of the Committee on Laws and Privileges:

SIR,—So far as I understand the facts of this case, Messrs. Davis & Fraser, previous to the year in respect to which the exemption is claimed, were doing business as pork packers in rented premises. Previous to the last assessment they had purchased other premises upon which they had erected buildings and in respect to these they now claim exemption. The right to exemption depends upon sec. 344 of the City Charter. Under sub-section (2) of that section any person engaged on the 28th day of April 1906 in any manufacturing industry in the City of Halifax, who enlarges or extends his buildings is entitled to a partial exemption. Obviously this part of the section cannot apply to Messrs. Davis & Fraser as the premises in respect to which the exemption is claimed were not those occupied at the date mentioned in the section. Sub-section (1) of the Act is more general and reads as follows:—

When any person or company proposes to purchase any land, or to erect any building in the City of Halifax for the purpose of establishing any manufacturing industry, the Council of the City may wholly or in part exempt the land and building, machinery and stock in trade of such person or company from taxation for the general purposes of the City, other than water rates, for a period not to exceed ten years from the establishment of such industry.

Under this the right to exempt is not an absolute right, but depends entirely upon the discretion of the Council, and the Council would be justified in making the exemption to Messrs Davis & Fraser if they saw fit.

- (1) Any member who has voted against a resolution, or resolution as amended, may at the meeting at which such resolution is passed give notice of reconsideration thereof. At the next meeting of the Council immediately after the calling of the roll and before any other business is considered the giver of such notice, or in his absence any other member on his behalf, shall briefly state his reasons for reconsideration and if the motion to reconsider is seconded the same shall then be put to vote without further debate and if carried the question so reconsidered shall then be read and disposed of.

His Worship the Mayor and City Council:

Gentlemen,—The Committee on Frewards met on May 20th, May 30th and June 3rd and beg to report as follows:—

- 1. Alderman Johnson has been appointed Chairman and Alderman Taylor Vice-chairman of the Board for the current year.
- 2. In a previous report the Board recommended that the tender of Wm. Jakeman & Son for veterinary sevices, being too high, be filed. The Board had since received from them a new tender at \$5.00 per horse for services and medicines. Doctors Jakeman were informed that this tender would be recommended for acceptance if they would see that the horses are properly shod and examine the horses' feet at least once a month. This condition has been accepted and the tender is submitted for your approval.
- 3. It is recommended that James Keefe, Call-man on No. 4. hose, be appointed Lieutenant on No. 4. hose, vice Liet. Wm. Robinson, resigned.
- 4. And that Marshall Gannon, Supernumerary on No. 4. hose, be call-man on that division, vice Keefe, promoted.
- 5. A recent fire on Fort Needham having shewn the urgency of an alarm box in that district, and the City Electrician having estimated the cost at \$150.00, it is recommended that a box be installed about midway on Kaye Street.
- 6. It has been decided to call for tenders for 100 feet of chemical hose, a set of harness for Quinpool Road house and twenty-eight suits of uniform clothing for the permanent men and to advertise for applications for twenty or more Supernumerary call firemen.

- 7. The Board having installed tappers in the houses of the call-men free of charge it is recommended that in every case where a tapper has to be shifted in consequence of change of residence or other cause the actual cost of shifting be paid by the fireman moving, &c., and that said charge be deducted by the Chief from any pay due such fireman.
- 8. Having in view the improvement of the internal economy and efficiency of the Department, an effort is being made to secure the services of mechanics in making new appointments. In order to ascertain the competency of certain men now proposed for appointment, the Chief desires to engage these men temporarily and the Board has concurred in his recommendation.
- It is recommended that John Honey be confirmed in his position as spare driver and his name restored to the roll as a member of the Department.

IN RE THE HORTON AERIAL LADDER.

OFFICE OF CITY SOLICITOR, CITY HALL, June 10th, 1907.

His Worship the Mayor:

SIR,—In response to your verbal request for my opinion as to liability of the City in this matter, I beg to say as follows:—

On 16th July 1906 the Board of Firewards called for tenders among other things for one furntable Aerial Truck with quotations for 75, 80 or 85 ft. ladder. On August 7th Messrs Macdonald & Co., offered to supply Horton Patent Aerial Truck with 75 ft. ladder for \$4500, 80 ft. for \$4900 and 85 ft. for \$5000. The Board in their report to the Council recommended that the 80 ft. ladder be purchased from Macdonald & Co., the same to be built to the requirements of the Board. This recommendation was adopted by the Council by resolution passed at a meeting held 9th August. The only notification of this action of the Council given to Macdonald & Co., was that contained in the letter of the Secretary of the Board of the 9th October notifying them of the acceptance and asking for specifications of the ladder. These Messrs Macdonald & Co., undertook to supply on 8th November. On 30th November the Board notified Messrs Macdonald & Co., that the specifications were vague and unsatisfactory, complained of the delay and required complete specifications of the ladder, truck and equipment proposed to be furnished including drawings or blue prints and particulars of a number of other matters in respect to the ladder. On December 3rd a member of Messrs Macdonald & Co., attended at a meeting of the Board at which the question of specification was verbally discussed and he declined to furnish drawings or blue prints. A further discussion of the specification was had with Mr. Macdonald on 7th February. On 30th May the Board called at the place of business of Macdonald & Co., and asked to see the ladder, but no ladder or any part of it was shewn them. On the 3rd June, the Board resolved that it did not approve of the specifications submitted and refused to accept them.

Upon these facts I am of opinion that there is no contract for the purchase of the ladder between the City and Messrs Macdonald & Co., and that the City will incur no liability by decling to go any further in the negotiations with them. My reasons for so holding are the following:—

- 1. The resolution of the Council approving of the recommendation of the Firewards to accept the tender did not in itself constitute a contract binding on the Ctty. Such can only be created by an instrument under the seal of the City and executed by the proper officials. (See Arnold on Municipal Corps., 4th ed., p 109 and cases in note; also City Charter, sec. 5). The resolution of the Council was in my opinion only an authority to the officials to execute such a contract and until acted upon could be revoked. The letter of the Secretary of the Board of Firewards of 9th October only called attention to the resolution of the Council and could have no further effect.
- 2. Even assuming that the resolution of the Council was an acceptance, it was only a conditional one—that the ladder to be supplied must meet the requirements of the Board of Firewards. Of those requirements they were the only judges and in the absence of any bad faith or improper conduct on their part their determination that the ladder proposed will not meet their requirements is conclusive. Messrs. Macdonald & Co. would probably be entitled to reasonable time and opportunity to satisfy the Board of their ability to meet the requirements. This they have had and having failed to meet those requirements the Council have a perfect right to put an end to the negotiations.

Moved by Alderman Johnson, seconded by Alderman Archibald, that said Clause 10 be adopted.

Moved by Alderman Hoben, seconded by Alderman Whitman, that Mr. Roderick Macdonald be permitted to address the Council on the matter. Motion passed.

Mr. Macdonald addresses the Council and exhibits a model of the Horton Aerial Ladder and Truck.

The following amendment to the original resolution is submitted:

Resolved. That the time for the building and supplying to the City of the 80 ft. Horton Ladder by Macdonald & Co., Ltd., as per recommendation of the Committee of Firewards to Council, August 9th, 1906, the whole when completed to be to the satisfaction of the Firewards, be extended for three months from date, provided that Macdonald & Co., Ltd., within ten days undertake to provide such ladder within such period for the approval of the Committee of Firewards.

Further Resolved, That unless Macdonald & Co., Ltd., notify the City (in writing) within ten days of their intention to build the ladder the City proceed with the purchase of the Seagrave Ladder as recommended by the Firewards.

Moved by Alderman Martin, seconded by Alderman MacKenzie.

Moved by Alderman Douglas, seconded by Alderman Taylor, that Mr. Macdonald be now given an opportunity to answer the Council whether he will accept the City's offer. Motion passed.

Mr. Macdonald replied that Macdonald & Co. would construct the said ladder within three months.

Alderman Martin's amendment is now put and passed unanimously. Read letter Board of Trade in re public holiday June 21st.

New Glasgow, N. S., June 5th, 1907.

L FRED MONAGHAN, Esq., City Clerk.

SIR,—We regret to have to advise you that after going carefully into the relative merits of Halifax and New Glasgow, we have decided to build our new plant at New Glasgow.

We have thoroughly canvassed the industrial advantages of the two places and this decision has only been reached after an exhaustive examination of the conditions, particularly the labor conditions, prevailing in Halifax at the present time. We cannot but note from time to time in the press the labor troubles, tending to disturb trade, which takes place in Halifax and which same are unknown here. In New Glasgow we have no unions to contend with such as exist in Halifax, and as our work is practically identical with the work done in the dry dock shops and on the slip we feel we would sooner or later have trouble with the Iron Workers' Union. Competition in our business at the present time is so very keen that we could not do work at a profit if we had to pay union wages and work union hours.

We have altered our plans since this matter was first talked of, and now propose taking up other lines of business and thus employing more men than was at first intended, so that the possibility of labor troubles becomes a more serious question.

We regret that we cannot see our way clear to take advantage of the generous offer extended by the City of Halifax, but after looking into the matter from all points we have reached the foregoing decision. This decision is based solely upon our present opinion of the relative merits of New Glasgow and Halifax as manufacturing centres, taking into account the advantages and disadvantages of each, and the offer extended will in no way be used as a lever to obtain any concessions from the town of New Glasgow, as we have just bought about thirty acres of land here and will build our new plant on this ground.

Thanking your Mayor and Council for your very flattering offer, and again regretting that now same has been made we cannot in justice to ourselves accept it, we beg to remain,
