HALIFAX, April 19th, 1910.

L. FRED MONAGHAN, Esq., City Clerk:

DEAR SIR,—After protracted negotiations with the Government a sale of the "strip" so called at Point Tupper has been concluded, yielding the sum of \$3045.73 and an offer has been received from Mr. H. N. Paint to take over the balance of the Cape Breton property for the sum of \$3504.27, making together \$6550.00, the above named sums to be distributed among the legatees and to be received by them in full of all claims on the judgment and property now held by the Institution for the Deaf and Dumb as Trustees for themselves and co-legatees.

Mr. Paint stipulates for sixty days for payment after he is notified that the legatees or a majority thereof, in interest, accept his offer.

The Directors of the Institution for the Deaf and Dumb who hold twenty shares given to legatees have voted in favor of the acceptance of the offer and recommend its acceptance by the other legatees.

The question now remains to be answered whether the legatees will accept the above proposal for a final settlement or whether they prefer to retain their interest in the Cape Breton property and look to sales to be made in the future:

OLD EXHIBITION LOTS.

CITY ENGINEER'S OFFICE, April 13th, 1910.

To the City Council :

Gentlemen,—Your Committee, to whom was referred the consideration of the disposal of the old Exhibition property, beg to report on the accompanying communication from the Bishop of Nova Scotia.

The Cathedral Committee ask for the sale of the four lots on College Street in the rear of Mr. R G. Beazley's property, for which they are prepared to pay the sum of \$1000.00 each. The Council have already decided to grant this request but the lots have not yet been deeded as the City rollers are on the property. They will be removed in a few days.

The Cathedral Committee ask the City to sell to them two lots on Morris Street adjoining the Cathedral property for \$3000 00. The City received for the six lots on Morris Street sold to the Cathedral Committee, the sum of \$18,000 00. If the City should comply with the request, the total amount received for eight lots would be \$21,000 00 or at the rate of \$2625.00 for each lot. That sum is probably the full value of the lot and in addition, the Cathedral Committee propose to remove St. Stephen's Chapel from Robie Street to the rear of the new Cathedral. The size now occapied by St Stephen's Chapel would then be assessed for taxes.

Under the circumstances, your Committee would recommend that the two lots be sold as requested on the same conditions as those named in other sales of lots in this property, and that the portion occupied for residential purposes shall be assessed for taxes; also that the site at present occupied by St. Stephen's Chapel shall be assessed for taxes when the Chapel is removed.

RE LEGISLATION.

OFFICE OF CITY SOLICITOR, April 27th, 19 1%.

His Worship the Mayor:

Sir,—I beg to advise the Council of the result of the last session of the Legislature as affects the City's legislation.

- 1. The City's borrowing bill has passed without any change.
- 2. Of the City is general bill the clause relating to the building lines passed with a rider providing that it should not go into force until approved by the Governor-in-Council, the reason for this being that the Eastern Trust Company, on behalf of Mr. Collins, who is a large owner on Oxford Street, while not actually opposing the bill, desired to have time to consult their client, and the Committee insisted on putting the rider mentioned on the clause, or, in the alternative cutting it out of the Act.
- 3. The legislation as to the School Board is somewhat confused. The City's own Act requiring the estimates to be submitted to the Council in detail and the School Board to live within its estimate and pay over unexpended balances has been passed without any alteration except the addition of a clause requiring the Trustees of the Sinking Fund to render an account to the School Board of the amount of its unexpended balances and accumulations on hand from time to time. A bill, however, was introduced by the Hon. Mr. McPherson and passed requiring the estimates when they exceed \$140,000 (which they always do) to be submitted to the Council in the first instance. This legislation is apparently in conflict with the unrepealed provision of the Charter and may cause some little difficulty in the working out.
- 4. The clause in the City's bill repealing the Cairns legislation was struck out and in addition a clause is added making it compulsory on the City to borrow the money to pay Mr. Cairns for the current year. As this provision materially affects the defence of the Action, I would like some instructions as to the Council's wishes in the matter,

5. The provisions as to the Juries Lists and the duplicate tax receipts apparently did not meet the approval of the Legislature and have been struck out of our bill.

Moved by Alderman Hoben, seconded by Alderman Hebb, that the same be considered clause by clause. Motion passed.

Clauses 1, 2 and 3 are severally read and filed.

Read clause 4 re Cairns superannuation.

Moved by Alderman Whitman, seconded by Alderman Edwards, that this matter be referred to the Committee on Laws and Privileges and that said Committee have full power to confer with and instruct the City Solicitor in reference to Mr. Cairns' action against the City.

Moved in amendment by Alderman MacKenzie, seconded by Alderman Hoben, that the defence of Mr. Cairns' action be abandoned and that the amount of superannuation due Mr. Cairns be borrowed from the Royal Bank and paid him.

Alderman Hebb asked for the opinion of the City Solicitor as to whether the legislation passed at the last session affected the City's defence to the action brought by Mr. Cairns.

The City Solicitor stated as his opinion that the effect of the legislation recently passed was that the City new has no defence whatever to the action.

GENTLEMEN,—The Charities Committee met this day and beg to submit the following report. Members present the Chairman, Alderman O'Brien and Alderman Wilson.

The Superintendents' report from April 1st to date, shows that during that time there were 24 persons admitted into the City Home, 1 born, 52 discharged and 7 died. Of the number admitted, 6 were chargeable to the Province and 18 to the City. The total number of inmates at this date is 352, made up of 215 men, 133 women and 4 children On the same date last year there were 207 men, 141 women and 4 children, a total of 352.

SIR,—I beg to report on the tenders received for cleaning catchpits. The lowest tender received was that of Robinson Bros., which is 95c. for each pit.

I made an estimate of the cost of cleaning catchpits before preparing the specification for tenders, and the highest cost, according to the returns of the City Storekeeper, was atout \$1.15 per pit. If the contract were given for this work, it would be necessary to employ an inspector who would cost not less than 10c. per pit and there would be required also assistants at the dump which would cost nearly 10c. more, making the cost by contract about the same as the cost by days work.

I would recommend, therefore, that the work be done again this year by days work and that a detailed statement of the cost be kept so that we may know to a cent what it is costing per catch pit to clean them. If any saving can be effected next year I should be glad to recommend doing the work by tender, but as it seems that it can be done without extra expense, I would recommend that it be done this year by days work.

SIR.—I beg to report on the accompanying letter from Mr R. J. Anderson 264 South Street. Mr Anderson has a lot on the south side of South Street 50 feet wide and 200 feet deep, for which he paid, about ten years ago, the sum of \$300.00 or about three cents a square foot.

The official line of South Street is laid down about two feet outside of the front of Mr. Anderson's property. Mr. Anderson is desirous of constructing a bay window on the front of his property and extending the entrance, and requests the City to sell him the two feet in front of the property, so that he may extend his lot to the official line.

This is the first case of this kind which we have had to consider and as there may be a great many more, the decision in this case will establish a precedent for the future.

The piece of land which Mr. Anderson wants, contains about 100 square feet and he is prepared to pay whatever the City considers a fair price. The legislation this year, if it passes, will authorize the City to dispose of the land, and I would recommend that it be sold to Mr. Anderson for the sum of \$5.00, which in my opinion is a fair value for the land.
