QUESTIONS BY MEMBERS.

RESOLUTIONS BY MEMBERS.

Moved by Alderman Wilson, seconded by Alderman Whitman, that the various Committees on Juries Lists be paid in accordance with the Act passed at the present session of the Legislature. Motion passed.

Alderman Whitman submits the following resolution :-

Whereas, it is considered advisable for the purpose of defraying expenditores for which the taxes of the current year would, if now collected, be applied, that the City of Halifax do borrow under section 310 of the City Charter from the Royal Bank of Canada an amount not exceeding thirty per cont. of the taxes for the current year.

And Whereas, the taxes for the current year amount to a sum over \$530,000.

Be it resolved, that the City of Halifax do forthwith borrow from the Royal Bank of

Canada the sum of \$159,000 00 to be applied for defraying expenditures for which the taxes of the current year would if now collected be applied, to be repaid to the said Bank out of the said taxes when collected, and that the City Treasurer be authorized on behalf of the City of Halifax to negotiate the said loan and to pledge the credit of the Uity of Halifax therefor.

Moved by Alderman Whitman, secon led by Alderman Bligh, and passed.

Alderman Bligh submits the following resolution :---

Whereas, the Canadian Pacific Railway Company have repeatedly signified their desire to reach Halifax by running rights over the Intercolonial Railway, and the Canadian Pacific Railway Company have intimated that if accorded said renning rights on reasonable terms, the Company will then consider certain valuable developments in connection with steamships, branch lines, terminals, hotels, etc.; and

Whereas, The Canadian Pacific Railway Company is ready at the present time to negotiate for the necessary running rights to reach Halifax; and

Whereas, the Maritime Board of Trade at its annual meeting August 19-21, 1908, adopted a resolution by a vote of 54-22 in favor of granting the Canadian Pacific Railway running rights over the Intercolonial Railway; and

Whereas, no satisfactory reason has been made public to explain the failure of the efforts of the Canadian Pacific Railway to obtain the desired entrance into Halifax;

Therefore Resolved, The City Conneil of Halifax hereby expresses the opinion that the interests of Nova Scotia and of Halifax would be bene fitted by giving the Canadian Pacific Railway running rights over the Intercolonial Railway and the City Clerk is hereby instructed to write to the Minister of Railways for corps of correspondence between the Canadian Pacific Railway and the Government in regard to running rights, and reports in relation thereto, and also to write to the President of the Canadian Pacific Railway for such further information as that Company may care to communicate in regard to its past proposals and offers in reference to the desired running rights over the Intercolonial Railway

Moved by Alderman Bligh, seconded by Alderman McManus and passed.

Alderman Hubley submits the following resolution :

Whereas, the present system of keeping the records of the Juries Lists is cumbersome, antiquated and expensive;

Resolved, that the City Clerk be instructed to prepare the new lists ordered by the Supreme Court for the present year, and which have been revised by the Juries Committee, on the card index system, and that he be paid out of the Contingent Fund the sum of two cents per name on the Grand, Petit and Special Juries for the work.

Moved by Alderman Hubley, seconded by Alderman Kelly, and passed.

Alderman McManus submits the following resolution :--

Whereas, during the past year an opinion has been generally expressed by the members of this Council that the City Prison should be re-organized;

And whereas, it is the duty of this Council to take advantag⁻ of any movement that has for its object the betterment of conditions of any institutions under their control.

And whereas, it has been suggested that an improvement could be made by placing the City Prison and City Home under one management and thus lessening the expense of the upkeep of said institutions;





To all to whom these presents shall come, --GREETING:

WW HEREAS by chapter one hundred and one of the Revised Statutes of Canada, 1906, intituled "An Act respecting the Demise of the Crown," it is, amongst other things, in effect enacted, that upon the demise of the Crown, it shall not be necessary to renew any commission by virtue whereof any officer of Canada, or any functionary in Canada or any Judge of the Dominion or Provincial Courts in Canada, held his office or profession during the previous reign; but that a proclamation shall be issued by the Governor General authorizing all persons in office as officers of Canada who held commissions under the late Sovereign, and all functionaries who exercised any profession by virtue of any such commissions and all Judges of Dominion and Provincial Courts to professions; and that such proclamation shall suffice and that the incumbents shall, as scon thereafter as possible, take the usual and customary oath of allegiance before the proper officer or officers thereunto appointed,-

Now, therefore, by and with the advice of Our Privy Council for Canada, We do by this Our Proclamation, authorize all persons in office as officers of Canada and all functionaries in Canada, and all Judges of the Dominion and Provincial Courts in Canada, who at the time of the demise of Our late Royal Father of glorious memory, were duly and layfully holding or were duly and lawfully possessed of or invested in any office, place or employment, civil or military, within Our Dominion of Canada. or who held commissions under the late Sovereign, or all functionaries who exercised any profession by virtue of any such commissions, to severally continue in the due exercise of their respective duties, functions and professions, for which this Our Proclamation shall be sufficient warrant.

And We do ordain that all incumbents of such offices and functions and all persons holding commissions as aforesaid shall, as soon hereafter as possible, take the usual and customary oath of allegiance to Us before the proper officer or officers hereunto appointed.

And We do hereby require and command all Our loving subjects to be aiding, helping and assisting all such officers of Canada and other functionaries in the performance of their respective offices and places.

- IN TESTIMONY WHEREOF, We have caused these Our Letters to be made Patent, and the Great Seal of Canada to be hereunto affixed. WITNESS Our Right Trusty and Right Well-Beloved Cousin the Right Honourable SIE ALBERT HENRY GEORGE, EARL GREY, Viscount Howick, Baron Grey of Howick, in the County of Norththumberland, in the Peerage of the United Kingdom, and a Baronet; Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, etc., etc., etc., Governor General of Canada.

I, the said Duncan Cameron Fraser, Lieutenant-Governor of Nova Scotia, assisted by His Majesty's Executive Council for Nova Scotia, and with their hearty and zealous concurrence, do therefore hereby publish and proclaim that the High and Mighty Prince George Frederick Ernest Albert, Prince of Wales, is now by the death of our late Sovereign of happy and glorious memory, become our only lawful and rightful Leige Lord, George the Fifth, by the Grace of God, King of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, Defender of the Faith, Emperor of India, to whom are due all faith and constant obedience with all humble and hearty affection; and I do hereby require and command all persons whomscever to yield obedience and govern themselves accordingly—beseeching God, by whom Kings do reign, to bless the Royal Prince George the Fifth with long and happy years to reign over us.
