FIRE HYDRANTS.

CITY WORKS OFFICE, July 6th, 1910.

To the City Council:

GENTLEMEN,—At a meeting of the Committee on Works held this day the attached report of the City Engineer on Minute of Council in re fire Hydrants on Water Street, north of North Street, and on North Street, east of Lockman Street, was read and referred to Council for its information.

CITY ENGINEER'S OFFICE, July 4th, 1910.

His Worship the Mayor:

Sir,—I beg to report on the accompanying letter and extract from Minutes of Council respecting fire hydrants.

There was a fire hydrant on North Street, near Water Street, before the changes were made in the railway yard and the water distribution system. The hydrant was removed when making the changes and has not been replaced. I have instructed the Foreman of the Water Department to replace it at his earliest convenience as it is needed to give efficient fire service in that neighbourhood.

There is no main for fire service on Water Street north of North Street, and as the only property to be supplied is owned by the Dominion Government, I do not think the City should make any expenditure All water pipes, hydrants, etc., for supply, either fire or domestic, on the property of the Dominion and Imperial Government, have been paid for by the government interested.

The Chairman of the Board of Fire Wards called attention to the defective condition of two hydrants in Ward Six. There is an error in the location of one of the hydrants, but the Foreman found the cause of trouble at the hydrant at the corner of Hanover and Vieth Streets and it was repaired by putting a new large nozzle on it so that the hose connection would fit better. The Chairman complains that the hydrant at the corner of Hanover and Union Streets has such a heavy leakage from the bottom of the hydrant as to render it practically useless. I am informed that this was reported by the officials of the Fire Department. On investigation it was found by Mr. Morrison that the waste valve had dirt in it and did not close tightly, allowing the water to escape when the hydrant was open. When the hydrant was closed there was no leakage whatever, and when the hydrant was open, as the area of the hydrant valve in 145 times the area of the waste valve, the absurdity of the complaint made by the officials of the Fire Department, that the hydrant was practically useless, is apparent. Mr. Morrison had the waste valve cleaned out as soon as his attention was called to it.

CITY ENGINEER'S OFFICE, July 4th, 1910.

His Worship the Mayor :

SIR,—At the request of your Committee I beg to report on the advisability of laying a 12" water distribution main pipe in Oxford Street, from Quinpool Road south.

All recent plans for this distribution have been made in view of the necessity of having a much larger main than a 6" pipe for the district to be supplied from Oxford Street east and west.

There is a 6" pipe in Coburg Road down to the Birchdale and Waegwoltic. A 6" pipe has also been laid in Oxford Street north and south from Coburg Road for a short distance. The last pipe laid in Oxford Street, between Coburg Road and Jubilee Road, was 12 inches in diameter.

A 6" pipe would not be large enough to supply the district bounded by Quinpool Road, Inglis Street, North West Arm and Preston Street, which must be supplied by the Oxford Street main. Nothing less than a 12" pipe would give a satisfactory fire service. It is probable that the low service will supply up the hill as far as Preston Street, while Mr. Morrison, Superintendent of the Water Department, has some hope that it will supply as high up as Walnut Street.

The pressure at the Birchdale and Waegwoltic and other buildings below Oxford Street and Coburg Road is much greater than is necessary, and the use of water where there are no meters is much greater in consequence, and even where the meters are in use the quantity consumed is greater in consequence of the heavy pressure.

If a distribution main were laid in Oxford Street from Quinpool Road, this district could be cut off from the high service, and some of the householders who are now unable to get water would get it.

The Council has ordered the laying of a pipe from Quinpool Road to Mott Street along Oxford Street on a special rate of \$21 47. It would be necessary to rescind this resolution before an order could be passed for the laying of a 12 pipe from Quinpool Road to the end of the 12 pipe south of Coburg Road. It will not be necessary at present to make any change in the pipe already laid.

The estimated cost of laying a 12" pipe from Quinpool Road to the end of the 12" pipe south of Jubilee Road is \$5687.00, and I would recommend that this work be done.

His Worship the Mayor:

SIR,—I beg to report on the question asked by Alderman Hoben at the last meeting of Council, viz: "How far north of the Payzant property the Committee on Works intend laying a 12-inch pipe on Oxford Street."

I just received the question too late to report to the Works Committee for the meeting of Council to-night. The extension north of the water pipe from the end of the pipe in front of Mr. Payzant's property northwardly has been made as far as Alderman Smith's house. It could not be made beyond Jubilee Road until we receive the new valves from the old country. There is one house beyond Alderman Smith's house on Jubilee Road.

The question of extension north of Alderman Smith's house has not been discussed by the Works Committee, and I have no instructions to lay the pipe farther than it has already been laid.

Mr. Morrison reports to me to-day that the cost of labor and materials is \$936.00 for the pipe laid, and that the distance from the end of the pipe to Alderman Smith's service pipe is 375 feet. Cost of a 6-inch pipe, which is always used in making an estimate for water tax, would be \$165, making a total of \$1,101.00.

In estimating the revenue from this extension I estimated the revenue from Alderman Smith's house \$23.80, Mr. Silliker's house \$16.40 and the other three houses \$12.00, total \$52.20 The pipe rate on vacant land would more than cover the balance of interest, which at 5 per cent. would be \$55.00.

If a special rate had been charged it would be \$11.00, which would be a hardship on the owners of the three small houses, while it would relieve Alderman Smith of one-half of his water rate. As the estimated revenue is sufficient to pay the estimated interest on the outlay, the usual custom was followed, and the extension made without making a special rate.

MANAGEMENT OF VEHICLES ON STREETS.

MAYOR'S OFFICE, August 5th, 1910.

To the City Council:

GENTLEMEN,—Many complaints have been made respecting the manner in which persons operating automobiles, motor-cycles bicycles, express waggons, etc., make use of the public streets, more particularly at or near the street crossings and it seems to me that our ordinances respecting the use of the streets by vehicles of all kinds should be amended so as to make clear the rights and duties of all persons travelling upon the same. It has occurred to me that some such regulations as outlined in the following paragraphs (some of them being a statement of the common law) might be adopted:—

All vehicles, including bicycles, shall keep to the left, and as near as possible to the curb.

Slow-moving vehicles must keep close to the left hand curb to allow faster-moving vehicles to pass them.

Vehicles overtaking others shall, in passing, keep to the right, but not go beyond the centre line of the street, the rule being that one-half of the street is reserved for traffic moving in one direction, and the other half for traffic moving in the other direction.

A vehicle turning to the left into another street shall turn the corner as near the curb as practicable.

A vehicle turning lo the right into another street shall pass to the left of and beyond the centre of the street intersection before turning.

Vehicles approaching a street car discharging or taking in passengers must stop to avoid accidents.

The speed of vehicles must be slackened at street crossings, and vehicles must stop when foot-passengers are upon the crossings.

Doubtless on consideration further amendments can be suggested. I would recommend that the matter be referred to the Committee on Laws and Privileges, who, with the assistance of the City Solicitor and Chief of Police, can take the whole subject into consideration.

Thairman Committee on Laws and Privileges:

SIR,—The Chief of the Fire Department informs methat the fire in question was in a barn immediately adjoining the house and property of Miss Eustace, and that but for the services of the Fire Department Miss Eustace's premises would have been destroyed. In order to extinguish the fire it was necessary to take the engines on Miss Eustace's property, and to do so it was necessary to level the fence. The right of persons engaged in extinguishing a fire or preventing its spread to destroy property in order to effect their purpose without making any compensation to the owner of the property destroyed is acancient as the Common Law. If such a claim as this were allowed, it would be impossible to put limits to the liability which would be incurred by the City in the extinction of fires.

I am of opinion that there is no liability on the part of the City, and that it would be a most dangerous precedent to make any compensation.

From our records of previous work, I should estimate that such cost to the City would be from twelve to fifteen cents per foot for tile duct and probably 15 to 18 cents per ft. for fibre duct. The latter figure however is only a mere approximation, as we have not yet completed laying sufficient of this material in order to arrive at a fair estimate of its cost.

In the event of the City agreeing to the above proposition, no charge will be made for the use of the Company's manholes, which, as you are aware, represent about forty per cent of the total cost of underground work.

SIR,—The water supply on Longard Road north of Young Street, Livingstone Street, Agricola St., Kane Street, Gottingen St., Kenny Street, Acadia and Roome Street, passes through the main on Gottingen Street from Bilby Street north.

In case of accident, or if for any other reason, it is necessary to turn off the water on Gottingen Street, north of Young Street, this whole district would be without supply

On Gottingen Street the pipe runs north to the City Prison, Trachoma Hospital and Hospital for Infectious Diseases. The result in case of fire might be disastrous, and in any case, it is too large a district to have to turn off for repairs. There should be at least two ways of getting water into the district.

The pipe on Agricola Street is 9". The other pipes, running both ways from it, are 6". The Agricola Street pipe was made larger, with the intention of some time in the future, connecting it with Bilby Street southerly through Agricola Street. With the same end in view, the pipe laid in Agricola Street, from Macara to Young Street, was made 9".

I would recommend that a 9" pipe be laid from the end of the pipe near Young Street to the end of the pipe at Kane Street, so that this district will be supplied through two different streets.

The estimated cost, including pipe, is \$883.00.

There are no houses along this proposed extension, but I make the recommendation in consequence of the serious condition which might arise should a five break out while the water is turned off in Gottingen Street.

The Acadia Powder Company's tender is the lowest, but the reason for not awarding the contract to them at the time the tenders were considered was that for some time past our foremen have been complaining that the dynamite delivered was not as powerful as we had been receiving formerly, although the specification was the same and the price charged had remained unchanged. Owing to an enforced absence from the office, and the pressure of work since, I have been unable to go thoroughly into the matter so that I could report on it until recently. The foremen agree in their complaint that the Acadia Powder Co. have not been supplying as destructive material as in the past, and consequently they were obliged to use more of it, which made the work cost much more. The representatives of the Powder Co. dispute this claim and state that they have always supplied good material. As the proof is in the results, I am obliged to accept the statement of our men. We have tested Blastine, on which G. B. Oland & Co. tender, and from the results of our test I believe the material would be satisfactory. If the dynamite supplied by the Acadia Powder Co. is at any time below the standard which we have been in the habit of using our work must cost more, consequently the difference

in the cost of work would not be as represented in the two tenders, but would be the reverse, the poorer dynamite being the more expensive material. The representatives of the Acadia Powder Co claim that they will supply in future the dynamite required by the specification. Under the circumstances I lay the facts before you for your decision.

His Worship the Mayor :

SIR,—The tar macadam pavements which are being laid on Sackville and Prince Streets are being put down to test this method of making roadways. Other cities have had a varied experience with it. Its life will be considerably reduced if teamsters are allowed to use the drags or shoes which they place under the hind wheel on going down the hill loaded. The narrow drags at present in use, will cut through the pavement, and once the bond is broken it will soon go to pieces.

I would recommend that the Street Ordinance be amended to provide that no drag or shoe less than 6" in width be used under the wheel of any loaded wagon, and that all drags or shoes must be turned up at the front end and be smooth on the bottom, without rivets, bolts, or projections of any kind.

The narrow shoes which teamsters are using on our bithulithic pavements are not doing it any good, and it is desirable to make a change in the interest of the bithulithic pavement as well as the tar macadam.

SIR,—I beg to report on the accompanying communication respecting the construction of a sidewalk on the north side of Coburg Road.

Mr. Hattie, representing the petitioners, asks for the construction of a sidewalk from Edward Street to the Waegwoltic Grounds, or rather those owning or representing property between Edward Street and Walnut Street, ask that the City lay that portion of the sidewalk pending negotiations with the property owners between Walnut Street and the Arm.

A concrete sidewalk has been ordered for the south side of Coburg Road, from Edward Street to LeMarchant Street, and as this is an important thoroughfare and as the sidewalk asked for would be a continuation of a permanent sidewalk all the way from the centre of the City to Edward Street, the request seems a reasonable one.

The estimated cost is \$4,781.00. I would recommend that a concrete sidewalk' with granite curb and gutter, be laid on the north side of Coburg Road, from Edward Street to Walnut Street, under the Permanent Sidewalk Act.

SIR,—I beg to report on the accompanying petition from the congregation of Chalmers' Presbyterian Church, Coburg Road, protesting against the construction of a concrete sidewalk in front of the Church property.

The sidewalk is ordered to be constructed on the south side of Coburg Road, from Edward Street to LeMarchant Street, with curb and gutter. The church property has a frontage of 111 ft. It is an objectionable precedent to establish, to allow an owner of one property to prevent the construction of a local improvement. However, that is a matter for the Council, not for the Engineer. Further, this property is at the extreme end of the proposed sidewalk. It would, I think, be dangerous to terminate the curb at the east side of this property and there would probably be accidents to wheeled traffic.

In any case, I would recommend that the curb be laid in front of the property, and continued around the corner of LeMarchant Street. If the Council considers it advisable not to lay the concrete sidewalk in front of the property this year, I think it would only be necessary to postpone the construction of this portion instead of rescinding the former order.
