The next step in the expropriation proceedings, is the approval of the plan and description. In accordance with Section 623 of the City Charter I have prepared a plan and description of the land required for a site for the High Service Reservoir. The land shown on the plan and included in the description, is required by the City for the purpose of constructing a reservoir for the high service water supply system. It will be necessary to expropriate the land required from each property. I therefore beg to submit for the approval of the Council, the plan and description of the land which it is now proposed shall be expropriated.

Beginning at a point on the west line of Robie Street, distant one hundred and fifteen feet (115') northerly from the prolongation westwardly of the south line of Cabot Street; thence westerly by a line at right angles to the said west line of Robie Street for a distance of two hundred and fifty-two feet (252') thence northerly by a line parallel to the said west line of Robie Street for a distance of four hundred and seventy-one feet more or less; thence easterly for a distance of two hundred and fifty-two feet (252') or until it comes to the west line of Robie Street at the south-east corner of property said to belong to David Nicholson; thence southerly by the said west line of Robie Street for a distance of four hundred and seventy-two feet more or less to the place of beginning;

The above described property being shown on a plan entitled "Plan Showing Land Required for High Service Reservoir," dated November 1st, 1912 and filed in the City Engineer's Office as Plan No. 2241.

As to the matter of failure of citizens to remove snow and ice from the sidewalks, His Worship had conferred with the Chief of Police and the City Engineer, and also the City Solicitor.

In answer to Alderman Hawkins' request that watchmen be placed at the level crossings of the Intercolonial Railway at Lady Hammond Road and Hanover Street, His Worship submitted a letter from Hon. Frank Cochrane, Minister of Railways, promising to take the matter up at once.

LEVEL RAILWAY CROSSINGS.

Mayor F. P. Bligh, Halifax, N. S.

Dear Mr. Bligh:—I beg to acknowledge receipt of yours of January 10th, in reference to the crossing at the foot of Hanover Street, about which you wrote me in June. I find that when the report was received regarding this request in July that I was in the west and the matter was not further dealt with.

The railway management claim that this crossing is not generally used by the public but merely by pedestrians going to the Lorne Yacht Club on the water front. In view, however, of your statement that there have been two or three people killed at that point and that you are looking for a repetition of the disas'er, I am asking for a further report and will also get some information re the Lady Hammond Road crossing where you wish gates installed and a watchman placed.

In answer to Alderman Martin's request at meeting December 19th that the Committee on Works confer with the Tram Company re a better service on the Gottingen Street spur, His Worship stated that Mr. Freeman, of the Tramway Company, had informed him that for the present winter the Company could only use one car on this extension, but after June 1st next, would be able to give a fifteen-minute service.

His Worship the Mayor reads and submits a letter from the City Clerk relating to the condition of the vaults in the City Hall, used in his department.

CITY CLERK'S VAULTS.

Office of the City Clerk, Jan. 23rd, 1913.

His Worship the Mayor:

Sir:—From time to time I have had occasion to call attention to the condition of the vault in the basement of the City Hall used by the City Clerk and others for storing City records.

Upon several occasions it has become flooded with water and is now again in that condition. I am not enabled to use the lower part of it for that reason and the crowded state of the upper part does not permit of access to records when they are required—sometines in a hurry.

The dampness is ruining the papers and is a cause of great anxiety to me.

On account of this vault and my fear of the strength of the vault in my office, I have for years deemed it my duty to be telephoned for by the Police to attend every fire in the neighborhood of the City Hall.

I have spoken to the City Engineer on these matters and at his suggestion I am asking Your Worship to request Mr. Doane to make a report to the Committee on Works.

At the same time I would like Mr. Doane to report on the necessity of fitting both vaults with steel instead of wooden shelving, and as to whether the strong room in the basement is suitably located and of sufficient size for the storing of my records.

For Your Worship's information I enclose copies of letters written to Mayor Chisholm.

Sir:—I beg to report that I discovered this morning a quantity of water on the floor of the vault in the basement of the City Hall where I have the City Charters and other documents stored. Considerable damage has been done to these books and I reported the matter to the City Engineer who will take immediate steps to remedy the trouble and save the books.

Since writing the above I have found the trouble to be worse than a casual observation led me to anticipate and that the loss is greater than I thought. If this vault is to be continued in use all possibility of dampness will have to be guarded against.

His Worship the Mayor, Chairman Committee on Works:

Sir:—A couple of years ago the strong room, or vault, in the basement at the north-west corner of the City Hall, used by the City Clerk and others, became flooded with water, which destroyed a lot of property there.

Mr. Morrison, the Superintendent of Water Department, informs me that the cause was a leak in a water pipe near George Street on Argyle, which pipe has since been repaired.

If the vault is not water-tight, a fire in the neighborhood would be likely to cause another flood. For this reason I am cautious as to using the lower part of the vault for storage purposes, and it is still empty.

In consequence, the upper deck of the vault is so encumbered that the things stored there are practically inaccessible.

I have great fear also that the vault in my own office is not constructed according to modern ideas, and that it would not, in event of a serious fire in the City Hall, preserve the valuable records filed there. Even if the walls are considered sound it should be fitted with steel shelving instead of wood as it is now.

It would relieve me of great anxiety if these matters were set at rest by an expert report.

CROSS PROPERTY FOR EXHIBITION PURPOSES.

Committee Room, City Hall, Jan 16th, 1913.

To His Worship the Mayor and City Council:

Gentlemen:—Your Committee on Finance beg to report that at a meeting held this day, there being present Aldermen Hoben, Acting-Chairman, R. V. Harris and J. C. Harris;

1 The Committee had under consideration the resolution submitted to the City Council on the 9th inst. by Alderman Martin in reference to the purchase of the Cross property, on the north-east corner of Almon and Windsor Streets, jointly by the City and Province for Exhibition purposes.

Messrs. W. J. Clayton and McF. Ha!l, of the Exhibition Commission waited upon the Committee and urged the necessity of purchasing this property at the present time, also submitted and read the following resolution, which was passed at a meeting of the Exhibition Commission on the 17th of December, 1912.

Moved by His Worship the Mayor, seconded by Commissioner Griffin and passed unanimously that it was desirable to purchase the property at the price of \$9,000, and that a Committee consisting of the President, Commissioners Clayton, Gough and the Secretary be empowered to make arrangements for the purchase of the same.

Your Committee recommend that the City Council agree to cooperate with the Local Government to purchase the Cross property on the north-east corner of Almon and W ndsor Streets, for Exhibition purposes, for the sum of \$9,000.00, and to borrow \$4,500.00, being its proportion of the purchase price.

Your Committee further recommend that the funds required for the City's portion of the purchase price be borrowed on a debenture for a term not exceeding five years, the amount to be refunded to the City by the Exhibition Commission.

Your Committee further recommend that the City Solicitor be instructed to prepare the necessary legislation to carry this recommendation into effect.

REPORT LAWS AND PRIVILEGES COMMITTEE.

Committee Room, City Hall, Jan. 22nd, 1913.

To His Worship the Mayor and City Council:

Gentlemen:—Your Committee on Laws and Privileges beg to report that at a meeting held this day, there being present Aldermen Whitman, Chairman, R. V. Harris, Hoben and Hawkins, the Committee had under consideration the correspondence between the Local Council of Women and His Worship the Mayor relating to the occupancy of the residence of the late George Wright, Young Avenue.

Mrs. William Dennis, President of the Local Council of Women, His Worship the Mayor and Messrs. Walter Black and T. W. Murphy were present and addressed the Committee on the subject.

Owing to a division of opinion as to whether the uses to which the Halifax Local Council of Women propose to put the George Wright residence are within the terms of the City Charter (section 763), the Committee feel that any decision arrived at by the City Council cannot effect the issue between the Halifax Local Council of Women and those who objected to such uses, and would recommend that no objection be made by the City to such occupation and uses.

The Chairman submitted the attached draft act for legislation for various civic services as prepared by the City Solicitor.

It is recommended that the same be adopted and forwarded to the Legislature for enactment.

Moved by Alderman Whitman, seconded by Alderman Hoben that the report of the Committee be adopted. Motion passed.

The draft Acts submitted with the report of the Committee are now considered clause by clause, and the several clauses thereof adopted.

AN ACT TO AMEND THE LAW RELATING TO THE CITY OF HALIFAX.

Be it Enacted by the Governor, Council and Assembly as follows:-

In this Act the expression "City" means the City of Halifax; the expression "Council" means the City Council of that City, and any committee or official herein mentioned by name means the committee of that name of the said council or city; the expression "The City Charter" means the Halifax City Charter, brought into force on the first day of March, 1907, by proclamation of the Governor-in-Council, dated the 20th day of February, 1907, and any sections herein referred to by number without other reference are the sections of the said City Charter so numbered, and this Act shall relate exclusively to the City of Halifax and the said Charter thereof.

- (1) The salary of the Chief of Police shall for the year beginning on the first day of May 1913 and for each succeeding year be the sum of fifteen hundred (\$1500.00) dollars;
- (2) The sum of one hundred dollars (\$100.00) required in addition to the amount provided in the estimates for the payment of such salary for the year 1913-1914 may be borrowed by the City from any bank or other fund available and together with the interest thereon shall be included in the estimates for 1914-1915 and rated and collected along therewith.
- (1) The salary of the Deputy Chief of Police shall for the year beginning on the first day of May 1913 and for each succeeding year be the sum of one thousand (\$1000.00) dollars;
- (2) The City shall also pay to the said Deputy Chief of Police the additional sum of fifty (\$50.00) dollars, the same having been voted to him by the City Council in addition to his salary for the year 1912-1913 but which was not paid to him for want of legislative authority in that behalf;
- (3) The sum of one hundred (\$100.00) dollars required in addition to the amount provided in the estimates for the payment of the salary of the Deputy Chief of Police for the year 1913-1914 together with the said sum of fifty (\$50.00) dollars may be borrowed from any bank or other fund available and together with the interest thereon shall be included in the estimates for 1914-1915 and rated and collected along therewith.
- (1) The salary of the Detective shall for the year beginning on the first day of May 1913 and for each succeeding year be the sum of nine hundred and fifty (\$950.00) dollars.

- (2) The City shall also pay to the Detective the additional sum of fifty (\$50.00) dollars, the same having been voted to him by the City Council as an addition to his salary for the year 1912-1913 but which was not paid to him for want of legislative authority in that behalf.
- (3) The sum of one hundred (\$100.00) dollars required in addition to the amount-provided in the estimates for the payment of the salary of the Detective for the year 1913-1914 together with the said sum of fifty (\$50.00) dollars may be borrowed from any bank or other fund available and together with the interest thereon shall be included in the estimates for 1914-1915 and rated and collected along therewith.
- (1) The salary of the Assistant Detective shall for the year beginning on the first day of May 1913 and for each succeeding year be the sum of eight hundred and fifty (\$850.00) dollars.
- (2) The City shall also pay to the Assistant Detective the additional sum of fifty (\$50.00) dollars, the same having been voted to him by the City Council as an addition to his salary for the year 1912-1913 but which was not paid to him for want of legislative authority in that behalf.
- (3) The sum of one hundred dollars required in addition to the amount provided in the estimates for the payment of the salary of the Assistant Detective for the year 1913-1914 together with the said sum of fifty (\$50.00) dollars may be borrowed from any bank or other fund available and together with the interest thereon shall be included in the estimates for 1914-1915 and rated and collected along therewith.
- (1) The salary of the City Marshal shall for the year beginning on the first day of May 1913 and for each succeeding year be the sum of eight hundred and fifty (\$850.00 dollars.
- (2) The sum of fifty (\$50.00) dollars required in addition to the amount provided in the estimates for the payment of the salary of the City Mārshal for the year 1913-1914 may be borrowed from any bank or other fund available and together with the interest thereon shall be included in the estimates for 1914-1915 and rated and collected along therewith.
- (3) Upon the resignation, superannuation, dismissal or death of the present holder of the office of City Marshal the office shall be abolished and the duties thereof performed by the ordinary members of the police force under the direction of the Chief of Police.
- (1) For the year commencing on the first day of May 1913 and for each succeeding year the remuneration of the Police Force shall be as follows:—
- (a) Privates, five hundred and thirty-five (\$535.00) dollars for the first year; six hundred and thirty-five (\$635.00) dollars for the second year; and six hundred and eighty-five dollars (\$685.00) dollars for the third and subsequent years;
 - (b) Sergeants, seven hundred and eighty-five (\$785.00) dollars per year.
- (2) The amount of thirty-five (\$35.00) dollars each required in addition to the amount provided in the estimates to pay the remuneration of the police officers and sergeants at the rates provided by this section may be borrowed from any bank or other fund available and together with the interest thereon shall be included in the estimates for 1914-1915 and rated and collected along therewith.
- (1) The salaries of the four sub-collectors in the office of the City Collector shall for the year beginning on the first day of May 1913 and for each succeeding year be the sum of seven hundred (\$700.00) dollars each;

- (2) The sum of two hundred (\$200.00) dollars required in addition to the amount provided in the estimates for the payment of the salary of the sub-collectors for the year 1913-1914 may be borrowed from any bank or other fund available and together with the interest the eon shall be included in the estimates for 1914-1915 and rated and collected along therewith.
- 501. (1) Every person, firm or company not a resident in the Province of Nova Scotia, who enters into any contract for the construction or alteration of any building in the City shall, before beginning any work under such contract pay to the City a license fee equal in amount to one-half of one-per cent. of the total sum payable under such contract, provided however, that the provisions of this section shall not apply to any such person, firm or company which at the time of entering into any such contract is assessed for purposes of taxation by the City in the sum of Five Thousand Dollars or upwards.
- (2) Every person, firm or company who contravenes or fails to comply with the provisions of this section, and the agent, foreman or other person in charge of the work on any such contract in behalf of any such person, firm or company, shall be liable to a penalty not exceeding double the amount of said license fee so payable, and in default of payment, to imprisonment for a period not exceeding thirty days, and in addition thereto, the amount of such license fee may be recovered by action in the name of the City and in any such action against any person, firm or company out of the Province sevice of the writ of summons or other process upon any such agent or foreman shall be good and sufficient.

The City may borrow the sum of four thousand five hundred dollars and apply the same in paying one half the cost of property purchased from Ma y E. Cross and others for the Provincial Exhibition Commission, and may secure the same by the issue of its bond or debenture for that amount under the hands of its Mayor and Treasurer and the seal of the City, such bond or debenture to bear interest at a rate not exceeding six per cent. per annum and to be repayable on the 1st day of January 1916.

The City may acquire from John A Meagher and William Branch the land requisite for a right of way from Yale Street to Yukon Street, and may maintain the said right of way, when so acquired out of the appropriation for Streets.

Subsections (1) and (2) of Section 712 and the sub-section substituted for subsection (1) thereof by Chapter 82 of the Acts of 1912 is hereby repealed, and the following substituted therefor:—

712 (1) Except as is otherwise provided no building not of the first or second class shall be erected within the following limits, in the statement of which the expression "east side line of Water Street" shall mean the east side line of Water Street as shown on the official plan of the City and not the line of the existing Street.

Beginning at a point on a line drawn in prolongation of the south side line of Fawson Street, distant eighty feet eastwardly from the east side line of Water Street; thence running westwardly by the said line drawn in prolongation of the south side line of Fawson Street and the south side line of Fawson Street to a point in line with the center line of Water Street; thence northerly by the center line of Water Street to Morris Street; thence westwardly by the center line of Morris Street to South Park Street in thence by Sackville Street; thence by Sackville Street to Brunswick Street; thence by Brunswick Street to Cogswell Street; thence by Cogswell Street to a line distant one hund ed and twenty-five feet westerly from the west side line of Gottingen Street; thence by said line nor therly to Gerrish Street; thence eastwardly by a line drawn in continuation of the center line of Gerrish Street to a point distant eighty feet eastwardly from the eas side line of Water Street; and including also the distance of eighty feet on both side

of each of the said streets or parts of streets forming the boundary line and eighty feet eastwardly from the east side line of Water Street from Fawson Street to Gerrish Street.

(2) East of eighty feet east of the east line of Water Street as shown by the official City plan between Fawson Street and Gerrish Street, no structure shall be permitted of wood, unless the same is entirely covered externally with metal or other uninflammable material, wit flat roofs of uninflammable material, and all openings properly protected, and in no case shall any such structure exceed three stories in height.

The Committee on Works may on the recommendation of the City Engineer grant a permit to any person for the placing on any street of a suitable post or other fixture for the purpose of ornamental lighting. Any such permit may be upon such terms and conditions, including payment of a rental, as the Committee on Works deem fit and may be revoked at any time without notice.

The City may borrow from any bank or other fund available the sums mentioned in the schedule hereto and apply the same to the purposes mentioned in respect to each and no other and the sums so borrowed together with interest shall be included in the estimates for 1914-1915 and rated and collected along therewith.

ORNAMENTAL LIGHTS.

Sir:—Attached hereto is a report from the City Engineer in re ornamental lights. The Committee on Works beg to forward said report to the Council for its information.

City Engineer's Office, Jan. 21st, 1913.

His Worship the Mayor:

Sir:—I beg to report on the accompanying report from the City Electrician respecting the proposal to instal so-called crnamental street lighting in certain business streets in the City.

Mr. Colpitt's report gives about all the information that I have. He states that the cost exceeds a great deal, that of ordinary street lighting, being in one City from which he received information, three times greater.

While Mr. Colpitt's report deals with the matter fully, he suggests that if the scheme meets with the approval of the Council it will be necessary, in addition to other requirements to obtain more definite data respecting installation costs. We should also have to obtain maintenence charges which cannot be given until some definite scheme is decided upon. In my opinion, it would be a big mistake to enter upon any such installation unless the wires are to be placed underground. To instal ornamental lighting with the number of poles suggested, bringing the wires down to the poles from overhead, would make an unsightly network of wires, which, instead of improving the appearance of the streets, would be a step backwards.

I would strongly urge the necessity for placing the wires of the Halifax Electric Tramway Company and any other company selling current over high potential wires, underground. If the proposal to acquire the Halifax Electric Tramway Company property and franchise is not approved by the Legislature, I would recommend that the Company be requested to use their surplus profits in putting their wires underground in the business district, and if they do not comply with the request, that the Public Utilities Commission be asked to make an order compelling them to do so as the amount of their surplus profits over their present dividend will permit.

I feel it is my duty not to ignore the present financial condition of the City in reporting on a matter of this kind, and the appropriation will be exhausted by the lights ordered; under the circumstances I do not feel justified in recommending that the Council incur any additional expense. If, however, some provision were made for putting wires underground and at the same time the City agreed with the Company for the use of any extra duct or ducts for its own wires, it may be possible that when we find out what surplus power we shall have at the incinerator, we shall be in a position to instal the lighting proposed with our own power, without additional expense. It is quite possible that such a scheme could be carried out. In the meantime, I am not in a position to recommend anything definite which would be favourable to the early installation of the ornamental lighting proposed, unless the property owners interested, volunteer to meet the expense.

City Electrician's Office, Nov. 16th, 1912.

To His Worship the Mayor and Members of the City Council:

Sirs:—In compliance with your request, I beg to submit the following report concerning ornamental street lighting. I have written upwards of forty Cities in the United States and Canada now having in operation some form of decorative street lighting for the purpose of getting information regarding costs and other data. Twelve of these have replied in a more or less satisfactory manner, and from which I have selected a number of those giving the most complete information, and averaged them, giving the following figures:—Average population of Cities taken 75,000; average spacing of standards on street 90 feet; average cost for installing \$90; average cost for maintenance \$42 per standard respectively.

Taking the streets suggested in the report of the Civic Improvement Committee and applying the above figures would give an average of ten standards to the block, counting both sides of the street, or a total of 152 standards for the streets named. The cost for installation depends largely on local conditions, and particularly so if underground wiring is employed. The cost for Halifax would probably be greater than the average quoted. The cost for maintenance varied so much in the data gathered as to be of little value for purposes of comparison, the error being in my opinion on the cheap side. In the majority of cases it is admitted that the cost greatly exceeds that of ordinary street lighting (in one case the rate is given as 1 to 3). At the same time it is claimed that the improved appearance and lighting results on the streets so treated amply justifies the extra expenditure. In every case reported, the property owners on the streets lighted participate in the expense, varying in amount from cost of installation to 75 per cent. of the total cost, including maintenance. In most cases the amounts are assessed at so much per foot frontage and collected in the same way as ordinary taxes, under the provisions of a special general improvement act.

As a general rule this type of street decoration is employed in business sections only, and in some cases is supplemental to the ordinary street lighting.

The tungsten incandescent lamp has until recently had a monopoly in this field, but at the present time the luminous arc lamp, because of its relative brilliancy and economy in power, is making a strong bid for the service, the relative cost in power consumed as compared with tungsten lamps being as from 2 to 3 to 1, in favor of the arc, while the color of the light is also superior for street lighting purposes.

The greatest hindrance to this scheme of lighting for Halifax is the existing pole lines on the streets. One of the chief attractions in White Way lighting is the unobstructed view of a long line of lights placed on oranmental standards, and if this view is obstructed by intervening posts of various sizes and shapes, the effect is practically spoiled.

In the Cities heard from, only two, Ottawa and Portland, Me., have overhead construction, and they are now arranging to have all wires in the business districts placed underground. Underground construction, while expensive, is not impracticable for Halifax, if confined within reasonable limits and the cost spread over a term of years. The street railway poles could be replaced by ornamental iron poles to correspond with the lighting standards, and could, where they serve, be used for both purposes. There are good reasons why this underground work should be undertaken, some of which indicate that the present time is most opportune. Large additions are about to be made to the capacity of the Tram Company's plant, and doubtless this will involve considerable alterations in the distributing system, which, if planned for with a view to underground construction in the near future, would save considerable expense. Overhead construction is dangerous because of the liability of wires falling during storm and the almost certainty of this in the case of sleet storms. It interferes with the work of the Firemen, and is a real source of danger to them. I would therefore strongly recommend the removal of the existing poles and overhead construction as a first step toward an improved lighting system of the down town district.

In event of this improvement scheme meeting with your approval, I presume that at least three preliminary steps would be necessary, viz:—(1) Early arrangements for underground construction on the streets named by your Committee; (2) An Act providing for assessment for some ratio of cost as in other Cities; (3) The obtaining of more definite data regarding installation, costs.

Gentlemen:—Your Special Committee have held several meetings in conference with Members of the Council of the Halifax County Anti-Tuberculosis League and have visited the Rockhead City property.

After very considerable discussion your Committee recommend that permissive legislation be secured enabling the City to convey to trustees for the League or to the League itself when incorporated, or to set apart and hold for the purposes of the League a plot of five acres in the north-east corner of the Rockhead farm; the property to be used exclusively for the purposes of a tuberculosis hospital and to revert to the City if not used for that purpose. The site is well located having regard to sewer and water connection and accessibility.

Also that the City secure permissive legislation enabling it to contribute \$1,000 towards the cost of erecting a sanitorium or hospital for the treatment of tuberculosis. The League has about \$5,000.00 in its treasury and proposes raising another \$4,000.00 by asking the Province for \$2,000.00, the County \$500.00, and the public for \$1,500.00.

The Committee also recommend that the City secure permissive legislation enabling it to make a grant of \$500.00 a year towards the maintenance of such institution, the balance of the cost being provided by the Province, County and League.

REALTY VALUATION FOR ASSESSMENT PURPOSES.

Manufacturers' Appraisal Company, Philadelphia, December 2nd, 1912.

Hon. C. R. Hoben, Chairman Finance Committee, Board of Aldermen, Halifax, Nova Scotia, Canada:

Dear Sir:—At the suggestion of Mr. E. W. Doty, Manager of the tax valuation department of this Company, and in conference with him to-day, I am pleased

to submit the following information concerning the probable cost of the installation of the Somers Unit System of Realty Valuation for the assessment of the land and buildings of your City. I understand that there will be a meeting of your Board of Aldermen on December 5th, and I hope this letter will reach you in time for consideration on that date. The estimate of cost is as follows:—

First.-We shall be pleased to furnish the services of two experts to assist your Assessors. One of these men will be a building expert who will direct the measurement and description of all buildings in your City, such measurements and descriptions to be entered upon cards so as to form a permanent record. The actual work of measurement and description will be performed by employees of your assessors. We believe that to do this work properly, and to compute the values of buildings will require the work of ten men for from forty to fifty days, or a total of between four hundred and five hundred days' work for one man, and that this work will cost you an average of \$3.00 per day. During the work of your employees and after the work has been completed our expert will personally visit all structures and will determine the factors of valuation and depreciation to be placed upon each building by a personal inspection. We shall also furnish a Somers System accountant, who will assist the Board of Directors by showing them how to obtain the judgment of the community as to valuation for land, and who shall direct the work of from five to ten clerks in the computation of the relative values of lots, based upon the values of units determined by the Board of Assessors. This expert shall also himself work on computations. We estimate that it will require approximately four hundred days' time on lot computations, and that these clerks can be secured for an average of \$3.00 per day. For the services of the two experts we shall charge a fee of \$750.00 per month each, such fees to be paid preferably twice a month, but if more convenient to be paid not less often than once a month. All building measurers and clerk hire shall be paid by the City.

To recapitulate, we will say that we believe that our services will on the basis stated cost in the neighborhood of \$3,500.00, and that the additional clerk hire and building measurers will cost in the neighborhood of \$2,500.00. In addition, the cost of printing of maps, circulars and other matters necessary to the installation of the Somers System will not exceed \$500.00. I believe that the outside total cost of the installation of the Somers System will not exceed from \$6,000.00 to \$6,500.00.

Second.—In order to facilitate the work of the installation of the Somers System it is highly important that before this work shall be started your City should make complete surveys showing on a reasonably large scale the dimensions and ownersships of all lots, with the widths of all alleys. The best way to do this is to make each block upon a separate sheet, and the scale preferred, although not absolutely necessary, is that of forty feet to one inch. The cost of making these maps is not included in the estimate for the installation of the Somers System and it is highly desirable in order to minimize the time of the assessors and experts in installing the Somers System, that the maps shall be completed before our experts reach Halifax. A good way to do this is to have the maps made upon tracing paper, and have the actual computations made from blueprints made therefrom. Then the changes in lot boundaries can be kept up to date each year by additions to the tracings or redrawing of block maps where the changes of boundaries have been so numerous as to make redrawing necessary.

Third.—We do not require the making of a written contract, but suggest that your Board of Aldermen if you decide to employ our services should pass an appropriate resolution covering the conditions herein outlined for the employment of our services. We are entirely willing to have the resolution contain the provision that our services can be discontinued upon ten days' notice if they prove unsatisfactory, and that we have the right to discontinue our services if payment of our fees shall not be made promptly.

We shall be glad to hear from you at any time that you may wish further information in regard to the services to be performed, and we suggest that any communication should be addressed to our Cleveland Office.

His Worship the Mayor:

Sir:—I beg to report on the accompanying letter from Wm. McFatridge, asking for a reduction in the amount charged him for water for the period ending Sept. 1912.

Mr. McFatridge's house is some distance from the road and a meter is placed on the pipe about fifty yards from the house. There was a break in the service pipe between the meter and the house, which did not show on the surface at first. Mr. McFatridge states that he had the plumbing overhauled as soon as he found that the reading was large, and finding nothing wrong, called upon Mr. Morrison, Foreman of the Water Department, who discovered the break in the pipe. Mr. McFatridge had it repaired and the consumption has been reduced to much lower figures.

As the Act was intended to cover cases like this, and in my opinion Mr. Mc-Fatridge has used proper care and precaution, I beg to recommend that his bill for the period ending September 1912 be made up on the basis of the average consumption for the three months ending November 1912, namely 4100 gallons per month.

LIONS FOR MEMORIAL TOWER.

Ottawa, January 27th, 1913.

To His Worship the Mayor:

Sir:—I have the honor to submit for the information of the City Council the following reference to the Memorial Tower erected on the North West Arm and dedicated by His Royal Highness the Duke of Connaught on August 14th last year.

It is now some five years since it was first proposed to erect a suitable Tower to commemorate the first meeting of an elective Assembly in Nova Scotia in 1758. That event is regarded of much historical interest as it has proved to be the planting of the germs of parliamentary rule in Canada and in all the overseas Dominions of the Empire.

In the presence of His Royal Highness last August I had genuine satisfaction in transferring to the City of Halifax the title deeds of the land on which the Tower is built, together with a hundred acres of land as a Park for the use of the people of Halifax forever.

The Canadian Club of Halifax at considerable cost and with much public spirit erected the Memorial Tower on its ideal site in the most beautiful portion of the suburbs of the City, where it will attract attention in all future years.

It is due to the fine spirit and personal energy of the President of the Canadian Club of Halifax and those associated with him, that the funds required to erect the Tower were raised. It is equally due to them that the erection of the Tower is enriched by valuable contributions from distant portions of the overseas Empire and from the several provinces of Canada; with these enrichments, this Memorial Tower stands unique among National Monuments and situated as it is in one of the most beautiful suburbs of Halifax it will continue to command admiration in future years.

At the time of dedication by His Royal Highness last August, the Royal Colonial Institute of London, was well represented. The gentlemen present have not forgotten the occasion and as a result we have the prospect of having presented a group of bronze lions as figurative guardians of the Tower. By recent letters it

is learned that Mr. Bruce-Joy, one of the leading Sculptors in England of the present day, is now engaged on these lions, and that we are justified in looking for real, works of art on the completion of the group. It will probably be July before the lions arrive on this side.

Moved by Alderman Hoben, seconded by Alderman Whitman that these several matters be referred to the Committee on Laws and Privileges for report. Motion passed.

Moved by Alderman R. V. Harris, seconded by Alderman Hoben that the matter of subpoenaing witnesses and the taking of evidence under oath before Committees of the Council and also the matter of the remuneration of Presiding Officers and Poll Clerks at Civic elections and plebiscites be also referred to the Committee on Laws and Privileges for report. Motion passed.

CONSIDERATION OF PAPERS SUBMITTED.

Read report Chief License Inspector covering applications for Liquor Licenses for the license year 1913-14.

Moved by Alderman Martin, seconded by Alderman J. C. Harris that the applications for licenses to sell intoxicating liquors in the City of Halifax for the ensuing civic year, which are set out in the report of the Inspector of Licenses for the City of Halifax, with all reports to the Council with respect to such applications, and all objections thereto, and all other papers deposited or filed with the Council or the said Inspector, in reference thereto, be, and the same are hereby referred to the Board of License Commissioners for the City of Halifax, to be dealt with under the provisions of the Nova Scotia Temperance Act, 1910. Motion passed.

Read draft Act to enable the City of Halifax to acquire the property and franchises of the Halifax Electric Tramway Company, Limited.

Preliminary Draft Act.

An Act to enable The City of Halifax to acquire the property and franchises of the Halifax Electric Tramway Company Limited.

Be it enacted by the Governor, Council and Assembly as follows:-

1. This Act may be cited as the Halifax Tramway Act.

2. In this Act, unless the context otherwise requires the expression "City" means The City of Halifax; the expression "Company" means The Halifax Electric Tramway Company, Limited.

PART I.

A poll of the Electors of the City of Halifax shall be taken in manner as hereinafter provided to ascertain whether they are in favor of the City acquiring the property and franchises of the Company in the manner and upon the terms set forth in this Act and operating the same by means of a Commission.

The voting on such question shall be by ballot at an election to be held at a date to be determined by the City Council, not later than the last Wednesday in April 1913.

- (1) At least thirty days' notice of such voting shall be given in the same manner as is required by the provisions of the City Charter relative to the holding of elections for Mayor and Aldermen, and all persons entitled to vote at such an election shall be entitled to vote on such question.
- (2) The City of Hali ax shall provide a suitable place in each ward in which the vote on such question shall be taken, and appoint necessary officials to conduct the voting, and any official so appointed shall be entitled to the same remuneration as that paid to a similar official in case of an election for Mayor or Alderman, and shall have like powers and privileges.

No person shall vote more than once on the said question.

The ballot paper for the voting upon such question shall be in the form "A" in the Schedule to this Act, and shall be furnished by the City of Halifax to the Presiding Officer appointed for the said election or under this Act.

If the voting on such question is held at any election for a Mayor or Alderman, it shall be the duty of every Presiding Officer to ask every Elector voting at his polling station, if he wishes to vote upon such question, and to tender him a ballot paper for that purpose.

Every polling station at such election shall be provided with a place screened from observation in which the voter may mark his ballot paper, and with pencils for that purpose.

The Presiding Officer shall, upon the request of any voter, explain to such voter the mode of marking his ballot paper.

Any voter who is unable through blindness or illiteracy or other cause, may, upon making oath to such inability, which oath may be in the form "B" in the schedule, have his ballot paper marked for him by the Presiding Officer.

If any voter places on the ballot paper more than one mark, or any mark by which he may be identified, his ballot paper shall be void and shall not be counted.

The City of Halifax shall furnish each Presiding Officer with a separate ballot box in which the ballots cast upon the question hereby submitted to a voter shall be deposited.

At the close of the Poll the Presiding Officer shall count the ballots cast, and the number marked in the affirmative, and the number marked in the negative of such question, and the ballots when counted shall be placed in the ballot box and returned to the City Clerk of the City of Halifax.

Immediately upon such vote having been taken, the City Clerk shall make a return to the Provincial Secretary showing—

(a) The total number of ballots cast;

(b) The number who have voted in the affirmative;

(c) The number who have voted in the negative.

If it appears from such return that a majority of the voters who have voted have answered the question in the affirmative, the Provincial Secretary shall forthwith make and publish in the Royal Gazette a proclamation declaring the second and third parts of this Act to be in force.

TO VIENDE PART II. The All to exceed the sail made while

Upon the coming into force of this part of this Act as provided in the first part hereof the City may proceed to acquire the property and franchises of the Company in the manner and upon the terms hereinafter set forth.

The City may offer the Company for its property and franchises the sum of two million nine hundred and eighty thousand dollars, the same being the amount of its bonded indebtedness (\$600,000) and the value of its capital stock (\$1,400,000 par value) at the price of \$170 per share.

Upon such offer being made the directors of the Company shall at once call a meeting of the shareholders at which the offer of the City shall be submitted for consideration.
