# GARBAGE INCINERATOR.

Gentlemen:—The Board of Control beg to report that in consequence of complaints made and petitions presented they found it necessary to make an inspection of the Garbage Incinerator Plant and surroundings. Delegations waited upon the Board at various meetings held in connection with the matter.

The Board wish to report for the information of the Council that so far as the Contractors are concerned they have complied with all the conditions of the specification. — There is no doubt that the citizens complaining had good grounds for so doing, but the trouble lay with the staff operating the plant and not with the destructor itself.

At a special meeting held to-day arrangements were made for the employment of more efficient help and your Board believes that this will remedy the existing conditions.

# C. R. Hoben, Esq., City Controller:

Dear Sir:—At your request we have carefully investigated matters at the Incinerator Plant and have found that the Plant has not been operated in accordance with the instructions given by the Superintendent of the plant, while he was in charge there.

The conbustion chamber is constructed to burn night soil and will hold from 25 to 30 barrels at one charge. Before the night soil is put into the chamber, the chamber should be hot, having a temperature of about 1000 degrees before the soil is admitted.

Last week was very wet and the garbage that was hauled to burn was of an inferior quality, being deficient in heat units and burned so that a high temperature could not be obtained at all times. Thursday night three night soil teams were hauling and overloaded the chamber by dumping in about 100 barrels of night soil, each barrel containing an average of 175 pounds or a total weight of about  $8\frac{3}{4}$  tons. Mr. Taylor who was on night duty at the plant, ordered the man who was hauling the soil not to load the chamber too full but he paid no attention to him and over loaded the chamber with the result that it had to be removed, causing trouble and a most unpleasant and unnecessary state of affairs.

If the plant is operated as directed and the temperature is there, there will be no such trouble as this.

It is intended and particularly specified that during the spring months, when night soil is to be disposed of in large quantities, that the fires shall be kept on during the twenty-four hours and the heat maintained in the combustion chamber. This is imperative.

We visited the plant last evening and found the premises perfectly clean with the plant running at full capacity, there being present a number of north end residents who could find no fault whatever with the plant itself.

# COPY OF LETTER AND TENDER SUBMITTED WITH SPECIFICATION FOR GARBAG DESTRUCTOR, APRIL 10th, 1912.

Dear Sirs:—In accordance with your call for tenders for garbage plant, dated February 28th, 1912, we submit herewith the standard specifications for the Sterling Refuse Destructor, with buildings and equipment, as prepared by the Griscom-Spencer Company Engineer, New York, as representatives of Messrs. Hughes & Sterling London, constructors of the Sterling System of Refuse Disposal. These specifications, and three blue prints accompanying, numbers 50-16, 50-17 and 53-4, together with all detail drawings and specifications which may be required or furnished later if the contract is awarded to us, will have the approval of the said Griscom Spencer Company, and Hughes & Sterling, and rights to the use of all patented devices embodied in the plans are included in the price named in our tender.

Certain special guarantees are called for in your specification of February 28th, These we cover by the following supplemental to the standard guarantees of the proposal.

A, b, c, d and e,—When properly operating, the plant will furnish these five requirements (referring to your section 11) and each of these is fully covered by the standard guarantee of the Sterling specifications.

F.—The weight of refuse incinerated per square foot of grate area is determined by the guarantee of a capacity of 50 tons per day destroyed on the 75 square foot of grates furnished, that is, 55 pounds of average quality per square foot grate per hour.

G—No guarantee of evaporation rate can be made without a definite chemical analysis of the average mixture of garbage and ashes to be consumed. A rate of one pound of water evaporated per pound of garbage can be produced by a mixture of 70 per cent. ashes, 20 per cent garbage and 10 per cent dry refuse. The presence of any considerable quantity of night soil in the matter to be destroyed decreases the rate materially, while an increased proportion of ashes and cinders increases the rate. To the average mixture of garbage and ashes can be added 15 per cent. of night soil, and all can be destroyed without nuisance in the Special Destroyer offered, producing 60 to 100 horse power in addition to that required for blower and lights.

The cost per ton for incinerating the mixture above specified, based on the wages in the specifications of the City of Halifax will be as follows:—

When the plant is operated at full capacity for 50 tons per 24 hours which is expected to be the case during three spring months only, at which time the night soil is being delivered, the employees will keep the fires going 24 hours per day.

The net income per day will be .... \$17.60

We therefore propose to furnish the building, destructor, chimney and necessary machinery, as specified and shown by the accompanying drawings, to be located on the north side of Young Street, between Kempt Road and Robie Street, furnishing the specified equipment complete and ready for operation, equipment for removing clinker from the building to an adjacent point outside by overhead trolly rail and suspended bucket and hoist, regenerator and blower for providing hot forced draft with by pass arranged in destructor setting to regulate evaporation of boiler, in accordance with the amount of steam required, ventilating platform and from openings over the furnace fronts, the construction and operation for 30 days after first putting in service to be under the direction of a competent representative of the Griscom-Spencer Company Engineers, New York.

# EMPTYING SEWAGE INTO NAVIGABLE WATERS.

### City Hall, June 4th, 1913.

#### The City Council:

Gentlemen:—At a meeting of the Board of Control held on the 30th May last the City Engineer submitted a report stating that there was at the present time before the House of Commons at Ottawa a Bill to prohibit the discharge of sewage into the Harbor.

The Board instructed the Secretary to write a letter of protest against the passing of this measure which was calculated to seriously effect the City of Halifax to the Members of Parliament and Senators representing this constituency and to the Honorable Minister of Marine and Fisheries, and also to request the aid of the Union of Canadian Municipalities in the matter.

This was at once done with the result shown in the following letter from the Honorable J. D. Hazen, Minister of Marine:

Dear Sir -I am in receipt of yours of the 31st ultimo, with regard to a Bill that was introduced by Mr. Bradbury at this Session, respecting the pollution of navigable waters.

This Bill has been referred for consideration to a Special Committee of the House of Commons and no legislation will be passed with regard to the subject at this Session.

When the Bill was before the House I pointed out that it was entirely too drastic in its terms and that there was no need of preventing the deposit of raw sewage in salt water in most cases as such water was not used for domestic purposes and with the rise and fall of the tide on the Atlantic Coast no damage could result.

I think you may rest assured that the interests of those communities which are discharging their sewage into the ocean will be safeguarded if in the future a Bill is passed by Parliament dealing with the matter.

### His Worship the Mayor:

Sir:--I beg to submit herewith a copy of a Bill introduced in the House of Commons at Ottawa, which will prohibit the discharge of sewage into the Harbor.

The Bill was sent to me by Mr. A. D. Gunn, Mayor of Sydney, who stated that he was calling his Council together to protest against the Bill. If it passes, it will be a very serious matter for Halifax and in fact for every city and town in Nova Scotia. It would cost the City of Halifax probably one million dollars to provide an efficient means of sewage disposal which would remove all the objectionable matter from the sewage. In my opinion it is entirely unnecessary and would be a great injustice to the City.

I would recommend that an immediate protest be made and that the attention of our representatives in Ottawa be called to the matter. I have already written to the Secretary of the Union of Nova Scotia Municipalities asking him to make a strong protest against it.

# THE HOUSE OF COMMONS OF CANADA.

# BILL 2

# AN ACT RESPECTING THE POLLUTION OF NAVIGABLE WATERS.

His Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:

1. No person shall put or deposit, or cause or permit to be put or deposited, or to flow or be carried, any sewage, offal or refuse, or any matter that is poisonous, noxious, decomposing, refuse or waste, into any navigable water, unless such matter is disposed of in accordance with regulations made under the authority of this Act.

- Every municipal corporation convicted of an offence against this section shall upon summary conviction be liable to a fine of not less than five hundred dollars and an additional sum of fifty dollars for each day during which the offence continues.

Every corporation, other than a municipal corporation, convicted of an offence against this section shall upon summary conviction, be liable to a fine of not less than two hundred dollars and an additional sum of twenty dollars for each day during which the offence continues.

Every person, other than a corporation, who is convicted of an offence against this section shall upon summary conviction be liable to a fine of not less than fifty dollars and an additional sum of ten dollars for each day during which the offence continues, or to imprisonment not exceeding two months, or to both fine and imprisoement.

2. The Governor in Council may make such regulations as are necessary to carry out the purposes of this Act, and such regulations shall be carried out and enforced by the Director General of Public Health and shall have force and effect as and from the date of their publication in the *Canada Gazette*.

3. Where at the date of the passing of this Act, any sewage or matter referred to in subsection 1 of section 1 of this Act flows into any navigable water, or into any other water which flows into any navigable water, this Act shall in the case of municipal corporations, come into force twoy ears after it is assented to by the Governor General, and in the case of other corporations and of persons shall come into force six months after such assent.

# Office Board of Control, May 31st, 1913.

Sir:—The City of Halifax has learned with very great concern of a Bill introduced into the House of Commons, Canada, entitled "An Act respecting the pollution of navigable waters." In the City of Halifax there is absolutely no need for such a measure, and if it became operative an immense useless expense would be entailed. I am directed by the Board of Control to bring this matter to your attention with the request that you will strongly protest against the passage of the Bill and use all your influence to that end.

# TRAMWAY STRIKE.

City Hall, May 27th, 1913.

#### To the City Council:

Gentlemen:-For the information of the City Council the Board of Control beg to report as follows:--

The Board of Control was organized on Wednesday, 7th inst. The new system had scarcely come into effective operation when on Friday morning, the 16th inst., the motormen and conductors of the Halifax Electric Tramway Company, Limited, went out on strike. At a meeting of the Board on that morning W. H. Covert, Solicitor for the Tram Company, called the attention of the Board to the fact that there was a strike, and asked that about ten special constables be sworn in to guard the property of the Company. A Committee from the Tramway employees appeared before the Board asking that the matter be submitted to arbitration and complaining of the dangerous manner in which the cars of the Company had been operating through the Streets in the forenoon. The Chief of Police stated that he needed no additional men at the present time to maintain order in Halifax.

At five o'clock in the afternoon of the same day an emergency meeting of the Board was held in consequence of gatherings of large crowds of people on the streets, and while that meeting was in session a number of arrests of new employees of the Company for carrying fire arms were made and a number of citizens also placed in the lock-up for assaulting some of the said new employees. The Chief of Police informed the Board that so far as he could foresee he could, with his present force, preserve the peace.

A number of meetings were subsequently held from time to time each day during the existence of the strike in an endeavor to effect an amicable arrangement between the Company and the employees. The Company strongly insisted in a demand for protection to their property; the employees urged that the matter be arbitrated, and very influential delegations of merchants and other citizens addressed the Board advocating that the laws be enforced and order maintained in the City.

It seemed to the Board that the wisest, surest and quickest way of meeting the situation was the securing of an immediate adjustment of the pending difficulty between the Company and its employees. Accordingly negotiations between the Company and the men, with the Borad of Control as mediators, continued until Tuesday, the 20th inst., when finally at a meeting at 4.30 o'clock on that day the men, through their representative, Sidney Mosher, stated that in the interests of peace and harmony the men had decided to accept a-new rate of pay based on the present Montreal schedule, viz., 22c., 23c. and 25c. per hour according to length of service, upon the signing of an agreement by both parties that all the men were to be reinstated in their former positions and not to be discriminated against in consequence of the strike.

The Board of Control is convinced that through their efforts the peace of the City was maintained and a satisfactory compromise effected. The Board was subjected to some criticism because it had not adopted drastic measures. A great deal of this criticism proceeded from lack of familiarity with the existing conditions. Upon the Board was the responsibility and it decided according to its best judgment. The strike was expeditiously brought to an end; a situation dangerous to life and property was avoided; the expense of military assistance was saved, and there was far less of violence, disorder and property loss, the Board believes, than had occurred in any strike under similar conditions in any other City. The Board for its justification relies uppon the results it achieved.

Gentlemen:—At a meeting of the Board of Control held to-day, the Board was addressed by a number of citizens, by O. E. Smith, representing the Tramway Company and by Sidney Mosher representing employees of the Tramway Company now not on duty.

Mr. Mosher supported by a committee of the men, stated that the unamious decision of the employees was to authorize him in their behalf to say that within fifteen minutes of the acceptance of the terms he was about to suggest every employee of the company would be at the doors of the Company's premises ready to go to work, if the Company will sign an agreement to submit the matters at variance between the Company and the men to a board of arbitration to be selected one by the Tramway Company, one by the said men and the third by the two so shosen. Such agreement to stipulate that all men now out are to be reinstated in their several former positions and that the company will not discriminate in the future against any of the said men. The agreement to be signed on behalf of the men by Mr. Mosher and a committee selected by the men.

I was thereupon directed by the Board of Control to notify you accordingly and to ask that the Company will at the earliest possible moment advise me as to whether it will accept the proposition made by the men.

The Board of Control will meet again at 4 o'clock this afternoon.

These cars are being driven by inexperienced and incompetent persons and in a reckless and dangerous way. This Company therefore desires to know as quickly as the authorities of this City can make up their minds whether or not the Company will be fully protected if it goes on with its legitimate business.

The Company, of course, holds the City responsible for the destruction of its property.

Gentlemen:—At a meeting of the Board of Control held this day Geo. W. C. Hensley and E. A. Saunders, Secretary of the Board of Trade, appeared before the meeting and submitted a resolution relating to a floating dock for the port of Halifax passed by the Board of Trade as follows:—

Whereas, the number of ships using the Port of Halifax and requiring drydocking facilities have demonstrated the necessity of two dry docks being provided; and,

Whereas, the Dominion Government has established a policy making it possible to provide the principal ports of Canada with first-class docks, and whereas such docks are to be built by the Government; and

Whereas, the port of Halifax being Canada'a principal Atlantic seaport and naval base and situated closely to the track of all north Atlantic shipping (consequently, a most important port for disabled and damaged shipping); and,

Whereas, the steamers "Alsatian" and "Calgarian" now nearing completion for the Allan Line mail service between Canada and the United Kingdom are, and steamers proposed to be built by other companies for the Canadian trade will be too large to be accommodated by the present dry dock;

Therefore Resolved, that the Halifax Board of Trade respectfully urge the Government to take immediate steps towards providing the Port of Halifax with a firstclass dock—floating or dry dock—either by extending to the Halifax Graving Dock Company such liberal terms as may enable them to acquire or build such a dock, or build such a dock and operate it under its direction. The resolution received the unanimous endorsation of the Board of Control.

At the request of the delegation the Board instructed the City Clerk to forward copies of the resolution to the Honorable Premier of Canada, R. L. Borden; The Honorable Minister of Public Works; A. K. MacLean, M. P., and Honorable Senators Roche, Power, MacKeen and Dennis.

The street is not in good condition and it is desirable that some improvement should be made. I cannot recommend the granting of their request to lay a curb only, because it would have to be paid for from the Street appropriation and the practice cannot be followed in every case as the street appropriation is not large enough to stand the drain. While exceptions have been made, it is not desirable, in my opinion, to do it in this case.

I have expressed a similar opinion to representatives of the petitioners and have been informed that the petition was circulated with the intention that if they could not get a curb they should ask for a sidewalk and curb. The petition is signed by all the property owners. The estimated cost of constructing a concrete sidewalk curb and gutter is \$535. This sidewalk would connect with a concrete sidewalk already laid. I would recommend that the sidewalks on both sides of South Street from Tower Road to LeMarchant Street be placed in the Sidewalk Schedule and that a concrete sidewalk curb and gutter be constructed on the south side of South Street between Robie and Davis Streets; also that a crossing be laid on the west side of Robie Street across South Street.

Sir:—I beg to report on the accompanying letter from J. D. Spencer in which he asks for a rebate on the bill charged for water rates at 75-77 Brunswick Street and 71 George Street.

I have had considerable correspondence in connection with these properties, and over a year ago I notified Mr. E. D. King of King & Barss that there had been considerable waste and that at one time the pipe was broken and the water wasting so badly that the tenants upstairs could not get any. Mr. King refused to accept any responsibility, and I communicated with Mr. Spencer who at that time was living in Louisburg. The only authority for reduction in water rates by meter is contained in section 6 of Chapter 84 of the Acts of 1909, and no reduction is permitted under that Act except under the conditions named, one of which is that the water charged for is in excess of that fairly required by the owner or occupant, the other that such excess has passed through the meter by reason of unavoidable accident or otherwise, without the negligence, default or failure to use proper care and precaution on the part of the owner or occupant of such premises.

As the taps and closets have been wasting from time to time as reported by the Meter Inspector, and the pipe burst, I am not justified in reporting that the owner or occupants have used proper care and precaution, as if they had watched the plumbing no such waste as that charged for could have occurred.

I have no desire to impose a heavy bill on any water taker but the responsibility placed upon me by the Act referred to makes it necessary for me to report the facts.

Sir:-In compliance with the request of your Board, I beg to report on the condition of Bell Street, formerly Bell's Lane.

There is very little traffic on this street between Barrington Street and Argyle Street, but between Barrington and Water Streets the traffic is very heavy. The street is not paved with permanent material and it is very difficult to keep it in good order, especially immediately adjoining the bitulithic pavement on Barrington Street and the stone block pavement on Water Street. The block should be paved more permanently so that it can be kept in good condition all the time.

The estimated cost of paving this block with stone setts with wide joints, as reported in 1910, was \$1903. I think we have sufficient setts on hand to pave this block, and as one-half of the estimated cost which would have to be borne by the City is \$952 and the value of the paving blocks on hand which would be used to pave it, is \$864, only \$88 would have to be provided in addition to the amount to be paid by the property owners.

When it was recommended before, some objection was made by one of the Aldermen in the Council on the ground that it would be objectionable for team traffic. The grade is not heavy and with wide joints between the blocks any team which can haul a load up from Bell street to the bitulithic on Barrington Street can haul more readily on the stone blocks. The bitulithic pavement is smooth and gives no foothold, while the joints in the blocks do. And further, there would be no rut to pull over at the edge of the pavement, as there is most of the time at present.

I would therefore recommend that this block be paved this season with stone blocks with wide joints.

# SUPERVISION OF WORK.

City Engineer's Office, May 21st, 1913.

His Worship the Mayor.

Sir:-In reporting last year on my office staff, I called attention to the necessity for some additional or swifter means of conveyance during the working season.

Four members of my staff, including myself, are from time to time called to different parts of the City in connection with the work of the office, the location of the work being scattered all over the City from Point Pleasant to Rockhead and from the Harbour to the Arm. We have been endeavouring to overtake this work with one horse, but of course that means that while the horse is out with one member of the staff, the other three cannot use it. This year, with the reservoir under construction at Shaffroth's Hill and possibly a sewer under construction along the Arm, it will be more difficult than ever to attend to the work as we should.

In comparison with a motor car, a horse is a slow mode of conveyance, as it is not nearly so rapid on level streets and very much slower indeed on the hills; also in comparison, considerable time is lost with a horse, waiting for feeding in the middle of the day and at places like the Incinerator, the vicinity of the railway and where the roller or concrete mixer is working on the streets. To go to work at either of the Lakes means the loss of half a day. To visit all the work in hand in the City in the busiest part of the working season takes at least half a day and during that time the horse can only be used by one of the staff. Either I or one of my staff should see the work at least once a day otherwise mistakes are made.

In consequence of these conditions, I have been unable to give the work the supervision which it requires and which I am anxious that it should receive. I am obliged to leave such work as the sewer work almost entirely to others, with at times most unsatisfactory results. The work costs more, not only in consequence of the delay in answering calls, but through neglect in not giving it proper supervision, and at times the unnecessarily large number of men employed. It is but natural that both foremen and men when left to themselves, should take advantage of the laxness.

Under the circumstances, I think the City would save money in the more economical construction of the work and enable the City Engineer's staff to accomplish more work in shorter time, if a car were provided instead of a horse. It is probable that a run-about would be sufficient for the work of the office, but if your Board contemplate the purchase of a car, they might consider it desirable to purchase a five passenger car, so that your Board could use it when they desired to do so; especially as the difference in cost for a Ford car is only \$75.00, the cost of the former being \$675 and the latter \$750. This mode of conveyance is being provided by many cities in recent years for the reasons that I have stated.

If your Board should decide to purchase a car, I think the horse should be retained for this working season at least, and whenever it is not required by the City Engineer's staff, the Plumbing Inspector should have the use of it to reach remote properties in which he has to make inspections. Mr. Morriscey is a good official, but his capacity is at times taxed to the limit in his efforts to keep up with his work.

The cost of the car could be charged to the different appropriations which the City Engineer's staff is spending.

### His Worship the Mayor.

Sir:-I beg to report on the enquiry from Carrick Limited respecting the City's intentions in reference to the extension of Connaught Avenue.

Connaught Avenue has been laid down on the City Plan from Quinpool Road to South Street. When the Avenue was laid out first by the Rosebank people, it was made one and hundred and twenty feet wide and was located as a part of a proposed boulevard to extend from the Park northwardly.

The accompanying plan shows in black the part laid down on the Official Plan. The red lines show the proposed extension southwardly to the Park to connect with Francklyn Street at the junction of Bower Road and Robie Street.

Carrick Limited represent the owners of property north of Chebucto Road and they propose, if the City intends to carry out the scheme eventually, to open the boulevard through their property as shown on the plan submitted. There is a missing link between Quinpool Road and Chebucto Road which should be connected if the scheme is to be carried through. Pine Street could be utilized for the greater part of this connection, but it would involve the taking of considerable private property. The original design was intended to go north to Quinpool Road only.

I have no doubt a City planner considering this proposed boulevard would lay it down approximately as shown on the plan, expecially as Carrick Limited and the other property owners north are desirous of carrying out the scheme. The only way in which the link between Chebucto Road and Quinpool Road could be insured would be to lay down the proposed lines on the Official City Plan, and if your Board decide that it is advisable to complete the scheme, immediate steps should be taken to locate the lines definitely.

I understand that Carrick Limited propose to make their street sixty feet wide only unless the missing link is established, but they are prepared to make it one hundred and twenty feet wide if it is connected with Connaught Avenue at Quinpool Road.

#### His Worship the Mayor.

Sir:—The concrete sidewalk work is not making as rapid progress as I should like to see. The prime cause is the rate at which we can lay the concrete. We can prepare the sidewalk for the concrete much more rapidly than we can lay it. Our mixer, purchased about seven or eight years ago, does good service, but occasionally, through wear and tear, something goes wrong and puts it out of commission.

We have sufficient work in sight to justify the purchase of an additional mixer so that we should always have at least one ready for work. For a time during the present season, I think it would be well to operate two and I would recommend that a mixer be purchased of the same manufacture as the one now in use and of such capacity and such price as may be considered desirable on investigation. The mixer we are using, cost about \$650 and has been a good investment for the City as well as the individual property owner.

Resolved, by citizens present in the Council Chamber June 13th, 1913, that the City Council be requested to extend the proposed North West Arm sewer to Point Pleasant.

Having subsequently given very full consideration to all phases of the problem your Board has unanimously decided to recommend that the said sewer be constructed to empty at a point in Point Pleasant Park near the summer house at the mouth of the Arm, that the City Engineer be authorized to take all the necessary preliminary steps to acquire the right of way for the sewer from Chebucto Road south, that the excavation for the sewer be done by contract, and that \$127,500.00 be borrowed, which sum the Board considers sufficient for the first year's operations. The Board's proposals eliminate the necessity of providing sedimentation tanks.

# COMMUTATION OF COMMON LOTS.

2. For any lot or portion of a lot fronting on Carelton Street the price shall be a sum equal to twenty-two years' of such original rental.

3. For any lot or portion of a lot fronting on College Street the price shall be a sum equal to twenty years of such original rental.

4. Upon any commutation the amount of rent in arrear due to the City shall be added to the price.

5. If commutation is desired for a portion of a lot only the price to be paid, including any amount for arrears of rent, shall be determined by the proportion borne by the area of such portion to the area of the lot of which it forms part.
