Ordinance No. 4 relating to "Streets" is hereby amended by adding thereto the following sections:—

- 56A. The Driver of every vehicle, including a motor vehicle, coming up with or overtaking any tramcar and intending to pass on the left side thereof shall if the tramcar is at a standstill or about to come to a standstill or stop, bring his vehicle to a standstill in the rear of said tramcar until after the tramcar is again in motion.
- 56B. For the purpose of warning or otherwise, no owner or driver of any motor vehicle shall make use of any siren, or other similar contrivance or device emitting or producing any sound resembling or likely to be confused with the siren, or other contrivance or device used for such purpose on apparatus or vehicles used by the Fire Department.
- 56C. On any alarm of fire the driver of every vehicle on the street traversed or to be traversed by any fire engine or other fire apparatus shall immediately draw or turn to the nearest side or curb so as to leave a clear path for the passage of said apparatus through the street.
- 56D. Every driver of any vehicle shall, on seeing any danger of collision with any vehicle, animal or person, or on receiving any warning, signal, or command from any person, or the driver of any vehicle requiring him to stop on account of any danger to any person or vehicle, stop immediately, and not proceed again until all danger has passed, and in every instance the driver of any vehicle shall immediately stop when required by any police officer, and place his vehicle in such position as he directs.

 - (a) Solicit any order by advertisement or otherwise, or
 - (b) Make any examination, take any measurement, or
- (c) Make any sale, or enter into any agreement, for the selling, furnishing or supplying of eyeglasses, spectacles or other optical applicances; and no agent of any such person, firm or corporation, shall in the City of Halifax solicit any order, make any examination, take any measurement, or sell, or enter into any agreement for the selling, furnishing or supplying of eyeglasses, spectacles, or other optical appliances.
 - (2), (3), (4), (5), as in Section 498 of the City Ordinances.

Any violation or non-observance of the Ordinance shall be punishable by imposition of a penalty of not more than fifty dollars or in default of payment not more than three months imprisonment.

It is a grave mistake to use the same name for more than one street. It is very confusing to Post Office employees and to merchants delivering goods ordered.

The petitioners have selected the name of June Street which is not duplicated in the City or anywhere else that I know of, and if your Board approve of it, I know of no objection.

Due notice of the intention of the Board having been duly given in the City newspapers a public meeting was held in the City Council Chamber to-day for the purpose of hearing the views of property owners and other citizens interested. Nearly all the property owners were represented at this meeting and several of them addressed the Board. Very little objection was taken to the laying down of the proposed boulevard the only contention of the land owners being that the property should not be locked up indefinitely without compensation, but rather that on the other hand the property should be taken over and the work proceeded with as soon as the lines are laid down on the Official Plan. At the request of the owners each of them will be furnished by the City Engineer with a blue-print of the proposed plan.

The following resolution was adopted by the Board of Control and is recommended for the approval and concurrence of the City Council:—

Resolved, that the Board of Control recommend the adoption of the location of the boulevard south of South Street as laid down on the Plan No. 2250, subject to the straightening if possible of the boulevard at the junction of Bower Road, Robie and Francklyn Streets, and that the City Engineer be authorized and instructe to lay it down on the Official Plan.

REMOVAL OF GARDEN REFUSE.

Gentlemen:-At a meeting of the Board of Control held to-day the two reports from the City Engineer attached hereto re removal of garden and other refuse were ordered to be forwarded to the City Council for its information.

His Worship the Mayor.

Sir:-I have been requested by your Board to report on the matter of the removal of refuse put out in quantities by citizens, from their gardens, back yards, etc.

It is the custom of a great many property owners, to allow refuse to accumulate during the winter even where garbage is removed regularly. At such properties, there is a general clean-up about the first of May, and people who have gardens, rake up the old vines, leaves and rubbish and place them on the street for removal with the other garbage. In doing so, many people are in the habit of raking over the soil of the garden and removing the stones on or near the surface. These stones are also placed in the receptacles for removal with the other garbage.

While the City undertakes the removal of garbage, I think they should be prepared to strengthen the service at the time when the demand is heaviest to meet the extra requirement. This would mean that at the Incinerator, burning must go on night and day for a time and in the removal, one or more extra teams would be necessary. We have been in the habit of meeting this extra demand as a matter of course. We are obliged, however, to decline to take stones from the gardens, plaster and other incombustible material from building work, not only because we cannot burn them in the Incinerator, but because they interfere with the rapid combustion of the other garbage.

The origin of municipal scavenging dates from the realization of the danger to health in the accumulation of garbage. In nearly all municipalities, the object is to remove that portion of the refuse which may create nuisance or by decomposing. may menace the health of individuals or the community. It has never to my knowledge been the intention to assist builders or manufacturers by the removal of the refuse of their work from which they are making their living. For a similar reason it does not seem to me that the municipality should be called upon to remove stones from gardens.

If, however, the Board does not take the same view, it is a question of cost only. We should be obliged to hire special teams for this work to remove such material to a dump, an expense which in my opinion should not be chargeable to the general taxpayer but to the individual who requires it solely in his own interest.

Sir:—I beg to submit a supplementary report on the removal of garden refuse, with especial reference to the letter of John C. Dingle attached.

Mr. Dingle complains that the City will not remove a barrel of refuse which he has put out. We have been removing all refuse that will burn, provided it is not mixed with ashes, but in order to insure the separation of the ashes our regulations require the refusal of barrels containing anything mixed with the ashes.

We do work which runs into the thousands in value every year, with the ashes which we collect, and if one property owner is permitted to mix ashes and other refuse together, others must be allowed the same privilege. If we do not adhere to this regulation strictly, we cannot enforce it at all.

To His Worship the Mayor and Board of Control.

Gentlemen:—I have, upon several occasions, called the attention of the City Engineer to the dangerous condition of Campbell Road, especially that portion of it between the Round House crossing and the crossing of the main tracks of the I. C. R. and I now lay the matter before your board, with the hope that it will receive immediate attention. This piece of roadway is very narrow, with two very dangerous level crossings, at short distances apart and with main tracks of railway on each side in almost continuous use by trains and engines. A constant menace exists here to persons who have to use the roadway for driving purposes, and as I have recently had a driving accident myself, at this place, I wish to emphasize the urgency of definite action being taken, either to have this roadway widened or abandoned and another road opened for public traffic.

I understand that Campbell Road is supposed to be and was originally a street sixty (60) feet wide, but the railways have been permitted to narrow it at different times and now portions of the roadway are only eighteen (18) feet wide.

I have reason to believe that the City is responsible for damages for accidents on this section of Campbell Road. I do not intend to make a claim, but I trust that this matter will be attended to and proper facilities provided for persons who have business along the water front, between Richmond and Fairview.

I am unable at this date to state whether prompt action was taken to stop the waste or not, and I would suggest that it is a matter for the discretion of the Board of Control. If I may venture to make a suggestion, however, I think such questions should not be allowed to stand until the City officials have forgotten the facts.

Ordinance re Horses Damaging Sidewalks.

An Ordinance to amend Ordinance No. 4 of the City of Halifax "Of Streets."

Be it ordained by the Mayor, Controllers and Aldermen of the City of Halifax in Council assembled as follows:

Ordinance No. 4 of the City of Halifax "Of Streets" as amended respectively by Ordinances Nos. 35 and 36 is hereby further amended by inserting after section 29 (B) the following section:—

29 (C) No owner or driver of a horse shall allow such horse to step or stray upon any sidewalk or sodded portion of any street or sidewalk. Both the owner and driver of any horse which shall (whether by reason of negligent act or omission or otherwise, actually step or stray as aforesaid shall be deemed to have so allowed, and proceedings taken against either the owner or driver shall not constitute a bar to proceedings or recovery against the other.

Moved by Controller O'Connor, seconded by Controller Scanlan that the report be adopted and the Ordinance read a first time.

Moved by Alderman Murphy, seconded by Alderman Smith that the said report and draft Ordinance be referred back to the Board of Control with the recommendation that the following words be added immediately after the word "sidewalk" in the third line of the proposed Ordinance: "and to actually injure the same," and for further report. Amendment passed.

Read report Board of Control re scientific assessment, and recommending that legislation be sought to authorize the borrowing of \$15,000.00 for the installation of scuh a system.

SCIENTIFIC ASSESSMENT.

City Hall, July 25th, 1913.

The City Council.

Gentlemen:—The last meeting of the City Council under the system in vogue before the inauguration of the Board of Control referred to this Board the very important matter of civic assessment. The subject was placed before your Board as an item from the Order of the Day, being "report Finance Committee, clause 4, recommending the borrowing of \$8,000.00 for the installation of the so called Somers Unit System of Realty Valuation. February 6th, 1913, page 480." With an earnest desire to bring about a more satisfactory system of assessment for the City of Halifax the members of the Board have given very serious consideration to the various phases of this important and intricate problem, and have come to the conclusion that the time has arrived when more modern methods will have to be applied for assessment for civic purposes.

At a special meeting of the Board held last evening, present Deputy-Mayor Powell, Chairman, and Controllers O'Connor, Harris, Hoben and Scanlan, the Board unanimously decided to recommend to the City Council that legislation be sought whereby the City may be authorized to install a unit system of property valuation for assessment purposes, said legislation to provide for the borrowing of a sum not to exceed \$15,000.00 for the purpose.

Although the major portion of the amount suggested would not be required during the civic year 1914-15, the Board deems it expedient that authority to cover all estimated expenditure should be included at one time in the permissive legislation proposed. No shoeme for scientific assessment based on mathematical calculations can become effective with the data at present available to the Assessors and the first steps necessary to be taken require a very large amount of work in preparation and printing of plans showing each block of the City separately with the dimensions and outline plans of each structure plotted thereon. This preliminary work is very urgently needed at the present time whether it is finally decided to establish any new system of assessment valuations or not. It would probably take a large portion of one year to accomplish, so that the larger portion of the amounts proposed to be borrowed will not likely be required until at least the civic year 1915-16.

Sir:—I beg to report on the petition asking for a sewer on Ivanhoe Street. The petitioner is moving seven houses from Pleasant Street and Pleasant Avenue to vacant lots on the west side of Ivanhoe Street. At present there is only one house on this street. It is on the west side in about the middle of the block. It drains across the street to Young Avenue.

There is a petition, signed by the owners of all the property on the east side of the street and by Mrs. Macdonald and Henry Macdonald who owns the lot at the south-west corner of Inglis and Ivanhoe Street, against the construction of the sewer.

The estimated cost of a sewer is \$5760. The estimated assessment is \$1550, of which the petitioner's share would be \$560?

I am of the opinion that if the seven houses are erected on this street, a sewer will be necessary, and would recommend that the sewer be placed on the Order Book to be constructed in its turn, provided the seven houses are erected on the property.

Sir:—I beg to report on the petition from Melvis S. Clarke, for an extension of the water system along Ivanhoe Street from Inglis Street to Atlantic Street. The district is low service; diameter of pipe required, 6-inch; distance 742 feet.

I am recommending the construction of a sewer in this street under certain conditions, and if this is adopted, I would recommend that the pipe be laid in the sewer trench.

The estimated cost of the work, if the pipe is laid in this way, is \$1004.00, and I would recommend that the special rate be \$50.20. If the water pipe is laid and not the sewer, the estimated cost is \$2596.00, in which case I would recommend that the special rate be fixed at \$129.80.

Sir:—I beg to report on the accompanying bill rendered to Mrs. Jas. Westhaver for water supplied at her property 403 Agricola Street for the period from Nov. 1912 to March 1913.

The meter was put on Nov. 1, 1912. It was read on Nov. 22nd and on Dec. 29th, showing a consumption of 4300 and 5600 gallons respectively. The meter was not read in January or February, and the March reading showed a total consumption of 367,600 gallons for the five months. As the large consumption occurred during the time that the readings were not made, I would recommend that the five months' bill be made up at the rate of consumption shown in November and December and that Mrs. Westhaver be notified that the large consumption was due to waste in the cold weather and she will be obliged to pay for it if it occurs again.

Sir:—I beg to report on the bill for water as rendered to Mrs. M. Willis for the quantity supplied at her property No. 124 Grafton Street from Sept. 1912 to March 1913.

The records show a considerable variation in the readings, ranging from 11,500 gallons in one month to 35,000 gallons. There is no record of waste, so that I am unable to account for the variation except that the large consumption was during the months of December, January and March, which suggests waste. As the readings have fallen again, the meter seems to be registering correctly. Under the circumstances, the law does not permit me to recommend a reduction.

- · Gentlemen:—The Board of Control beg to report that Sydney P. Dumaresq, Architect of the Public Market Building, claims a fee of 2 1-2 per cent. on the total amount of the original tenders received for the construction of the Building, viz.,

Your Board do not consider Mr. Dumaresq entitled to fees on the total amount of the original tenders, but only to 5 per cent. on the cost of building actually to be constructed. The difference between the amount claimed by Mr. Dumaresq and that to which the Board of Control believe he is entitled to recover is \$348.05. The Board therefore recommends that the Architect's fees be fixed at \$5,986.60 instead of \$6,334.65, as claimed, and that he be paid at present \$3,000.00 on account, His Worship the Mayor dissenting.
