I find that the Canada Cement Co. have but one price on which to sell their goods, so that it makes no difference whether the City buys direct or through its agents.

Therefore the prices quoted and intended to be quoted would be the same by all tenderers so they state, but a misunderstanding seems to prevail as to the meaning of Sec. 6 of the specification, which reads "Tenders to state price per 100 lbs. of cement, net weight, etc.

Frank A. Gillis & Co, and Rhodes, Curry & Co. through an oversight figure the price as 55 5-7 and 57 1-7 plus the cost of the bags, 10c per 100 lbs. net. Jas. Simmonds, Ltd., merge the cost of the bags, 10c, into that of the cement, viz—55 5-7 and 57 1-7 cost per 100 lbs. net.

J. C. Calder do not quote the price per 100 lbs net but the price per barrel, etc, and that being the same as Jas. Simmonds', Ltd., I put that price down as theirs, which may be an error on my part.

Brookfield Bros. & Piercey Supply Co, quote 44 2-7 and 45 5-7 per 100 lbs. net weight plus the price of the bags, 10 cents, which is strictly in conformity with the specification.

Under the circumstances, I would suggest that it is a case for lenient treatment, and while I cannot recommend under the provisions of the Act, I would suggest that a fair charge would be \$4.00 for the year ending March 1914, about an average of the amount paid for the other two years.

### TUBERCULOSIS HOSPITAL.

Read report Board of Control re Tuberculosis Hospital covering documents referred to therein.

Gentlemen:—The Board of Control beg to recommend for approval the report dated April 16th, 1915 of the Board of Control of 1913-15 which is attached hereto.

The Board has had a conference with the Board of Managers of the Tuberculosis Hospital at which it was mutually agreed that the entire liability of the City in connection with the operations of the Hospital is limited to \$2500.00 and that the Hospital is to be conducted so that that sum shall not be exceeded in any year.

An opinion from the City Solicitor as to the financial liability in connection with the Hospital is submitted herewith.

Sir:—The Act authorizing the establishment by municipalities of sanitoriums for tubercular patients (Chapter 16, 1912) after authorizing the establishment, provided that the Governor-in-Council might grant in aid of the establishment one fifth of the cost, not exceeding in any case \$4,000.00 and payment towards its support a sum not exceeding \$1.00 a week for each patient, not to exceed in any case \$1,000.00 a year; and further authorized the municipality to assess for the cost of the maintenance.

This Act was amended by Chapter 63,1914, which authorized specifically the establishment of a sanitorium by the City of Halifax or by the City jointly with Dartmouth and the County and to vest the control of the sanitorium in a board of trustees, and further authorized the payment by the Province towards the support and maintenance of the sanitorium so established of the sum of \$2.00 a week for each patient.

Section 27 of Chapter 74 of the same year, being the City's General Act, authorized the City to take over the sanitorium already established by the Anti-Tuberculosis League and vest its management and control in a board of trustees composed of six members of the City Health Board and four persons to be annually appointed by the Council, and authorized the City to contribut to the cost of the maintenance a sum not exceeding \$5.00 a week for each patient admitted from the City and unable to defray the cost of their maintenance, not exceeding in the whole \$2,500.00 in any year, and authorized a sui not exceeding that amount to be placed in the yearly estimates.

The legal situation then is that the Government's contributions to i cost are limited to \$2.00 a week for each patient. The City cannot legally co tribute towards the cost of its maintenance more than \$2,500.00 a year, at the trustees in whom the institution is vested cannot compel the City to contribute more than that amount or make the City legally liable for a great sum.

Gentlemen:—It having been brought to the attention of the Board of Control that the Management of the Tuberculosis Hospital in the City of Halifax have been unable to secure payment from the Provincial Government of the statutory fees payable towards the maintenance of patients until the City by a formal resolution declared the said Hospital to be a Municipal Institution, the Board of Control at a meeting held this day adopted the following resolution, which is recommended to the City Council for approval:—

"Respecting the undertaking known as Hazelwood Sanitorium for tuberculosis patients, it is resolved that the City Clerk be instructed to write the Provincial Secretary that the City Council has acted on the legislation passed at the 1914 session of the Legislature (Chap. 74) appointed citizen trustees and contributed towards the cost of maintenance of such institution in accordance with the provisions of such legislation and the City has recognized the institution as a municipal undertaking as is evidenced by the resolutions hereto annexed.
