CITY AUDITOR'S REPORT TAX COLLECTIONS FOR OCTOBER 1926

and Members of City Council.

Dear Sirs:-

I attach hereto my usual monthly statement of Tax Collections during October and the outstandings as at 31st October last and have to report on same as follows:

The collections on account of back years taxes during October, including those in respect of the year ending 30th April last, amounted to \$39,946.32 as compared with \$35,392.12 for the previous month.

The following is a comparison of the collections on account of back years taxes this year with last year:

from which it will be seen that although there is a falling off of \$6,950.87 in the collection of back years taxes this October as compared with the same month last year, still the collections on account of these taxes for the six months to 31st October last are \$32,462.48 better than last year.

The receipts on account of the taxes of the Current Civic Year during October amounted to \$34,823.68. The Collections on account of Current Years Taxes compare with last year as follows:

so that although there is a falling off this October as compared with the same month last year of \$6,254.45 still there is an increase this year in the collection of current taxes for the six months ending 31st October of \$27,172.15.

It will therefore be seen that although the back and current years tax collections together are \$13,205.32 less this October than the same month last year still these collections for the six months to 31st October last are \$59,634.63 better this year than last.

The total arrears of back years taxes at 31st October last amounted to \$1,774,643.40, as compared with \$1,891,153.70 at the same period last year.

The special Tax Refunding Sinking Fund in respect of the arrears of Taxes for the years prior to 30th April 1925 now amounts to \$117.000.

I would again call your attention to the large sum of \$442,524.49 still outstanding for the year ending 30th April 1926, which arrears are not embraced in our Tax Refunding Scheme and which sum has been borrowed from the City's Bankers. You will note the collections on account of these taxes for the month of October only amounted to \$19,132.60.

I would also call your attention to the fact that at the close of the present Civic half year i.e., 31st October, there remained \$746,276.74, uncollected of the Current Years taxes and that the

collections for month of October only totalled \$34,823.68.

I would further call your attention to the fact that the consolidated records of back years taxes recently compiled by the Collectors! Special Staff are not being kept up to date.

I beg to report on a petition from property owners on Allen Street asking the City to grade and take over that part of the Street between Chebucto Lane and Harvard Street, not already accepted by the City, that the petition is signed by the owners of 85% of the frontage.

The street is closely built up with the exception of the property owned and occupied by the Monastery of the Good Shepherd.

The street is in a fair condition and the estimated cost of grading it to sub-grade is about \$400.00

Section 602 of the City Charter provides that when a petition signed by persons owning not less than two-thirds of the property fronting on the street, is presented, the Committee on Works shall direct the Engineer to report on the matter of such petition-

- (a) W hether in his opinion it is desirable that such street shall be accepted by the City and
 - (b) The cost of grading the same.
- (c) The Committee on consideration of such report shall decide whether or not to recommend to the Council the acceptance of the street or any part thereof, and the grading of the same at the cost of the owners of the properties fronting thereon.

I have already reported to the Committee that our street appropriation is insufficient to ke ep the streets already owned and accepted by the City in first-class condition and repair, and that for this reasonit is inadvisable at present to accept any more streets.

This street has already been accepted for about half its length and it is the first through street from Windsor Street to Harvard Street, north of Quinpool Road, and is in about the middle of the black from Chebucto Road to Quinpool Road, and if the Committee decide to accept any streets under existing conditions, I would recommend that the City Grade this street at the cost of the property owners and when graded that it be taken over and accepted by the City.

Dear Mr. Mayor:

The Salvation Army is desirous of making application to the various manicipalities throughout the Province, who benefit directly or indirectly from Grace Hospital, for municipal aid in the shape of grants.

The Local Hospitals Act, Revised Statutes 1923, Chapter 54, Section (1) authorizes municipalities to grant aid to any hospital in Nova Scotia, in such amounts as they may from time to time determine, and to vote and collect rates for same, provided such hospital is either-

- (1) A hospital established or maintained by a Municipal or Town Council, or
- (2) is a hospital established and maintained by private persons or benevolent organizations where-
- (a) Such hospital is declared by a Resolution of the Council of the Kunicipality under which it is situated to be a public hospital, and
- (b) Where such Council has granted to such Hospital not less than Five Hundred Dollars per annum towards its maintenance.
- (c) Where the Governing Board of such Hospital includes a representative appointed by such Council.

The City of Halifax already makes a grant of Four Hundred Dollars to this Institution, and the Mayor of the City is ex officio a member of the Advisory Board of the Hospital.

I am instructed by the Advisory Board to make an application to the City for the passing of the following resolution so as to put the hospital in the position of being able to apply to other municipalities, under the Local Hospitals! Act for such grants as they may feel themselves able to make.

"RESOLVED that the Grace Maternity Hospital, located in the City of Halifax, be recognized as a Public Hospital, under the provisions of the Local Hospitals" Act, Revised Statutes 1923, Chapter 54, and that the sum of Five Hundred Dollars be placed in the estimates for the ensuing year in lieu of the grant now made to such institution of Four Hundred Dollars.

I trust that this Resolution can be passed, as it will assist materially in financing the institution, which has, during the past few years, beenobliged to carry a very heavy deficit.

Inspector of Humane and Penal Institutions to investigate conditions at the Halifax City Home and Tuberculosis Hospital.

I am directed to inform you that under the provisions of Chapter 59 of the Revised Statutes, 1923, "of the Inspector of Humane and Penal Institutions" the Inspector has no statutory jurisdiction to inquire into the Tuberculosis Hospital which is not an Institution receiving aid from the Government of Nova Scotia. Further that Chapter 1 of the Acts of 1924 declares that Chapter 59 relating to local Hospitals shall not apply to any Hospital within the City of Halifax.

With respect to the Halifax City Home, the scope of the inquiry asked for is considered to exceed the regular inspectorial duties of the Inspector of Humane and Penal Institutions and is regarded as being more properly the subject of a Judicial inquiry.

The Government therefore deems it inexpedient that such an investigation should be conducted by the said Inspector.
