RESIGNATION OF EX-ALDERMAN McCARTHY FROM EXHIBITION COMMISSION

Read resignation of Ex-Alderman McCarthy from Exhibition Commission:

May 16th, 1929 Roy Building, Halifax, N.S., May 16-29 His Worship the Mayor, and Members of Halifax City Council. Gentlemen:-I believe there is some difference of opinion as to whether or not a member of the Halifax City Council who is also a member of the Exhibition Commission automatically ceases to be a member of the Commission when he ceases to be a member of the City Council. However, realizing the possibility of the City Council as a whole, feeling that city representatives on the Exhibition Commission should be members of the City Council and have a voice and vote in that Body, and with a desire to give the City Council complete freedom in this respect, I hereby respectfully tender my resignation as a city representative of the Exhibition Commission. Mours Truly, James W.McCarthy His Worship the Mayor submits and reads an opinion of the City Solicitor in reference to the tenure of office of Aldermen on the Exhibition Commission:-City Solicitor's Office Halifax, N.S. May 16th,/29 His Worship the Mayor, City. RE MEMBERS OF EXHIBITION COMMISSION Sir:-In reply to your request for my opinion as to the status of members of the Exhibition Commission appointed by the Council, I beg to say as follows: The Provincial Exhibition Act provides for the appointment of four members of the Commission by the City Council and " of the four persons appointed in 1898, the one first named shall retire on the first day of November 1899; the next one on the first day of November 1900, and so on, the members yearly retiring in rotation, but being eligible for reappointment. Their successors shall each hold office for four years" The first and most important question is whether this provision is affected by the provision contained in the City Charter, Section 112, that any Alderman appointed on any Committee or Board ceasing to be an Alderman shall cease to be a member of such Committee or Board and the Council shall appoint another to fill the vacancy. It appears clear to me that this provision relates only to the Committees and Board for which provision was made by the next preceding sections of the Charter and is not intended to apply to a Board constituted under another Act creating a corporation entirely distinct from the City **-7**-

Apart from this general principle the fact that the tenure of office of members of the Commission is for four years is entirely inconsistent with the motion of a commissioner ceasing to hold office when no longer a member of the Council, because unless re-elected he would automatically cease to be a member of the Commission at the expiry of his three year term.

I am, therefore, for these reasons, of opinion that the provision of the City Charter does not apply to the Exhibition Commission.

The remaining difficulty is caused by the fact that during the War and for several years after, no Exhibition was held and apparently the appointment of Commissioners either lapsed or was made in some irregular way. Since the revival of the Commission, appointments have been made and evidently, from the Minutes of Council, they had in view a re-establishment of the principle of rotation as laid down in the Exhibition Act.

On these facts, I am of opinion that any member of the Council appointed to the Commission who has since ceased to be a member of the Council does not on that account gease to be a member of the Commisson but will continue to be a Commissioner until the expiry of the period indicated by the Minutes of the Council at the time of his appointment.

TRAFFIC

Regarding Traffic and Parking of Cars, it might be that some of the new members of Council are not acquainted with what took place last year. For their information we undertook to control our traffic and the parking of cars, but owing to the Motor Vehicle Act and our own Ordinances not agreeing and technicalities entering into them this ultimately could not be carried out. Some authorities thought it could be, but the final authority thought it could not be, and those who violated the spirit of the law could not be molested.

The Government, after being waited upon a number of times by Mr. Bell, Oity Solicitor and myself and with the help of members of our Legislative Committee, we had the inconsistencies of our Ordinances and the Motor Vehicle Act ironed out, and now with Council ratifying the work of the Police Committee, under whose direction the traffic and parking regulations, comes, we will this year be able to conduct these matters in the interest of the great majority.

Although I agree with the Press in tts attitude of always suggesting things to be done as soon as possible when it is for the betterment of the community, I do think they should not insist upon saying or stating why things are not done when with a little thought they know it is not our fault and especially when we have tried to do what we think should have been done but could not owing to some legislative technicalities preventing us doing so.

RESOLVED that this Council do under the authority of an Act in amendment of the Motor Vehicle Act, passed at the last Session of the Provincial Legislature, being Chapter 61 of the Acts of the said Session hereby delegate to the Police Committee of this Council the power to designate the highways or sections of highways in the City on which no parking signs, or signs permitting parking for such limited periods of time only as the said Committee determines, shall be erected

TAX COLLECTIONS FOR APRIL

Read report of the City Auditor covering Tax Collections for the month of April 1929:

City Auditor's Office, May 16th, 1929

His Worship the Mayor, and Members of City Council.

Gentlemen:

Report on Tax Collections for the month of April 1929 is submitted. Collections from the various sources reported each month amount to \$94,484.80, against an amount of \$144,029.09 for the same month last year.

A large part of the decrease is accounted for in the falling off of collections of arrears of taxes. In April 1928 exceptionally large amounts were collected on account of the Civic Years prior to 1926-27, in connection with which the property liens were then expiring, and these collections of course do not show in April this year.

Comparing the amount of taxes collected on account of the Current Year with the amount collected last year on the Current Year I find that this year 77.885% of the taxes were collected and last year 78.609%; indicating adecline of less than one per cent.
