QUESTION - ALDERMAN WYMAN RE SNOW REMOVAL FROM SIDEWALK

Alderman Wyman wanted to know why the snow had not been removed from the sidewalk on the east side of Barrington Street from North Street to the Dockyard Gate.

The Commissioner of Works advised that the sidewalk abuts the property of the Canadian National Railways who are responsible for the snow clearance.

The Chief of Police stated that his Department had issued 183 tickets during February, one of which could have been issued for this violation.

His Worship the Mayor said that the matter of snow removal had been the subject of much comment and that while the time factors are difficult to deal with, he contended that if the City were going to demand of adjacent property owners, conformity with the law, the City staff should ensure that the City is not a violator before tickets are issued. He suggested the most simple way would be to treat the City as other violators and present the Summons to the City Manager.

QUESTION - ALDERMAN HEALY RE FIRE HAZARD - BUILDINGS ORDERED TO BE DEMOLISHED

Alderman Healy asked if any action had been taken with respect to the direction of the Committee on Works to the Fire Chief to make a rigid inspection of all buildings being considered for demolition to determine whether fire hazards exist in such buildings.

The City Manager replied that he had issued instructions the next morning to have the inspections carried out and that he would check further to ascertain whether or not his order had been carried out.

QUESTION - ALDERMAN TRAINOR RE HIGH SNOW BANKS AT CROSS-WALKS

Alderman Trainor referred to the fact that snow is piled high at many corners, making it difficult for older people to cross and creating a hazard to children who are liable to slide under the wheels of passing vehicles. He asked who is responsible for clearing the snow at these corners.

The Commissioner of Works replied that the City is responsible, but he propose to submit an amendment to Ordinance No. 3 whereby the abutting

property owners would be responsible for such snow clearance.

QUESTION - ALDERMAN O'BRIEN RE SIDEWALK SNOW REMOVAL

MOVED by Alderman O'Brien, seconded by Alderman Abbott, that Staff be requested to submit a report projecting the costs of sidewalk snow removal based on the experience of removing snow from City properties. Motion passed.

QUESTION - ALDERMAN LeBLANC RE APPROPRIATIONS FOR CAR ALLOWANCES AND TRANSIT PASSES

Alderman LeBlanc requested a report to be submitted at the first meeting of Council when the estimates are being considered showing the amount of money included in the 1962 Estimates for Car Allowances and Transit passes.

His Worship the Mayor directed the City Manager to prepare the necessary report.

QUESTION - ALDERMAN DeWOLF RE THROWING SNOW IN STREET

Alderman DeWolf asked if it is permissible to shovel snow onto the street after a driveway has been filled in by the snow plow to which the Commissioner of Works replied in the affirmative.

LEAVE OF ABSENCE - ALDERMAN BREEN

MOVED by Alderman Wyman, seconded by Alderman Lane, that Alderman Breen be granted leave of absence of three months effective as of January 1, 1962 due to illness. Motion passed.

ADJOURNMENT

A meeting of the City Council was held on the above date.

After the meeting was called to order the Members present, led by the City Clerk, joined in reciting the Lord's Prayer.

There were present His Worship the Mayor, Chairman; Aldermen Lane, Macdonald, Butler, Meagher, LeBlanc, Trainor, Healy, Connolly and O'Brien.

Also present were Messrs. P. F. C. Byars, R. H. Stoddard, W. J. Clancey, L. Mitchell, L. M. Romkey, G. F. West, J. F. Thomson, V. W. Mitchell, R. B. Grant and Dr. A. R. Morton of Staff and Mr. G. S. Cowan, Q. C.

The meeting was called specially to consider the draft of the proposed new City Charter.

MOVED by Alderman Trainor, seconded by Alderman Healy, that Council defer final consideration of the proposed City Charter at this time but that consideration of same be proceeded with over the ensuing year so that it can be presented to the Legislature during the 1963 session.

At 3:15 p. m. His Worship the Mayor left the Chair to address Council from the floor, and the Deputy Mayor assumed the Chair.

His Worship the Mayor requested that Council not defer this matter as deferment would delay legislative approval for one year and a new Charter is vitally necessary for the efficient operation of the City.

He stated that the City Manager, Deputy City Solicitor and himself had gone over the draft Charter thoroughly and proposed to make certain alterations which he asked the Members of Council to consider before deferring consideration of the document.

He pointed out that the draft gives the Council wide and general powers, none of which would become operative until after proclamation by the Governor-in-Council; and that none of the Sections would be proclaimed until

Council so requested. This would give Council a further opportunity to further debate the various Sections.

He referred to three main objections of Council, as follows:

1. The elimination of Section 909 of the present Charter, respecting powers of the Board of School Commissioners, in the draft Charter.

His Worship the Mayor advised that an identical Section has since been included in the draft as Section 367A.

2. The matter of appointment of permanent Members to the Point Pleasant Park Commission, and the administration of the Park.

His Worship the Mayor stated that Council has already indicated its policy with respect to Commissions and Boards.

3. The matter of Public Hearings.

His Worship the Mayor stated that the Act would not come into effect until after proclamation by the Governor-in-Council and that if Council approved of each Section of the new Charter separately, public hearings could be held on the individual Sections, if Council deemed it necessary, before each was proclaimed.

He explained that there is a general Section dealing with the date on which the new Charter would become operative.

3:30 p. m. His Worship the Mayor resumes the Chair.

Alderman Trainor, with the permission of his seconder, withdrew his motion to defer.

MOVED by Alderman Trainor, seconded by Alderman Healy, that Council adjourn and meet as a Committee of the Whole. Motion passed.

3:50 p. m. Council adjourned.
