MINUTES

Minutes of meetingsheld on December 6 and 12, 1962, were approved on motion of Alderman Connolly, seconded by Alderman Butler.

PUBLIC HEARING - CITY CHARTER, PARTS 7, 8, 9, 10 AND 11

MOVED by Alderman O'Brien, seconded by Alderman Abbott, that the public hearing scheduled at this time in connection with Parts 7, 8, 9, 10 and 11 of the revised City Charter, be deferred until the next regular meeting of Council. Motion passed.

RECOMMENDATIONS - FINANCE AND EXECUTIVE COMMITTEE

The following recommendations were submitted from the Finance and Executive Committee at meetings held on December 20 and 27, 1962: Leave of Absence - Commissioner of Health

A report was submitted from the City Manager advising that Dr. A. R. Morton, Commissioner of Health and Welfare, will assume his duties on a full time basis as of January 2, 1963.

MOVED by Alderman Connolly, seconded by Alderman Abbott, that in view of the changed circumstances regarding the state of health of the Commissioner of Health no action be taken on the matter of his early retirement. Motion passed.

Widow's Pension - Mrs. Amos Woodworth

That Mrs. Kathleen Woodworth, widow of the late Amos Woodworth, be paid a pension amounting to \$447.44 effective as of December 1, 1962 under the authority of Section 310 H, sub-section 3 of the City Charter.

MOVED by Alderman Healy, seconded by Alderman Connolly, that the recommendation be approved. Motion passed.

Children's Hospital

That approval be given to the following procedure to assist the Children's Hospital to proceed with its planning in accordance with the report entitled "Report of the Committee to Recommend Usage of Certain City Lands in the Hospital Area, Halifax, N. S.":

1. The City shall agree to transfer freehold title to Block K to The Children's Hospital immediately. The consideration for the transfer will be the market value of the land as determined by independent appraisal. The City is now arranging for the appraisal of the Anderson Square property and the square footage value placed on Anderson Square should be applicable to Block K.

> 2. The City shall agree to transfer freehold title to Block L to The Children's Hospital when the Mental Hospital facilities have been relocated. The financial consideration for the transfer shall be at the same square footage rate as is agreed for Block K.

3. In consideration of the land transfers outlined in 1 and 2 above, The Children's Hospital shall agree to convey the site of the present Children's Hospital to the City when the new Children's Hospital is available for use. Specifically, the lands to be transferred are Blocks H, P, and G as shown on Plan No. P554/6. The financial consideration for the land transfer shall be at the same square footage rate as is applicable to Blocks K and L.

4. That no value will be placed upon the present Children's Hospital facilities at this time. The possible future use of these buildings as a Chronic Diseases Hospital will be the subject of detailed studies by the Regional Authority or by the City, If these detailed studies indicate that all or part of the buildings have a useful life after they have been vacated by The Children's Hospital, a purchase price shall be determined by arbitration. The Arbitration Board shall consist of three qualified members of a recognized appraisal institute. One appraiser would be appointed by the City, one by The Children's Hosiptal and a third by the Province or by the first two appointed.
