#### QUESTIONS

## Question - Alderman Meagher Re: Fence Along Railway Cutting

Alderman Meagher referred to his question of several months ago when he asked that the Canadian National Railways be requested to erect a chain link fence along the railroad cutting west of the Quinpool Road bridge as a safety measure to reduce the hazard to children.

The Development Officer stated that the present situation is that nothing is being done pending determination on a site. The Court House Commission has indicated agreement in principle to the waterfront site, but City Council had expressed a desire to meet with the Court House Commissioners on the proposed site, and the scheduled meeting at the site had been postponed due to inclement weather.

Alderman Black asked that early action be taken to arrange another meeting with the members of the Court House Commission, on the site.

#### Question - Alderman Black Re: New City Prison

Alderman Black asked what progress had been made with respect to the erection of a new City Prison.

The City Manager stated that the matter is in the hands of the Regional Authority, and that he was not aware of any action having been taken other than the original discussions by that Authority.

His Worship the Mayor stated that he had discussed the matter with Mayor-Elect Zatzman of Dartmouth and had indicated to him the desire for a meeting as soon as possible, at which time the matter of the new prison will be discussed.

Alderman Wyman advised that Mr. Pratley is making a careful study of the above report and is going to prepare a report for the Bridge Commission of his reactions to it because of his interest in the matter.

Alderman O'Brien wanted to know if the City's representatives on the Bridge Commission will take a more vigorous stand for the kind of recommendation which the City staff makes clear should be supported. He stated he was unhappy with the Commission getting so far along without there appearing to be more solid influence from the City's representatives on the Commission.

Alderman Wyman did not feel that the City Council needed to or ought to wait for whatever may come from Mr. Pratley on this matter.

He advised that if Council says it does not agree and requests a further study of the matter the Bridge Commission will give the answer that it has no money with which to pursue such a further study. If Mr. Pratley does make a

further study and submits another report, he is doing it without remuneration because of his interest.

Replying to Alderman O'Brien, Alderman Wyman stated that the City representatives on the Commission at the time of the consideration of the Pratley Report, felt it was important the progress toward a solution of the traffic problems involving bridges, should not be delayed.

They, therefore, agreed that the report be sent forward as the Commission's recommendation with the understanding that all parties concerned with it would have an opportunity to study it and to make their recommendations before any definite action would be taken.

It was agreed that a meeting of the Committee of the Whole Council be called to discuss the Staff Report.

#### CITIZENS REHABILITATION COMMITTEE

In 1945 a Citizens Rehabilitation Committee was set up on the recommendation of His Worship the Mayor for the purpose of welcoming families of returning soldiers from theatres of war. This Committee continued operating for the years 1945, 1946 and 1947 and an appropriation was provided under the authority of Section 315, sub-section 6, of the City Charter.

The outgrowth of this Committee was that Mrs. M. B. Fineberg continued to provide gifts for children of immigrants landing in Halifax en route to other points in Canada. This has been continued from year to year by Mrs. Fineberg and money has been provided by the Mayor in Office on request, out of the contingent account. No separate appropriation has been established for this service since 1947.

Mrs. Fineberg's services are very commendable. However, it does not seem to be the responsibility of the City of Halifax and should be a service which should be provided by the Federal Government and considering that apparently none of these immigrants take up residence in the City of Halifax it is therefore recommended that we discontinue providing funds for this purpose.

AND WHEREAS by subsection (1) of Section 9 of the said City Charter, the City Council of the City of Halifax may from time to time by resolution determine the honorarium to be paid to the Deputy Mayor during the period in which he holds such office, in addition to the indemnity or compensation which he receives as an alderman;

AND WHEREAS by subsection (1) of Section 10A of the said City Charter, the City Council of the City of Halifax may from time to time by resolution determine the indemnity or compensation to be paid to each alderman of the City;

NOW THEREFORE BE IT RESOLVED that the remuneration to be paid to the Mayor of the City of Halifax for the period January 1, 1964 to December 31, 1964, shall be at the rate of Ten Thousand Dollars (\$10,000.00) per annum;

AND BE IT FURTHER RESOLVED that the honorarium to be paid to the Deputy Mayor of the City of Halifax during the period January 1, 1964 to December 31, 1964, in which he holds such office, in addition to the indemnity or compensation which he receives as an alderman of the City, shall be at the rate of Five Hundred Bollars (\$500.00) per annum;

AND BE IT FURTHER RESOLVED that the indemnity or compensation to be paid to each alderman of the City of Halifax for the period January 1, 1964 to December 31, 1964, shall be at the rate of Two Thousand Five Hundred Dollars (\$2,500.00) per annum.

Alderman A. M. Butler felt that the indemnity for the Office of Mayor should be increased in line with the duties and responsibilities of the Office.

He advised that he would make a submission to the next meeting of the Finance and Executive Committee.

# COMPENSATION - PROPERTY OWNERS - BICENTENNIAL DRIVE AREA

Alderman O'Brien stated that he had attended meetings with other members of Council and City staff, which were held in the Provincial Building.
