Authorities. He pointed out that the original specifications called for seeding, but sodding is being suggested with a layer of stone immediately under the structure where sod or seeding will never be of any use. He said that the Province is being requested to share the cost.

Alderman O'Brien asked if it were not possible to make the appraisals upon the assumption that this work would be completed.

His Worship the Mayor pointed out that the direction of Council was that the appraisals be made after the work is completed and changes would have to be made by a vote of Council.

Alderman O'Brien was of the opinion that the instructions had a time limit.

His Worship the Mayor said that was not his understanding.

Staff were directed to check the minutes and a report submitted to the next Council meeting.

Question - Alderman O'Brien Re: Centennial Committee

Alderman O'Brien asked whether or not the City's Centennial Committee had made any progress toward a report.

His Worship the Mayor stated that meetings were held at which sub-committees were appointed to study proposed projects, but they were not in a position to report to Council as yet.

Alderman O'Brien asked if there were any risk of the City losing its share of the Federal Funds available for some public project here because of delay.

His Worship the Mayor said there was a greater risk

from Provincial action than there is on any part of the City.

He stated that he would report to a subsequent meeting of Council.

Question - Alderman O'Brien Re: Awarding of Tenders for Lamps

Alderman O'Brien asked if the City Solicitor had received a request from the School Board regarding the refusal of Westinghouse to comply with the awarding of a low tender for lamps.

The Deputy City Solicitor informed Council that the letter had been received only today.

Alderman O'Brien asked whether or not the Solicitor is able to enforce the award.

He was requested to submit a report to the next meeting of Council.

Question - Alderman Richard Re: Management Consultants

Alderman Richard asked when a report could be submitted from the Finance and Executive Committee regarding the appointment of Management Consultants.

His Worship the Mayor said that no action had been taken on the matter during the City Manager's absence, but shortly after his return from vacation the matter would be processed and would appear on the agenda of the next meeting of Council.

Question - Alderman Meagher Re: Tenders for Gravel

Alderman Meagher asked who has the tender for supplying gravel to the City of Halifax this year.

The Commissioner of Works stated that Maritime Sand and Gravel were awarded one part of the contract and at the moment there is a conflict as the tenderers are not adhering

to the specifications. He pointed out that if the tenderer is not supplying materials to meet the specifications, the City Manager can obtain the materials from some other supplier and, if the cost is higher than the contractor who should have supplied the proper materials, that contractor (tenderer) must pay the difference. He said the City Manager recently wrote to the tenderers and they claimed they could supply the proper materials and they did for a day or two, but the City is still not satisfied, and upon the City Manager's return Monday, the matter will again be considered.

Alderman Meagher asked who has the tender for the trucking of the gravel.

The Commissioner of Works stated that the gravel this year was supplied on the site.

Question - Alderman Macdonald Re: Capital Borrowing Street Lighting

Alderman Macdonald asked what has been done with respect to carrying out the street lighting installations on Hunter Street, money for which was provided in the Capital Budget in 1963.

The Commissioner of Works stated that tenders were awarded some time ago and installations will be made shortly.

Question - Alderman Macdonald Re: Redevelopment of Common

Alderman Macdonald asked if work were going to be carried out on the redevelopment of the Commons this year.

His Worship the Mayor said that this matter has been the subject of a study by the Development Department Staff, and a report would be submitted to the Development Committee shortly.

Question - Alderman Richard Re: Street Lighting - Hydrostone Area

Alderman Richard asked if any progress had been made on the installation of new street lighting in the Hydrostone Area.

His Worship the Mayor stated that plans are underway now by the City Electrician and will be submitted to the Committee on Works shortly.

RATIFICATION OF COUNCIL ACTION - FOUR CIRCUS PERFORMANCES PER DAY

The City Clerk advised that a telephone poll of the members of Council had been carried out with respect to a request that the Sells-Gray Circus be permitted to hold four performances per day at not less than one hour and fifteen minutes each.

Alderman Richard suggested that the City Solicitor
be instructed to draft rigid regulations regarding circus applications and that these be on file in the City Clerk's Office
so that any person seeking an application could be given a
copy of the regulations and told that these regulations are
laid down by City Council and must be adhered to.

MOVED by Alderman A. M. Butler, seconded by Alderman Wyman, that the action of the Mayor and City Officials be ratified in connection with the special arrangements made with the Circus Officials and Canadian Legion. Motion passed.

PUBLIC HEARING RE: REZONING OF LAND - #980 MACLEAN STREET FROM R-2 ZONE TO R-3 ZONE

The minutes of the meeting held on July 16, 1964, were approve

A public hearing was held at this time in connection with the application of the owners of the property at #980 MacLean Street to have the land rezoned from R-2 Zone to R-3 Zone.

The City Clerk stated that the matter had been duly advertised and that a petition, signed by twenty-nine property owners in the are opposing the rezoning, had been received, in addition to approximatel fifteen letters from residents in the area protesting against the rezoning.

The Director of Planning displayed a plan showing the area involved and explained the proposal.

Mr. Stewart McInnes appeared on behalf of the petitioners who object to the rezoning on the grounds that any down grading of the zoning would have the effect of lowering property values in the area and would tend to change its present character and nature.

Mr. H. B. Rhude, appearing on behalf of the applicant, stated that the land in question would not be built upon but would be used for parking for four cars only, the balance being landscaped; and the proposed 40-unit apartment house would be constructed wholly on the portion of land which is zoned R-3.

He contended that the residents in the area are unnecessarily upset about the proposed development, and expressed the opinion that property values will be enhanced rather than being adversely affected.

MOVED by Alderman Meagher, seconded by Alderman Richard, that the land at #980 MacLean Street be rezoned from R-2 Zone to R-3 Zone.

However, after consultation, the Company had agreed to honor the contract.

Report - Management Consultants

His Worship the Mayor stated that the matter is not properly before the Council because the matter is still under consideration in the Finance and Executive Committee. He stated that

he would be reporting to that Committee when his submission has been completed.

At the last meeting of City Council on July 16, 1964, a petition from the property owners neighbouring on the Halifax Grammar School was referred to Staff for a report. The petition deals with unsatisfactory conditions on Atlantic Street caused by traffic generated by the School.

The matter of vehicular traffic, car parking and driveways for the Grammar School was previously the subject of discussions between City Staff, School Administration and property owners. The improvements introduced by the School as a result of these discussions appeared to be satisfactory. However, the new petition indicates that the matter will require further study.

Unfortunately, the Headmaster and Assistant Headmaster of the Grammar School are away and Staff is not able to discuss the matters raised by the petition. However, the question will be raised with the School Administration immediately on the return of the Headmaster from his vacation. In the meantime, while the School is closed for the summer vacation, the traffic problems which it may be creating should not be present.

REPORT - DEVELOPMENT COMMITTEE

To His Worship the Mayor and Members of the City Council.

The Development Committee at a meeting held August 13th considered various items of civic business and now reports as follows:

Survey - Armdale Rotary and North West Arm Bridge

- 1. It is recommended that a firm of Engineering Consultants be retained jointly by the Province and the City of Halifax:
