Some time ago Mr. L. W. Collins presented a Brief to the Development Committee of City Council urging the restoration of certain waterfront properties, thereby preserving a portion of the historic part of our city which will be of great interest to our own people and a major tourist attraction.

At our last Council meeting it was unanimously agreed to write you and members of City Council urging "that City Council give careful consideration to the proposals set forth by Mr. Collins with a view to following his recommendations where feasible".

WHEREAS; The possibility of relocating City Field has been mentioned by some authorities to make way for such a cultural centre, and

WHEREAS; The Nova Scotia Museum of Science is urgently required to move from its present inadequate quarters in the premises of the Nova Scotia Technical College

THEREFORE BE IT RESOLVED that the Halifax Board of Trade strongly urge civic authorities to allocate the present City Field area for such a cultural centre with particular emphasis on the Nova Scotia Museum of Science as the initial occupant, thereby reinforcing those who have expressed this opinion, and

BE IT FURTHER RESOLVED that City Council urge the preparation of a Master Plan for such a cultural centre, making maximum use of existing ground area so that eventually a complex may be established to contain other amenities such as a centre for the performing arts, a home for the Museum of Fine Arts and other important institutions."
