A discussion ensued on the matter and it was MOVED in Amendment by Alderman Shannon, seconded by Alderman Meagher that item No. 11 "Sewer Development Charges (Ord. 153)" as shown in the staff report of December 14, 1978, in the amount of \$54,061.22, be deleted from the total write-off.

The Motion to amend was put and lost with three voting for the same and five voting against.

The Main Motion was then put and passed with Alderman Shannon against.

Architecture and Construction Assessment -Call for Proposals - Brunswick Street

The following is the recommendation of the Finance and Executive Committee:

"That City Council authorize an award of contract to the Kleinfeldt Group to complete the structural assessment, architectural exterior assessment, the street scape, and to include disbursements for printing for an amount not to exceed \$45,000.00, subject to approval of cost sharing of 50% by Central Mortgage and Housing Corporation, and confirmation of cost sharing from Heritage Canada to the Kleinfeldt Group not to exceed \$45,000 in gross total."

A letter dated December 27, 1978, was submitted from the Acting Chairman of the Halifax Landmarks Commission which His Worship noted, requested that the item be deferred.

Alderman Shannon indicated she was surprised to receive the letter from the Commission and advised that she spoke to Commodore McMillin, Chairman of the Sub-Committee for Brunswick Street saying their concern is that the interior assessment was not included in the staff recommendation nor in the recommendation of the Committee.

Alderman Shannon expressed the feeling that the Landmarks Commission would like Council to realize they are not entirely happy about the matter but said she stressed to Commodore McMillin that Heritage Canada is not interested in the interior architectural assessment of the buildings nor economic potential, and are not prepared to cost share in the two components. Alderman Shannon advised that Heritage Canada has indicated there may be some units of housing in which they may want interior architectural information and they would be prepared to pay the consultants separately for such information. Alderman Shannon indicated she would like to see Council proceed with the staff recommendation.

Discussion ensued on the matter and it was MOVED by Alderman Shannon, seconded by Deputy Mayor Downey that, as recommended by the Finance & Executive Committee, City Council authorize an award of contract to the Kleinfeldt Group to complete the structural assessment, architectural exterior assessment, the street scape, and to include disbursements for printing for an amount not to exceed \$45,000.00, subject to approval of cost sharing of 50% by Central Mortgage and Housing Corporation and confirmation of cost sharing from Heritage Canada to the Kleinfeldt Group not to exceed \$45,000 in gross total; funds to be paid from Account No. 411 085 HAA02.

Discussion ensued on the matter and it was MOVED by Alderman Sullivan, seconded by Alderman Clarke that Halifax City Council request that the Department of Public Health have the Atlantic Health Unit order a co-ordinated, three municipality approach to rodent control, abatement, and extermination.

The Acting City Manager advised that other matters were discussed when staff reviewed the matter and suggested the item be deferred to the next regular meeting of the Committee of the Whole Council in order that staff may present what it perceives might be achieved in this area.

Council then agreed that the item be deferred to the next regular meeting of the Committee of the Whole Council.

Quality of Water, Chocolate Lake

At the Safety Committee meeting, a letter was submitted expressing concern about the quality of water in Chocolate Lake which was submitted as a petition, and the Committee agreed that a report be prepared for Council on the matter.

Tendering Process - Metro Centre Sound System (Alderman Maley)

Alderman Maley asked that a detailed report from the Metro Centre Commission be made available for the January 3 meeting of Committee of the Whole Council, the said report to describe the tendering process employed with regard to proposals for the Centre's sound system.

QUESTIONS

Question Alderman Hamshaw Re: Entrances to Lacewood Drive and Bridgeview Drive (North and South)

Alderman Hamshaw requested that the matter of entrances to Lacewood Drive and Bridgeview Drive (north and south) be brought before Council during their Capital Budget deliberations.

The Acting City Manager noted that a staff report on this matter had recently been issued and assured Alderman Hamshaw that this item will be considered at a future budget meeting.

Question Alderman Wooden Re: Streetlights on Dunbrack Street

Alderman Wooden noted that a large number of streetlights along Dunbrack Street were recently turned off owing to a malfunction. However, she advised that, despite this malfunction, the street appeared to be well lit and asked that, in this time of restraint, staff submit a report on the feasibility of decreasing the number of lights on this street.

Question Alderman Wooden Re: Emergency Telephone Number (Halifax Police Department)

Alderman Wooden advised that she has received a number of complaints from residents of Ward 7 concerning problems in contacting the Police Department at their emergency number. She asked that a report be submitted to the Safety Committee on the operation of this number and any difficulties the Police Department may be experiencing with it.

Question Alderman Wooden Re: Senior Citizens Housing (Mainland South)

Alderman Wooden requested the status of a feasibility study on senior citizen housing in Mainland South previously authorized by Council.

His Worship advised that an item of additional funding will be provided for this project in the 1979 budget and added that he would press for an affirmative response to Council's request.

Question Alderman Maley Re: Point Pleasant Drive Pavement

Alderman Maley advised that she has recently noted several bad cracks in the pavement on Point Pleasant Drive. She requested a staff report on this matter and asked that consideration be given to including these repairs in the 1979 budget.

Question Alderman Clarke Re: Sign Ordinance

Alderman Clarke requested an information report as to when the Sign Ordinance will be brought forward for consideration by Committee of the Whole.

Question Alderman Clarke Re: Report from Board of School Commissioners

Alderman Clarke requested a copy of the report recently prepared by the Board of School Commissioners concerning the lowering of admission requirement for first graders. He also asked to be advised as to when the Board intends to present its recommendations on this matter to Council.

Question Alderman Clarke Re: Amendments to the Municipal Elections Legislation

Alderman Clarke referred to correspondence received from the Union of Nova Scotia Municipalities concerning proposed changes to the municipal elections legislation and asked if recommendations from the City's Elections Procedures Committee would be available for the January 17 meeting of Committee of the Whole Council.

His Worship advised that the possibility is unlikely as a meeting of that Committee has not yet been convened.

Continuing Expenditure in 1979 (Social Planning Department
- Senior Citizens Transit Tickets)

A staff report dated December 28, 1978 was submitted.

MOVED by Alderman Sullivan, seconded by Alderman Meagher that City Council authorize staff to charge as a prior and first charge against the Social Planning budget for 1979 an amount not to exceed \$33,750 and for a period of time not later than March 31, 1979 for the purpose of providing funds for the purchase of Senior Citizens Transit Tickets. Motion passed.

Responding to a question from Alderman Meagher, Mr. T. Stewart of the Social Planning Department advised that, as several outlets have depleted their supply of these tickets, the Department intends to begin redistribution by the first week of January, 1979. He also noted that approximately 750,000 transit tickets have been used by senior citizens in 1978.

Pollution Control Charge

Alderman Shannon expressed concern regarding the extensive program of pollution control in which the City has been engaged. She noted that limited action has been taken to date to encourage neighbouring municipalities in this regard and added that, at present, senior levels of govenment would not appear to be giving precedence to this matter. Alderman Shannon suggested that Council examine its obligations with regard to pollution control and, if they are found to be as imperative as initially perceived, discussions should be instigated with the Province and the other municipal governments, both on the matter of cost-sharing agreements and the types of pollution control proposed.

His Worship noted that the City had been partially motivated by the necessity of providing a more adequate system for sewage control, but agreed that a less expensive method than that proposed by MAPC may be equally feasible.

After some further discussion, the Acting City Manager advised that staff will be asked to submit a detailed report outlining the events leading up to the City's present position in the pollution control program and to include recommendations for consideration in further discussions with other levels of government, should such discussions be deemed expedient by Council at that time.

Street Closures - Yukon and Yale Streets

MOVED by Alderman Meagher, seconded by Alderman Sullivan that City Council authorize staff to continue until March 31, 1979 the temporary closure of Yukon and Yale Streets at their intersections with Monastery Lane, and that Wednesday, February 21, 1979 at 7:30 p.m. be set as the date for a public hearing to consider the permanent closure of these streets. Motion passed.
