1. CALL TO ORDER

The meeting was called to order at 6:46 p.m. in the Media Room, City Hall.

2. APPROVAL OF MINUTES - March 28, 2011

- 5. **CONSIDERATION OF DEFERRED BUSINESS**
- 5.1 Case 15775: Halifax Peninsula Laying Hens
- A staff report, dated February 7, 2011, was submitted.

Ms. Mackenzie Stonehocker, Planner, gave a presentation on the Halifax Peninsula Land Use By-law. She provided a brief outline of the staff research, the public information meeting and opinion surveys, the experience of other municipalities, and the alternatives open to Peninsula Community Council and to Regional Council.

The Committee members entered into a discussion with Ms. Stonehocker providing additional clarification in response to questions on pilot projects, animal and property controls under existing by-laws and the role of the Nova Scotia Department of Agriculture. Councillor Sloane requested that staff undertake additional research on how the Department of Agriculture and the municipality could work together on this issue.

Mr. Fred Connors, citizen, requested permission to speak and the Committee agreed to hear a brief presentation. Mr. Connors outlined his experience in caring for backyard chickens, the responsibilities, and the community engagement that has resulted in his neighbourhood.

The Committee concluded that it did not agree with the staff recommendation and the existing By-law should be amended. The Chair stated that she could not support the Committee's decision as she felt there were not sufficient controls in place to ensure responsible ownership of laying hens. The Chair then called for a vote.

MOVED by Mr. Lovitt, seconded by Councillor Sloane that the District 12 Planning Advisory Committee recommend that Peninsula Community Council:

- 1. Amend the existing Halifax Peninsula Land Use By-law in order to permit backyard laying hens, taking into account further information on the Department of Agriculture's mandate; and
- 2. Pursue amendments to the HRM Charter in order to enable pilot projects.
