# 9.1.1 Bi Annual Workforce Report

The following was before the Standing Committee:

- A staff information report dated January 7, 2015
- A copy of the staff presentation

Ms. Cathi Mullally, Director of Human Resources delivered a presentation entitled: HRM Workforce Report to the Standing Committee. Ms. Helga Wolf-Billard, Manager, Corporate Safety reported on health and safety in regard to the HRM Workers Compensation Board (WCB) classification reports for administration, recreation and bus transportation. Ms. Wolf-Billard noted a correction to presentation slide 14 entitled: WCB Claims – HRM Rates, clarifying at the administration premiums increased by \$32,000 not \$24,000.

The Standing Committee entered into a discussion with staff responding to questions of clarification. Additional requests for information in future reporting were made as follows:

- The inclusion of the Auditor General's business unit in the data provided
- Provide a breakdown of the distribution by age group within each business unit
- Identify annual trends of attendance
- The inclusion of a quarter over quarter/year over year comparison for Workforce Profiles
- Identify percentages of active versus inactive employees per business unit
- Identify what preventative educational work is being done to track trends in the number of grievances and types of injuries filed (e.g. include as a notation)
- Outline the composition and mandate of the Attendance Management Committee

Councillor Karsten asked staff to clarify the total number Fire & Emergency employees, noting that the staff presentation identifies 476 employees (active and inactive), and the staff supplementary information report dated January 19, 2015 to Regional Council identifies 406 FTE firefighters. Deputy Fire Chief Brian Gray clarified that the 406 FTE firefighters refers to the operational employees and not the full complement of staffing. He explained that the operational employees are the firefighters and officers within the stations.

It was noted that the staff information report dated January 7, 2015 will be forwarded to all members of Council for their information and is available on the public agenda.
