He stated that in November 2011 a complainant had advised HRM that the house was derelict and a fire hazard; reading from the complaint regarding the property. Mr. Travers indicated that, since November, he had done everything possible to try and solve this problem and the remaining bags were leaves cleared as part of the clean up, and two lobster traps were part of the wood removal. He presented a letter he wrote to Councillor Sloane dated April 25, 2012 and read it into the record. In closing, Mr. Travers stated that he intended to comply and had remedied

many things so far; noting he hoped to proceed with the continuation and completion of this work within seven to ten days.
