9.3.1 Case#223579, 1020 Bellevue Avenue, Halifax

The following was before the Standing Committee:

• A staff recommendation report dated April 16, 2014

Mr. Robert Ryan, Compliance Officer, By-law Standards, provided an overview of the April 16, 2014 staff report; presenting photographs of the property in question.

Mr. Ryan responded to questions around the Stop Work Order issued August 2012.

The appellant, Mr. Mit Jha of 38 Portland Hills, Dartmouth, commented on other buildings in HRM being in worse condition than his building and questioned the process. Mr. Ryan advised the process is complaint driven.

Mr. Jha expressed concern not having his lawyer present for the hearing and there being no provision to allow his lawyer to be present. His lawyer contacted Mr. Ryan requesting a extension as he would be out of town and unable to attend, but was denied.

Mr. Randolph Kinghorne, Municipal Solicitor asked Mr. Jha if he was requesting an adjournment from the Appeals Standing Committee in order to speak with legal counsel; to which Mr. Jha responded yes.

MOVED by Councillor McCluskey to defer the appeal of Case 223579, 1020 Bellevue Avenue, Halifax to the next meeting after June 1, 2014. There being no seconder the motion was lost.

Mr. Jha proceed to present his appeal to the Standing Committee; indicating that he had asked to demolish the building last year but was denied because there was the question of who was going to pay for it. He spoke to the complaints made by neighbours but was unsure as to how many complaints there were. As well, how he had asked Mr. Ryan for an extension on the demolition date where the building is eight feet from the neighbouring property, he did not want to demolish it in the winter where it is unsafe for the workman to go on the roof. Mr. Jha had contacted a contractor and was told the demolition could be done June 30, 2014.

In response to a question raised by Councillor Adams, Mr. Jha stated that his lawyer had contacted HRM staff and legal respecting concerns about how the demolition request has been dealt with. He had been advised not to make any decisions without his lawyer present.

Further discussion was held on Mr. Jha's request to have his lawyer present at the hearing.

Mr. Kinghorne spoke to judicial process and that the Court could overturn the Standing Committee's decision on the basis of Mr. Jha's request to have legal counsel present at the hearing.

MOVED by Councillor Adams, seconded by Councillor McCluskey that the Appeals Standing Committee defer the appeal of Case 223579, 1020 Bellevue Avenue, Halifax to the next meeting after June 1, 2014 to allow the appellant's lawyer to be present. MOTION PUT AND PASSED.
