9.1.1 Possible Support for Engage Nova Scotia

The following was before the Standing Committee:

• A staff recommendation report dated January 30, 2015

MOVED by Councillor Fisher, seconded by Deputy Mayor Nicoll that the Community Planning and Economic Development Standing Committee recommend that the Audit & Finance Standing Committee

- (1) Halifax Regional Municipality, working closely with the Halifax Partnership (HP), provide an initial grant of \$50,000 to Engage Nova Scotia (ENS) this fiscal year with the possibility of an additional grant next year, subject to Council approval and if certain conditions are met.
- (2) Approve the withdrawal of funds in the amount of \$100,000 from the Operating Surplus Reserve, Q328 to cover the operating grant for fiscal 2014/15 and 2015/16 respectively.
- (3) Halifax Regional Municipality and ENS sign an Agreement along the lines of the one set out in Attachment A to govern the relationship between the two parties and to set out conditions for continuation.
- (4) Halifax Regional Municipality participate actively in the work of ENS where appropriate over the coming year.

Ms. Maggie MacDonald, Acting Managing Director, Government Relations and External Affairs and Mr. Chris Bryant, Senior Advisor, Government Relations and External Affairs responded to questions from the Committee.

In response to questions from Deputy Mayor Nicoll, Mr. Bryant advised that Mr. Danny Graham, a Board Member of Engage Nova Scotia was present and could respond to specific questions with regard to the work of Engage Nova Scotia, if the Committee wished. The Committee agreed to hear Mr. Graham and he was invited to come forward.

Mr. Graham addressed the Committee and provided background information on the origin and mandate of Engage Nova Scotia, advising that Engage Nova Scotia is a network of individuals and organizations from across the Province taking action on the Province's economic and social challenges by changing attitudes and introducing new ideas. He added that the group wants to get more Nova Scotians involved and engaged in solving these challenges, and rely less on government to resolve these issues.

Mr. Graham responded to questions.

In response to a question, Mr. Graham explained that the funding the group receives will go toward supporting evens like a Symposium on Economy, Attitude and Wellbeing they are hosting in June 2015.

A discussion ensued and the Committee was generally supportive of this initiative, however, there was concern that the wording of recommendation 2, as written, suggests the Municipality was going to provide \$100,000 for the next 13 months to Engage Nova Scotia, whereas, the intent was to provide \$50,000 this year with the idea of re-examining it next year for providing an additional \$50,000. The Committee felt an amendment would provide clarity around this aspect.

MOVED by Councillor Fisher, seconded by Deputy Mayor Nicoll that recommendation 2 of the motion be amended to read as follows:

"Approve the withdrawal of funds in the amount of \$50,000 from the Operating Surplus Reserve, Q328 to cover the operating grant for fiscal and 2015/16."

THE AMENDMENT TO THE MOTION WAS PUT AND PASSED.
