 - 8.3.1 Amy Melmock Neptune Theatre 2016 Renovation Campaign

The following was before the Committee:

- A submission entitled, A Proposal for Halifax Regional Municipality, Neptune Renovations 2016.
- A Power Point Presentation

Ms. Amy Melmock, General Manager, Neptune Theatre Foundation provided a presentation. Her presentation focussed on the renovation project the Theatre has planned for the summer of 2016. She advised that the estimated project cost is \$3.6 million and that they have secured \$1.1 million from private and corporate contributions; \$1.1 million in additional corporate support is pending, and that \$1 million in support has been requested from the federal and provincial governments. Ms. Melmock also advised that Neptune will contribute to the campaign annually through its capital fund and that community participation will be encouraged through social media and seat campaigns. She indicated that the Theatre will be requesting from the Municipality a contribution of \$100,000 in April of 2016.

Ms. Melmock responded to questions.

The Chair suggested Ms. Melmock forward the Theatre's request via correspondence and the Committee would then consider forwarding it to staff.

9.1.3 Support for Destination Eastern and Northumberland Shores (DEANS)

The following was before the Standing Committee:

MOVED by Councillor Craig, seconded by Councillor Watts

That the Community Planning and Economic Development Standing Committee recommend to Regional Council that:

- 1. A grant of \$6,400 per year, renewable annually for up to five years, be paid to Destination Eastern and Northumberland Shores (DEANS) beginning in the 2015-2016 fiscal year and continuing through the 2020 2021 fiscal year.
- 2. the grant be paid through Destination Halifax; and
- 3. Destination Halifax and DEANs sign an agreement on how the grant gets spent and reported on.

Councillor Watts, in referring to the report, noted that it states the tourism sector is undergoing change and a new tourism strategy was being developed. She added that once the strategy was completed it would be helpful for staff to provide a presentation to the Committee on the future direction of tourism and the impact and opportunities for HRM as a result.

In response to a question of clarification, Ms. Maggie MacDonald, Managing Director, Government Relations and External Affairs explained that with regard to recommendation 1, i.e. a grant of \$6,400 per year, renewable annually for up to five years, would be at Council's discretion to renew on an annual basis.

The Community Planning and Economic Development Standing Committee recommend that Halifax Regional Council:

- 1. Establish the Off-Leash Park Program as a permanent service to be considered as part of annual HRM business planning and budgeting process.
- Direct staff to develop an Off-Leash Dog Parks Administrative Order (AO) that will replace the Off- Leash Dog Parks Strategy 2007 by establishing policy objectives, service level requirement, and minimum criteria and procedures for the provision of off-leash facilities based on the Off-Leash Dog Parks Strategy 2007 with the changes and actions outlined in Attachment 1.

Mr. Peter Bigelow, Manager, Policy and Planning, Parks and Recreation provided a presentation of the Off-Leash Parks Strategy, as outlined in the submitted staff report. Mr. Bigelow responded to questions of clarification.

Councillor Watts noted that many residents are looking for clarity around this issue and she advised that as HRM provides clarity, it may result in confusion among the public. She emphasized the importance of HRM's clear communication on the Strategy and ensuring consistency in the message. Councillor Watts also noted that, with this being a statistics-based strategy, it will work best for those dogs that are licensed. She added that the Strategy may encourage more dog owners to license their pets because, to some extent, the licensing of dogs will drive service delivery.
