7.1 Weed Growth in Lake Banook and MicMac

This matter was deferred from the January 15, 2015 meeting of the Committee with a request that staff report regarding additional information received from Lake Management Services.

Ms. Katie Perfitt, Organizer, David Suzuki Foundation and Ms. Kate Mac-Eachern-Ali, Halifax Blue Dot Campaign Volunteer gave a brief presentation indicating that their purpose was to request Halifax to sign the declaration for the Right to a Healthy Environment. Ms. Perfitt indicated that the model distributed to members was being used across Canada.

Ms. Perfitt and Ms. MacEachern-Ali, responded to questions from members of the Committee.

With regard to what other municipalities are doing beyond signing the declaration, Ms. Perfitt noted that municipal elected officials are bringing the discussion of the right to healthy environments to the Provincial and Federal levels.

Councillor Karsten suggested that in signing the declaration, Council could expect significant work would be required to fulfill the intent of the declaration.

Deputy Mayor Nicoll noted that the campaign is about the right to a healthy environment and indicated that the balance of protecting the environment and achieving prosperity is a sensitive one.

MOVED by Deputy Mayor Nicoll, seconded by Councillor Johns that the Environment and Sustainability Standing Committee request a staff report examining the Blue Dot Campaign's requested declaration of support. MOTION PUT AND PASSED.
