The meeting was called to order at 1:03 p.m. and adjourned at 2:27 p.m.

Councillor Watts stepped down from the Chair to speak to the matter, and Deputy Mayor Nicoll assumed the Chair.

The following motion was placed on the floor at the May 14, 2015 meeting of the Environment and Sustainability Standing Committee:

THAT Environment & Sustainability Standing Committee not forward a recommendation to Regional Council to consider a declaration of support for an Environmental Bill of Rights.

Councillor Watts proposed that the Committee defeat the motion, indicating that she would then bring forward a motion to support the alternative from the staff report regarding a partial declaration.

THAT the Environment and Sustainability Standing Committee recommend that Regional Council make a declaration on the right to a healthy environment as per Attachment B of the staff report dated September 18, 2015, with the following amendments:

- replace all references to "The City of Port Coquitlam" with "The Halifax Regional Municipality."
- amend item 5 to remove two occurrences of the phrase "by December 31, 2016,"
- remove item 6, and
- add "The Halifax Regional Municipality requests that the Blue Dot campaign make available the full text of this resolution on their website."

8.3 Presentations

8.3.1 Raja Ubhi and Samuel Reeves, QUEST NS re: District Energy and the Cogswell Interchange - The Next Steps

The following was before the Environment and Sustainability Standing Committee:

- A handout entitled "District Energy and the Cogswell Interchange: The Next Steps"
- A report entitled "Transforming the Cogswell Interchange: a district energy opportunity"
- A document entitled "Critical Path for Implementing District Energy at the Cogswell Interchange"

Samuel Reeves and Raja Ubhi provided information to the Committee from a roundtable discussion they hosted earlier in the year regarding district energy possibilities at the Cogswell interchange. They provided an overview of key considerations including the ownership structure, funding and policy, system design, and project implementation, and they highlighted the need for a feasibility study.

Deputy Mayor Nicoll inquired how prices are set under the model used in Markham, Ontario. Mr. Ubhi responded that it is an unregulated model where prices are set by private firms.

The Chair thanked the presenters for their information, noting that the matter provides a challenging but important opportunity for the municipality to consider.

8.3.2 Robin Tress, Ecology Action Centre re: Home Adaptation Audit Program

Robin Tress, Coastal Adaptation Coordinator with the Ecology Action Centre delivered a presentation regarding a Home Adaptation Audit Program (HAAP). She informed the Committee that her intent was to launch the program in 2016 in order to educate homeowners on the risks from climate change impacts and to provide recommendations on how to reduce those risks. She indicated that a pilot program would target 1800 homes, mostly in flood risk areas of Halifax.

Ms. Trees expressed an interest in collaborating with the municipality to deliver the program and outlined several ways in which a partnership could proceed. She noted that some financial support may be provided by the University of Waterloo if there is tangible support from the community.

MOVED by Deputy Mayor Nicoll, seconded by Councillor Karsten

THAT the Environment and Sustainability Standing Committee request a staff report examining request for interest in participating in the Ecology Action Centre's Home Adaptation Audit Program (HAAP).

Deputy Mayor Nicoll noted that the Halifax Regional Water Commission may be interested in the program and suggested the report may consider how HAAP could assist residents with Stormwater management.

In response to a question from Deputy Mayor Nicoll, Ms. Tress indicated that many of the proposed 1800 pilot homes would be in the Sackville area, but that they would look to identify other areas of high risk.

Councillor Karsten questioned whether the program may offer false hope to residents, as some issues related to shore erosion are very difficult to counter. Ms. Tress responded that the auditors would be trained to give advice only on specific issues. For example, she noted, if there is a recommendation that the properly be regraded, the homeowner would be advised to consult an engineer.

In response to additional questions, Ms. Tress advised that for the first time in Canada, insurance claims due to flooding exceed claims related to fire. She noted that there is no available insurance coverage to homeowners for overland flood damages in Canada.
