1. CALL TO ORDER

The Chair called the meeting to order at 1:10 p.m.

2. APPROVAL OF MINUTES

6. CONSIDERATION OF DEFERRED BUSINESS

6.1 TERMS OF REFERENCE

The draft Transportation Standing Committee Terms of Reference were before the Committee.

The Committee discussed the role of the Traffic Authority with regard to this Committee and Regional Council. Mr. Reashor indicated that reports have come forward in the

past on the role of the Traffic Authority, and Councillor Watts requested that something be put together for this Committee's information.

Members requested clarification on the Standing Committee's recommendations of appointments to boards and committees. Ms. Murphy advised that recommendations on appointments will be coming before the Standing Committee next month.

Councillor Hum inquired whether the Safe Communities Network Committee could fall under the mandate of the Transportation Standing Committee. Ms. Murphy clarified that the Safe Communities Committee is not a Committee of Council. The Chair requested that minutes from the Safe Communities Network Committee be provided to members for their information.

Mr. Reashor clarified at the request of members that budget items will go to the Audit and Finance Standing Committee for review, however if there is a specific budget item that members of the Transportation Standing Committee want to review, it can be arranged.

Councillor Watts requested that a synopsis of the transportation budget be presented to this Steering Committee.

MOVED by Councilor Blumenthal, seconded by Councillor Hendsbee, that the Terms of Reference of the Transportation Standing Committee be approved. MOTION PUT AND PASSED.

7.1 TIMELINES FOR TDM PROJECTS

7.2 PENINSULA TRANSIT CORRIDOR STUDY UPDATE

Mr. McCusker provided an update on the Peninsula Transit Corridor Study and responded to questions.

7.3 MOTION OF ADMINISTRATIVE STANDING COMMITTEE – January 24, 2011 – Appointment to Transportation Association of Canada

This item arises from a motion of the Administrative Standing Committee passed at their January 12, 2011 meeting requesting the Transportation Standing Committee to not make an appointment to the Transportation Association of Canada Board of Directors pending a review of the Terms of Reference. Discussion ensued regarding this appointment.

MOVED by Councillor Hendsbee, seconded by Councillor Fisher, that an HRM staff member with a technical and/or transportation background (as recommended by the Deputy CAO) be recommended for appointment to the Transportation Association of Canada Board of Directors instead of an elected official. MOTION PUT AND PASSED.

Councillor Blumenthal provided a verbal update on the projects of the Advisory Committee on Accessibility in HRM (formerly called the Advisory Committee for Persons with Disabilities).

8. ADDED ITEMS

8.1 Councillor Sloane's March 1, 2011 Regional Council motion regarding the Winter Parking Ban

Councillor Watts commented that she believes the Transportation Standing Committee should have an opportunity to review the staff report on the winter parking ban, which is scheduled to be presented at the March 24, 2011 Transportation Standing Committee meeting prior to the matter being discussed at Council. Council may look to the Committee for advice on this matter at the March 1st Council session, and the Committee would not be prepared to give a recommendation without fully understanding the budget and service standard implications that would come from possible changes to the ban, which will be outlined in the staff report.

MOVED by Councillor Watts, seconded by Councillor Blumenthal, that the Transportation Standing Committee recommend that Regional Council defer Councillor Sloane's motion on the March 1st Regional Council agenda regarding the Winter Parking Ban until the Committee has an opportunity to review and make recommendation on the forthcoming staff report on the matter and further that all aspects of Councillor Sloane's motion be addressed in the staff report. MOTION PUT AND PASSED.
