#### 7.1 BID Contributions Fund: 2012 Recommended Awards

The July 19, 2012 staff report was before the committee. Mr. Peter Greechan, Grants and Contributions, explained that this is the first time this grant program was before the committee.

MOVED by Councillor Smith, seconded by Councillor Lund that the HRM Grants Committee recommend that Regional Council approve the eight (8) awards detailed in Attachment 2 of this report for a combined total of \$106,000 from operating account C771- 6919 and C764 – 6919.

# 7.2 HRM Community Grants Program 2012 – 2013: Appeals

The July 23, 2012 staff report was before the Committee. The Committee discussed funding for Cat Rescue Maritimes, The Anglican Church of the Apostles and Shelter Nova Scotia.

Mr. Peter Greechan, Community Developer, Grants and Contributions, responded to questions of clarification from the Committee on the report.

A discussion ensued.

MOVED by Councillor Walker, seconded by Mr. Higdon that the Grants Committee amend the recommendation from the July 23, 2012 staff report to include;

- 1. Funding of \$1,400 to Cat rescue Maritimes, and \$5,000 to the Anglican Church of Apostles, bringing the total to \$32,549 from operating account M311-8004 (Community Grants Program)
- 2. The decline of 7 appeals as detailed in Attachment 3.

MOVED by Councillor Walker, seconded by Mr. Higdon that recommends that Halifax Regional Council approve:

- 1. The six (6) awards detailed in Attachment 1 of the July 23, 2012 staff report and an award of \$1,400 to Cat Rescue Maritimes and an additional \$5,000 to The Anglican Church of the Apostles for a combined total cost of \$32,549 from operating account M311-8004 (Community Grants Program);
- 2. Amended conditions of funding for the Lake Charlotte Area Heritage Society and the Secret Theatre Society as detailed in Attachment 2 of the July 23, 2012 staff report;
- 3. The decline of seven (7) appeals detailed in Attachment 3 of the July 23, 2012 staff report.
